## Two Men Rob Zeeland Area Family

# Abduct Woman, Parents Tied Up

ZEELAND — A Zeeland township couple was tied and robbed at their home and their daughter abducted Wednesday night by two male subjects who stopped at their home near 88th Ave. and Ransom St.

The daughter was released five hours later in her car and two subjects believed involved were arrested at their homes in Grand Rapids and Wyoming and were held in the Kent county jail today awaiting arraignment.

Ottawa County Det. Martin Heyboer said two subjects drove into the driveway of the residence at about 10 p.m. Wednesday, knocked on the door and entered the house. One of the subjects carried a shotgun and the other a knife, Heyboer said.

Once inside the two went through the house and found about \$70 and then ordered the husband to tie up his wife with a telephone cord. The husband was tied with rope and the two subjects ordered the 41-year-old daughter to leave with them in her car.

Heyboer said the father and mother worked themselves from their bonds and called deputies

at about 11:05 p.m.

He said the two subjects and the daughter drove around Ottawa County and entered Kent County in the Grandville area at least twice before releasing her in her car in Grandville at 3 a.m. She drove home alone and returned about 4 a.m.

Taken into custody were Richard Lewis and Dennis Hutson, both 26. Lewis is from Wyoming and Hutson is from Grand Rapids.

## Motorist Pinned In Car Wreckage

Mark Alyn Hassevoort, 21, of 120th Ave., West Olive, sustained multiple fractures when the car he was driving north along 120th Ave. went out of control south of Taylor St. in Olive township and hit a tree.

He was taken to Holland Hospital where his condition today was listed as "serious."

Ottawa County deputies said Hassevoort was pinned in the wreckage of his car for about one hour before being removed. The accident was reported at 9:45 p.m. Wednesday.

## Car Smashes Into Russ' Restaurant, Leaves Accident

Damage has been estimated as high as \$8,000 at Russ' East-town Restaurant, 361 E. 8th St., where a car ran through the west wall along Chicago Dr. early Wednesday, backed out and continued along eastbound Chicago Dr.

A spokesman at Russ' said the car pushed through the west wall and went half way into the dining area in the northwest section of the building, smashing booths and moving the marble-faced west wall about four inches off its foundation.

Deputies said the late model green colored car should show considerable damage.

The restaurant was closed at the time of the accident.

## Police Charge Man With Felonious Assault

A 29-year-old Holland man is expected to be arraigned in Holland District Court Tuesday on charges of felonious assault with a knife in the vicinity of a local restaurant Monday at 11:52 p.m.

Holland Police officer Henry (Mike) Pathuis arrived first at the scene after the man was reportedly going to assist someone in the restaurant. The assailant threatened Pathuis with the knife but it was taken away by a woman reported to be the assailant's mother.

## Armed Navy Flares Found

Armed, high intensity flares used by the Navy during Lake Michigan maneuvers have been found washed ashore in West Michigan and could pose a potentially dangerous condition for persons finding them.

Holland Coast Guard Chief Ronald Perry said one of the flares was discovered south of Saugatuck and others have been reported elsewhere in the past two days.

Perry said the flares are armed and could ignite at any time and they pose a threat of extreme burns from the intense flames.

The flares are in aluminum casings and are three inches in diameter and 18 inches long with the inscription "U. S. Navy BUWEPS. Location Marker, Marine, Mark 25 Mod 3." and followed by a serial number.

## New Fire Truck Arrives Monday

The Holland fire department's \$136,236 aerial tower fire truck is expected to arrive in Holland Monday from the factory near Columbus, Ohio, according to Fire Chief Marvin Mokma.

The 43-foot long truck with an 85-foot aerial tower has been on order two years and will be formally dedicated Friday, Jan. 10.

## Open House Set At Dairy Farm

GRAND HAVEN — The Plover Vale farm, operated by the Fraazas near Zeeland, has scheduled an open house for dairymen in the Ottawa County area on Friday, Jan. 3, reports Larry Stebbins, Ottawa County Extension Director. Featured at this open house will be the highest producing dairy herd of this size in the state of Michigan. John, Jerry, and Lyle Fraaza's 133 Holstein herd produced an average of 20,269 pounds of milk and 791 pounds of butterfat, in the 1974 testing year. The open house will be held from 10:30 a.m. until 11:30 a.m. followed by lunch and meeting with dairy extension specialists and extension staff. Reservations for the lunch are necessary, so contact the Extension office in Grand Haven for the details and arrangements.

The afternoon program will focus on Michigan State University feeding, breeding and herd health programs. Dr. Don Hillman of the dairy department will review with Jerry Fraaza the feeding program of this outstanding herd. Dr. Clint Meadows also from the dairy department will be reviewing with Lyle Fraaza the breeding program and herd health programs. There will be an opportunity for dairymen to ask questions of the Fraazas and other dairy specialists. The afternoon program will be held at the Hudsonville High School cafeteria.

Another event, according to Stebbins, is the agricultural inflation seminar, "Can Farmers Survive in '75?" at Doo Drop Inn in Muskegon, Tuesday Jan. 7.

## Allegan Council Wants to Raise Employees' Pay

ALLEGAN — Tight money and inflation notwithstanding, The Allegan City Council with the help and insistence of City Manager Ken Bollinger is trying to give a pay increase to someone they don't have to.

The city's union affiliated employees (excluding the police), 12 of them to be exact, are under contract to the city until March of 1976. They received a 10 per cent pay increase July one, one that according to manager Bollinger was not substantial enough even at that time to combat rising costs.

Under their present contract they are not scheduled to receive any further increases until March of 1975.

"Even that won't put them anywhere near where they should be," Bollinger said.

City labor attorney Michael Ward has informed council that it must first submit proposed salary increases to the union for its approval.

"The city doesn't wish to open a can of worms by ditching the present contract, we just want to add to it," said Bollinger. He would not comment on the amount of the proposed increases, saying that "until we receive union approval it would be unethical."

## Commissioners Adopt Soil Act At Last Meeting

GRAND HAVEN — Ottawa County Commissioners, at their last regular meeting of 1974 Friday, adopted an ordinance on the Soil and Sedimentation Act and urged the state legislature to remove certain exemptions from the act.

The act governs construction and development of lands along lakes and streams but exempts mining, logging and agriculture from the provisions.

Commissioners tabled a tentative contract with the sheriff's department for study and agreed to purchase \$20,000 worth of furniture for the Mental Health facility under development in Grand Haven.

Commissioners also agreed to pay Port Sheldon and Georgetown townships a total of \$2,000 for mapping done by the townships before the county started its mapping program.

Commissioners William Winstrom of Holland, Fred Fritz of Conklin and J. Nyhof of Grand Haven attended their last meeting as commissioners. All were defeated in bids for re-election.

## Farnsworth Gets Post on Budget

LANSING (UPI) — Rep. James J. Farnsworth, who was defeated in the August primary, Monday was named an executive assistant and legislative liaison with the Department of Management and Budget.

The Plainwell Republican, who served in the House for 12 years, was vice chairman of the House Appropriations Committee and an acknowledged expert in government fiscal affairs.

Gerald H. Miller, director designate of the department, said Farnsworth will concentrate on executive branch projects and construction projects.

Farnsworth, an automobile dealer, was a constitutional convention delegate in 1961 and is a former mayor of Otsego.

## Democrats To Convene On Jan. 11

GRAND HAVEN — The Ottawa County Democratic Party will hold its county convention to name delegates to the state convention Saturday, Jan. 11, at 8 p.m. in the county building, 414 Washington.

The county is allowed 34 delegates to the state convention to be held Jan. 25-26 in Detroit. The state convention will elect new state officers, state central committee members, and new 9th district officers.

Three committees appointed for the county convention follow: resolutions—Larry Smith, Frances Postmus and Steve Fawley; credentials — Jay Yager, Sam Carini and Pearl Hierholzer; rules — Ray Bush, Bob Costa and Kathleen Pribe. Committee members are asked to report at 7:30 p.m.

Plans are being made for a charter bus for the Detroit convention.

## Blood Test Reveals Driver in Fatality Under Influence

Results of a blood alcohol test released by Holland Police Tuesday revealed that Franklin H. Williams, 33, of Hamilton and Springfield, Mo., who died in a double fatality accident here Christmas Eve was driving under the influence of alcohol.

Williams, who was traveling northbound in the southbound lane on I-196 business loop near the south Washington Ave., exit struck a vehicle driven by Janet Lynn Koopman, 22, route 3, 43rd St. A passenger in her car, Peggy Ruth Tuesink, 22, 1499 40th Ave., Hudsonville, was killed.

Ms. Koopman, was reported in "satisfactory" condition in St. Mary's Hospital Tuesday.

## Allegan to Open Downtown Office For Food Stamps

ALLEGAN — A bottleneck for food stamp purchasers will be eliminated Thursday when the Allegan County Department of Social Services opens a special application and certification office at 137 Brady St., in Allegan, according to Harold Leep, director of the department.

Leep said the store-front office will be staffed by six persons including three intake workers, two screeners and a receptionist.

Actual food stamp sales still will be made from the department's main office in the county annex at 116 Chestnut St. The new office will only handle applications and certification.

The positions of "screeners" have been added to help applicants prepare for the actual process, making sure they have all necessary papers and information. Leep said this would help eliminate long waits by people who arrive without required material.

The two new jobs were made available under the new federal Education and Training Act which provides funds for governmental service positions.

Leep said the new office will be open during the noon hour as well as during regular business hours. He emphasized that only the Brady St., entrance should be used, with the park-emergency use only.

## High Court Favors City In Paving

### Denied Application Opposing Assessments On South Shore Dr.

The city of Holland was informed Monday that the Michigan Supreme Court has denied the application of five South Shore residents to appeal a ruling to the Court of Appeals which had supported the city in its policy of assessing property owners for street improvements.

In effect, this gives the city permission to proceed with paving the two-mile stretch of South Shore Dr. which has been a legal (and sometimes emotional) issue for several years.

The current chain of events started in July 1973, when five South Shore property owners started a class action suit in Ottawa Circuit Court protesting the validity of special assessments against abutting owners.

After a trial, visiting Circuit Judge Harold Van Domelen of Hart ruled in favor of the plaintiffs. An appeal by the city of Holland, to the Court of Appeals in Grand Rapids, brought a reversal in the spring of 1974, the court ruling in favor of the city. Last summer, the same five plaintiffs appealed to the Michigan Supreme Court, and today's decision denied the application "because appellants have failed to persuade the court that questions presented should be reviewed."

While the main issue was property assessments, plaintiffs presented a strong case on effects to the environment, removal of trees, etc., with the result that many design modifications were made since plans were first drawn in the middle and late 1960s.

One result of lengthy negotiations with South Shore residents was the city's decision to set assessments to \$10 per assessable foot with proper consideration to odd-shaped lots.

Deputy City Attorney Jack Marquis handled the city's case in court litigation.

City Manager William L. Bopf said today that the city has applied to federal agencies for federal assistance in South Shore Dr. improvements in the approximate amount of \$400,000. If granted, Bopf felt that construction might start in late spring and be completed during the 1975 construction season.

Cost of paving the two-mile stretch is estimated at \$900,000 to \$1 million. The \$10 a foot assessment would provide approximately \$171,000.

A federal grant would substantially reduce the city's share in South Shore Dr. improvements, Bopf said.

## Police to Wear Bullet Proof Vests

Holland patrol officers will be wearing bullet proof vests soon following approval by City Council.

Police Chief Charles Lindstrom said the vests will be issued to police officers and detectives and are of a light weight material that makes wearing them more comfortable than earlier types.

Council approved \$3,420 to purchase 60 of the vests which are expected to arrive in about two weeks. Lindstrom said the vests are becoming more popular with law enforcement departments.

## Mostly Submerged by National Developments

# Local News in '74 Not Spectacular

There was little spectacular news in Holland during 1974.

In general, whatever happened in Holland was submerged in the more dramatic developments in national news, although Holland shared with Grand Rapids and the state of Michigan in the excitement of seeing Gerald R. Ford Jr. become President of the United States in August.

It also appeared that the majority of people in the community were fed up with Watergate in Washington, and there was a fervent hope that 1975 would take a more positive stance in the matter of getting going.

Locally, significant developments included the downtown beautification program, a successful Dial-A-Ride minibus system, and the opening of the last 24-mile link of I-196 between Holland and Grandville. The dedication took place Dec. 11 at Grandville, and the entire 80-mile freeway from Grand Rapids to Benton Harbor was named the Gerald R. Ford freeway.

The familiar red minibus Dial-A-Ride system was put into operation Feb. 4, almost entirely funded by the state of Michigan. When Gov. Milliken sampled its services Oct. 11, he said the Holland system was regarded as the best in the state. In the November election, Holland citizens voted a half mill for three years to continue the service.

Holland received approximately \$480,000 in federal revenue sharing during 1974 which helped finance the downtown beautification program, two fire trucks, five road trucks, and property for parks, as well as funding some city departments.

Holland voters approved bond issues of \$1.8 million for improvements to the water system increasing capacity from 14 million gallons to 21 million, and \$1.1 million for sewer im-

provements which is financing two storm sewers and three sanitary sewers, including replacement of the Central Ave. sanitary trunk from 13th to 19th Sts. The latter was begun in October and completed well ahead of schedule so that the first hard surface coat could be completed.

The energy crunch had its effect on Holland and elsewhere in the spring, and the economic slump in the fall caused layoffs and cutbacks in local services and industry, causing the caseload at the Michigan Employment Security Commission to jump five times over the level a year ago.

The 1973-74 snowfall totaled 74.29 inches, a relatively light amount for Holland area which is in the snow belt region. Holland appeared to have an unusually wet spring, and the 1974 total precipitation amounted to 37.41 inches, which is several inches more than the 31-33 inches usually recorded for this area.

Another highly successful Tulip Time festival was staged in Holland in May. Gov. Milliken donned a Dutch costume and wooden shoes to scrub the streets with local burghers. Rain on Thursday cancelled the children's parade which was held the following day. Lavina Cappon, former Dutch costume inspector for klompen dancers, was grand marshal at the opening parade and 104-year-old Zachary Veldhuis of Hamilton was grand marshal for the parade of bands.

In June, the city opened the fine new Bouws Recreation Pool in Smallenburg Park which was initiated by a \$100,000 gift of Mr. and Mrs. Russel Bouws.

In May, Wendell A. Miles of Holland, took his oath as judge of the U.S. Western Michigan District.

In July, Mr. and Mrs. William Winstrom of Park township deeded 21 acres of prime marshland and wooded area to the Michigan Department of

Natural Resources for use as a wildlife area. The area is on 160th Ave. near Perry St.

In May, His Excellency Joseph M. A. H. Luns, secretary general of NATO, received an honorary degree of Doctor of Humane Letters at a Hope College convocation.

In September, Consumer Advocate Ralph Nader addressed an overflow crowd in Dimmet Memorial Chapel.

In October, Hope College staged a recognition dinner honoring its former president, Dr. Irwin J. Lubbers, and Mrs. Lubbers, on the occasion of renaming the renovated science building Lubbers Hall for Humanities and Social Science.

Late in October, Cong. Guy Vander Jagt spoke at the opening of the Michigan Artrain in Hudsonville.

Following presentation in 1973 of the TriBrook report, a study into health needs of the community for the next 10 years or more, the Holland Hospital Board in 1974 hired TriBrook to coordinate all planning and construction, and retained Caudill, Rowlett, Scott of Houston, Tex., as architects. The architectural firm developed a master plan now under study for schematic plans. The hospital has engaged in cooperative studies and shared services with other hospitals in the area. In April, the hospital opened an outpatient surgery unit allowing patients with minor surgery to return home the same day.

In March, Willard C. Wichers retired after 32 years with the Netherlands Information Service and was appointed honorary consul for press and cultural affairs. The office in City Hall is now known as the Netherlands Consulate.

On the county front, the Ottawa County Board of Commissioners is gearing up for an experimental program for welfare clients. In April, the board voted to close the controversial county landfill in

Olive township near Pigeon Creek on June 1 but later made July 8 the effective date.

In June, the name of Black River in Ottawa and Allegan counties was changed to Macatawa River.

Late in May, 450 friends of Joe Moran gathered in Civic Center for a Joe Moran day dinner marking Joe's retirement. His successor, Matt Urban, had started in mid-February as assistant recreation director.

There were several strikes in the area — the Board of Public Works employees and Michigan Power Co. on July 1, and the Ottawa county road commission employees on July 10. All were resolved relatively soon although some final settlements took longer.

In September, West Ottawa voters approved an 18.9 millage renewal but rejected a companion 1.5 mills by only four votes. Millage proposals had been defeated twice before. In December, the board decided not to renew the contract of its superintendent.

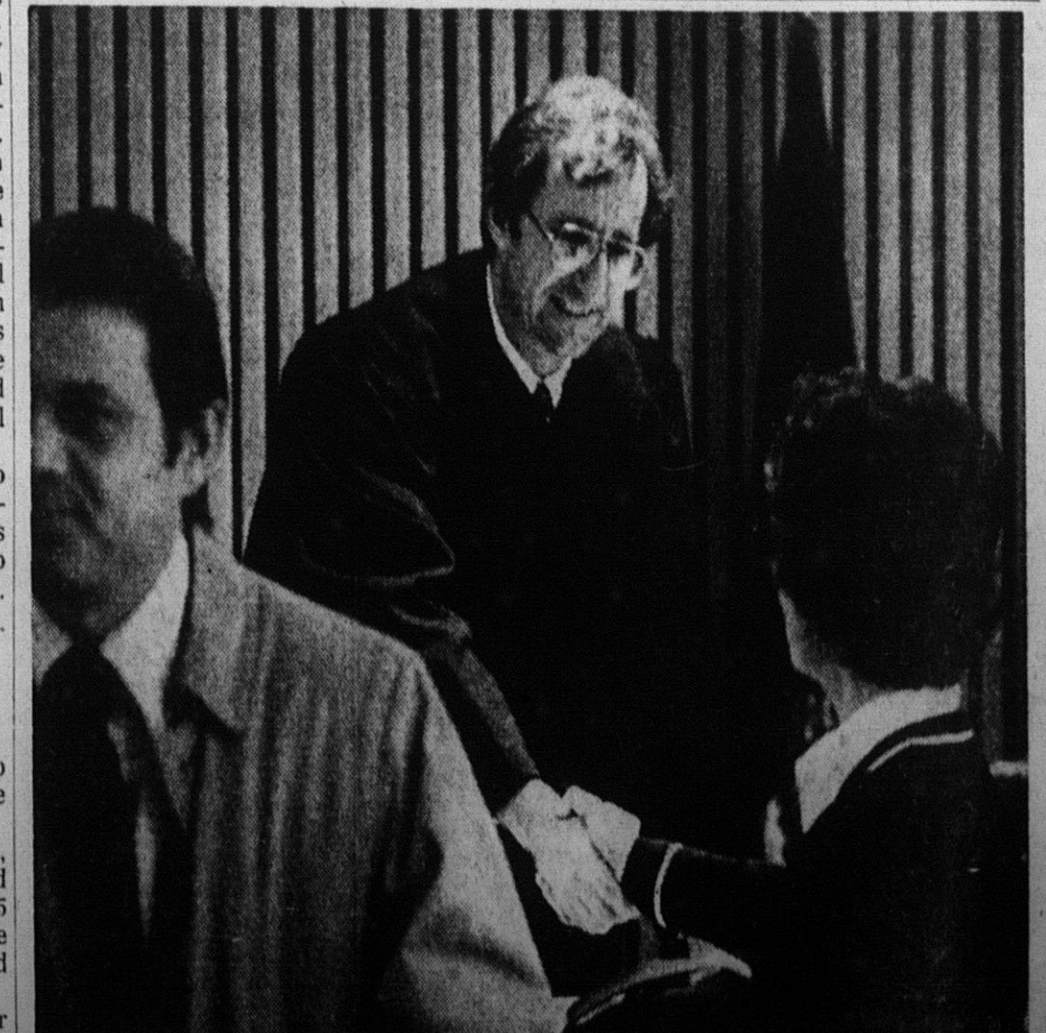
An explosion in the gas passage area ripped apart a section of a boiler at the James De Young power plant. Damage was estimated at \$250,000 but there was little or no interruption to service.

Late in November, Mayor Lou Hallacy's charter revision exploratory committee held its first meeting with former Mayor L. W. Lamb Jr. as chairman.

In September, a record 2,198 students enrolled at Hope College, up 94 from a year earlier.

Late in September, the Hope College pull remained unresolved after the rope broke twice. It was restaged with a new rope a few days later and the freshmen won, the eighth time in 30 years. The pull at Black River (now Macatawa River) has been an institution for 76 years.

It was the fifth year in a row that there was no increase in the city tax rate.

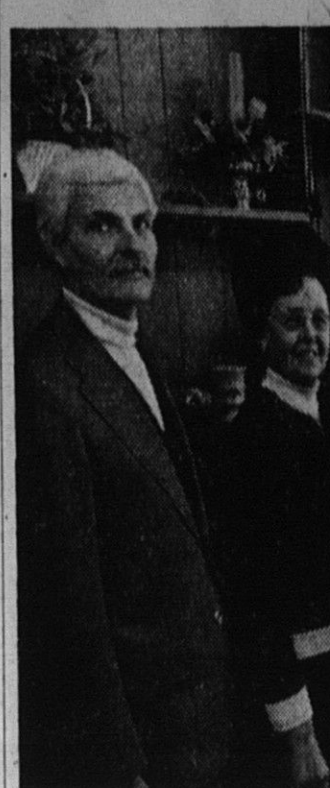

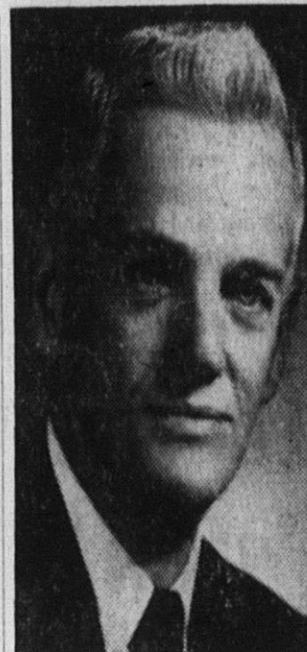

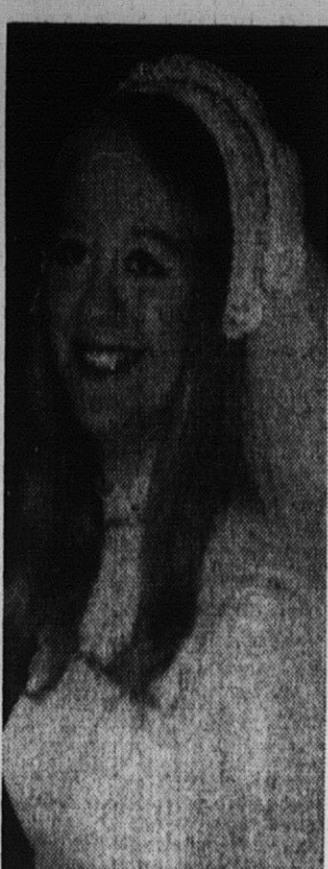

GRAND RAPIDS — Holland Christian's basketball team sputtered much of the game Friday night at Calvin College's Knollcrest, but in the end turned a nip and tuck ball game into a 58-49 decision over Grand Rapids Christian. The Maroons now have chalked up six wins against a single setback this season, but will be put to a severe test next Friday when they do battle against perennial power River Rouge in the Panthers' own gym.

At times the Maroons seemed a bit unsteady on offense, and the defense suffered lapses on occasion. The foul shooting also left something to be desired as Christian connected on only eight of 18 at the stripe.

A bright spot in the performance of the Maroons was the effect of their full court press which was used on occasion in the second half. This resulted in numerous turnovers by the Eagles, and allowed Christian to turn things around a couple of times when they appeared to be in trouble.

Christian started strong, jumping to an 8-2 lead, then held on to a 12-10 margin at the quarter. Jon Houseward, who turned in a fine all-around game, collected six of his 12 points in the opening quarter.

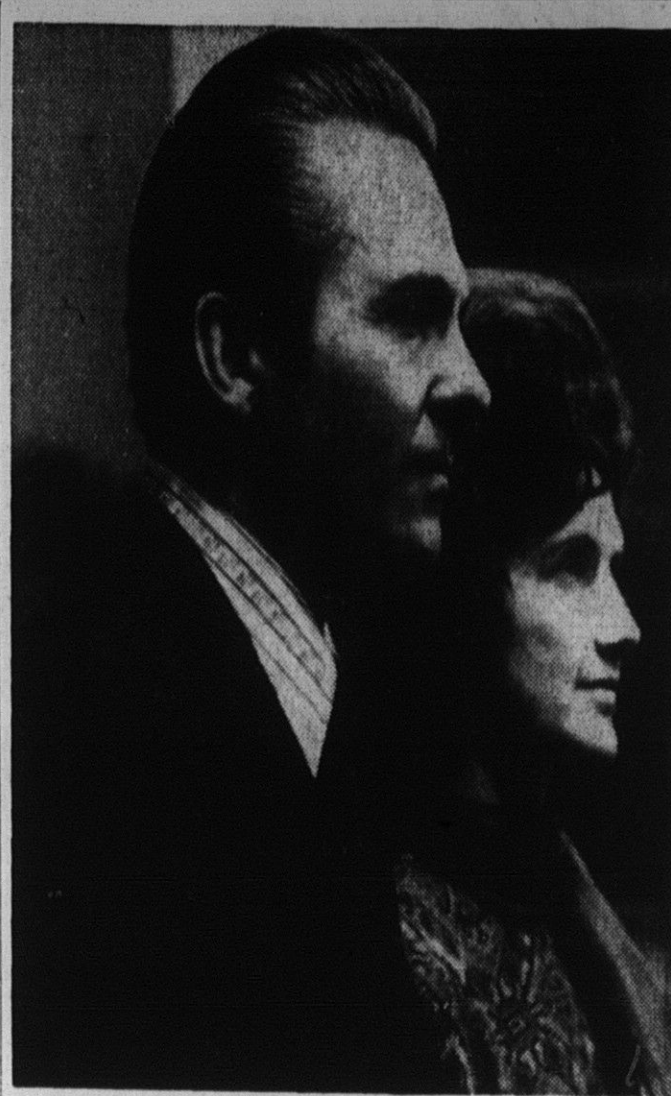

## 1974 — A PIVOTAL YEAR

Every year at this time people become nostalgic and reminiscent and try to summarize the importance of the year just past. Mostly these reflections turn out to be sentimental observations and very breakable resolutions. But this year has been an important one from which our nation has learned at least two very important lessons.

First we have learned that American affluence has limitations. Gas shortages, sugar scarcity, energy crises of various kinds have proved to us that we don't have an unlimited supply of everything and that in the future we can't have just everything we set our hearts on. We'll have to learn to get along with less so that other people in the world can have a chance at more. America has permanently changed. It is no longer the fairland of unlimited wealth.

Next we learned that despite the fact that we have put together the best democracy in world, there are rascals enough in it to wreck it for us if they are given the chance.

But we learned at the same time that the system was good the world, there are rascals enough in it to wreck it for the rascals and that it had the capability of throwing them out. Watergate may not ever be a pleasant memory for living Americans, or a happy chapter in the history books, but it does teach that we can trust ourselves to the system we have devised if we will live by it.

It hasn't been pleasant to learn either of these lessons, but both of them tell us something about the world in which we will live from now on. And that's the way time gives us wisdom.

## Sunday School Lesson

Sunday, Jan. 5  
The Master Teacher  
Matthew 5:17-20, 24-29;  
13:33-35

"Do Teachers Teach" — an editorial in a national weekly magazine had this suggestive heading. Teachers desire recognition; the public wants good teaching; the children and youth need a good example and instruction that will fit them to become useful citizens of the republic. This lesson portrays Jesus as the Master Teacher from whom we can all learn.

1. The teaching of Jesus has timeless authority. Matthew's gospel was written about 60 A.D. after that of Mark, and also after several epistles. It contains material not in the other gospels, much of the greatest sermon, the Sermon on the Mount, the story of the Wise Men, and several parables. It contains several references to the Old Testament and hence it was written especially for the Jews, portraying Jesus as the promised Messiah. Matthew does not mention his own name, does however call himself a Publican. Jesus was called Rabbi and Prophet, both terms suggest teaching.

Jesus had a deep sense of mission. He did not come to destroy the law or the prophets but to fulfill. Evidently some considered Jesus radical. Jesus stressed the constructive and the enduring, to His disciples. Note what he says about two groups in the kingdom, those who will be called the least in the kingdom and those who will be called great. Take note also of the contrast between the righteousness of the scribes and Pharisees which emphasized the outer things of religion while Jesus demands a pure inner life.

II. Hearing is not enough. After Jesus had preached the Sermon on the Mount He told His hearers what to do with His sayings. Listeners have responsibilities. We are all builders. Character building is important. Jesus was a carpenter and used an illustration from His trade. One man built upon rock. When the storm came it stood; the other man built upon the sand and when the storm came "it fell and great was the fall of it."

In life storms come and go. Today many people can't take troubles, problems, reverses and sickness, but there are also those who conquer and stay on top of life's circumstances. Experience teaches that faith in Christ gives power and confidence. In building, a foundation is important. In building character this is also true. It's great when a person can say, "On Christ the solid rock I stand." Put "these sayings of mine" in your heart and life will be victorious.

III. God's Kingdom works quietly. In His parables Jesus spoke of the ordinary things of life. When He spoke of leaven his hearers understood and got the point. In the Bible leaven at times stands for corruption but in this parable, found in Matthew chapter 13 which contains many parables, it refers to the quiet, inner, invisible power of the gospel. Of this it is good to be reminded, for today much emphasis is put upon noise, excitement and advertising. In the churches today the unseen, silent forces are at work and there are results which the reporters of newspapers see not but which God's angels note.

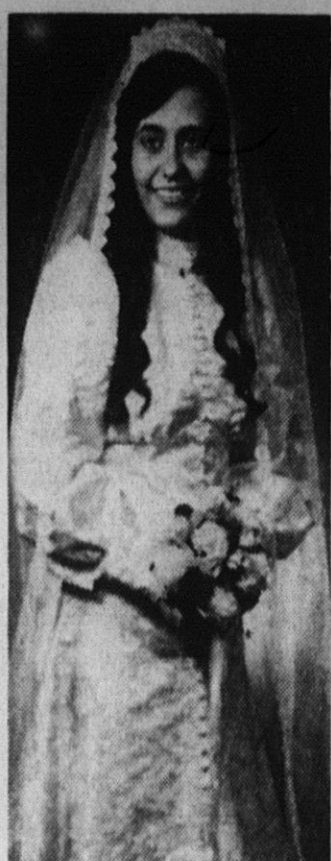
