Sen. Hart Given Honorary Degree

An honorary doctor of laws degree was conferred upon U.S. Sen. Philip A. Hart of Michigan at a Hope College convocation this morning in Dimmet Memorial Chapel marking the start of a new term for college students.

Participating in the ceremony were Dr. Calvin A. Vander Werf, president of the college, and Hugh De Pree, president of the board of trustees. The senator met with students at breakfast this morning, held a press conference and had lunch with faculty members before returning to Washington.

In addressing the convocation, Sen. Hart spoke of the difficulties in finding answers to today's problems, and the temptation to oversimplify the solutions by retreating into history "and give somebody a good, old-fashioned knock on the head with Teddy Roosevelt's big stick."

"It is a shame that we can no longer refresh ourselves with old-fashioned solutions. It would all be so much easier if technological progress had stood still because there would be no need to manufacture new political techniques to match them," he said.

He added that U-2 planes and Pueblos which are weapons of war occasionally generate incidents that are dangerous, and when these incidents occur, America must never lose sight of the ultimate national interest: survival in an ordered world.

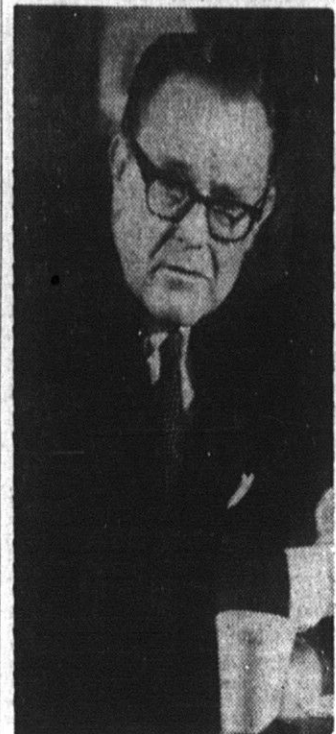
At the earlier press conference he termed the seizure of the Pueblo by North Korea in international waters as an act of war and he wholeheartedly approved President Johnson's stand in using all diplomatic channels to seek the release of the carrier and the men. Should this fail, he said an "awesome decision" would have to be made, one he hoped would best serve for a long time.

On the alewife problem in Lake Michigan, he favored encouraging commercial fishermen to develop techniques to harvest the alewife for commercial products but also pointed to the danger of a too well developed program whereby the absence of alewives could be a threat. From alewives he turned to pollution problems of Lake Michigan and he said the public

at long last is aware that clean-up is necessary.

But he said while everybody might agree in principle that a billion dollars should be spent to save the lake, their enthusiasm might wane when hard facts dictate that an industry should close down or cities should vote big bone issues for improved sewage systems.

"People living in the west or southwest have long recognized

the value of water and nobody bats an eye at a price tag of \$579 million for a water project, but the people here, long accustomed to huge water resources, are not yet up to that point," he said.

He then turned to a favorite subject of the proposed development of Sleeping Bear Dunes into a national park, and expressed the hope that it would carry this year in Congress. This program affects some 50,000 to 60,000 acres in Leelanau and Benzie counties not far from Traverse City. It calls for 32 miles of shoreline on Lake Michigan.

On automotive safety requirements, he anticipates many kinks in the law will have to be straightened out. On the "truth in packaging" law which becomes effective next July 1, he felt housewives would appreciate true facts on weight and less promotion on such aspects as "king size" or "2 cents off."

Allegan County Crime Rate Up

ALLEGAN — Crime is on the upsurge in Allegan county, according to a report released by enforcement agencies. The report, which compiles data released by city, county and state law enforcement agencies and computed by the Allegan County Sheriff's Department, shows that property crimes make up the largest important statistical increase over 1966.

The biggest property crime increase was in county break-ins, which more than doubled last year's figure. During 1967, 275 break-ins were recorded compared to 124 in 1966 — an increase of 120 per cent.

The second largest crime was a 31 per cent increase in county automobile thefts with 64 cars reported stolen in 1967 compared with 49 in 1966. Also up from last year, incidence of malicious destruction to property made a gain of 24 per cent with 193 complaints registered in 1967 and 155 in 1966.

Larcenies were also up in 1967 with a 12 per cent increase over last year. The total for both grand and simple larcenies for 1967 was 350. A total of 312 were reported in 1966.

Tulip Time Advertised in New Cancellation

Postmaster Louis Haight today announced the use of a new stamp cancelling machine that went into service at the post office Wednesday.

The cancellation, 'Holland, Mich. Tulip Time Festival Every Year in May,' was selected by the Postmaster General's office in Washington from the suggestions sent in by Holland Post Office.

The machine, financed by the New Car Dealers Association, Holland merchants and private individuals, will advertise Tulip Time on all mail going out of Holland until May 20, Haight said.

Haight estimates 17,000 cancellations a day for the machine, which, according to regulations, can be used six months out of the year. Haight said that he has already received two requests for cancelled stamps from collectors.

Tulip Time president Louis Hallacy, vice president Jacob De Graaf and festival manager William H. Vande Water witnessed the initial operation of the new cancellation machine Wednesday.

Get Your Dog License Now

Only about 10 per cent of dog owners in Holland city have obtained dog licenses so far in City Hall.

Feb. 29 is the deadline. Price of licenses in the Ottawa county portion of the city is \$2 for females and \$1 for males and unsexed. In the Allegan portion, the cost is a straight \$2 per dog. All dogs four months and older must be licensed.

Statistics reveal that there is an average of one dog to seven persons. This would mean approximately 3,500 dogs in the city.

Viet Visit 'Tears Apart' Grand Haven Newsman

EDITORS NOTE: Douglas Tjapkes, general manager of radio station WGHN in Grand Haven, has just returned from a visit to Vietnam. He is a member of a musical trio and played in Vietnam. The following is his story on what he saw in that war-torn divided country.

GRAND HAVEN — It tears you apart...

The needs are so great, the results of the war are so evident...

No matter where you go in Vietnam, from bustling Saigon to the Mekong Delta to the Central Highlands, the war is ever present.

In dirty, smoky, smelly Saigon, life goes on as usual, but each night you sleep to the background of "thumping mortars."

Flares can be seen shining in the sky in the distance. In front of our house, Vietnamese soldiers on guard 24 hours a day, kept weapons at their side. At midnight, they rolled barbed wire across the busy street, limiting traffic to one lane. From then until daybreak, all vehicles passing by would be checked.

From the moment of our arrival in Vietnam until the moment of our departure, we lived with war.

Army motorcades shriek through the crowded streets, Red Cross ambulances raced to military hospitals, helicopters carried in a flow of injured war victims to medical help.

But much could not be seen until we drove through the gates of secluded hospitals, rehabilitation centers and orphanages.

We handed out crutches, gifts from considerate Americans, to wounded Vietnamese soldiers and we sang in their hospital rooms. They were so grateful they hobbled along behind, on their new crutches, to see the excitement on their friends' faces upon receiving the gifts and hearing the music. Since pianos or organs were not always available, we played accompaniment that had been pre-recorded on a small battery operated recorder. No place was too remote... no audience too small to hear the music.

Our language was not understood—but we quickly learned that music is indeed an international language.

We sang for the Viet Cong in a prison camp. They couldn't believe that someone still cared and could still find room in their hearts for love.

Various experiences, various emotions tore us apart.

I saw our GI's building a school for Vietnamese children. Why wasn't the American press more interested in the many rehabilitation and civic projects? As a member of the press I bowed my head... I could give no answer.

I visited an orphanage occupied by tiny youngsters who had been abandoned by poverty-stricken Vietnamese mothers. They were out of money and out of rice that day... we each kicked in five American dollars—enough to buy a large supply of rice.

I looked down the rows of beds in a Vietnamese hospital, occupied by new mothers, with

their tiny babies in baskets at the feet of the beds.

The hospital was strictly for survivors of war victims. We gave the mothers gifts, but the bleak look remained in their faces. Their babies had been robbed of their fathers by the war.

Just before we left the Central Highlands, a mine was set off by the VC just behind our house. A window in my bedroom was blown out.

Was the trip worth it?

Was it worth the terror and the danger, just to bring a little love to Vietnamese war victims, survivors, orphans?

Our emotions were mixed when we left.

But the war continues...

Carousel Sold to Local Corporation

Carousel Mountain Ski Resort, a 60-acre winter sports development near Lake Michigan just south of Macatawa Park, has been sold to the Macatawa Development Corp.

The announcement was made Saturday by Dr. J. Raymond Christy of Holland, president of the Macatawa Development Corp., who said plans call for developing the resort into a year-round recreational center. The transfer will be effective April 19. Christy said the sale price was \$300,000.

The transaction was made with the United Insurance Co. of Chicago which obtained the property about a year ago on a mortgage foreclosure. The company decided in November to operate the resort this season and Larry Phillips of the investment division came to Holland to direct the operations. Extensive improvements were made on the 60-acre development.

Winter was slow in arriving but Christmas weekend brought the first ideal weather and the ski lodge has operated every day since. Despite a January thaw the past week, the base remains at 10 to 14 inches, and artificial snow has been made on occasion.

Dr. Christy said drawings are being made for year-round activities and will be announced in a few weeks.

Sale of the property was listed about a month ago with Westdale Realty Co. of Holland.

Phillips plans to remain until the end of the current season and about April 1 will return to his duties with United Insurance in Chicago. He said Carousel's season has been most gratifying this year.

Allegan City Council Studies Hangar Sale

ALLEGAN — City Council heard proposals last week for the sale of privately owned hangar facilities adjacent to the municipal airport.

Hangar owners Pete Collins and Buell Daniel suggested that the city (1) allow free access to municipal runways from the hangars until such time as the property is disposed of, (2) purchase buildings and land from the owners for \$4,800 or (3) purchase property for \$4,000 with allowance of accommodations for owners' plane and guarantee of free access to runways for five years.

Mayor James Rolfe suggested an alternate proposal that the city purchase the hangars and rent the property with a small increase in rental fees, and Councilman Leo Hoffman recommended that the city arrange for appraising the property.

Council extended the deadline two months with appraisals to be made in the meantime.

Holland Firm Begins Work on Repairing Road

GRAND RAPIDS — L. W. Lamb Co. of Holland has been awarded a contract to repair the north lane of the US-131 freeway in downtown Grand Rapids, a program which involves closing this lane for 3½ months. The section was damaged a year ago when a fuel tanker was involved in an accident and burned the freeway bridge which spans Grand River and railroad tracks. The \$189,388.56 repair job will be paid by the insurance company of the firm which owned the truck.

Louis Brondyke, 78, of 15 West 29th St., died Thursday morning at his home following a heart attack.

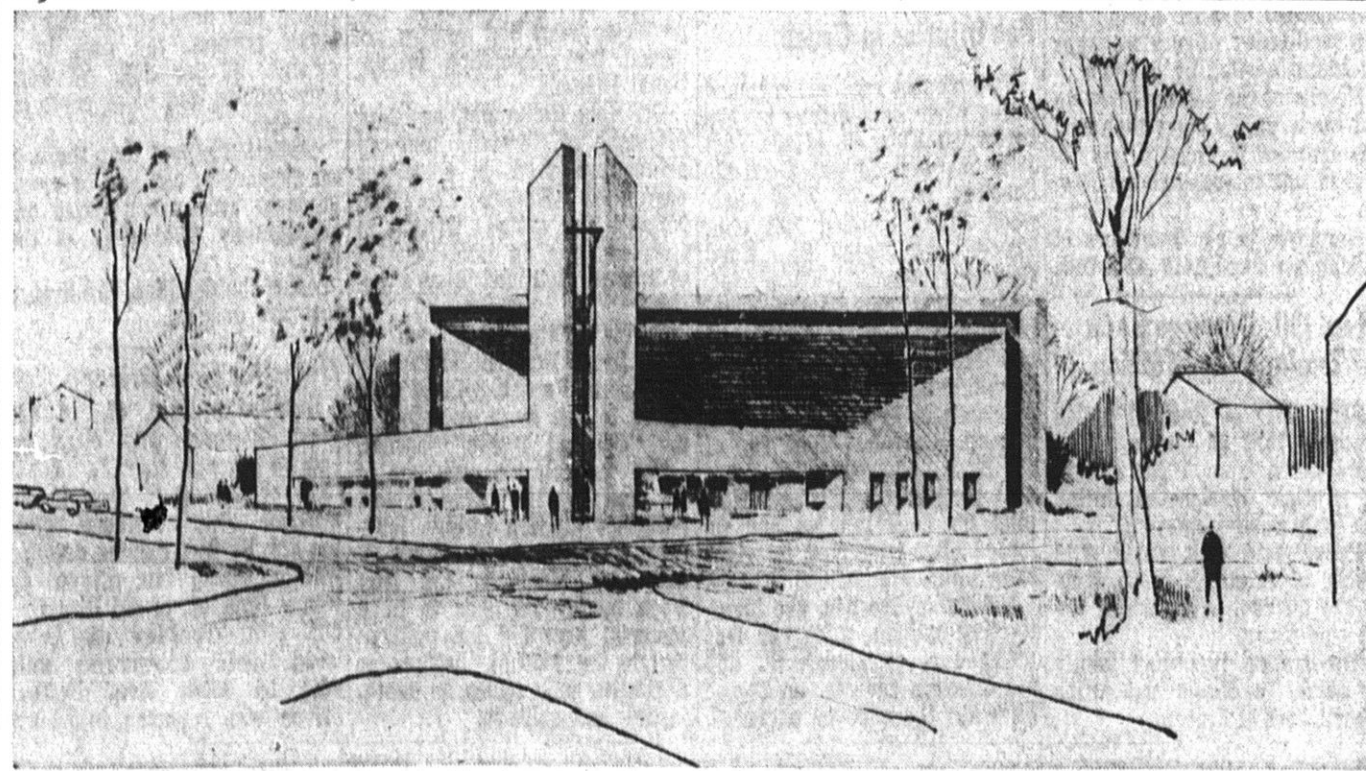

Plans Are Announced For New St. Francis Church

Msgr. Julian A. Moleski, V.F., pastor of St. Francis de Sales Church of Holland has announced that approval has been granted by Bishop Allen J. Babcock to start construction on the new 750 capacity church.

Designed by Koprowski Associates, Architects of Grand Rapids, the contemporary edifice is scheduled for completion in December 1968.

General contractor for the \$500,000 church is Elzinga & Volkers of Holland. Holwerda Plumbing and Heating of Grand Rapids and De Fouw Electric of Holland are the major subcontractors. Progressive Engineers of Grand Rapids are the mechanical consultants while Darvas Associates of Ann Arbor

are the structural consultant engineers.

A 45-foot high twin masonry bell tower will announce the open-quarry tiled entrance at the corner of 12th St. and Maple Ave., the site of the recently demolished wood frame building that was purchased from a Lutheran Parish, served as part of the elementary school for two years and then as the chapel for the Spanish speaking parishioners from 1958 through 1962.

The steel trussed nave is enclosed by masonry wall faced with brick inside and out with bronze colored aluminum sash, cedar wood ceiling, nylon carpeting and features a clerestory window of art glass set in wood

that extends up from the grade on each side and across the top of the nave.

The low section along Maple Ave. contains the ushers' room, brides' room and the main vesting sacristy, located to allow the priest to greet the people before and after Mass as well as facilitate the processional entry to the altar.

The gold carpeted sanctuary which is designed to encourage full participation will project into the nave—with the oak pews radiating out from the centrally located marble altar so that no one will be seated more than 65 feet away.

The presiding chair will be set two steps up from the altar at the apse end while the tabernacle will be highlighted in a niche to the right of the chair. This recess will be skylighted from above and contain a mosaic panel depicting the "Tri-

umphal Christ."

The pipe organ console will be located at the front of the section of pews to the right of the sanctuary with the pipes located high on the adjacent brick wall.

The confessionals will be recessed into the brick walls to the right and left of the sanctuary while the marble baptismal font will be located to the left of the sanctuary so that all in this new House of God's People might witness the baptisms that will take place.

Included in the plans is a full basement which when completed in the future will have a parish activity room for 500, a small stage, a club room and a large kitchen. The heating system is designed so that with the addition of condensers in the future, the entire building including the meeting room in the basement can be air conditioned.

Neglected Dwelling Ordered Torn Down

A run-down frame house at 322 Pine Ave. will soon be torn down following a series of court actions citing the premises as a public nuisance and fire hazard.

Ottawa Circuit Court has ordered the owner to demolish the dwelling and garage and to clear the premises. If the demolition is not completed in 30 days, the city may order the work done and charge costs to the property owner.

The Department of Environmental Health has been involved in the case since complaints were first registered about 1½ years ago.

The house, believed well over 60 years old, had had a series of rental occupants and the last tenant had 10 children and some "visitors" for a total of 15 in the house which had been painted dark red and apple green. The city department placarded the house when the family left, and the premise was unoccupied for many months, serving as a target for broken windows, illegal entry and otherwise misuse.

Department officials said conditions were much worse in the inside than the outside which revealed only peeling paint and a porch and garage falling down.

Legal procedures, which may serve as a pattern for removing other dwellings not meeting building code requirements, started with a complaint filed Nov. 16, 1967, by the City of Holland in Ottawa Circuit Court, citing the dwelling as a

public nuisance and fire hazard and seeking an injunction ordering demolition and removal.

On Dec. 11, a hearing was held before Judge Chester A. Ray. Appearing in support of the city were the city attorney, fire inspector, city appraiser, building inspector, housing inspector and director of the Department of Environmental Health.

On Dec. 21, a judgment was issued in favor of the city ordering the owner to demolish and remove the dwelling and accessory building.

The city's action was taken under the recently amended Housing Code.

The first objective of any housing program is to maintain existing housing facilities in a safe and healthful condition through enforcement of minimum standards of the Housing Code, Holland housing consultant, Dale Wyngarden said.

But inevitably, certain dwellings due to age, neglect or abuse, reach a state where they no longer are fit for human habitation and where the cost of putting them in such condition is not reasonably related to the value of the dwelling, Wyngarden said.

In the Pine Ave. dwelling case, legal steps were taken only after repeated communications with the owner, an absentee landlord, went unacknowledged.

Among the minimum standards for housing requirements in Holland are hot and cold running water, complete bath, adequate heating system, adequate light and ventilation, and sufficient area for occupants.

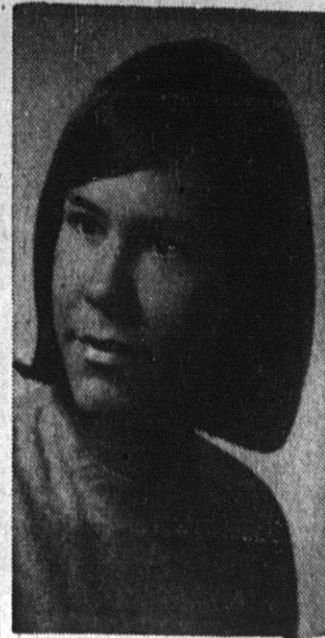

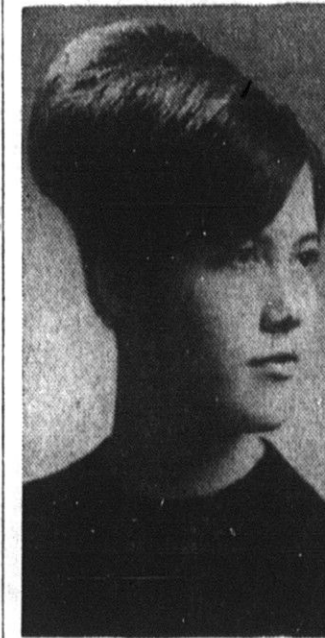

active talk, Dr. Benesch pointed out the necessity of reviewing repeatedly a painting in order to understand it. It may take years to know whether an art work is really lasting or not, she said.

Claude Monet, "the impressionistic painter, was revolutionary in that he painted what he saw, not objects as they actually were. He was followed by others such as Renoir, Gauguin and Cezanne who to varying degrees held to his idea. Cezanne, the father of modern art, tried to paint intellectually and introduced the use of cubes and spheres of color. Picasso split objects into simple geometric forms and rejoined them side by side, thus going one step beyond Cezanne, Dr. Benesch said.

Artists such as Kandinsky looked at his own paintings as representative of mood, not objects. All through the history of art two trends are apparent in contrast to one another—the trend toward purely intellectual painting and that of exuberant painting, Dr. Benesch said.

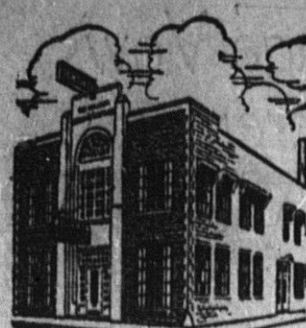

Sunday School Lesson

Sunday, Feb. 4
The Witness of Christ's Works

John 4:46-54; 5:2-9a, 17-18
By C. P. Dame

Jesus called attention to both His words and His works. This lesson tells about two miracles, John calls them "signs" and both were performed in order to teach our Lord's deity. Jesus has power to change lives—this fact please keep to the fore.

I. Faith becomes stronger when it is tested. Jesus tested the faith of a father, a nobleman, whose son "was at the point of death." Jesus remained two days in Sychar and fellowshiped with the new believers there. From Sychar, Jesus went to Cana, in Galilee. The Galileans welcomed Him for they had seen His works in Jerusalem and they were proud of Him.

A government official, living in Capernaum heard Jesus was in Cana, which was about twenty miles away, and went to Him and begged Jesus to come and heal his son. Jesus talked about the desire of people to see signs and wonders—this remark was intended for the Galileans, not for the distressed father, who kept on begging Jesus to come.

Jesus told him to go his way for "thy son liveth." This father's persistence deserves admiration. The father obeyed Jesus and went home. Every step homeward was a proof of his faith. He "believed the word that Jesus spake unto him." When he got home the servants told him that his son was better and he learned that the son began to mend at the very hour Jesus told him his son lived. The father's faith was tested. Has your faith been tested lately?

II. Obeying Jesus pays. The second miracle recorded in the text took place in Jerusalem where Jesus had gone to attend "a Feast of the Jews," which one we do not know. Every male Jew was required to attend the three Feasts—Passover, Pentecost, and the Feast of the Tabernacles. In Jerusalem, by the Sheep Gate, there was a pool, which had five porticoes, in which many sick people lay, waiting to be healed. In the RSV, this verse is not found, for it is absent in the best manuscripts. Jesus asked one man who had been ill for 38 years, "Do you want to be healed?" Why Jesus asked this particular man we do not know. The Lord's question implied the possibility of being healed. Jesus told this man to "Rise, take up thy bed, and walk." The man obeyed and got up and walked.

The Lord saw him later in the Temple and warned him to sin no more. Sin is costly; it was in his case. Jesus healed the man on the sabbath day. When some people saw this man carrying his mat they criticized him who referred them to Jesus whom they then persecuted because of this. Jesus said to His critics, "My Father is working still, and I am working." To these words they objected strongly.

For two reasons they hounded Jesus, one because He healed on the sabbath day, the other because He made himself equal with God, whom He called His Father. Services of compassion are always in order.

One of the main objectives of such a study is student, parent and teacher involvement.

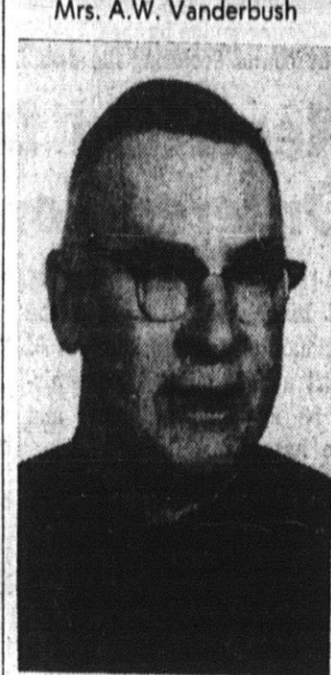

Christian Takes 11th Straight Win

River Rouge Falls, 51-48 To Maroons

Holland Christian's basketball team passed its toughest test of the season Saturday, when they downed second-ranked River Rouge by a 51-48 score.

The game was played before a sell-out crowd of more than 2,600 fans in the Civic Center and was Christian's 11th straight win.

In recording their first win ever against River Rouge, Christian used a great 1-3-1 defense, which kept the Panthers from working the ball in close for high percentage shots. As a result the Maroons nearly stopped Rouge's offense cold, with the exception of forward Victor Wharton, who made 10 of the Panthers' 21 baskets. Most of his buckets were from 20 to 25 feet out.

De Nooyer and Bob Van Langevelde each had five points in the quarter, while Wharton had six.

Brower and Dozeman gave the Maroons a 17-11 lead before the Panthers, with an all junior starting five, narrowed the margin to 19-18 at the four minute mark. Bob Dozeman and Van Langevelde scored keeping the Maroons ahead and they went off at halftime leading 24-22.

Van Langevelde had four for Christian and Wharton and Bill Kilgore four each for River Rouge in the second period.

Foul shooting in the fourth quarter proved the margin of victory for the Maroons. After hitting on only four out of 11 in the first half, they made nine of 13 in the final eight minutes. Brower led the winners in the period with seven points, including five-for-five at the charity stripe.

Wharton scored eight of the Panthers' 14 points, in an effort to pull the game out.

Bill Kilgore, 6'7" River Rouge center, fouled out with 4:51 remaining in the game.

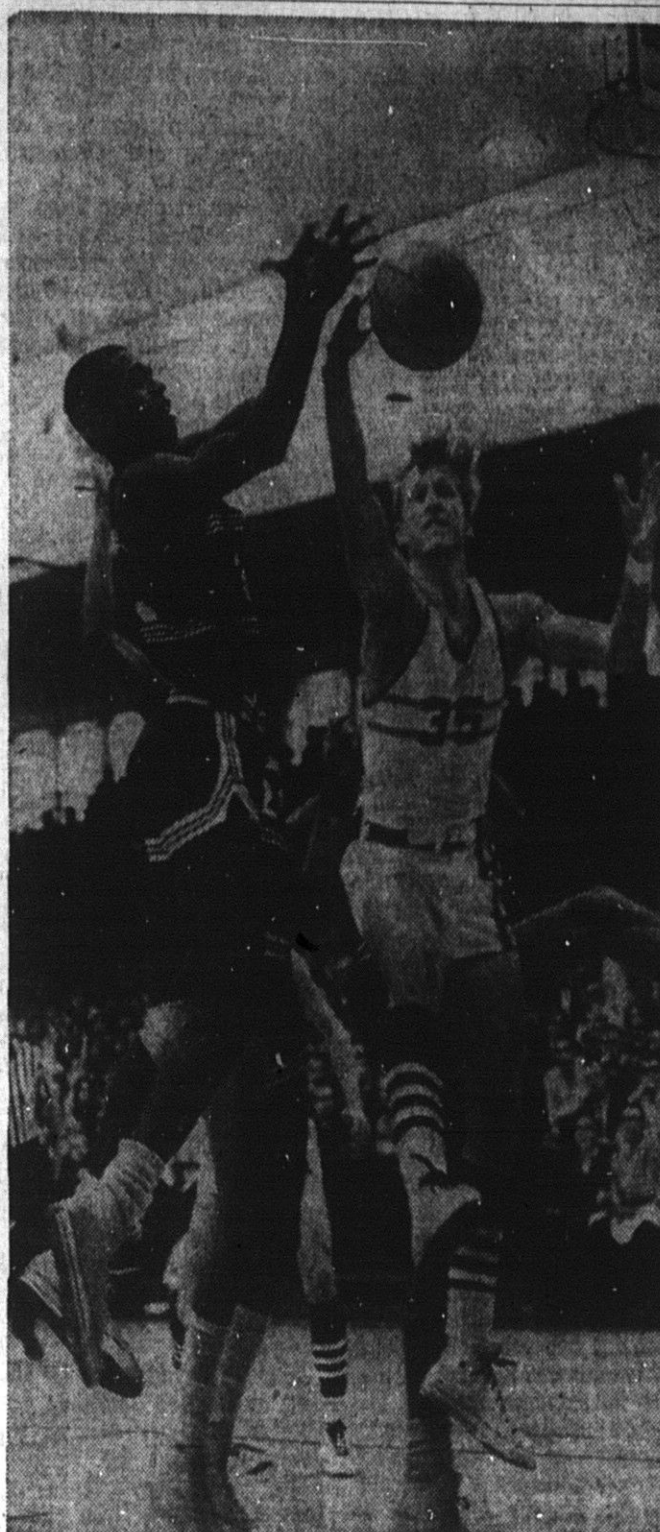

GRANDVILLE—Shooting over 50 per cent from the floor the entire game, Holland High's basketball team decisively triumphed over the Grandville Bulldogs, 96-65 Friday night in the Grandville gymnasium.

The victory cemented the Dutch in first place in the Valley-Coast Conference with a 9-0 record and are now 10-1 overall. Grandville dropped to 5-3 in the league and posts a 5-6 overall mark.

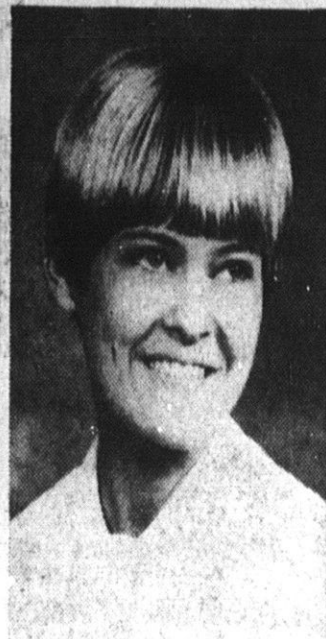

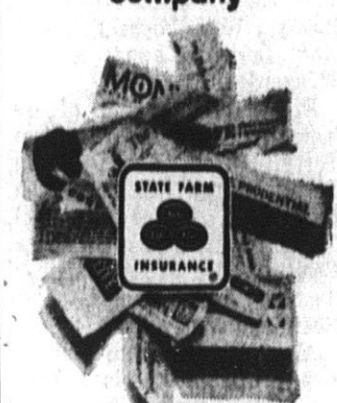

Kalamazoo never trailed enroute to winning its 10th game of the season. The Hornets hit 11 of their first 18 field goal tries while building up a 22-10 advantage midway through the opening half.

Paced by the shooting of Grand Rapids freshman Bryan Vossekuil, the Hornets owned a 39-26 halftime lead after scoring 19 baskets in just 35 attempts. Hope, meanwhile, sank only nine of 30 tries.

Vossekuil scored a career high 26 points by making 11 of 17 field goal attempts and four free throws. During Kalamazoo's explosive first half Vossekuil sank seven of eight attempts from the floor.

Game scoring honors went to Hope senior Floyd Brady with 28 points, 20 of them in the second half. Kalamazoo's zone defense limited Brady to just three field goal attempts during the first half. The 6'3" Chicagoan finished with nine baskets and added 10 free throws. Brady, the league's leading scorer with a 35 average, moved within nine points of the all-time Hope career scoring record. He has 1,733 points and is closing in on the Paul Benes' career mark of 1,742 tallies.

The closest Hope came during the second half was six points, 57-51, with 6:43 left in the game. Kalamazoo missed its next attempt and Hope claimed the rebound. Hope guard Gary Rympa was fouled in the backcourt, but the Grand Rapids senior missed the first of a bonus free throw situation and Kalamazoo gained the rebound.

The Hornets responded with a basket and two free throws to open the margin to 61-51 with 5:20 left in the contest.

Kalamazoo coach Ray Stefan had his charges slow things down and work for the good basket. Hope came within eight points twice in the closing minutes of the game, but each time the Hornets were able to rebuild the lead.

Gene Nusbauer added 20 points for the winning Hornets while teammate Bob Trenary scored 17.

The only other Hope player in double figures was freshman guard Randy Adolphs who scored 12 points in a reserve role. The 5'9" Petoskey native hit six of eight attempts from the floor.

Kalamazoo finished with 31 baskets in 67 tries for 46 percent clip while Hope sank 24 of 65 attempts for 37 percent.

The winning Hornets held a 42-41 edge in rebounds. Hope center Bruce Van Huis, the league's leading rebounder, hauled down 21 caroms while Vossekuil was high for Kalamazoo with 10.

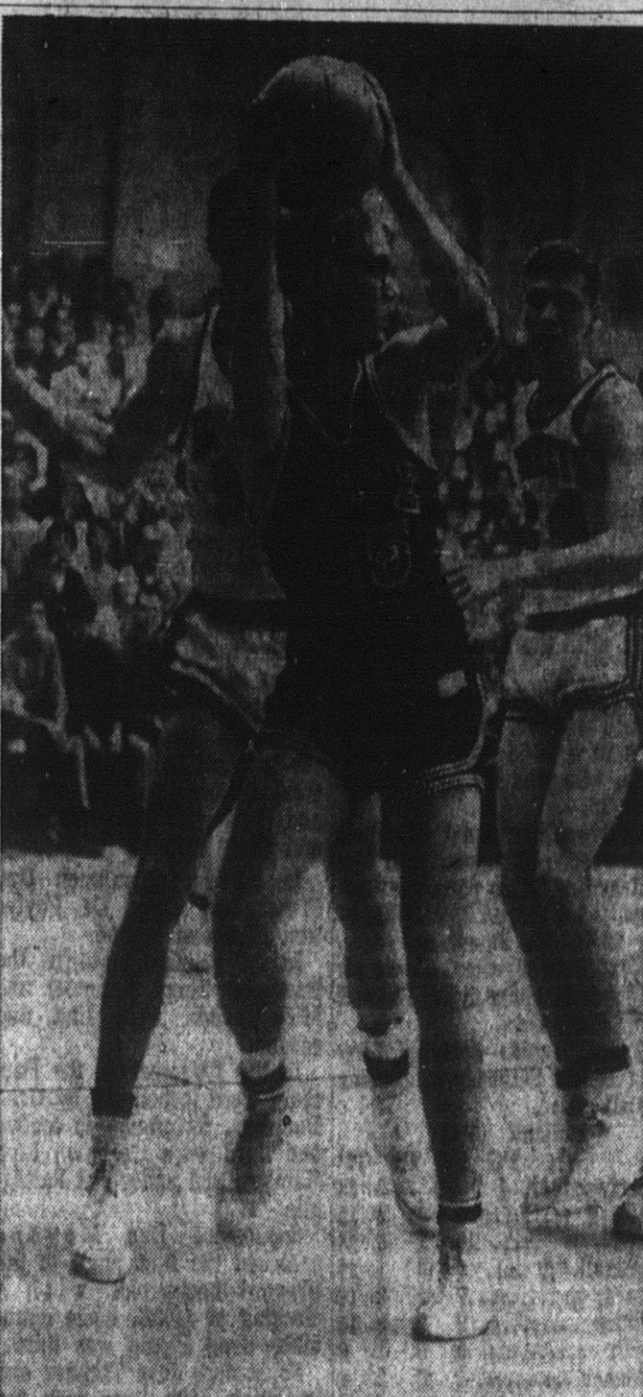

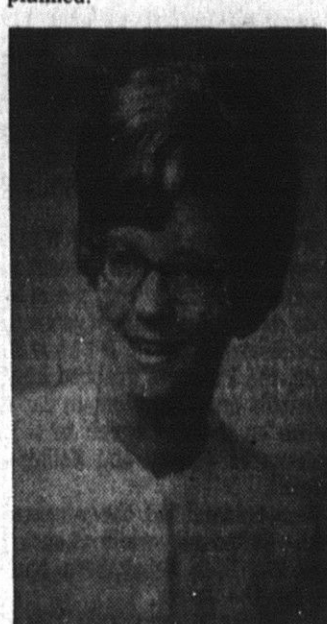

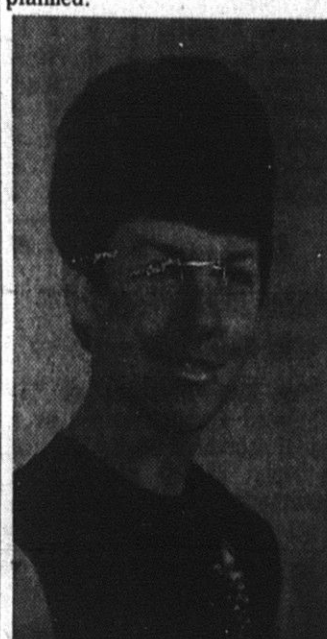
