## Dutchmen Win 83-74 Over Knights

Hope College's basketball team put on its best shooting performance of the season to defeat Calvin 83-74 in the Civic Center Wednesday night before 2,500 fans.

The Flying Dutchmen connected on 30 of 59 shots from the floor for 51 per cent as they led the entire game. The winners notched 47 per cent of their shots in the first half and 57 per cent in the second half en route to victory.

Hope scored three straight baskets in the first 1½ minutes, and took a 10-2 lead before Calvin started to really function. The Knights closed the gap to two points on a tip-in by Rich Schrotenboer at about the 14-minute mark of the first half and never got any closer.

With the score 16-14 Hope hit five straight points before the Knights tallied again. Hope led by 10 points several times during the first half, and took a 40-30 lead at the intermission.

Hope got some fine outside shooting especially in the later stages of the first half when they were firing over Calvin's zone defense. Carl Walters gunned in five of eight from the outside to lead the first half attack. The Flying Dutchmen made nine of their 17 field goals in the first half on outside shots.

Calvin could get no closer than five points in the second half as Floyd Brady hit for 19 points and Gary Rypma 13 in the half. The Knights made six straight points to close the gap to 49-44 at 13:45 of the second half.

The winners outscored the Knights 16-7 over the next five minutes to open up the largest lead 66-51 at the 8:26 mark of the half. The score was then 66-51. Brady had eight points during the five minute stretch.

The closest Calvin could get after that was nine points, the final margin.

The game featured some rugged competition for rebounds. Calvin was able to win the backboard battle 47-33, but in doing so picked up 27 fouls—18 of them in the second half.

Hope converted on 18 of 26 free throws in the second half. Their overall total from the foul line was 23 of 39 (59 per cent).

Two of Calvin's players, Kim Campbell and Dean Douma, fouled out and three others had four fouls at the end of the game. Calvin's fouls increased as they frantically tried to get the ball in the closing minutes of play.

A smiling Russ De Vette, Hope's coach, said "it was as good a game as we've played all season." He praised guards Walters and Rypma along with Brady.

Walters had 18 points and Rypma 19, and they both turned in good floor games.

Brady led all scorers with 29 points, and was Hope's leading rebounder with 13. He also did a good job of stopping Calvin's Campbell, the Knights' leading scorer and rebounder. The Knight forward ended a frustrating night with only nine points.

Bill De Horn, who returned to the Calvin squad last week after being suspended, played his best game of the season. He grabbed 22 rebounds and scored 20 points for the Knights.

Douma, hitting both from the outside and on driving shots, contributed 20 points for the Calvin cause.

The Knights meshed 29 of 76 field goal attempts for 38 per cent and 16 of 24 free throw tries for 67 per cent.

With its victory Hope regained a share of first place in the MIAA. Hope and Kalamazoo both have 6-1 records. Calvin, the defending MIAA champions, is now 3-4 in the league.

Hope's overall record is 10-6 while the Knights, who have lost four straight, are now 6-9.

Hope travels to Alma for another league game Saturday night. Calvin will host Ferris State College.

A Holland serviceman who received injuries in Vietnam when he ran into a punji stick (a weapon resembling a sword) has been taken by helicopter to a hospital in Qui Nhon on the east coast of Vietnam.

Injured was Pvt. Lloyd E. Bouwens, son of Mr. and Mrs. Earl R. Bouwens of 1907 West 32nd St.

According to a letter received by the parents Saturday the punji stick which is made of bamboo lodged in Bouwens' knee and surgery would be necessary. A letter received Monday stated that he may be taken to Japan and he expects to be out of action for about a month.

Pvt. Bouwens has been in Vietnam since Aug. 1. He enlisted in the service Feb. 6 of last year. His address is Pvt. Lloyd E. Bouwens, RA 16851-046, C. Co. 1st Battalion, 8th Cavalry, 1st Cavalry Division, APO San Francisco, Calif. 96490.

## Hearing Set On Waters

Michigan's program of establishing water quality standards for its interstate lakes and streams will be initiated following a public hearing to be held in the Muskegon County Court House, Muskegon, on Feb. 23, it was announced today by Loring F. Oeming, executive secretary of the State Water Resources Commission.

This hearing will be concerned with the St. Joseph River system and Lake Michigan, Oeming said. Subsequent meetings at other locations will deal with the state's other interstate waters.

The proposed standards have been developed by the Commission in cooperation with the State Departments of Agriculture, Conservation and Public Health, and with the guidance of experts outside state government, in an effort to insure maximum protection for the greatest number of water uses.

Information on present and prospective future uses of the waters involved will be presented at the hearing, and the Commission will then designate the surface waters in the St. Joseph River basin and the shoreline of Lake Michigan according to the various water uses to be protected.

Notification of the public hearing has been sent to municipalities in the area as well as to interested organizations. Persons attending the hearing will be given an opportunity to express their views on the Commission's proposals.

Under the provisions of the Federal Water Quality Act of 1965, water quality standards must be established on all interstate watercourses, together with a plan for their implementation and enforcement, by June 30 or Michigan will yield this function to federal authorities.

## Fire Razes Large Barn

FENVILLE — Twenty-seven cattle, 16 horses and other items were destroyed in a fire which razed a large barn at the Robert K. Bushee farm on New Richmond Rd. about 1½ miles north of here Wednesday.

The loss was estimated at between \$35,000 and \$40,000.

Also destroyed besides the livestock were more than 4,000 bales of hay, 900 bales of straw, pony carts, saddles, wagons, milking machines, an old-fashioned sleigh and other items.

The fire had a good start before it was discovered about 6 a.m. and the barn was engulfed in flames when Fennville firemen got to the scene.

The cause of the fire has not been determined.

## Appointments Made at Hope

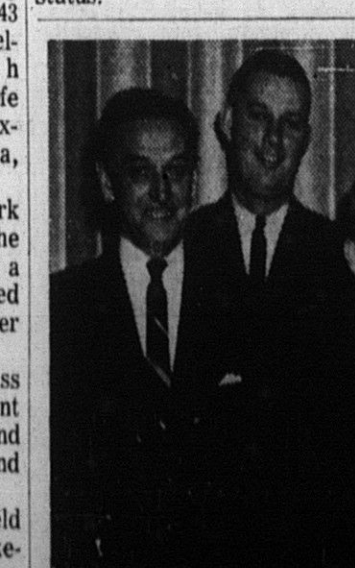
Hope College President C. A. Vander Werf today announced the appointment of Mrs. John L. Bouman and Thomas Lee Renner to new positions.

## City Treasurer's Office to Be Open Saturday Morning

The city treasurer's office in City Hall will be open Saturday from 9 a.m. to noon for the convenience of property owners paying fall taxes. The deadline is Tuesday, Feb. 14. Thereafter a 3 per cent penalty is added through Feb. 28.

After Feb. 28, the tax rolls will be taken to county treasurers in Allegan and Ottawa counties. Penalty March 1 jumps to 4½ per cent and thereafter an additional ½ per cent for each month.

Total levy for fall taxes in Holland city in both Ottawa and Allegan counties is \$642,719.73. This amount also covers assessments and delinquent summer taxes.

To date \$446,177.25 has been collected or 69.42 per cent of the total levy.

Holland city property owners pay \$380,409.29 to Ottawa county and \$58,156.84 to Allegan county in the fall levy.

Dog owners also are reminded that Feb. 28 is the deadline for obtaining dog licenses without penalty. On March 1, the license fee is doubled.

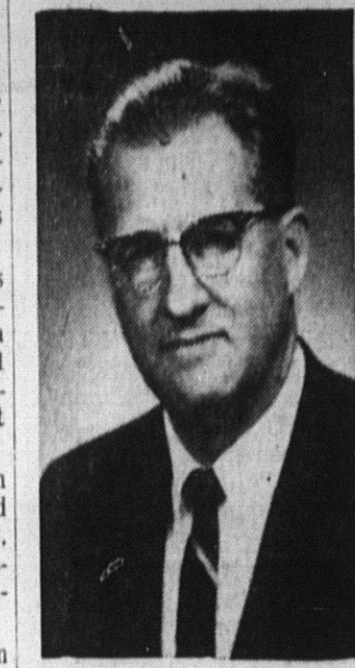

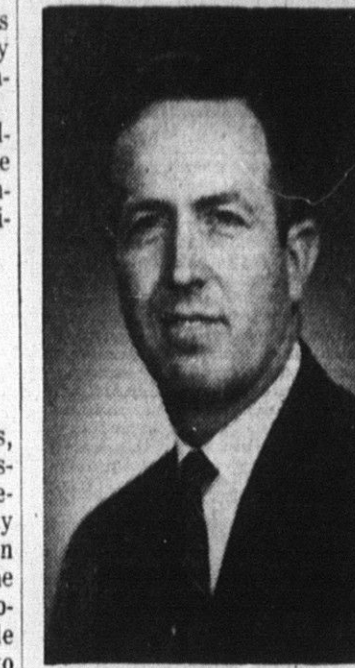
## Fire Razes Garage

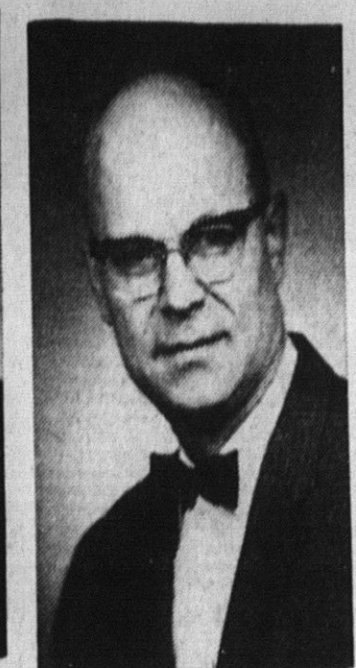

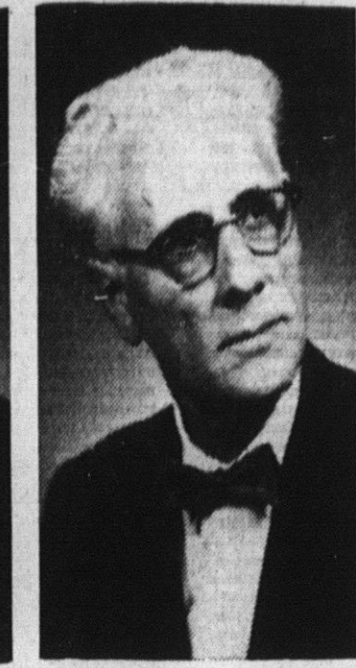
State police said Ferguson apparently did not see the 63 car northbound C and O freight train. Ferguson was treated at Douglas Community hospital for scalp lacerations.

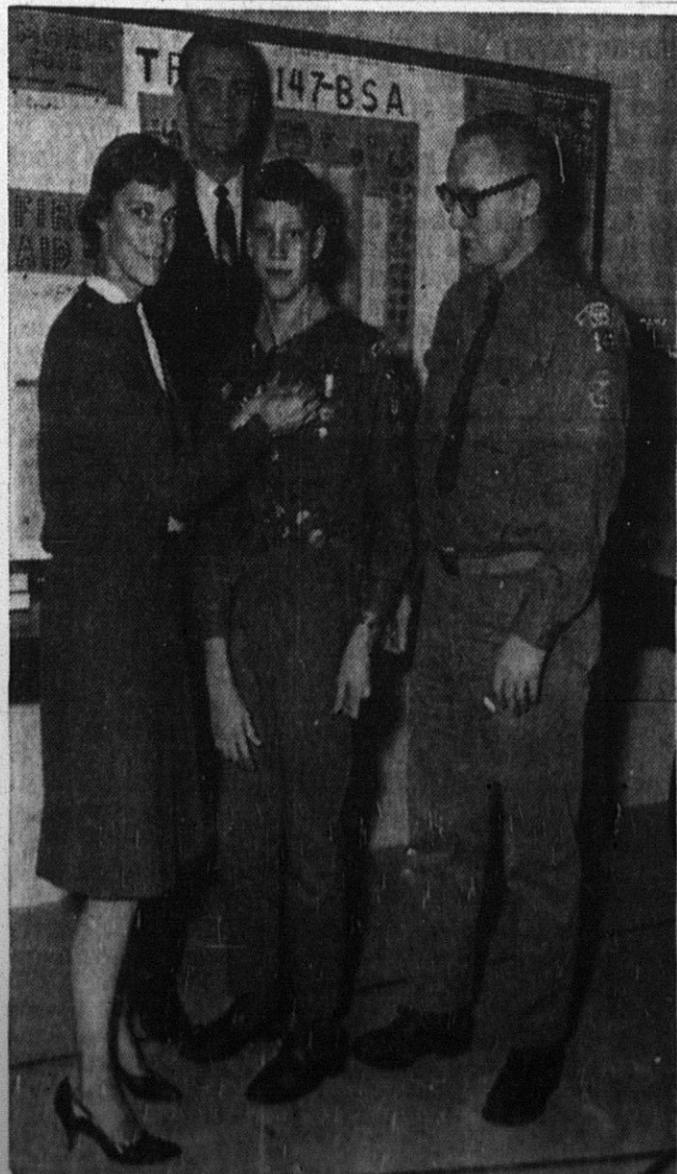
## Schools Entered In Jenison Area

## Floriculturist Speaks At Garden Club Meeting

"The long-term goal of the research in floriculture at Michigan State University is to maintain an adequate supply of continually flowering plants," Everett Emino of the M. S. U. horticulture department, told Holland Garden Club members at the luncheon meeting on Thursday afternoon at the Woman's Literary Club.

The speaker illustrated his lecture with colored slides showing how bulbs are forced into early blooming for the various holidays. After a precooling period of nine weeks, the bulbs are potted for four or five weeks and later the forcing process in greenhouses takes place.

This research project has shown that certain varieties are more successfully forced than others. The "Paul Richter" and "Charles" varieties of tulips are excellent for forcing for the Christmas season and the beautiful red "France" tulips are good for Valentine Day.

Other slides showed tulips, hyacinths and daffodils which had been forced for Easter. Mr. Emino recommended the "Paul Mickelson" poinsettia as

the longest lasting. He advised club members to purchase flowers at the goose neck stage or buds which are barely showing color.

Other phases of research work shown included the elimination of the burnt tips of lilies, the search for improvement in pansy seeds and the study of the abnormal plants in an effort to understand the normal. The practical application of all this will eventually produce more efficiently the plants and flowers desired by the commercial market.

## No. 1 Rated Team Scores 89-77 Win

MUSKEGON — Art Davis and Ralph Houston each scored 24 points to lead Muskegon Heights as the Tigers ran over Holland High's basketball team 89-77 Thursday night at the L. C. Walker Arena.

Davis not only tied for the scoring lead, but intimidated Holland's Dan Shinabarger with harassing defense. Shinabarger, who led the Valley Coast Conference in scoring with a 23-point average, managed only four points in the game.

Houston, shooting mostly from the outside made 12 of 24 shots despite Holland's determined effort to defend against his long-range aerials. He also grabbed 10 rebounds.

Completing the destruction for the Heights, ranked number one in the Class A ratings, were Steve Kidd with 14 points and Jim Turer with 12 points and 13 rebounds.

The powerful Tigers took charge near the middle of the first period. After Holland tied the score at 7-7 at 5:05 of the quarter, the Tigers outscored their opponents 16-6. The Heights held a 23-13 lead at the end of the period.

Muskegon Heights went into a full-court press in the early stages of the game, and garnered several baskets by taking advantage of mistakes by the Dutch.

Holland played their best basketball in the second quarter, and the Tigers only outscored them 23-20 in the period. Jim Fortney, playing his finest game of the season hit five baskets to pace the Dutch in the second period. Fortney finished with 23 points to lead the Dutch scoring. Holland made 69 per cent from the floor during the period (nine of 13).

The score at the half was 46-36 in favor of the Tigers.

Muskegon Heights ran the lead up to 19 points with about 3½ minutes left in the third period after stealing the ball and fast breaking. The period ended with the Tigers leading 71-55.

Kidd sank a field goal at 7:06 of the fourth period to give the winners their largest margin of the game—20 points. The score was 77-57. With his team ahead by 15 points with about four minutes left in the game Heights' coach, Don Westman, put in several substitutes. The Dutch narrowed the gap to 12 points against the second-stringers.

The Dutch made a determined effort to catch the Tigers throughout the game, but couldn't match the Tigers' speed and Houston's hot shooting. Holland had to work hard to score against the harassing defense while the speedy Tigers zipped down the court to score with seeming ease.

Besides Fortney, Holland had three other players in double figures. John Thomas had 15 points and 13 rebounds. Steve Jacobusse had 12 points, and Jim Swartz had 11.

Muskegon Heights made 40 of 84 shots from the floor for 48 per cent, and nine of 13 from the foul line for 69 per cent.

Holland hit 30 of 63 field goal attempts for 48 per cent and 17 of 24 free throws for 70 per cent.

Muskegon Heights had a small edge in rebounding. The victory was the eleventh of the season for the undefeated Tigers. Their league record is now 10-0. Holland is now 8-4 and 8-3 in the VCC.

## Capacity Crowd Hears Dave Brubeck Quartet

Holland Civic Center was filled to capacity Thursday night when four "ordinary-looking men walked on the stage, took their instruments and proceeded to south out their extraordinary jazz improvisations.

Only Dave Brubeck and his quartet could catch the Holland audience for the two hours of jazz that followed in the inimitable Brubeck manner.

From the first notes of "St. Louis Blues" to the final notes of "Take Five" listeners became involved in the provoking, unexplored paths of compound time with Brubeck at the piano, Paul Desmond on sax, Gene Wright on bass and Joe Morello on drums.

If specific titles could not be recalled, melodies of "old favorites," "Tangerine," "Stormy Weather" and "Johnny One-Note" could be identified in Brubeck's exotic time-signatures and overlaid, counterpoint rhythms.

The familiar "My Old Kentucky Home" notes were distinct in the bass solo by Gene Wright.

If the listener was not a "real jazz fan," he couldn't help but be attracted to the four warm personalities that have become the symbol of

progressive jazz not only in America but also in the world, even behind the Iron Curtain.

Their style and enjoyment of work commands audience involvement and communication and it is understood why their exchange tour is acclaimed as among the most successful of all such tours by the United States State Department.

While the audience chuckled at the light, humorous exchanges between the members and applauded the solos, they were excited by the final "Take Five" number, considered one of the most challenging of time-signatures.

Brubeck carried the listener through Desmond's five - four composition by playing the beguiling constant on the piano and holding it through Morello's drum solo.

In "Take Five," favorite of many, Morello subtly escaped the rigidity of the five-four time and wove intricate counter-patterns over the piano figure, for a "really swinging" final number.

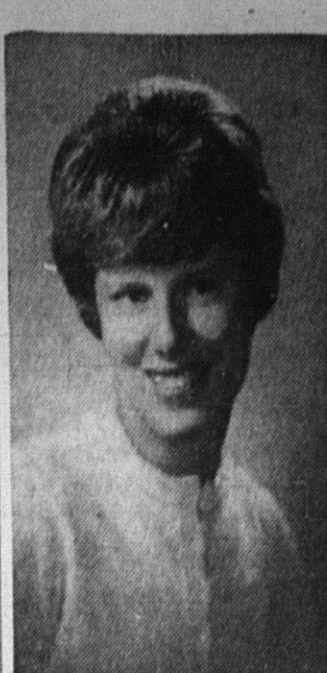

The will had been contested in Ottawa Circuit Court. Circuit Judge Raymond L. Smith Thursday signed an order dismissing the appeal, thus remanding the will to probate court for admission to probate in the usual course.

The attorney general appeared on behalf of the public in defense of the will, by reason of the bequest to charity. James W. Bussard, prosecuting attorney for Ottawa County, represented the Ottawa County Humane Society, also a beneficiary under the will.

Attorneys for the estate also stated that there was no settlement and nothing was paid in connection with the withdrawal of the objections. The decision to drop the suit followed an investigation of facts and circumstances, and terminates not only the pending litigation but also any future right to challenge the will.

## Sunday School Lesson

Sunday, Feb. 12  
The Call to Repentance  
Luke 13:1-9

The word "repentance" is not popular enough today. That is one reason why this word should get a lot of attention studying this lesson. Repentance is essential to salvation and sanctification.

I. Jesus often corrected the thinking of people. Some people told Jesus about "the Galileans whose blood Pilate had mingled with their sacrifices." Evidently some Galileans had broken a Roman law. Pilate sent some soldiers to the scene. These Galileans were in the act of sacrificing and the soldiers slew them and mingled their blood with the sacrifices. Some thought that these Galileans were unusual sinners and therefore they got what they deserved. Jesus disagreed. Jesus disagreed.

Sudden deaths, accidents, calamities come to the good and the bad. Personal affliction is not necessarily due to wrongdoing, although all wrongdoing has sad consequences.

A tragedy had taken place in Jerusalem. Eighteen workmen while building Pilate's aqueduct were killed by the falling of a tower at the pool of Siloam. This project was financed by monies from the Temple. Some people thought that these workmen were exceptional sinners and hence the accident.

Troubles, unexpected tragedies come to all kinds of people. These events are calls to repentance lest we perish. God summons people to turn to Him—away from sinful and godless living.

II. God is very patient. The Parable of the Barren Fig Tree is found only in Luke. Jesus told about a fig tree that was bearing no fruit. The owner said that for three years it had brought him nothing and so he said it should be cut down. The dresser asked for another year and the tree got another chance.

The fig tree represented Israel, a highly favored nation. Although it had received special favors and privileges it had failed. Our nation too is favored. We are a highly privileged people. The nation is full of irresponsible people. God's judgment is bound to come. God will not tolerate uselessness. We must live fruit-bearing lives. If we fail to bring forth fruit we miss the purpose God has in mind for us.

The Christian Church is here for a God-given purpose. When the church shows concern only for man's material needs and ignores his spiritual need—salvation of the soul, the church misses the mark.

The words, "why cumbereth it the ground" or "use up the ground" note. Some people say that it is nobody's business how they live and what they do or don't do. When a person hurts himself he hurts others also. The reckless driver, the gambler, the drunkard, the thief, the loafer, the freeloader, these all hurt themselves and others. Some people in a community take out more than they take in, others put more in than they take out. What do you do?

And let's remember that God too has His rights. One of the saddest statements in the Bible is the statement Jesus made regarding Jerusalem, — "how often would I have gathered thy children together, as a hen doth gather her brood under her wings, and ye would not!"

## '76 Group Explained At Early Bird Breakfast

Aims and purposes of the 1976 Committee were explained by Glen G. Velker, administrative assistant to Charles R. Sligh Jr., executive vice president of national program, at an Early Bird breakfast of the Chamber of Commerce this morning in Hotel Warm Friend before more than 100 persons.

Velker cited the need for reversing the trend toward Socialism in the national government by injecting conservatism and returning the country to original principles as cited in the Constitution and the Bill of Rights.

The 1976 Committee is political but not partisan, although it expects to accomplish more through the Republican party than through the Democratic party. Provision is made to terminate the Committee July 4, 1976, a need or desire to continue after that date, the name likely would be changed, Velker said.

He spoke of increasing controls of government and quoted Norman Thomas, six-time candidate for President on the Socialist ticket, as saying that 70 per cent of the 1932 Socialist platform is now law and there is no further need for a Socialist party.

The national debt at present is 1 1/2 trillion dollars and if the government set aside 10 per cent of its budget and have no further deficits, it would take over 100 years to pay off this debt, Velker said.

The blame for such a state of affairs, he indicated, lies with Congress and the President, and the 1976 Committee aims to promote a Conservative for President. For this, the Committee suggests Ezra Taft Benson, secretary of agriculture under Eisenhower, for President in 1968 and Sen. J. Strom Thurmond for Vice President, both chosen for their continued adherence to conservative policies. Neither are avowed candidates, but the Committee hopes to build national publicity in their favor. "We are not optimistic about getting either nominated," he said.

He said a half million copies of the 16-page committee booklet have been mailed from the headquarters in the Sligh block in Holland.

He described the Committee as a blue-ribbon group of 100 members, presently listing 37 members. Out of this will come 1976 Clubs on a local basis to promote the program. Ten such clubs already are in operation. He said the Committee operates on a budget of some \$50,000, most of it coming from committee members. Requests for donations have yielded some \$6,000 in \$10 and \$15 donations.

The Committee will not support Romney for President in 1968, he said, because the committee does not feel Romney is a Conservative.

The Committee will be doing little about convention delegates in Michigan in 1968 since delegates in this state are pretty well controlled by party organizations, but in 10 years the situation may change, he said.

The Committee is flexible about candidates and hopes that new leadership will emerge, possibly a groundswell similar to the one that sparked Wendell Willkie's nomination in 1940.

## 4 Businesses Are Entered By Burglars

Four Holland business places in the vicinity of Lakewood Blvd. and North River Ave. were entered by burglars early Tuesday, but the total take in the breakins appeared to be less than \$25.

The burglars broke out windows to gain entry at Pete's Place, Fyne Weaver's Standard Service, and Naber's Market, all located at the intersection of Lakewood Blvd. and River Ave., and at North Side Texaco, 201 North River Ave., Ottawa County sheriff's deputies said.

The breakins were believed to have occurred around 2 to 2:30 a.m.

The thieves were reported to have taken about \$13 in change from a cash register at Fyne Weaver's service station and between \$9 and \$10 in change from a cash register at Naber's Market.

Deputies said the burglars failed to open the cash register at Pete's Place containing several dollars in change and overlooked a cigar box under the cash register containing an undetermined amount of cash.

Owner John Riemersma of North Side Texaco had removed the cash drawer from the station's cash register prior to closing the station. Two \$10 rolls of quarters under the cash register were overlooked by the thieves, deputies said. Riemersma told deputies nothing appeared to be missing.

The burglars entered Pete's Place by breaking the glass out of the front door, and apparently left the same way, deputies said. They said the building had not been entered before 2 a.m.

The breakin at Pete's Place was reported to deputies at 5 a.m., and a sheriff's patrol discovered the North Side Texaco breakin when officers spotted the broken window in the overhead door.

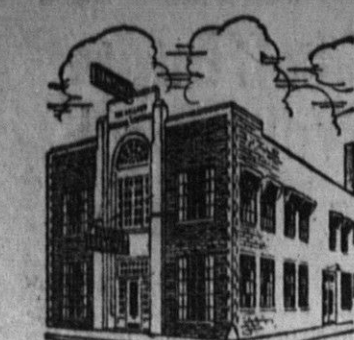

The Maroons led throughout the game in winning their eleventh game. They've lost three.

Christian opened up a 16-6 lead with 2:44 left in the first period, and held a 20-14 edge at the end of the period. Lappinga notched 10 points in the frame. The Maroons made 61 per cent of their shots in the period.

East Grand Rapids got hot in the second period and closed to within two points at 22-20 at 6:10 of the quarter. The teams then traded baskets in a hot shooting spree which ended with the Maroons on top 32-30. Christian scored 10 straight points in the last three minutes to close the half with a 42-30 lead.

The third quarter was the poorest in shooting for both teams, but the Maroons tacked on 10 points to their lead for a 59-37 bulge at the end of three quarters.

The Pioneers went into a zone defense in the final period, and the Maroons were content to work the ball around for a good shot. They hit five of 10 during the period for 50 per cent.

The Maroons opened up their biggest lead, 28-points, with about four minutes left in the game. The score was then 67-39.

The Maroon reserves took the floor. Six of them, in fact, were in action against the Pioneers for a few moments until one of the referees noticed the error.

Christian continued to hit a high percentage from both the floor and the foul line. They made 29 of 60 from the floor for 48 per cent and 11 of 14 from the foul line for 79 per cent.

East Grand Rapids bagged 21 of 60 field goal attempts for 35 per cent and only four of 11 from the foul line for 36 per cent.

Leading scorers for the Pioneers were Jon McIntyre with 16 points and Sam Korrick with 12 points.

Christian dominated both the offensive and defensive boards, picking off 39 to 20 for East Grand Rapids. Hulst led the Maroons with 12 rebounds. Lappinga had 10.

Christian which played three games in the last five days will have a seven-day rest. The Maroons return to action against West Ottawa at the Civic Center next Tuesday night.

The loss dropped the Pioneers' record to 2-11. They return to the Tulip City for a game with Holland High this Friday night.

## West Ottawa Wins Over Forest Hills

Pure determination sparked the West Ottawa basketball team which rallied in the final minutes to rout Grand Rapids Forest Hills by a deceiving 11 point margin, 78-67, Tuesday night in the West Ottawa gym.

Rapidly maturing with each game, freshman Len Loncki paced the Panthers with 16 points for the team's first victory in eleven starts. The Rangers post a 2-7 O-K League mark.

Employing controlled offensive patterns and a tight man to man defense, West Ottawa piled up a ten point lead with 2:30 remaining in the first quarter. The Panthers maintained a first period lead, 18-9.

In the second period the Rangers utilized a zone defense and full court press which vexed the young West Ottawa team, and narrowed the Panthers halftime edge, 34-30.

From the floor in the first half the teams were nearly matched. West Ottawa hit on 39 per cent making 11 of 28 while the Rangers sank 11 of 27 for 41 per cent.

Guard Steve Russ of Forest Hills, pumping in nine of his total 19 points was responsible for almost half of the Panthers point production in the third period. West Ottawa's margin was again narrowed at the close of the third quarter, 53-50.

Early in the fourth quarter West Ottawa increased their lead to five points on two 20-foot jumpers by Mike Kolean. Kolean dumped in two more before he fouled out with 3:46 remaining. Forest Hills also saw foul troubles as their strong defensive threat, Randy Ashley, fouled out with 4:08 left.

With 3:00 remaining the Rangers forged ahead to take a one-point lead, 66-65. But the Panthers, spurred by the threat of an impending eleventh straight defeat, took command and allowed the Rangers only one foul shot in the final minutes.

West Ottawa improved its shooting percentage in the second half hitting 18 of 40 for 45 per cent. The Rangers managed to connect on 14 of 39 for 36 per cent.

Neither team could control the boards as West Ottawa grabbed 16 offensive and 29 defensive rebounds compared to 12 and 25 respectively for the Rangers.

From the free throw line West Ottawa sank 25 of 37 and Forest Hills tossed in 17 of 34.

Obviously pleased with his team's fine effort, Coach Jack Bonham praised all members of the club. "We needed to win this one. We've been steadily improving," Bonham said.

West Ottawa had lost to Forest Hills on Dec. 27, 62-61. Starting guard Jim Visser played most of the game with a pulled leg muscle.

The Panthers, who are now 1-3 in O-K league action, will travel to Zeeland Friday for another league game.

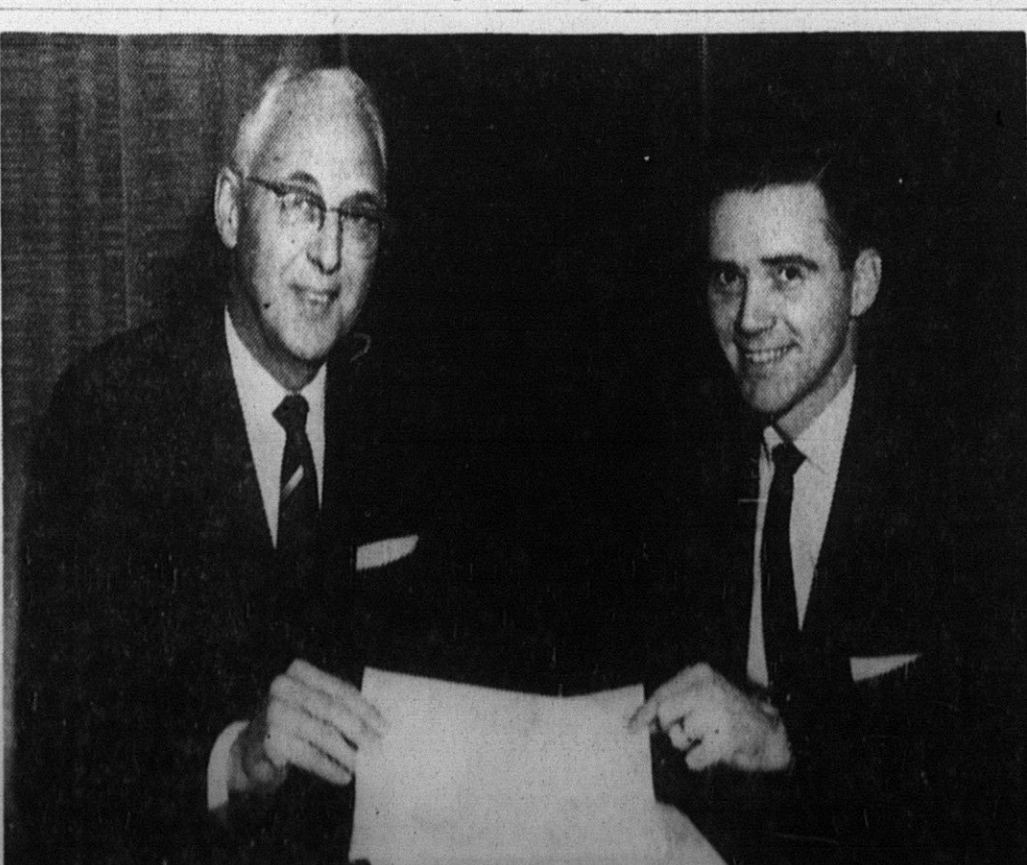

## John Donnelly Tells Club About Holy Land in Slides

Addressing fellow members of the Century Club Monday evening in the Tulip Room of the Warm Friend Hotel, John F. Donnelly said, "In a city like Jerusalem, or almost anywhere in the Holy Land, one is painfully conscious of the transitory condition man endures."

He illustrated his talk, "The Land of Promises Still has Promises," with slides taken on a recent two weeks sojourn with his family in Lebanon, Jordan and Israel.

Noting the disturbing quarrels, wars and destruction that the Holy Land has witnessed in its long history, Mr. Donnelly estimated that it has experienced a catastrophic change every 400 years. This he felt vividly illustrated in one of the best of the remaining crusader churches in Abu Gosh near Jerusalem.

His slides showed a stone from a previous Roman ruin used in the construction of the Crusader church. The site, that of Herod's temple, which was destroyed by Roman soldiers about 70 A.D., has witnessed a capsule history of the Holy Land, he said.

It was here, he continued, that Abraham brought his son Isaac; here that David conquered; here that Solomon built the first temple to the Lord—a temple that fell into ruins. This was rebuilt, only to be torn down by Herod who replaced it with a splendid building. This in turn was destroyed and the site used by the Roman, Hadrian, for a temple of Jupiter.

Later, the speaker said, the Christians replaced the temple with a Byzantine church. Later, a second, larger Byzantine church was destroyed by the Muslims to provide a site for a Mosque, which was used until 1099 when Crusaders made the Mosque into a Christian church. It remained a Christian church until the Muslims regained it in 1197. Although the land has gone from Arab control to Turkish, to English and back to Arab, the speaker said, the Muslims have held the Mosque ever since.

"So you see the long processes of building ending in destruction to be followed by new building," Mr. Donnelly said. "And the strife goes on. In fact it was in this courtyard that King Abdullah of Jordan was killed in 1951."

Mr. Donnelly noted that, although this capsule history gives the impression of constant destruction, the periods between such destruction were often times of great growth and of great building. To illustrate he used pictures he took of a model of Jerusalem as it was on the eve of the city's destruction by Titus in 70 A.D. Calling attention to the magnificence of the four towers of the Antonia fortress, Herod's palace, the Caiaphas palace, David's tomb and other impressive structures, Mr. Donnelly stated long periods of time, imagination, love of beauty, thirst for lasting glory as well as the desire to worship God in a suitable way, plus hours without measure of back-breaking work went into building all this.

The speaker illustrated the

glories of the land's history with slides of the spectacular Roman ruins at Jerash in Jordan, and of the ruins of the magnificent buildings at Baalbek in northern Lebanon.

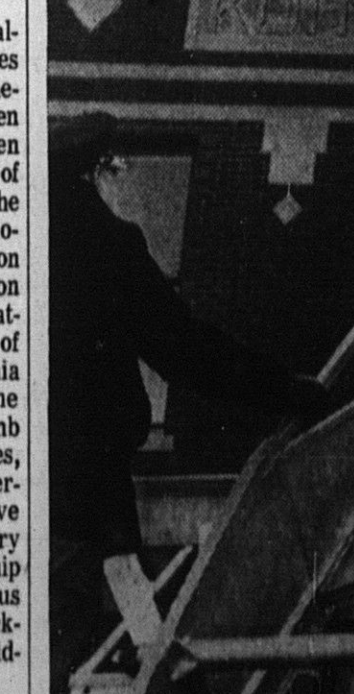
Continuing with glimpses of the civilizations of later centuries, the speaker showed slides of a fourth century synagogue in Caphtanum, the Church of the Synagogue in Nazareth, the remains of a fifth century Byzantine church, an 18th century Turkish Mosque in northern Israel at Akko; and of present day buildings and gardens in Amman, Haifa and Jerusalem, commenting, "It would be wonderful if these buildings and these cities could live to enjoy a unique fate — that of wearing out rather than being destroyed."

Mr. Donnelly concluded with slides of the beautiful hills and sea of Galilee and the comment that all this "should prompt us to work and pray for peace — peace not only in the Holy Land but in our own land and other lands, and most of all in our own hearts, that we may someday enjoy the lasting peace Christ promised."

Music for the evening was provided by David Tubergen, Hope college student and recent winner of the Young Artist Competition of the Battle Creek Symphony. He played the first movement of the Bruch Violin Concerto in D Minor and "From the Canebrake" by Samuel Gardner. He was accompanied by Miss Dianne Hagle, Hope college student from Ripley, N.Y.

Mrs. Marion Stryker, who presided, gave memorial tribute to Mrs. John A. Telling, a former member of the Century Club.

The pattern was similar to Christian's 75-48 win over Ludington Friday night. In both contests the Maroons held narrow leads at the intermission and blasted their opponents apart in the second half.

Christian used a full-court zone press along with their man-to-man defense in the second half to increase the tempo of the game and run away from their visitors. The Maroons put the press on after they scored a basket, and it brought on several turnovers and generally upset the Tigers.

Bob Van Langevelde sparked the harassing press. The Maroon guard stole or recovered the ball four times and was a thorn in the side of Allegan's guards. Van Langevelde also scored 11 points and led the team with four assists.

Allegan never led in the game although they tied the score at 22-22 in the second period. Christian took a 9-3 lead in the first two minutes of play. The Tigers started to hit and the opening period closed with the Maroons ahead 18-14.

Christian made only two of 11 field goal attempts (18 per cent) in the second quarter, but Allegan wasn't much better as they made only four of 13 from the floor (30 per cent).

The Maroons were able to take a 29-22 halftime lead because of their foul shooting. They made seven of nine free throws in the second quarter. Christian enjoyed sharp foul shooting throughout the game, and made 25 of 32 for 78 per cent.

The winners had two stretches where they hit eight straight points as they turned the game into a rout in the third period. They scored eight straight in less than two minutes to take a 38-24 lead early in the period, and closed the quarter with another eight straight to make the score 51-30. Christian outscored Allegan 20-3 in the stanza.

The winners kept up the pace in the final period as they outscored Allegan 18-8. Christian's coach Art Tuls played his reserves quite a bit in the final period.

In the second half the Maroons meshed 18 of 39 from the floor for 46 per cent. Their overall field goal percentage was 42 per cent (27 of 64). Allegan, in contrast made 29 per cent from the floor (15 of 51).

Steve Bushouse, playing one of his best games, led all scorers with 17 points. He and teammate Don Hulst each had 11 rebounds to pace Christian's backboard monopoly. The winners outbounded Allegan 38-16 overall.

John Lappinga scored 12 for Christian. He is the leading Maroon scorer, hitting in double figures in 11 of his 13 games.

Bob De Nooyer notched 11 points for the winners.

Allegan's only scorer in double figures was Bill Ter Avest with 10 points.

The victory was Christian's tenth in 13 games this season. Allegan's record is now 4-8. A crowd of about 2,200 was on hand for the Allegan game which was Christian's homecoming game. The throng was entertained by a hard-fought defensive game between the faculty and the Alumni All-Stars during halftime. The game ended in a 0-0 tie.
