Known as 'Mr. Oratory of Michigan'

Oratory Expert Dies Here at 72

Dr. William Schrier, 72, of 22 West 25th St., associated with Hope College since 1939, died Tuesday in Holland Hospital after an illness of several months.

Born in the Netherlands in 1900, he came to Kalamazoo in 1903 and became a naturalized citizen in 1913. He attended Kalamazoo College and the University of Michigan, distinguishing himself as an orator and debater for four consecutive years. In 1924 he was winner of the University of Michigan Oratorical Contest by unanimous vote of five judges.

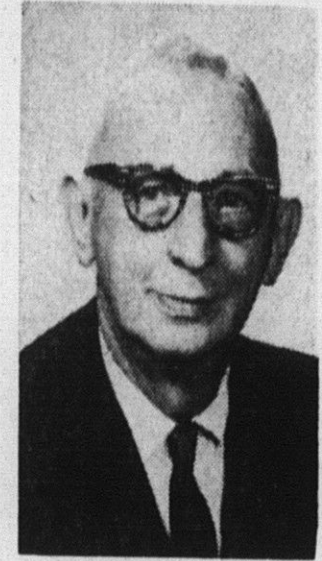
He took graduate work at the University of Michigan, obtaining an M.A. degree in 1931 and a Ph.D. degree in 1945. He was an instructor at St. Louis University, University of Colorado and the University of North Dakota before coming to Hope College as chairman of the speech department in 1939.

During his career at Hope College, Dr. Schrier had the

distinction of producing more oratory winners than any other college in the region, some becoming winners of national contests. Dr. Schrier was associated with the Michigan Speech Association, the Central State Speech Association, was a member of the honorary forensic societies Pi Kappa Delta with a degree of special distinction, Delta Sigma Rho, and held emeritus membership in the Speech Association of America.

He was the author of many articles and published three books, "Gerrit J. Diekema, Orator" in 1950, "Winning Hope College Orations" in 1966 and "Contest Oratory" in 1971.

Known as "Mr. Oratory of Michigan," he retired from active coaching oratory and

extemporaneous speaking in 1967 but continued with the Department of Speech at Hope College for a longer period.

He was a member of Hope Church and the Holland Rotary Club.

Surviving are the wife, the former Ada Ann Meyers; one daughter, Mrs. Robert (Sally) Japinga of Vancouver, British Columbia, Canada, and three grandchildren, Richard, William and Kathy.

Lake Macatawa Hearing Slated Here Next Week

A public hearing on watercraft problems on Lake Macatawa is scheduled at 1 p.m. Monday, March 26, in council chambers of Holland City Hall, called by the marine safety section of the Department of Natural Resources of the state of Michigan.

Among subjects to be discussed is control of wake areas on the lake, particularly in view of high water levels and shore erosion. No-wake areas were proposed in some sections some years ago, but the popularity of water skiing and speed boating has complicated the situation.

Zeeland Crash Claims Man, 84

ZEELAND — An elderly Drenthe man was killed and four persons, including two children, were injured in a two-car collision Tuesday at 2:26 p.m. at M-21 and 96th Ave. south of here.

Reported dead on arrival at Zeeland Community Hospital was Ray Ellen, 84, of 850 64th Ave., driving a car south on 96th Ave.

Ottawa County deputies said it appeared Ellen pulled into the path of a car eastbound along M-21 and driven by Henry Nykamp, 69, of 344 East Central, Zeeland.

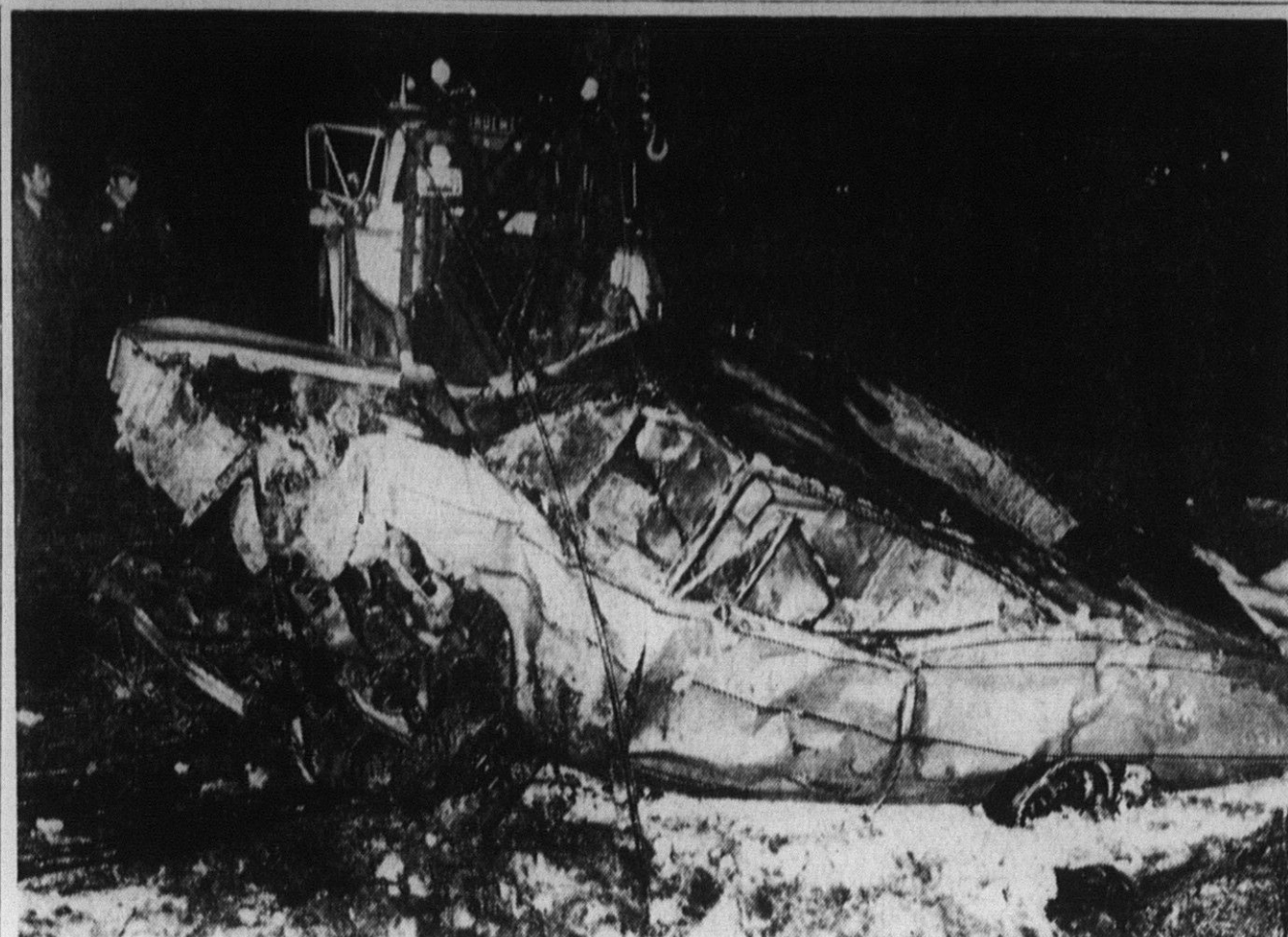
Nykamp was admitted to Zeeland hospital with possible back injuries and was in "good" condition today. His wife, Mary, 65, was admitted with internal injuries and was in "critical" condition.

Two grandchildren of the Nykamps were injured. John Ter Haar, 5, son of Mr. and Mrs. Jarvis Ter Haar of route 3, Zeeland, was admitted to the Zeeland hospital with a possible broken neck and was in "good" condition. Mary Leeuw, 2, daughter of Mr. and Mrs. Marvin Leeuw of 82 West Main, Zeeland, was treated in the hospital and released.

Ellen's death was the fifth traffic fatality reported in Ottawa County this year and compared with seven deaths last year at this time.

Ellen was born in the Netherlands and lived in Iowa before moving to the Drenthe area 30 years ago. He was a member of Drenthe Christian Reformed Church.

Survivors include a sister in Amsterdam, the Netherlands.

Skill Center Vote Likely In the Fall

GRAND HAVEN — Likelihood of another vote for an Area Vocational Center in the fall resulted from a thorough discussion among members of the Ottawa Area Intermediate Board of Education Thursday.

The March 8 vote held in Ottawa county and the northern part of Allegan county turned down the issue by 216 votes out of a total of 18,500 cast.

The intermediate board instructed the superintendents of local boards to relay opinions and recommendations, and the initial consensus was another vote in the fall. Area residents also will be consulted. All interested persons are invited to make their wishes known to the Grand Haven office.

The board also approved a new name for the intermediate board on recommendation of the State Board of Education. The new name is Regional Enrichment Materials Center Board (REMC). The Ottawa intermediate district is one of 20 such educational planning areas in the state. Approximately \$9,245 is expected this year to assist in buying materials for the center. The Intermediate Office already has a media center.

Also approved was .13 mill for the general fund budget for 1973-74.

May 10 was set as a hearing to consider a request for property transfer from the Saugatuck school district to the Hamilton school district. The request was made by Mr. and Mrs. Dennis Heavener.

The board approved hiring an additional psychologist, social worker, consultant for the visually handicapped and consultant for the hearing handicapped. Because of mandatory special education, these requests are minimal for the 1973-74 school year and may have to be revised at a later date.

The board requested the superintendent to investigate the feasibility of having another carrier for the employee hospitalization insurance program.

Also approved were salaries for the professional staff for 1973-74 with total increases listed at approximately 4 per cent.

James Roth of Plainwell pleaded guilty to a charge of attempted robbery and bond of \$20,000 was continued. He was to return April 16 for sentencing.

Police said both cars were westbound on 16th when the Berends car, stopped at the intersection, was struck from behind by a car driven by Debra Lynn De Weerd, of 629 West 27th St.

Car Rolls During Pursuit, 1 Killed

The son of a custodian at the State Police post in Grand Haven was killed when the car he was driving went out of control along northbound I-196 at 12:02 a.m. Tuesday just inside the Holland City limits in Allegan County during a pursuit by South Haven state police.

Killed in the crash was Golden Donson, 23, of Muskegon Heights. He was the first traffic fatality reported in the city this year.

Three passengers were injured in the crash, one of them seriously.

Admitted to Holland Hospital with multiple abrasions and possible back injuries was Horace L. Williams, 20, of Muskegon Heights. He was listed in "fair" condition.

Treated in the hospital and released were Anthony Ray Williams, 16, and James Arthur Arnold, 25, both of Muskegon

Heights. Williams was treated for a fractured shoulder while Arnold suffered contusions and lacerations.

Donson was reported dead on arrival at Holland Hospital.

South Haven state police said officers on patrol spotted the 1968 model car traveling along I-196 at a high rate of speed and began the pursuit at about 118th Ave. south of Ganges.

Troopers said they were about one mile behind the car at the time and gained about one-half mile on the car when it went out of control two-tenths of a mile inside of the Holland City limits, a distance of about 15 miles. Speeds reached 125 miles per hour at the time of the crash, troopers said.

Troopers said the car rolled about 480 feet before coming to rest in a ditch along the right side of the expressway. All the occupants remained inside the crushed vehicle.

Holland firemen were called to help remove the victims with rescue equipment. Holland police had been notified of the pursuit and were standing by near the city limits when the car went out of control.

Zeeland Council Acts on Welfare

ZEELAND — City Council Monday adopted a resolution pertaining to use of welfare and requested the state take action to trim welfare rolls.

The resolution, similar to one adopted by officials in Gladwin, urges the state to begin a program whereby all able-bodied welfare recipients should accept employment or be enrolled in a job training program.

Council said a request from Ottawa Door Lights, Inc., to rezone land in the industrial park was unnecessary and that the proposed uses of the land were consistent with present zoning. The firm had sought to rezone the land from D1 to D2 industrial.

All city departments are to take part in a Civil Defense simulated disaster exercise Monday at 7:30 p.m. to test emergency preparations under a disaster situation.

Maentz Named First National Board Chairman

Thomas Elected Bank President

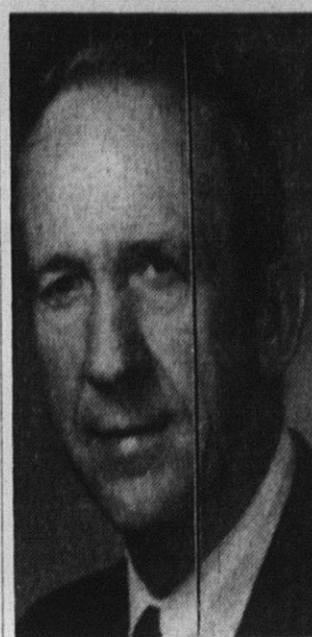
The board of directors of First National Bank of Holland Wednesday announced the election of Donald J. Thomas as president and chief executive officer of the bank. Henry S. Maentz, former president, was elected chairman of the Board.

Thomas, who has spent all of his banking career with First National, joined the bank in 1936. He was first elected on officer in 1947, was named cashier in 1950, vice president in 1959, and has been a member of the board of directors since 1956. A graduate of Kalamazoo Central High School, Thomas received his B.A. degree from Hope College in 1938, and graduated from the Stonier Graduate School of Banking at Rutgers University in 1956.

Thomas has been active in community affairs and served several terms on the board of directors of the Holland Chamber of Commerce of which he was treasurer, and was a member of the boards of the Greater Holland United Fund and of the Holland Tulip Time Festival. He was for 15 years a member of the board of the Herrick Public Library and is also a past president of that Board. He is a member and past president of the Lions Club of Holland. Thomas and his wife, Martha, reside in Holland.

Until his election as chairman, Maentz had been president of First National Bank since 1936. He is a graduate of the Culver Military Academy and the University of Michigan. Active in numerous community affairs, Maentz was for 20 years, until 1971, a member and was at one time President of the City of Holland Board of Public Works. He is past president of the United Fund of Holland and of the Holland Chamber of Commerce and was a Board member of the Holland Economic Development Corporation, The Holland Youth Council, the Visiting Nurses Association, the Holland Chapter of the American Red Cross and several other civic organizations.

He is a past state chairman of the U. S. Savings Bond Program and was active in the

founding of Windmill Island, one of Holland's leading tourist attractions. Maentz is a 36-year member of the Rotary Club and is a member of the Macatawa Bay Yacht Club. Mr. and Mrs. Maentz reside in Holland.

Forrest Opies' Freightier Trip Has Big Climax

Mr. and Mrs. Forrest Opie of 795 South Shore Dr., had a climactic home-coming after a freighter trip to South America. On their return to Holland they were in the East Palestine, Ohio train wreck early Sunday morning.

Their car was not among those derailed, but they were taken by ambulance to the city hall in East Palestine where they stayed until about 2:50 a.m. until 10:30 a.m., when the remaining cars on their Amtrack train had been checked and put back into service for the trip to Chicago. In Chicago, the Opies and those of the 167 passengers on the train were put up at the Palmer House as guests of Amtrack.

According to Mrs. Opie, there were only 19 injured in the wreck, two seriously enough to remain in the hospital in Ohio. One man had been instantly killed in the wreck, also. Medical treatment was available in East Palestine for the minor injuries sustained by most of the injured. The fire department and auxiliary of East Palestine also provided sandwiches and coffee for the waiting passengers.

The trip to Chicago from East Palestine in the remaining cars of the train, did not include a diner, so more sandwiches and coffee were brought aboard at Fort Wayne, Ind.

The Opies arrived home late Monday, their cruise to Brazil, Argentina and Uruguay almost overshadowed by their Ohio experience.

They were among only eight passengers on the freighter voyage. During their stay in Montevideo, Uruguay they were guests of the Enrique de Castellet family, which also hosted Jane Mokma of Holland Christian High when she was an exchange student in Montevideo under the Youth for Understanding program last year.

Two Cars Collide Injuring Three

ALLEDALE — Three persons were injured in a two-car collision Saturday at 10:55 a.m. along 48th Ave. 1/2 mile south of M-45 in Alledale Township.

Ottawa County deputies said a car driven north along 48th Ave. by Timothy Arthur Poelman, 17, of 4551 Bauer Rd., Hudsonville, went out of control on icy pavement, slid sideways and crossed the centerline.

The Poelman car was struck in the right front by a southbound car operated by Shirley Ann Vande Weg, 23, of Alledale.

Poelman suffered facial lacerations and possible neck injuries while a passenger, his brother, Charles, 16, sustained a possible fractured collar bone. Both were taken to Grand Rapids Osteopathic hospital for treatment.

The Vande Weg woman was not reported injured but her passenger, Noreen Rotman, 16, of Alledale, sought her own treatment for bumps and bruises.

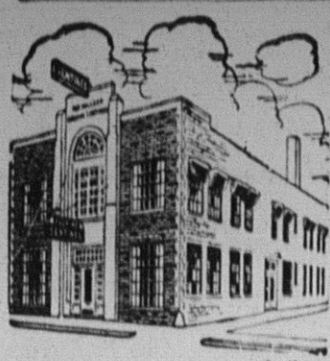

A PROBLEM AND A GRIPE

Michigan State Police Director John Plants has a problem and a gripe. His problem is youngsters from 18 to 20 who were given the legal right to drink last year. He says there was a 77 per cent rise, during 1972, in the number of 18-20-year-old drivers who were drinking and involved in accidents. He says that 35 more people died in accidents involving young drinkers. What's more, 2,800 more people have been injured by drivers in this age group who have been drinking.

This isn't a problem only for the Director of the State Police. It's a problem, and a pretty scary one, for everybody who travels in an automobile. This kind of travel is dangerous enough without being exposed to the fatal irresponsibility of tipsy young drivers. Something surely will have to be done to reduce the number of accidents caused by these youngsters for the liquor reason.

And that's Director Plants' gripe. The courts don't seem to be much concerned about the business. The police have arrested 32 per cent more people for drunk driving, but the courts have convicted only 22 per cent more. Almost 60 per cent are acquitted after having been arrested. Director Plants is discouraged, and many think he has reason to be.

This is such a difficult matter to control. We know how fatal drinking drivers can be. We think better controls would help solve many of the problems. Canceling the drivers license of drivers convicted for drunk driving would help. This is the first step to getting these menaces off the road.

Director Plants complains that if a couple of people are found dead from an overdose of drugs there will be a dramatic public reaction, but killing 35 more people per year through drunken driving he is sure won't cause even a public ripple. He is right in his complaint, and we are wrong to tolerate such a state of affairs.

Sunday School Lesson

Sunday, March 25

God Cares

Psalms 103:8-14; John 3:16-17

By C. P. Dame

"It is terrible to lose faith in people," so spoke a woman in a nursing home. It is tragic to have no faith in God or to lose it, but it is a great blessing to believe in God who cares and revealed it in Jesus Christ.

I. "The Lord is merciful and gracious," and for this we should be thankful for we are sinners. In the past we have studied about the creation of the universe and man, his fall, and the deterioration that followed. This lesson is the first of a series of six, telling about man's redemption.

Psalms 103 is a hymn of praise written by David. In the first five verses he tells about his personal relationship to God; verses 8 to the end are more general, relating what God has been and done for the nation. The six verses of the lesson text offer much opportunity for discussion. Verse 8 gives four facts about God — His mercy, His grace, His slowness to anger and His steadfast love. We are sinners and have no merit, but we can claim mercy from a merciful God "who does not deal with us according to our sins." Those who fear God show reverence for Him and experience the fact that God differs from man.

Being merciful, God forgives sin. David experienced it as the words, "He removed our transgressions from us" indicate. We sometimes say we forgive but keep on remembering, but God forgets, for according to Micah, He casts "all our sins into the depths of the sea."

II. "Like as a father pitieth his children so the Lord pitieth them that fear Him" so said David. God is our Creator, our King, our Judge, and also our Father, by virtue of creation and redemption. God pitieth His children because they suffer, are weak, foolish, shortsighted and easily misled by false leaders. God knows our frame, knows our strong and weak points. Jesus took upon Himself our frame and became like unto us, sin excepted.

III. "For God so loved the world" — He acted because He loved and "gave His only begotten son." John 3:16 is the gospel in a nutshell. Spurgeon, the great preacher, said that he waited years before preaching on this great text being afraid that he would not do justice to it. God gave the Son "that whosoever believeth in Him, should not perish, but have everlasting life." Note the contrast between the word "perish" and "everlasting life" — some choose to perish through unbelief, others choose to have eternal life by believing. We face a choice.

An elated Ten Harmel commented, "Sure, I was a little worried when they led by 10 points but I had faith in the guys that we would come back. We were playing tough defense."

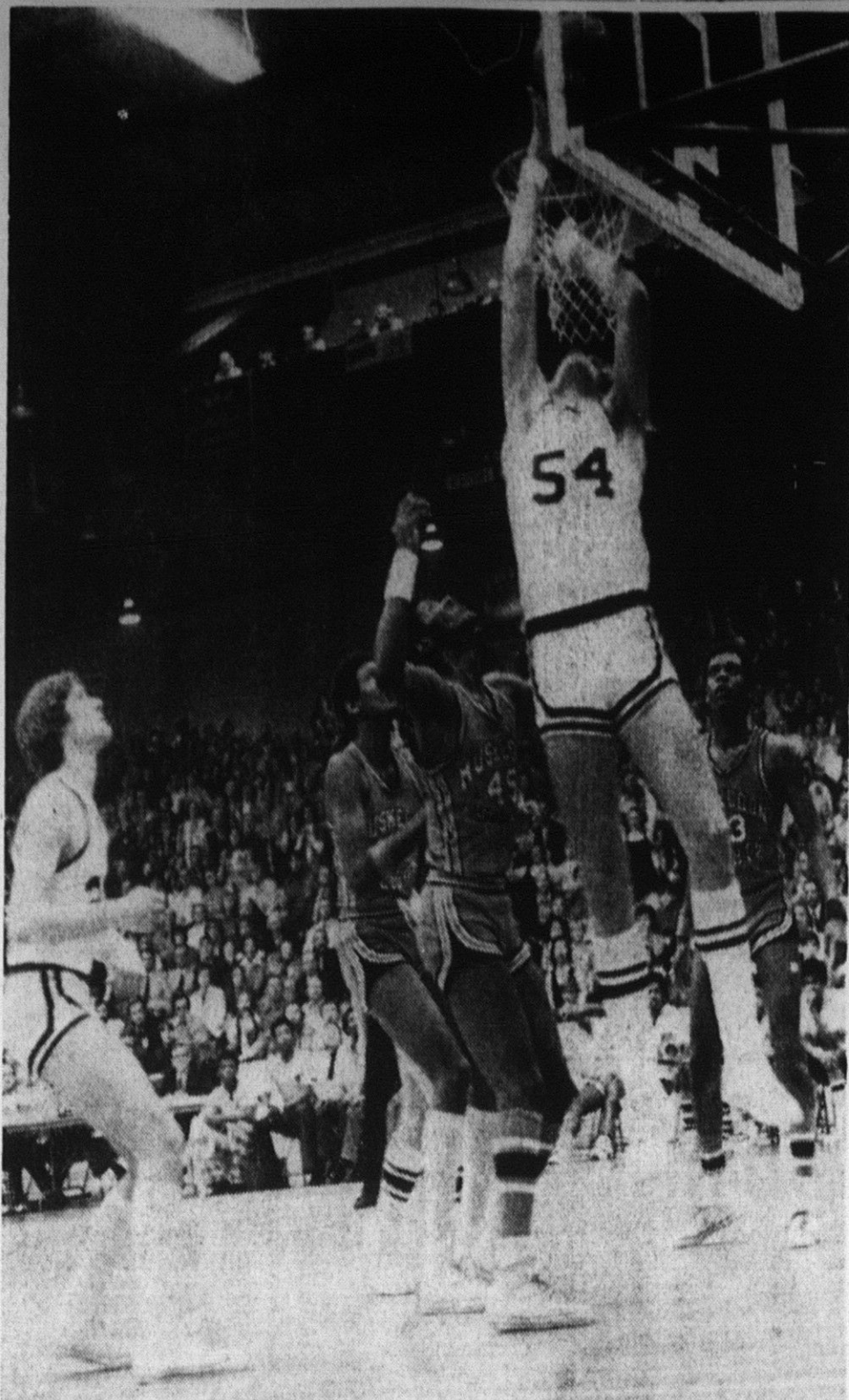

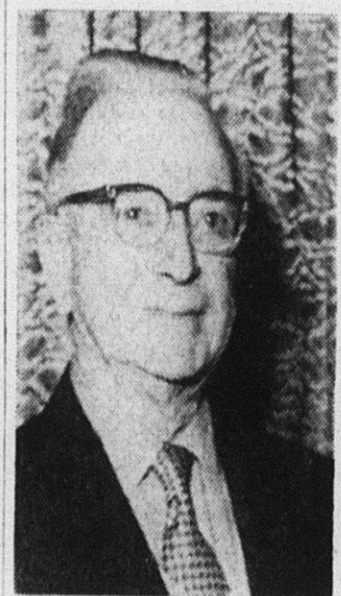

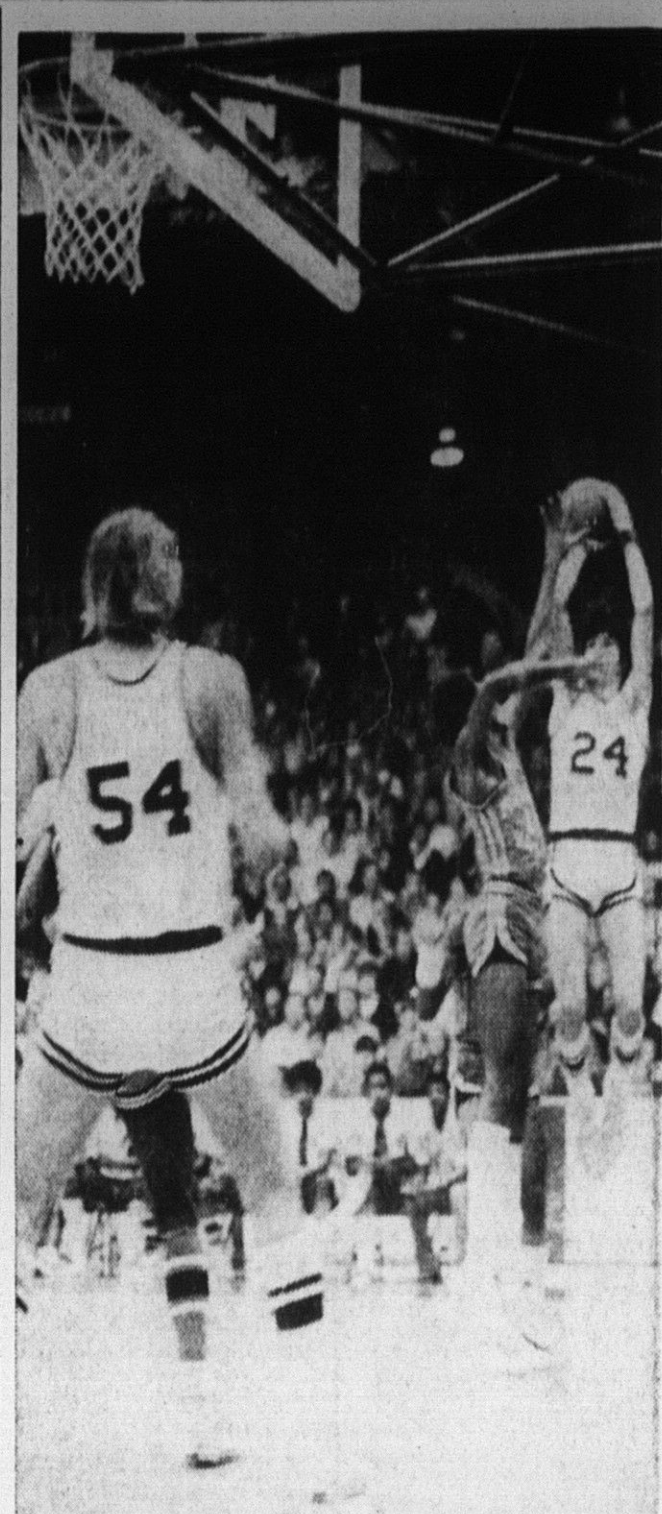

Council Okays Zoning Package

After nearly a full hour of presentations, discussions, slides and objections voiced at a public hearing, City Council Wednesday night approved a rezoning package on areas lying east of US-31 bypass and north of 32nd St., described as one of six areas under study for the entire city.

The rezoning had been under study by the Holland Planning Commission for more than two years.

The vote was 5 to 1, with Councilman Elmer Wissink dissenting, not from opposition to the general concept but voicing concern over commercial development. Absent were Councilmen Albert Kleis Jr., Donald D. Oosterbaan and Morris Peerbolt.

Representing the Planning Commission was its chairman, Howard Kammeraad, who explained the need for comprehensive study ever since 20 acres at the southeast corner of Waverly Rd. and 16th St. were rezoned for Meijers in February, 1971. Kammeraad said plans and guidelines were necessary in view of the changing nature of East 16th St. and its future link with I-196 a mile east of the city limits.

Kammeraad emphasized the necessity for a balanced approach to commercial, residential development in the Holland Heights area. The proposed changes encompassing three types of commercial, one in-

dustrial, three types of residential and a good share of agricultural area, have been repeatedly shown in maps in the Sentinel. The new ordinance is a supplement to the master plan of 1953 which was revised in 1960.

Roger Stroh, head of the Office for Environmental Health, presented a petition signed by 372 persons in the Holland Heights area supporting proposed plans. City Planner Dale Wyngarden showed slides, explaining the rationale behind the thinking, particularly with regard to utilities and the key factor of the 16th St. interchange for I-196.

Objections came in a communication from the Holland Board of Realtors requesting a 60-day delay, and from John Vogelzang, representing Vogelzang Enterprises of Holland, which had been denied a zoning request two weeks ago for commercial development on the north side of 16th St. on property known as the Plaggenmarm farm.

Carol Myers, 891 East 10th St., told Council the 372 persons signing the supporting petition represented over 90 per cent of the residents of the area and asked Council to remember citizen opinion in retaining the residential character of the neighborhood.

Russ Homkes opposed the plan, stating that if Thrifty Acres got rezoning permission, why not allow it across the street up to 12th St.

Bas Bouman, 891 East 16th St., asked why only 20 acres of the 640 acres in the southeast quad were rezoned, and was informed the other area was outside the utility service area.

Mike Gorno, 193 East Sunrise, regarded it as an excellent plan with due consideration for mounting traffic on a main traffic artery.

City Manager William L. Bopf reminded Council of an endorsement by the Holland Chamber of Commerce last Dec. 20 and explained controlled development of commercial property under the ordinance.

Mayor L.W. Lamb Jr. said the proposed ordinance cannot please everybody but Council is concerned with proper land use, a term used over and over in the final report of the goals committee. "We must avoid development like 28th St. in Grand Rapids," he said.

Councilman Lou Hallacy, who is Council's representative on the Planning Commission, pointed to the need of orderly planning, pointing out this is one of six segments of the city under study by the commission. Nearly all members of the Planning Commission were present. About 65 persons were in the audience.

Council authorized advertising for bids with opening April 12 and a tentative award date of April 18.

A city manager report on parking violations in the city focusing on a growing practice of parking-between sidewalk and curb carried with it the information that police will begin ticketing such improperly parked vehicles within one week. This is specifically for those cars parked between the sidewalk and the full height curb area.

The report said such illegal parking is inconsistent with community values that have been so indicative of Holland for many years.

"I would strongly urge persons considering the purchase of an extra vehicle to give due consideration to an appropriate place to park, prior to its purchase. It is amazing how we as Americans can strive to reduce pollution, ask for beautification throughout our communities and in the vast majority of cases give little consideration to where we are going to park the second, third and even fourth vehicle. If we are to achieve our national purposes and keep our cities from deteriorating, such considerations will have to start with the individual," City Manager William L. Bopf said.

Council approved the transfer of \$1,000 from the contingency fund to the police department salaries and wages account for additional man hours necessary to complete installation of the shooting range in police building.

Also approved was a city manager recommendation of increasing pay for a crossing guard at Junior High School from \$20 to \$40 weekly in view of difficulty and harassment experienced in that area. The school system pays half of the costs.

Juvenile Study Held...

"The Conference on Criminal Justice and Corrections Reform" was the topic of the branch meeting of the American Association of University Women last Thursday night in Durfee Hall.

Maria Mergentime, Chairman of the Michigan Juvenile Delinquency study, spoke about her own experiences in Detroit and also shared some of Dr. Karl Menninger's thoughts. Dr. Menninger, author of "The Crime of Punishment" is an outspoken critic of the present criminal justice system and was the keynote speaker of the conference which was sponsored jointly by the AAUW and the Northwestern University Evening Divisions.

Dr. Menninger said it is typical to take revenge of people who do wrong. They must be punished. So far we have gotten nowhere. Criminals have been put away and forgotten. In years past hospitals and mental institutions were in the same position. People went to the hospital to die. This is no longer true. It's time we do something for the criminal too. He stated we should look at a criminal as a person who has failed to integrate himself to our way of life.

Mrs. Mergentime feels the place to start reform is with the juvenile. Work should be done in the schools with the child who causes trouble as well as the Special Ed children. Some children need a differently structured program in the schools. As an example of success in this area she referred to the Pilot Program in Detroit where problem kids pick their own "free school" and do much better.

She said as things now stand when a kid is picked up for doing something wrong (which he may or may not have done) a long slow process begins. Just for starters he is held in detention up to two or three months waiting for his hearing. In that time he gets educated to crime. She said we should change our attitudes from feeling punishment must take place to "We do not want to punish but rather reform." If we legalize

capital punishment again we are going backwards. We also have to thin out non-crimes such as being truant, and running away from home for which kids can now be jailed. One possible way to do this is through Youth Assistance Services. It offers counseling and takes the place of the courts.

Mrs. William Hillegonds reported on two of the speakers at the conference. The first was Dean Robert McKay, Dean of the New York University Law School, and Chairman of the New York State Special Commission on Attica. He said he had acquired a sense of outrage at the way our criminal justice system works as a result of his participation in the Attica study. The protection of society depends on the correction of the criminal and yet 80 per cent of the crimes in our country are committed by repeaters. Our prisons for the most part degrade, and encourage vengeance and retribution.

Programs within institutions must offer healthy activity, books and education, relevant vocational training, and freedom of religious practice if they are to correct. Court procedures which often involve long delays, excessive bail, plea bargaining, and unequal sentencing must be improved. People are beginning to ask the right questions and non-institutional corrections programs such as Pre-Trial Intervention and Volunteers in Probation are beginning to spring up across the country.

The second speaker was Milton Rector, President of the National Council on Crime and Delinquency. He has worked in this field for 28 years. He stated that the public continues to believe the myth that institutions protect us in spite of the fact that experts agree that only 20-30 per cent of those now held in maximum security need this protection from themselves and society.

Of those now in maximum security, 70 per cent could respond favorably to community-based non-institutional corrective programs. Two-thirds of those involved in our criminal

justice system are now in the community on probation or parole. Only public involvement can bring needed changes and this is slowly beginning to happen across the country.

Mrs. Robert Linn reported on the speech by Dr. Norval Morris, Director of the Center for Studies of Criminal Justice, of the University of Chicago. In his speech he stated that there is growing agreement among professionals and experts in this field as to the direction we must go. Priorities for the criminal justice system must include equity and justice, exclusion of socio-medical problems from corrections, better training for police and other law-enforcement personnel, shifting away from large institutions toward community corrections which can take many forms: probation and parole, work-release programs, halfway houses and pre-trial intervention.

Most important of all, however, is public awareness and involvement. Once established, many of the suggested changes would be less costly. The most expensive method of correction is incarceration in an institution; expensive in money and in damage done to the offender. Remembering that 98 per cent of all prisoners will eventually be released from institutions, it is in everyone's interest that they be helped to become useful members of society rather than a greater threat to it.

Following a question-answer period, Don Meindersma of the Juvenile Court, who was present as a guest, was asked to share some of the things being done for juvenile offenders in Ottawa County. He said they stress early intervention and the use of volunteer probation officers. He also told about the group home in Grand Haven and the Shoplifting school which is used for shoplifters. He feels that the local situation is handled much better than big cities can handle their problems.
