# West Ottawa Names New Coordinator

Clifford Marcus Leaves  
Zeeland; Will Become  
Principal of New School

West Ottawa School Supt. Lloyd Van Raalte Wednesday announced that Clifford M. Marcus, Zeeland High school principal, has accepted a position the the West Ottawa staff.

Marcus, who was with Holland public schools from 1952 to 1958, will serve as equipment coordinator for the new West Ottawa High School which soon will be under construction and will work with the school staff in developing a high school curriculum.

which, it is hoped, will lead to early accreditation of the new high school by the North Central Association of Colleges and Universities.

After the new high school opens a year or two hence, Marcus will become high school principal. Meanwhile, Olin Walker will continue as principal so long as high school classes are housed in the Howard Ave. building.

He is expected to remain as principal of Beechwood School after it reverts back to elementary uses. Supt. Van Raalte said Walker had done excellent work in guiding the program for ninth and 10th grades the last two years. He currently is engaged in preparing for 11th graders in September.

Marcus, who has made his home in Holland for several years, is a graduate of Holland High School and Hope College. His first teaching position was as instructor and principal of the Christian School at Redlands, Calif. He taught at Spring Lake Junior High School and at Wyoming Park High School before returning to Holland in 1952.

At Holland high school he taught English and social problems and later became administrative assistant to the principal and served as coordinator of student teaching in the high school. He left the local school system in September, 1958, to become principal of Zeeland High School.

He is expected to begin his new duties around July 1.

Ground breaking for the new West Ottawa school is expected shortly after June 1.

# Crachy Faces New Charge

GRAND HAVEN (Special) — Elmer Joseph Crachy, 31, Chicago, who was found guilty of nighttime breaking and entering by a Circuit Court jury April 19, was faced with supplemental information Wednesday as drafted by Prosecutor James W. Bussard, charging him as a third offender which can bring a sentence of 15 to 20 years.

Crachy, who was to have appeared Wednesday for sentence in the April 19 trial, pleaded not guilty to the supplemental information and waived a jury trial which was set for May 16. Bond was set at \$15,000.

Previous felony convictions cited in supplemental information are a larceny of a motor vehicle Aug. 5, 1949, in Cook county in Illinois and a second degree burglary charge Sept. 30, 1947, at Crown Point, Ind.

Crachy was convicted in Ottawa Circuit Court last week of a nighttime breaking and entering involving a breakin May 7, 1959, at Plumb's super market on Beacon Blvd. in Grand Haven.

# Wetherbee, Hoppe Grad, Gets Position

Ron Wetherbee, assistant football coach at Coopersville High School for the past two years, has been named the head football coach at West Ottawa High School, the West Ottawa Board of Education announced Wednesday.

Wetherbee will be West Ottawa's first football coach and will begin his program next fall. Plans call for the Panthers to play a modified schedule next season and a full schedule the following year.

A former star football player at Zeeland High School and Hope College, Wetherbee joined the Coopersville staff upon his graduation from Hope in 1958.

The 23-year-old Wetherbee will teach social studies and English in addition to his coaching. He will also be assigned a spring sport, Supt. Lloyd Van Raalte said.

While at Coopersville, Wetherbee also coached varsity baseball and was junior high basketball coach and taught American and world history.

While at Hope, Wetherbee was a halfback and fullback and played four years of football for the Flying Dutchmen. In high school, Wetherbee played halfback and was named the most valuable player. He played three years of varsity football in high school.

He graduated from Zeeland High School in 1954 and was voted the most valuable baseball player. He played four seasons of varsity baseball. Wetherbee is also a fine softball player and participates each summer in the Holland and Zeeland leagues.

Wetherbee is a member of the Phi Alpha Theta National Honorary History fraternity at Hope. He is presently working on his M. A. at Western Michigan University.

The son of Mr. and Mrs. William Wetherbee of Zeeland, he is married to the former Dorothy Vereke of Zeeland. They have one daughter.

Wetherbee was selected for the West Ottawa post from a field of 22 candidates.

West Ottawa will begin play in the Grand Valley Conference in 1961. West Ottawa will have 11 grades next fall and the full 12 grades by 1961.

With the addition of the 11th grade next fall, West Ottawa will advance from Class C to Class B. Next semester the enrollment will be about 440. When the Panthers begin playing in the Grand Valley, they expect to have 650 students.

# Ronald Reagan Visits Holland

Screen Actor Ronald Reagan who also holds claims to being a top-notch businessman and TV star arrived in Holland shortly before 11 a.m. Wednesday and was greeted by local businessmen and civic leaders in Hotel Warm Friend. His visit to the city was sponsored by the local General Electric plant.

After meeting press and radio representatives, Reagan went to Civic Center to address some 300 local business and professional men associated with Holland service clubs. The gathering, usually held during Tulip Time, was arranged by the Inter-Club Council.

Speaking on "Business, Ballots and Bureaus," the Hollywood star delivered an address quite different from what might normally be expected from a screen representative.

It was a hard-hitting address on socialistic trends in national government and the strong need for tax reform in order to preserve the concept of American freedom.

Reagan (pronounced Ragan) said the government has so liberalized everything from veterans aid to farm aid as well as owning and operating thousands of businesses that compete with private enterprise that unless something is done to keep the government solvent and stabilize the currency, American freedom will not exist as it is known today.

He strongly urged economy in government, a cutback in bureaucracy and a down-to-earth view on spending. At no time did he mention General Electric but he sharply criticized TVA operations, the biggest producer of electricity in the free world, the biggest consumer of coal in the whole world, yet one in which rural electrification lags behind most of the rest of the country where this job is done by privately owned utilities.

He quoted Karl Marx who once said the way to impose statism on a people or socialism on a country was to tax the middle class out of existence. He also quoted Khrushchev as saying, "In 15 years there won't be a cold war. Your country is becoming so socialistic that in 15 years the causes for conflict between our two countries will have disappeared."

Reagan said some people feel a little inflation is necessary to the nation's expanding economy. "True, our inflation for the last few decades has been only a few percentage points a year, but it is accompanied by a system of progressive taxation based not on the value of the dollar but on the number of dollars earned. As we earn more dollars to compensate for its shriveling value, we find ourselves in ever-higher surtax brackets."

In urging national budget cuts Reagan told his audience not to be tempted into the trap which programs should be kept and which ones should be dropped. He urged consideration of a tax reform measure now before the House Ways and Means committee co-authored by Herlong, a Democrat, and Baker, a Republican. He urged writing Congressmen adding that 40,000 letters less than 100 for each Congressman are considered evidence of a trend in Washington.

# Board Okays New Salary Schedule

Schedule Provides  
\$400 Differential  
For M.A. Degrees

The Holland Board of Education at a special meeting Monday night adopted a salary schedule for teachers which remains at \$4,100 for beginners with an A.B. degree but provides \$400 differential for M.A. degrees.

The schedule will terminate on the 12th year at \$6,500 for A. B. degrees but will provide a 13-year step for M. A. degrees for a top of \$7,100. The new schedule was worked out by the teachers committee of the board and the salary and welfare committee of the Holland MEA district.

Teachers on the committee present were Robert Van Dyke, Eugene Prins, Jack Aussicker, Chairman Carl Selover and Ted Boeve, president of the MEA.

The salary schedule provides \$200 increments each year with \$300 increments after the third and seventh years. The schedule for teachers with M. A. degrees is \$400 more in each case. The current schedule for teachers with A. B. degrees started at \$4,100 and progressed in 13 steps to \$6,500. The differential for M. A. degrees was \$300.

It is estimated that the new schedule will cost an additional \$50,000 or slightly more in the 1960-61 school budget. Supt. Walter W. Scott said that current millage around 10 1/2 mills and the same amount of school aid should be sufficient to meet the budget without any special election for added millage.

Board members generally viewed the new schedule with added consideration for advanced training as a step toward accomplishing the long studied merit plan. Scott briefly reviewed teacher assessment, particularly the three-year probation period which is followed in the local school system.

The beginning salary remains at \$4,100, the same as last year. Scott said generally there are more teachers who want to teach in Holland than positions that are open except in certain specialized areas. "We feel we generally can attract the same quality of teachers as many systems which offer more," he said.

It was pointed out that the larger differential between A. B. and M. A. degrees is part of a trend encouraging more training for teachers.

The board also adopted a policy granting a day a year emergency leave for teachers to be deducted from regular sick leave.

The special meeting lasted exactly one hour. President Carl C. Andersen presided. The proposed schedule was presented by James Hallan of the teachers' committee. Board Members Wendell A. Miles and Harry Frisell were absent.

# Waives Extradition

GRAND HAVEN (Special) — Paul Henry Dunlap, 27, South Bend, Ind., waived extradition to Indiana before Judge Raymond L. Smith in Circuit Court Monday to face charges in Indiana on second degree burglary. He had been picked up April 14 by sheriff's officers in Grand Haven Township on charges of driving without a license and for having an unregistered revolver. Unable to pay fines of \$10 and \$25 plus costs, he was remanded to county jail.

# Mrs. George Kollen Dies in Ann Arbor

Mrs. George E. Kollen, who marked her 93rd birthday anniversary a week ago, died at 8:30 p.m. Wednesday in the home of her son and daughter-in-law, Prof. and Mrs. John L. Kollen, in Ann Arbor where she had made her home for the last eight years.

About 30 years ago she donated a plot of land to the city for park and playground purposes, known as Kollen Park on Lake Macatawa.

Mrs. Kollen, for many years a civic and religious leader in Holland, had served as member of the Holland Board of Education for 30 years, the last three as board president. She was a member of Hope Reformed Church since 1896, had served as Sunday School superintendent for 10 years and was a member of the Women's Board of Domestic Missions of the Reformed Church in America.

She was a former president of the Century Club and had served as president of the Woman's Literary Club for 12 years. She also had been a member of the Women's City Club of Grand Rapids, the Holland Garden Club, past president of the West Central District of the Michigan State Federation of Women's Clubs, as well as a member of Delta Kappa Gamma.

# Holland Couple Killed in Crash

ANDERSON, Ind. (Special) — A Holland couple was killed Thursday afternoon near Anderson, Ind. when their car was hit broadside by a semi-trailer loaded with bricks at the intersection of Ind. 32 and Ind. 13.

Police reported that Hilbrand Bourma Sr., 67, of 2395 Lakewood Blvd., Holland, died instantly and his wife, 64, died while being rushed to the hospital. The driver of the semi was uninjured.

The couple had been permanent residents of Holland for the past four years but had spent their summers in the area for 32 years. They were formerly of Oak Park, Ill. Bourma was a building contractor for 45 years and currently was in business with three of his sons in Berwyn and Forrest, Ill.

ZEELAND (Special) John G. Nykamp, 65, of Oakland (Holland route 3) died Wednesday at his home following a few days illness. He was a member of the Oakland Christian Reformed Church and was a farmer who had lived in the Oakland area all his life.

Surviving are the wife, Grace; a daughter, Mrs. Earl Brouwer of Zeeland; two grandchildren, Gary and John Brouwer; three brothers, William and Albert, both of Oakland, and Nick of Zeeland; two sisters-in-law, Mrs. Arthur Nykamp of Holland and Mrs. Henry Nykamp of Oakland.

# Select Local Man in Test

Alvin H. Dyk of 367 Wildwood Dr., Holland, has been selected by the Office of Civil Defense Mobilization in Battle Creek as one of four home owners in Michigan to have fallout shelters installed in their homes.

Work on the prototype shelter is expected to begin in about one month, subject to the approval of City Council. Ottawa County Civil Defense Director Hans Suzenaar made the announcement today at a meeting of Civil Defense and city officials at the County Civil Defense office in Holland.

The proposed shelter will be open for public inspection on specified days. The project is part of a national research program being carried on by OCDM. Cost of the shelter is about \$1,000, Suzenaar said.

The national program is intended to create public interest and stimulate private construction of fallout shelters by home owners throughout the country.

# Radar Warning Base Closed in Grand Haven

GRAND HAVEN (Special) — Monday closed a short chapter in local air events in Grand Haven with the closing of headquarters for the CR 21 of the 45th brigade radar detachment of the Fifth Army.

The 21 enlisted men are being reassigned to the Chicago-Gary defense area. First Sgt. Joseph Michael, a native of Grand Haven, will be staying until June to complete closing the detachment. He said the billet at 1023 Washington St. will be turned over to its owners, Mr. and Mrs. Percy Floto, Tuesday following an agreement to terminate a five-year lease May 12.

The detachment has been operating at the top of Water Tank hill overlooking the city, operating a missile warning base for two years. Cost of the Grand Haven installation was set at \$17,320.

The Army said, "Test results would indicate that air defense would be better served in greater operational efficiency by relocating the Grand Haven base."

# Maplewood Christian to Be Enlarged

Society Increases  
School Tuition Rates  
At Some Levels

Holland Christian School Society in a special meeting Monday night in the high school gymnasium approved a board proposal to erect an addition to Maplewood Christian grade school. The Maplewood school was opened in 1958.

Officially, the society authorized the board to obtain detailed plans and specifications for a six-room addition and to arrange for the erection without delay. Approximate costs of construction and furnishings will be \$90,000. Ben Altena, chairman of the planning committee, reported.

The new rooms would be used to house junior high school pupils, making the Maplewood school a kindergarten through eighth grade school. Altena said seventh and eighth grade pupils now housed at South Side school would be moved to the Maplewood area, relieving elementary housing at South Side. The Central Ave. and Fifteenth St. schools also operate a junior high program and will continue to do so, he said.

It was also pointed out that in the near future as the lower grade sections increase in number, it may be necessary to add extra rooms for seventh and eighth grade students to all other elementary schools making them all kindergarten through eighth grade schools.

The Dutch scored six runs in a big third inning in the first game which saw Norm Schut and Ron Vander Molen hit home runs. Sharky Vander Woude walked to lead off the third. ## Colorful Holland Landmark A Victim of Modern Times

An old Holland landmark is due to be torn down soon, a victim of change and modern times.

The Waukazoo Inn, long a favorite summer resort hotel for many people throughout the country, is scheduled to be razed. Workmen will begin tearing down the old hotel next week.

The hotel was built in 1906 by John C. (Judge) Everett who acquired 600 acres of land along the north shore of Lake Macatawa in 1903. It has remained in the Everett family until the present time, owned now by Walker Everett, of Waukazoo, Judge Everett's son, and two daughters, Mrs. Earl Lothrop of Greenwich, Conn., and Mrs. Roger Q. White, Lake Forest, Ill.

The inn was built facing Lake Macatawa since there were no roads leading to the lakefront at the time of its construction and all guests at the hotel arrived by boat.

When the hotel was still new, it was far ahead of most resort hotels of its time. In the gaslight days, the inn with its excellent facilities was considered an ultra-modern hotel.

In 1910 the inn was comparable to many of the more fashionable eastern resorts. Included on the hotel grounds were quarters for servants of the guests.

From 1910 to 1930, Waukazoo Inn was the center of entertainment in the Holland area, featuring dances, fashion shows and horse shows.

The late S. E. Paulus of Holland was manager of Waukazoo Inn for 38 years before his retirement in 1938. Mr. Everett said that the retirement of Paulus, forced by ill health, hurt the operation of the resort hotel.

But perhaps the greatest factor in the death of the popular old inn is the changing American way of life.

People used to come to Waukazoo Inn for long periods during the summer when the heat in large cities often became unbearable. Now air conditioning and electric fans have done away with the need for resort hotels.

Faster means of transportation make it possible for persons to spend a day or two on weekends at a resort and get back to their jobs, and people no longer need deluxe resort accommodations.

Everett's reasons for tearing down Waukazoo Inn were that "the changing pattern of American life has removed the necessity for summer hotels and they are no longer economically sound."

He said, "The shortness of the season for an unheated resort hotel and increasing taxes due to urban expansion of Holland and the surrounding area make a resort hotel unprofitable."

"A frame building nearly 60 years old comes to the end of its usefulness just as a person does," Everett said.

The land on Lake Macatawa's north side will remain in the Everett family. Some 15 cottages owned by the family will continue in operation under the management of Roger McLeod of Holland. Everett said that he will remain in the Holland area because he loves the city.

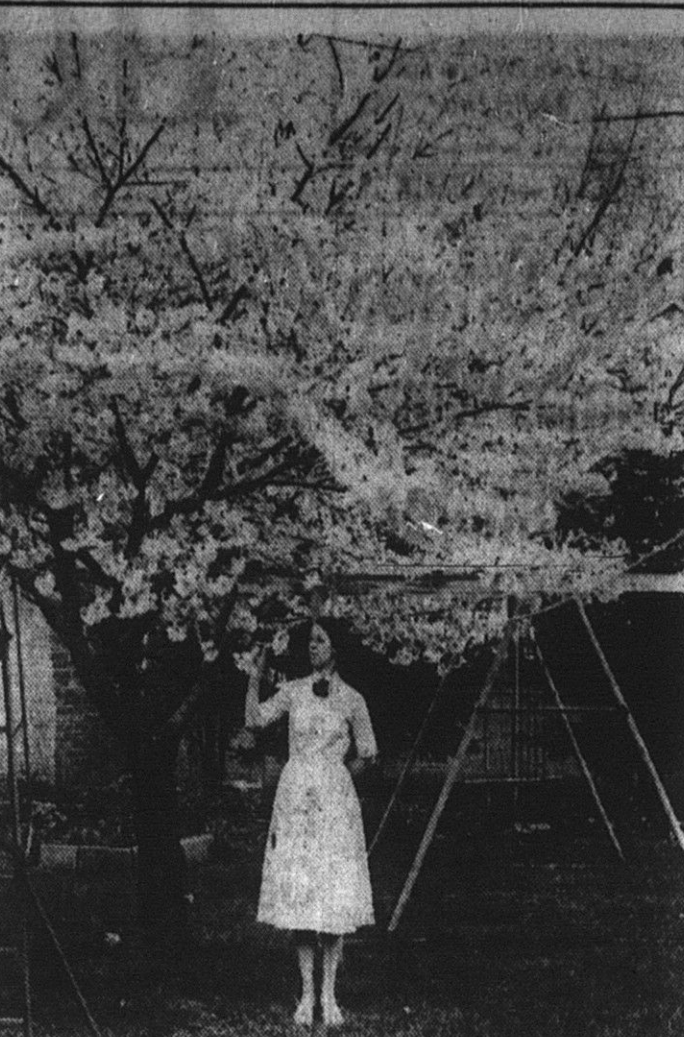

## Rep. Lohman Gives Report To Supervisors

ALLEGAN (Special) — Making his annual report to the Allegan county board of supervisors, State Representative Ben E. Lohman (R-Hamilton) charged Friday that "more money isn't always the answer to every state problem."

Lohman said there was an equally pressing need for "dedicated people in top state administrative jobs" and he disclosed that "many well-paid state employees are actually holding down a second, outside job."

The veteran Republican legislator, a member of the powerful House Ways and Means committee, felt that the "moonlighting" by state administrators indicated a lack of dedication on their part, rather than too low pay scales.

Lohman also reminded the Allegan supervisors that the legislature has control only over general fund expenditures, or about \$400-million of the state's total expenditures of \$1 1/2-billion. He expressed the belief that the special "earmarked" or restricted funds would be getting into deeper trouble this year, dipping into the general fund and bonding at an ever increasing rate.

He estimated that state agencies issuing bonds at the rate of from \$300 to \$400-million a year, "letting the next generation pay the shot seems to be the trend in Lansing, too," Lohman said.

He also expressed the belief that "Michigan is now moving faster toward socialism than most other states . . . We're approving legislation now that would never have been even considered in committee back when I first went to Lansing."

Lohman also questioned the wisdom of the "open end budget" that the legislature has been approving recently, in which expenditures are geared to income.

A large share of the state's fiscal problems can be traced to the fact that Michigan has the highest percentage of state-supported colleges and universities in the nation. More than 90 per cent of all college students in the state are enrolled in state-supported schools, he pointed out.

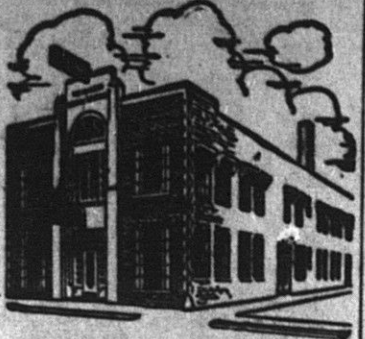

## POLITICS

The pot is boiling merrily every  
day and it will continue to boil.  
There are many stories appearing  
in print these days about politics  
and the many problems that  
confront our president every day.  
Recently there appeared in the  
New York Times Magazine a state-  
ment about presidential qualifica-  
tions. The senator Margaret Chase  
Smith of Maine is quoted as say-  
ing, "The greatest mistake that  
any president makes," she wrote,  
"is to be too cautious, and to shy  
away from decisions and actions  
for fear of making a mistake. We  
are living in times when the world  
is changing very rapidly, and  
when a president cannot take a  
"don't rock the boat attitude or  
operate on a "wait-and-see" policy.  
The intense competition that we  
are getting from Russia simply  
makes such a policy suicidal for  
our nation."

In the same magazine there  
were remarks by a leading intel-  
lectual of the Democratic party,  
Prof. Arthur Schlesinger, Jr., of  
Harvard University who thought  
that a president cannot fulfill his  
obligations "by waiting for things  
to be brought to his desk," and  
adds: "He must actively seek out  
private information to supplement  
and correct information fed him  
through official channels. The  
president who believes that the  
day's work begins when agreed-on  
staff recommendations arrive in  
his in-box, and ends when he has  
initiated them, could not have a  
more superficial view of his res-  
ponsibilities."

The words of both of these peo-  
ple both Republican and Demo-  
crat should give everyone some-  
thing to think about. We wonder  
just how these two people would  
handle the job if they found them-  
selves in the president's shoes in  
this year 1960. We have many  
problems and many of them are  
world problems. It is easy to sit  
on the sidelines and tell people what  
one thinks. It is not always so

## Lesson

Sunday, May 1  
The Pure in Heart  
Matthew 5:8; 5:27-27  
Luke 9:41-42

By C. P. Dame

The word "pure" is much used  
in advertising and in daily life.  
This fine word is used 28 times  
in the New Testament. In our  
world there is a great need for  
people with a pure heart.

1. Jesus calls the pure in heart  
blessed. Many today disagree with  
Jesus. In the Bible the word heart  
means the center of the personal-  
ity. The heart includes the mind  
and the will. The Bible tells us  
that the heart is the source of  
man's troubles. Jesus said, "Out  
of the heart proceed evil thoughts,  
murders, adulteries, fornications,  
thefts, false witness, blasphemies."  
The heart is pure when its  
desires and motives are right and  
true. The pure person is single-  
minded, his heart is not divided.  
The phrase "pure in heart" re-  
fers not only to clean thoughts  
regarding the sex life but it also  
implies that the person is wholly  
devoted to God and dedicated to  
the welfare of others.

The early Christians were known  
for chastity and charity. They  
were free from foulness and greed.  
It stands to reason that noble con-  
duct follows when the inner desires  
and purposes are good. In short  
to be pure in heart means to be  
like Jesus Christ. And that in-  
volves becoming a new person in  
Christ.

The pure will see God. Only a  
person with a cleansed heart will  
see God. An artist sees the beauty  
of a picture because he has the  
eye of an artist. Only the pure  
in heart see God in nature, in  
human life, in history. There is  
an affinity between the person  
whose heart is pure and a holy  
God for Scripture speaks of "holi-  
ness, without which no man shall  
see the Lord." To see God is a  
Christian's ultimate goal. Now we  
see dimly but in heaven, face to  
face.

II. Self-discipline is essential to  
great living. Adultery is strictly  
forbidden in the Bible. Jesus not  
only forbids the act of adultery  
but also the lustful look, which  
reveals the sinful heart. Experi-  
ence teaches that unchastity does  
not lead to happiness. The Lord  
tells tempted people to adopt drastic  
methods, saying that if the  
right eye gives offense to pluck it  
out and if the right hand of-  
fends cut it off. In figurative lan-  
guage Jesus summons people to  
give up anything that is as pre-  
cious as the right eye or right  
hand rather than to yield to sin.

Divorce was common in the days  
of Jesus. There were two schools  
of thought, one advocated law  
views, another said that divorce  
was only allowed in case of adul-  
tery. Moses taught that the man  
who divorced his wife had to give  
her a bill of divorce which was  
proof that she had not com-  
mitted any crime. Jesus taught  
that the marriage tie is indisol-  
uble. The words "saving for the  
cause of fornication" are found in  
Matthew but not in Mark and  
Luke and hence there is a differ-  
ence of opinion. Some churches  
permit the remarriage of the in-  
nocent party. The intention of mar-  
riage is that two people, a man  
and a woman, become one flesh  
for life. Those who marry should  
have this as their aim. A marriage  
which has but a meager chance  
to be successful should be avoided.  
Disciplined living is called for  
in happy homes.

The sins which trouble us today  
have a long history. Many today  
take solemn oaths and sacred  
promises lightly. The Jews in the  
days of Jesus resorted to various  
tricks in order to avoid keeping  
a promise. The Lord commands  
that we keep oaths and tell the  
truth in simple language. If this  
would be done life would be far  
less complex.

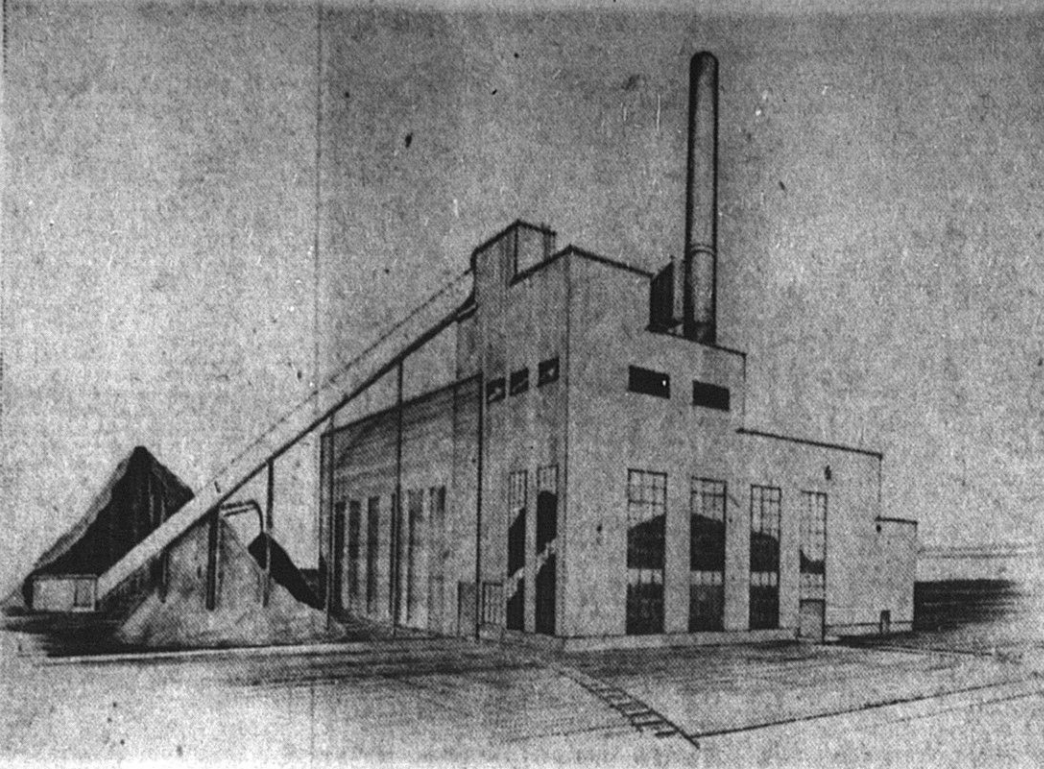

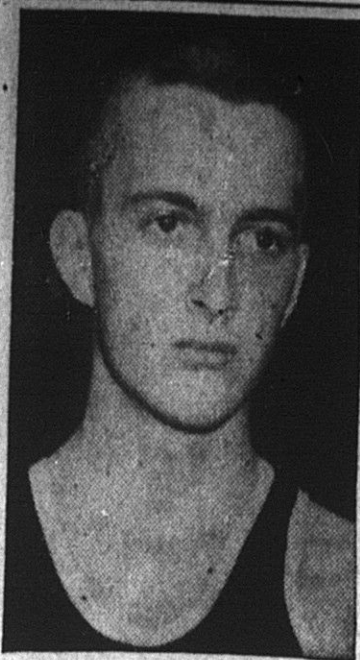

## Rozeboom Sets Mark; Hope Loses

Jim Rozeboom broke his own 880-yard record with a 2:01.3 performance against Grand Rapids Junior College Saturday at the 2nd St. track but Hope slipped in the final two events to lose the track opener, 72-59 to the Raiders.

Rozeboom, a Kalamazoo sophomore and co-captain, set the mark of 2:03 last season against Calvin. This record had broken a Hope mark which had stood for 23 years.

Hope was leading 59-56 with two events left in the dual meet. But the Raiders swept the two-mile and then won the mile relay to top the final 14 points.

The Raiders ran the relay in the fine time of 3:35.9 while Hope also turned in a fine time of 3:37. The Dutch relay team is composed of Jim Mohr, Jon Schoon, George Walters and Rozeboom.

Ray Ritsma turned in a fine performance with a 132'9" heave of the discus while Rolland Schut captured the pole vault as he soared 11'9" and John Kleinheksel won the broad jump with a leap of 20'7 3/4".

Don Gallo tossed the shot 42' 7 3/4" for first place while Bill Vander Bilt tied with two Raiders at 6' for the first place in the high jump. The field events were staged at Van Raalte Field.

Rich Bakker captured the high hurdles in 16 seconds and Jon Schoon won the 440-yard dash in 54 seconds for the other Hope firsts. Karl Elliott of GRJC won both dash events and Jim Bruce won the mile and two mile, while Mike Murray won the javelin and tied for first in the high jump to be the meet's double winners.

## Direct Relief Rolls Soar In Allegan

ALLEGAN (Special) — Allegan county will face increasingly serious problems unless members of the board of supervisors take a "more realistic attitude toward its budgets."

That's the warning given board members Friday afternoon by Allegan Supervisor James Farnsworth as he lined one wall of the supervisors' room with charts showing ever-increasing cost of direct relief and hospitalization for indigents.

But the main point of Farnsworth's argument was found in a table which showed that social welfare department expenditures have totaled \$373,696 more than the amount budgeted during the past six years.

During the same period, the county's general fund balance at the beginning of each year has dropped from \$226,402 in 1956 to \$19,555 as of Jan. 1, 1960.

In the last quarter of 1959, he pointed out, it was necessary to spend \$68,000 of 1960 tax receipts — so the county already is "in the hole" to that extent.

Farnsworth emphasized that he had no fault to find with administration of the social welfare department when he pointed out that direct relief, hospitalization and operation of the county infirmary and medical care facilities cost an amount equal to 46 per cent of all county expenditures in 1959. But he did urge the board to set up a budget for 1961 based on current welfare costs or face the prospect of an ever increasing deficit.

The board's finance committee is currently at work on a preliminary budget for next year. At present, the new budget shows total county appropriations of \$795,014 as compared to actual expenditures in 1959 of \$639,999.

Farnsworth estimated that a "realistic budget" would require an increase in the county tax rate or only about a quarter of a mill more than the 4.512 rate levied this year.

## Hope Nine Drops Two Games To Alma in First MIAA Tests

Hope College's baseball team dropped a doubleheader to Alma College Saturday, 13-7 and 7-2 in its opening MIAA games of the season in Riverview Park.

In the first game, 13 Alma hits and five Hope errors helped the Scots while in the nightcap a five-run Alma rally on three hits, three walks, and an error made the difference.

Alma jumped off to a 3-0 second inning lead in the first game and added another run in the third before Hope dented the plate. Tim Vander Mel doubled and scored on an error of John Vandenburg's drive to second base.

The Scots put home two more tallies in the fourth but Hope matched the total in the bottom of the frame. Pitcher Sharky Vander Woude walked and Gary Bylsma singled and both scored on Vander Mel's second double to make the score 6-4.

But the Scots added three more runs off Vander Woude in the fifth to take a 9-4 lead. Larry Dykstra replaced Vander Woude during the frame and retired the side.

Alma got one run in the sixth but Vander Mel gave Hope new life in the bottom of the sixth when he tagged a home run into the grandstand with Bylsma, who had singled, and Jim Van Dam, who had doubled, on base. This made the score 10-7 but the Scots scored three more runs in the top of the seventh.

Terry Ebricht started for Alma and was relieved by Dalton Contrell in the sixth. Hope made 10 hits off the two hurlers with Vander Mel and Bylsma getting three hits and Doug Japina, Ron Vander Molen, Dykstra and Van Dam one each.

In the second game, Hope pushed across a run in the second. Vander Mel was safe on an error. He was sacrificed by Vander Woude to second and took third on Jerry Nieuwsma's single. He scored on Bob Reid's single.

But Alma tied the score in the bottom of the second and scored another run to take the lead in the fifth, 2-1. Bylsma was safe on an error in the Hope sixth and scored on Nieuwsma's single.

Alma broke loose in the bottom of the sixth. A triple to Murray, double to Mulligan, single to Peters, three walks and an error produced the five runs.

Bruce Hoffman, Hope starter, was replaced during the inning by Pete Bylsma, who retired the side. Alma collected eight hits in the second contest while Hope had only four off Jacobson and his sixth inning replacement, Osborne. Nieuwsma got his second single in the sixth to account for the Hope hits.

## Plan Driver Training at Saugatuck

SAUGATUCK (Special) — Saugatuck Public Schools will offer driver training instruction to its students during the summer months beginning this June.

Present plans call for the classes to begin on Monday, June 6, at 9 a.m. The first week will consist of classroom instruction, and students will complete approximately 30 hours of classroom work prior to actual driving. Beginning on Monday, June 13, driving instruction periods for individual students will be scheduled, which should permit students to carry on with their normal summer-time activities. Donald Myers, local high school instructor, will be in charge of the summer program.

Classes will be open to resident high school students of the Saugatuck School District and to those tuition students from the Douglas and Harrington School Districts who attend or plan to attend Saugatuck High School. Preference will be given to present ninth-grade students.

If enrollments permit, present eighth grade students who are 15 or more years of age will be admitted to the classes. Students of the Saugatuck School District who attend parochial schools also are eligible to enroll in the course.

Superintendent of Schools Burton R. Aldrich states that the primary reasons for moving the driver instruction classes from the regular school year into the summer months are economy of operation of the program and elimination of high school class scheduling problems.

It is estimated conservatively by the Board of Education that a savings of \$700 can be effected by offering summer instruction. Most schools in the surrounding area are now operating courses in driver training during the summer months.
