2 HOLLAND MEN MISSING ON FLIGHT

Many Cases Processed In Court

Several persons appeared in Municipal Court on various charges the last several days.

Johnnie Baldwin, 27, Grand Rapids, who was found guilty of a charge of driving while under the influence of intoxicating liquor April 13, was put on probation for one year. He must pay \$50 fine within 60 days and pay \$5 a month supervision fees. He must refrain from drinking or frequenting places where sold for consumption on the premises. His operator's license has been forwarded to the Secretary of State.

Reed Allen Kuite, 22, of 99 East 31st St., was placed on a year's probation on a reckless driving charge dating back to April 7. He must pay \$100 fine, \$3.90 costs, \$5 a month supervision fee, must refrain from driving and leave his operator's license with the court until the probation officer is satisfied that his license may be returned to him.

Ruby Deckard, 19, Allegan, paid \$15.30 on a false pretenses charge involving the use of a fictitious name on a charge account. A 30-day jail sentence was suspended on condition there be no further violations. Restitution has been made.

Thirty representatives of 11 Catholic congregations in the area met Tuesday evening at St. Francis de Sales Church for an informative meeting concerning the 10th annual Diocesan Development Fund campaign to be conducted throughout the diocese of Grand Rapids on May 17. The drive will run for one week.

The Rev. Msgr. Julian A. Moleski, pastor of St. Francis and dean of the Holland deanery, was host at the gathering which featured a panel of four leaders of the campaign appointed by the Most Rev. Allen J. Babcock, bishop of Grand Rapids.

Panelists were the Rev. Msgr. Joseph C. Walen, Anthony Preston, Harold Gillisse and Thomas Glakely, all from Grand Rapids. Each speaker outlined specific phases of the appeal which last year netted \$690,000.

The revenues are used for the education of young men in the priesthood, Catholic charities, religious instruction of Catholic children attending public schools and services to migrant workers.

Msgr. Moleski reported that 200 solicitors composed of 25 teams will call on approximately 750 potential donors in St. Francis parish. Parish co-chairmen are Arthur Wich and Frank Conley. Richard Nourie is parish pledge card auditor.

Land, Air Search Is Launched

James J. Taylor, Andre Docos Missing When Plane Vanishes

A land and air search was launched today in Holland-Muskegon area for two 40-year-old Holland businessmen who vanished in a light plane while practicing instrument landings in Muskegon area.

Missing are James J. Taylor, 40, of 123 West 26th St., vice president of Taylor's of Holland (shoes and men's clothing), and Andre (Andy) Docos, 40, of 401 Fairhill Dr., manager-personnel accounting at the local General Electric plant.

Taylor and Docos took off from Park Township Airport north of Holland at 7:30 p.m. Wednesday in a Cessna 172 (Cessna Skyhawk) owned by the Holland Flying Club of which the two are members.

They headed for Muskegon airport to practice instrument landings. At 9:30 p.m. they had their last contact with the field and were told to switch their radio to another frequency as their signals were not being received adequately. When last heard from they were southwest of Muskegon.

Overcast skies hampered a search this morning. There were offers from several flyers to participate in a search. The Coast Guard conducted a search along the Lake Michigan shore with no results.

The local airport received many calls from residents in the vicinity of 160th Ave. and Greenly St. about four miles northwest of Holland that an aircraft was heard flying very low Wednesday night. Two private planes and a helicopter searched the scene this morning but were hampered by a 300-foot ceiling. The helicopter came from Greenville and is owned by Vernon Johnson. One private plane was piloted by Chris Smith and the other which belongs to Bay Haven Marina was piloted by Bruno Vejrosta (flying instructor at the local airport).

Area pilots and residents raised \$800 to finance the helicopter search at a cost of \$50 an hour. Accompanying Pilot Johnson was Glenn Timmer of the Ottawa Civil Defense office and Doug Elzinga.

Muskegon airport authorities reported that the Holland plane took off shortly after 9:30 p.m. without lights. This information was radioed but was not acknowledged.

Many offers from pilots have been received and plans calling for more thorough searches are scheduled as soon as the visibility improved.

The Ottawa County Sheriff's posse of 36 members gathered at the Coast Guard station shortly after noon today to begin a search of the dunes area north of Grand Haven.

Four carloads of General Electric employees reported at noon today to sheriff's headquarters to join in the search. All morning, state police, sheriff's officers and others had crisscrossed the entire area between Muskegon and Grand Haven with no results. Officers were concerned over the wooded Little Black Lake area on the Ottawa-Muskegon county line which is inaccessible because of marshes, trees, and undergrowth.

John Van Wieren, manager of the Park Township Airport, said he was not present when the pair left the airport but he had serviced the plane earlier in the day, filling both fuel tanks. He said the plane was in excellent condition and the gas supply would allow 4 1/2 hours of flying.

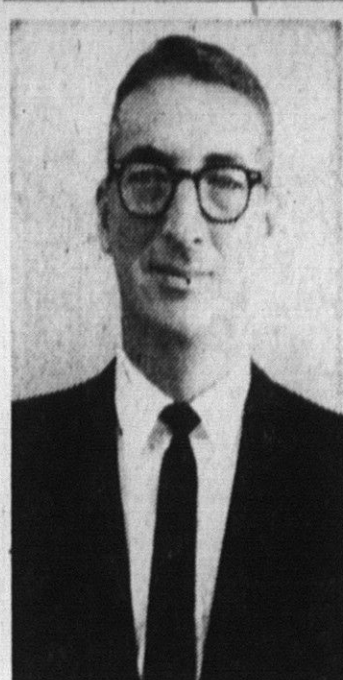
He described the single engine plane as a four-place plane, one well equipped for a small plane. It was purchased by the Holland Flying Club about two years ago. The club which has about 15 members, also owns a smaller plane, a Cessna 140, a two-place job. The missing plane cost about \$14,000 when new.

The club has been in existence five or six years. Docos currently is club treasurer.

Taylor is father of five children and Docos of two. Taylor's interest in flying resulted from five years with the Naval Air Force during World War II in which he spent four years overseas in the Pacific theatre, participating in most of the campaigns there.

Docos had no previous flying experience. He became interested in flying on his arrival in Holland in 1956. The two men were close friends.

Taylor, a native of Pennsylvania, is a graduate of Grove

City College in Pennsylvania and took graduate work in New York University, earning a master's degree in merchandising and retailing.

Docos became associated with General Electric shortly after his graduation from the University of New Hampshire in 1948. He is a former Jaycee and has been active in YMCA work.

Taylor and his family came to Holland in 1952 from Grand Rapids and became affiliated with his father, Percy, in Taylor's of Holland which occupies two stores on Eighth St. between Central and River Aves. The younger Taylor served as chairman for the Community Chest-Red Cross drive in 1955.

Park Permits Go On Sale Saturday

Beginning Saturday state park motor vehicle permits will be sold at the entrance to Holland State Park.

Price this year at Holland and also Grand Haven State Parks is \$2.15 for the annual permit or 60 cents for a daily permit. The annual sticker will admit the car and occupants to any state park in Michigan. Lou Haney is manager of the Holland State Park.

Fees previously were collected by state park personnel but this year will be collected by the park concessionaire. The increase in price (15 cents on annual permit and 10 cents on daily permit) will go to the concessionaire. This will relieve park personnel for other services to park visitors.

Permits at Warren Dunes Park at the Michigan-Indiana line and Sterling State Park at Monroe also will be in charge of concessionaires. Licenses will be available all season.

FBI Agent Bob Lalley Retiring

Robert L. Lalley today announced his retirement from the Federal Bureau of Investigation, effective May 29, and will become associated with the Trust department of Michigan National Bank in Grand Rapids, as head of business development and public relations.

Lalley was born in Lowell and received his early education in his home town and subsequently earned a B. S. degree from Central Michigan University at Mount Pleasant. New Rock Museum Added To Little Netherlands

A new feature at the Little Netherlands this year will be the Mineral Museum newly established in one of the buildings.

Mr. and Mrs. Sipp H. Houtman who operate the Little Netherlands exhibit for the Tulip Time committee have assembled over 1,000 rocks and fossils from all over the continent to make one of the finest such displays in this part of the county. They estimate that 25,000 miles of travel were needed to locate the collection.

Their latest trip was to the Glass Mountains of western Oklahoma where they spent a day with Fred Patterson, the champion live rattlesnake supplier of the area. Patterson took them up a mountain and at the top they found a great plateau of flat rock smooth enough for a tennis court.

With a pick axe, their guide cut out great pieces of white gypsum, the underside resembling intricate gardens and forests of pink coral. The trip down with the delicate cargo

was an adventure in itself.

In a gully in Tennessee, the Houtmans found rocks which a farmer had cleared from his pasture lot. Cracked open with a chisel and sledge, these rocks proved to be geodes filled with millions of quartz crystals gleaming like multicolored diamonds and almost as hard (much harder than steel).

Another time the Houtmans located a bed of limestone fossils said to be a hundred million years old but revealing perfect shapes of shell, horned coral and marine flora and fauna.

The Little Netherlands, located at the rear of the Netherlands Museum at 13th St. and Central Ave., will open May 9 and remain open through May 16, the last day of Tulip Time. It will reopen July 1 until Labor Day.

Hours during Tulip Time will be 9 a.m. to 9 p.m. The rest of the season, the exhibit is open from 9 a.m. to 5 p.m. It is not open on Sunday.

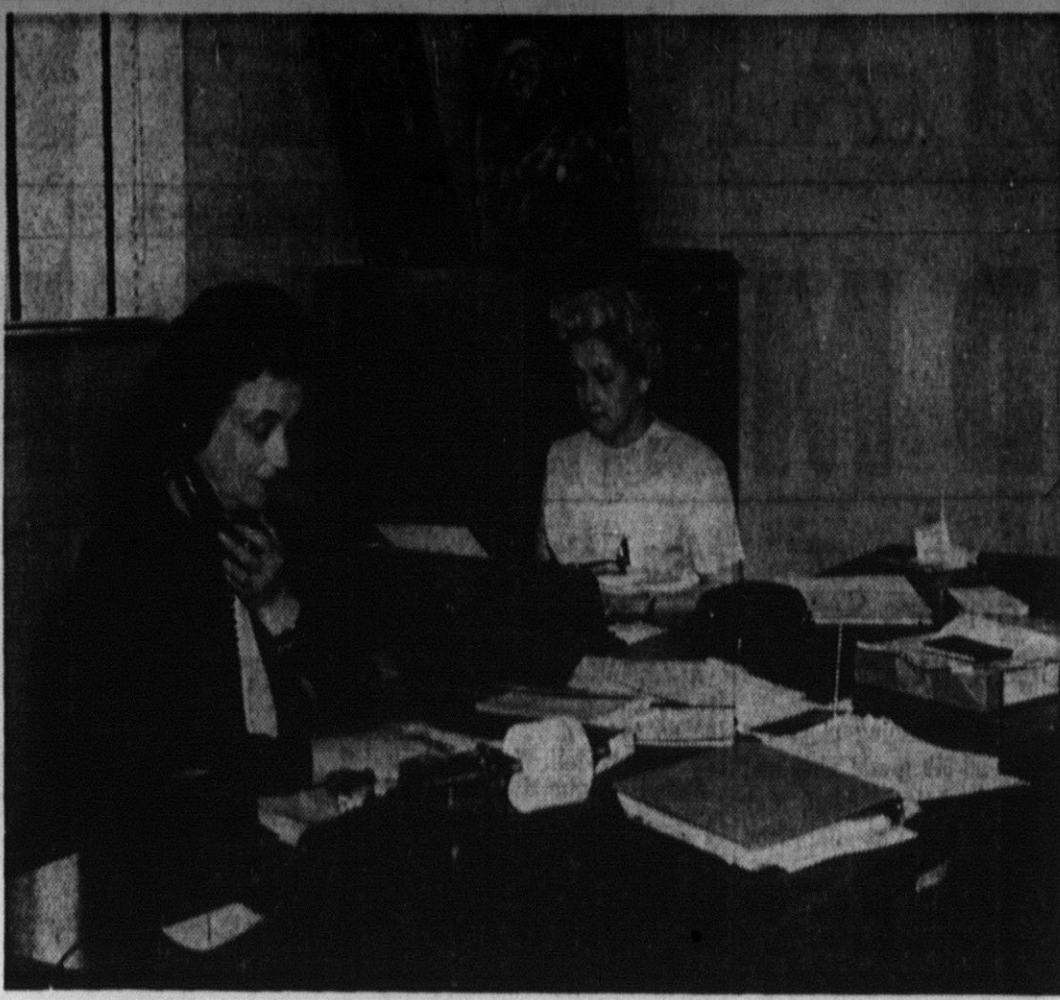

Requests for Tulip Time Housing Ahead of 1963

How does Holland care for so many visitors during Tulip Time?

This question has been asked ever since the first festival 35 years ago. And the answer is the Tulip Time Housing Bureau operated through the Tulip Time office in Civic Center.

Now in operation for over 25 years, this bureau each year lines up local homes willing to care for visitors, a good part of whom cannot be accommodated in hotels and motels, even though such accommodations are taxed to the full for miles around.

Mrs. Mattie Buursma, housing chairman, said the housing bureau is still in need of more homes for the 1964 festival May 13 through 16, and asks persons wishing to pen their homes to Tulip Time guests to call the housing office in Civic Center at 396-4191 or 396-7182.

Work of the housing bureau starts early in February when some 500 cards are sent to local residents who previously have entertained festival guests.

With the return of these cards, coding is done on large sheets and assignments made to persons requesting early reservations. The bureau also handles requests for hotels, motels, cabins and guest homes.

In the processing, each person desiring accommodations must send in a \$2.50 deposit of which \$2 is applied to the room rent and 50 cents as a service fee. For children under 15, only \$2 is required as deposit. These forms list such data as how many nights lodging is needed, dates for lodging, double or twin beds desired, and mode of travel (car, train or bus). The latter has considerable significance on whether the visitor must be housed within walking distance of downtown, or whether he has his own transportation.

Confirmation orders are made in four copies with the pink copy going to the customer, the blue copy to the renter, the white copy for working office files, and the yellow copy is filed alphabetically in case other records are mislaid.

Mrs. Buursma has canvassed all lodging places in Holland area extending to the resort section. Although rooms to be rented are inspected, Tulip Time does not assume any liability. If cancellations are made within 10 days of the festival, refunds are made.

Housing requests are 23 per cent ahead of registration at this time last year. Requests to place bus groups run high, many of them for four full days. Such groups often are placed in guests homes in the same general area.

Requests have come in from Canada, New York, Vermont, West Virginia, Arizona, Montana, Missouri and from all over the middle west.

The bureau also handles reservations for meals for large groups.

As for those people who come to Holland during the busy festival without reservations, the bureau also cares for them. "Nobody will have to sleep in his car," Mrs. Buursma says. "If we run out of rooms we make a public appeal and we always manage to find what we need."

Flag Poles Get Coat of Paint

Walter Calkins, 52, is a flag pole painter. He has been working his trade all over the country from Michigan to Texas and California for over 35 years.

Calkins and his partner, Carl Sperling, were in Holland Thursday and Friday, taking part in the annual pre-Tulip Time Spring cleanup.

After applying a fresh coat of silver paint to the two flag poles in front of City Hall, the two moved over to the relatively short 35-foot pole in Centennial Park.

While sitting on a "swing" held by ropes to the pole, Calkins said he has only fallen from a flag pole once. "It was about as high as this one," he said, "only a baby. It bent half way to the ground before it snapped."

The biggest pole he has painted was over 800 feet above the ground at its tip. His method is simple and fast, both very necessary, especially for the larger poles, when a change in the weather can halt work.

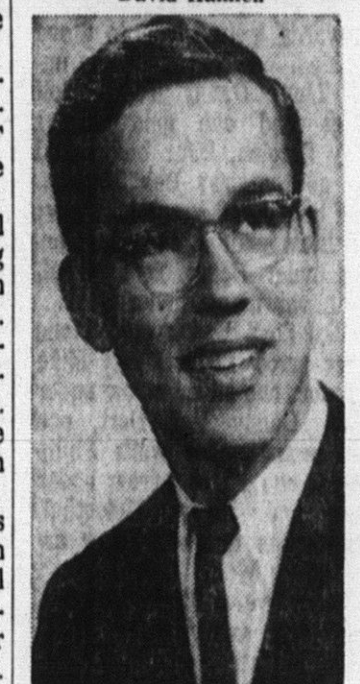
Calkins attaches his swing to the pole. The two ropes extend from each side of the "swing," around the pole a few times, then back to the "swing." With this apparatus, he can pull himself up, grasp the pole with his legs, then move the rope and seat higher, until he reaches the top.

When Calkins goes up, he attaches a rope to the top of the pole. The can of paint is tied to this rope, brought to the top, then lowered slowly as he moves down the pole, painting as he goes.

Sperling said they have nine poles to paint in the city, all in city parks, except for the two at City Hall. He said they also hope to paint the poles at city schools during July.

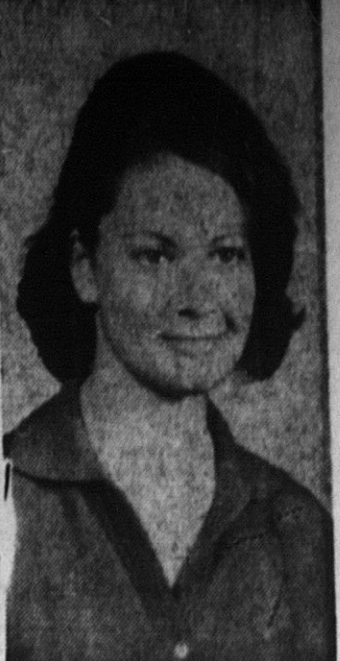

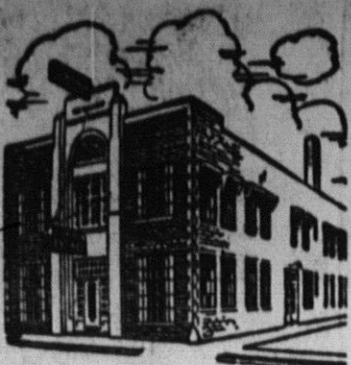

Americans love Shakespeare.
If there has ever been any doubt
about that, it is now being
destroyed. President Johnson
has perpetuated the Shakespeare
Anniversary Committee original-
ly appointed by President Ken-
nedy and now the Ford Founda-
tion has given the committee a
quarter of a million dollars to
celebrate the bard's 400th an-
niversary. In setting the com-
mittee to work, President John-
son had quite a bit to say:

"The 400th anniversary of the
birth of William Shakespeare is
calling forth special celebrations
and festivals all over the world.
Proper note of this occasion will
be taken throughout the year
1964 by our official United States
Anniversary Committee.

"This committee will direct
its efforts to reawaken interest
in the vitality and beauty of the
English language through the
works of William Shakespeare.
It will work closely with teach-
ers of the English Language,
teachers of speech and Shake-
spearean scholars throughout
the country.

"One of the committee tasks
will be to distribute information
in foreign countries of our many
American Shakespeare Festivals
which are taking place in the
anniversary year. This infor-
mation can be of assistance to
foreign tourists visiting our
country and will help our coun-
try and will help our govern-
ment in stimulating more visi-
tors to the United States.

"Through an understanding
and appreciation of Shake-
speare's plays each of us can
gain a better insight into many
of the personal and world prob-
lems which face us today."

Among the projects contem-
plated by the committee are the
printing and large scale distri-
bution of a brochure listing pro-
fessional performances of Shake-
speare throughout the United
States, encouraging library and
museum exhibitions, promotion
of regional conference, a nation-
al conference to be held at the
Folger Shakespeare Library,
and plans to encourage interest
in Shakespeare through a na-
tional essay contest with state
and national prizes.

Sunday School
Lesson

Sunday, May 3
Christian Principles
in Earning a Living
Luke 12:22-31;
I Thess. 4:10b-12
By C. P. Dame

It is one thing to be a Chris-
tian on Sundays in church and
it is a different matter to be a
Christian at work in a shop or
store or office, earning a living.
The world of our day needs
Christians who apply Christian
principles every day no matter
where they are or what they
do. The person who tries this
knows it is not easy.

I. Worrying is un-Christian.
The words, "Take no thought,"
are better translated, "do not
be anxious about what to eat
and what to wear. Today, in
our land, millions must choose
what to eat, wear, and buy—
and this worries some. Remem-
ber, Jesus never taught His dis-
ciples to live thoughtlessly and
make no provision for the fu-
ture. Too many people don't
care about the future. They
think the government should
take care of them. In some in-
stances the government has fos-
tered that attitude.

Jesus argues that since God
gave us life He will give us
provisions for its maintenance
and inasmuch as God gave us
bodies He will clothe them.
God who cares for birds and
the flowers of the field, will not
neglect His children. Keep in
mind that Jesus spoke these
words about worrying to His
disciples. He reminds His dis-
ciples that they have a heav-
enly Father. This we should re-
member daily.

The Lord says that Gentiles
who are only concerned about
food and clothing should not be
an example to believers. These
Gentiles have no faith. Instead
of worrying, Christians should
fix their minds upon building
the kingdom of God. When a
person becomes interested in
eternal things the paltry, pass-
ing things of life are side-
tracked. They who attend to
the things of God's kingdom
can safely trust God's readi-
ness to provide for their needs.

II. We are here to work.
Some people do not like to
work. Paul told his converts to
"study to be quiet, and to do
your own business"—mind their
own affairs and to work with
their own hands. We still have
meddlers in our society and
churches. In other lands and in
our own also, some people do
not like to get their hands dirty
in their work. For many people
an education seems to
mean a vacation for their
hands—they shun all manual
labor. They like to get money
in nice, clean hands.

Paul gives two reasons why
Christians should work. One is
that they may win the respect
of the outsiders by the work
they do and by the spirit in
which they do it. There are
certain kinds of work in which
the Christian should have no
part. The other reason is that
Christians may have what they
need. Christians should not be
chiselers, parasites, always
looking for a handout from the
government. Christianity makes
for self-reliance, a wholesome
pride and self-respect.

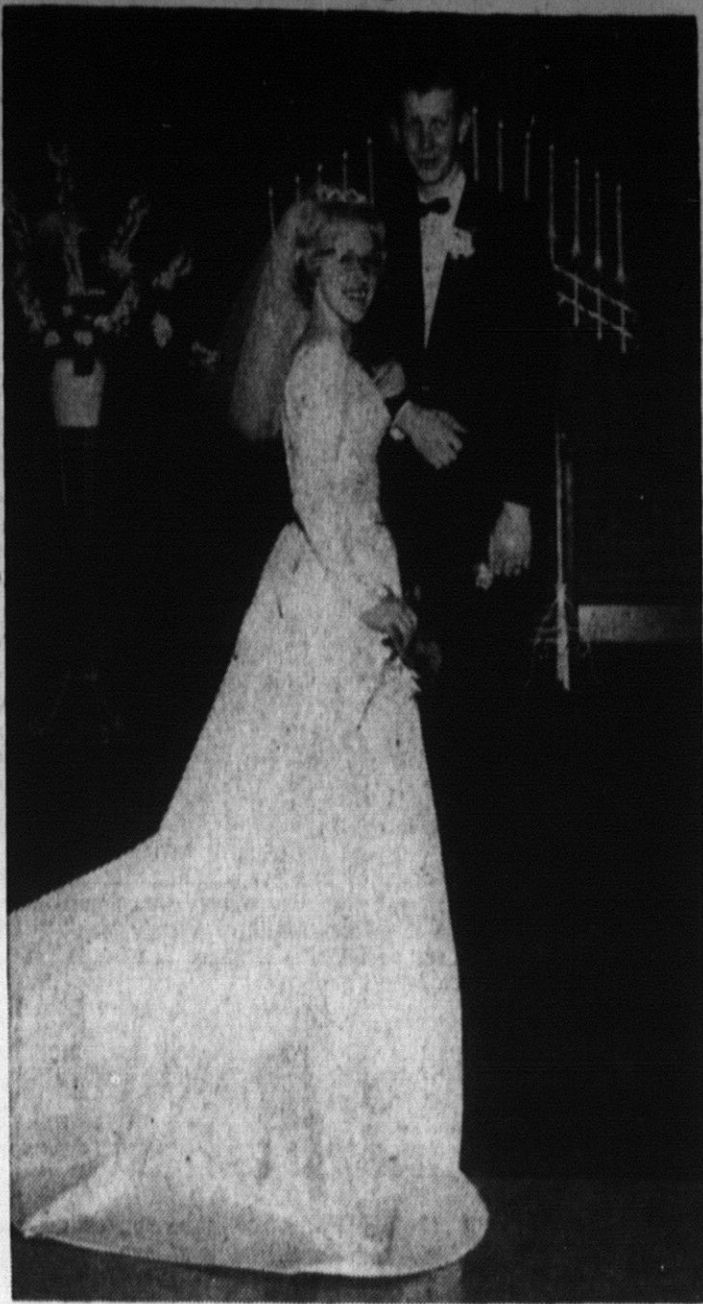

Color Harmonies Told At Arranging Workshop

At a workshop held on Thursday morning at the Woman's Literary Club, Mrs. Thaddeus Taft gave instruction and assistance in flower arranging to arrangers interested in participating in the Holland Garden Club's spring flower show, "Nature's Color-Drama," which is to be held in the club May 13 through 16.

Mrs. Taft reviewed the basic principles of arranging and distributed mimeographed copies of some of her research into color and color harmonies. She defined drama as "any series of events having dramatic interest or results," and added "that the successful arrangement shows a completion of these basic principles—scale, balance, harmony, rhythm and accent."

The instructor told the arrangers to combine the principles of design with the principles of color to achieve harmony, which is nothing but the pleasant grouping of color, form and line. An example of Mother Nature's color eye is the complimentary harmony of a tiny yellow petaled pansy with its deep violet center. In talking about the moods of color she mentioned reds and yellow for

gaiety and cool blues for quiet.

One color tip was that an overabundance of white flowers in a colored arrangement gives a separated look; another was that the warmest colors should be the focal point of an arrangement. Mrs. Taft listed color harmonies as monochromatic, complimentary, analogous, triadic, split-complimentary and double-complimentary.

After challenging her audience to use fresh and strong ideas she showed them samples of some pictures with many interpretations of various themes of the different seasons of the year. Flowers and greens were available and she supervised while the groups made arrangements "in their hands," an arranging method which makes it easy to make last minute changes before putting it in a vase.

The last flower arranging workshop will be on May 7 at the Woman's Literary Club at 9:30 a.m. Mrs. Taft will again be in charge and all those interested in exhibiting in the Flower Show are urged to attend and bring flowers, flowering branches, containers and all other necessary materials.

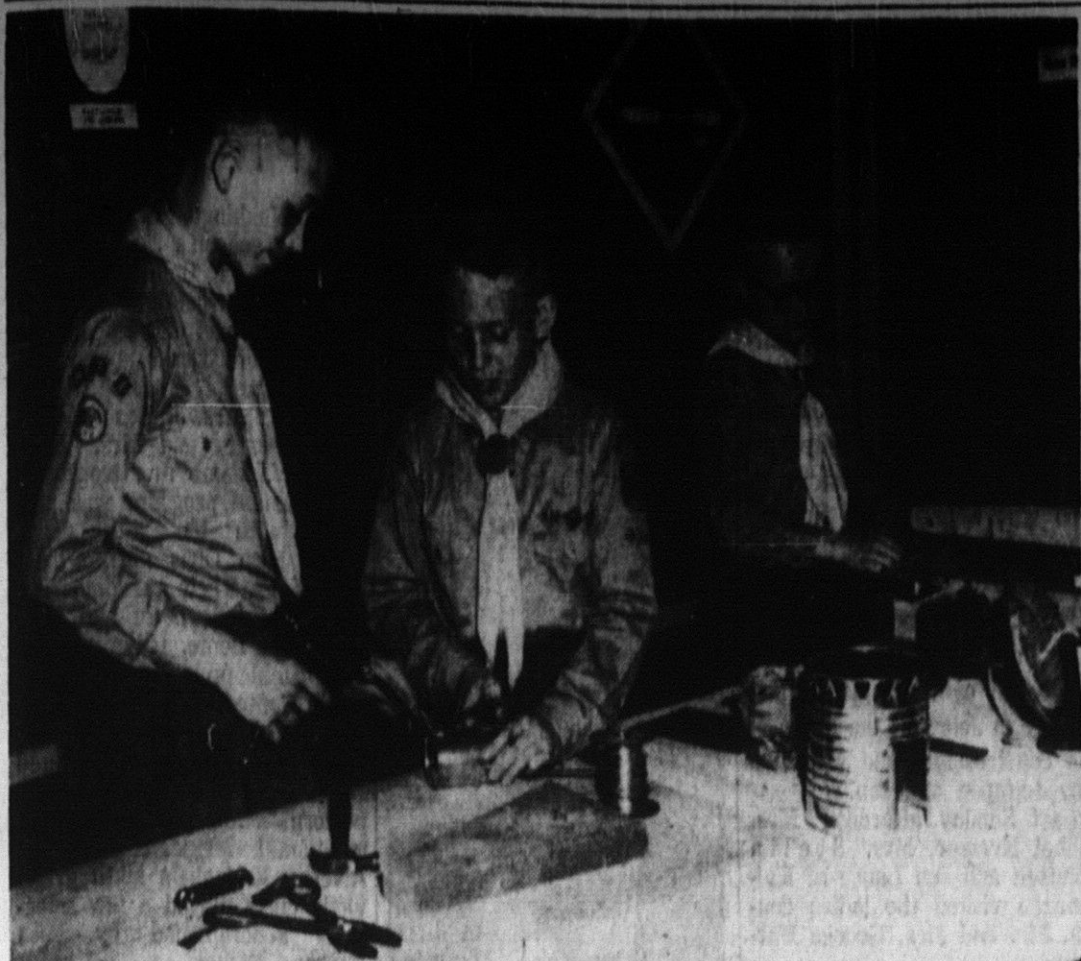

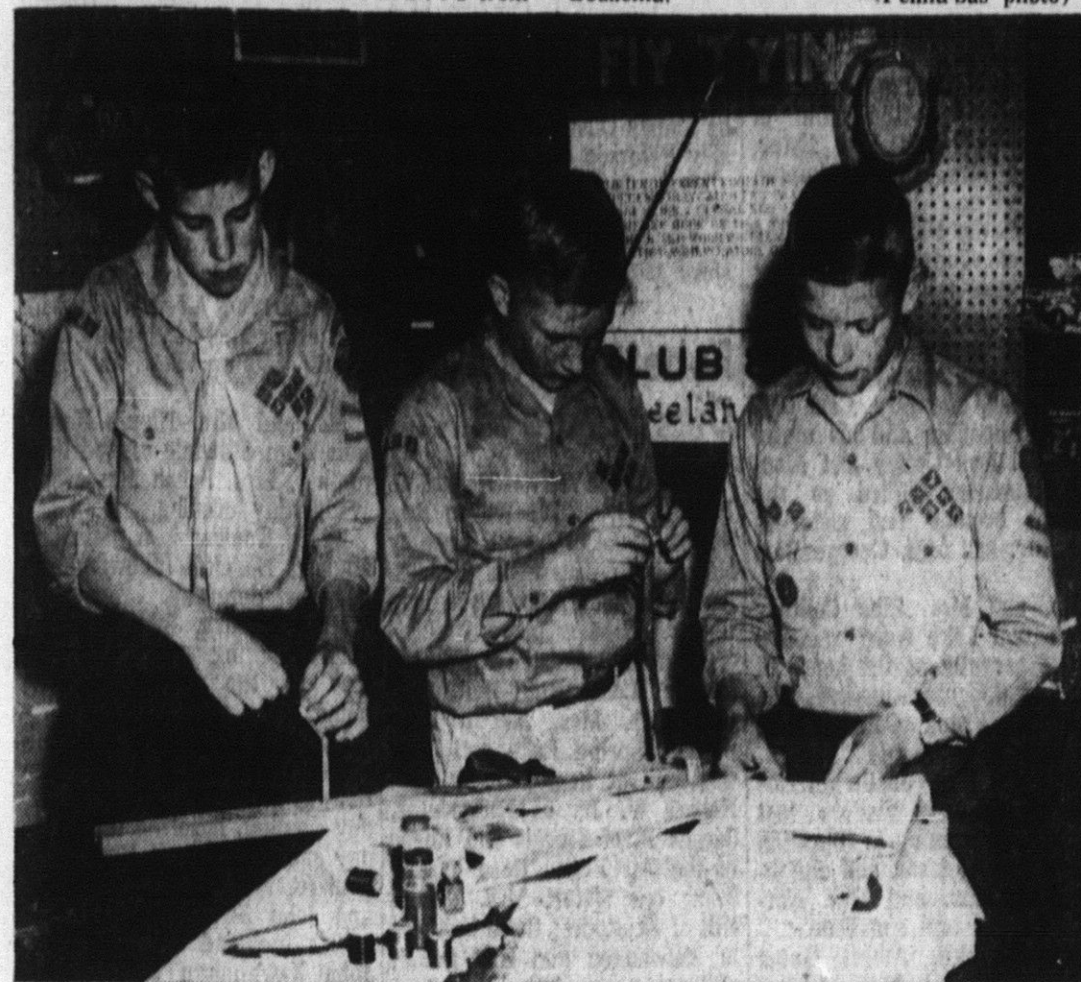

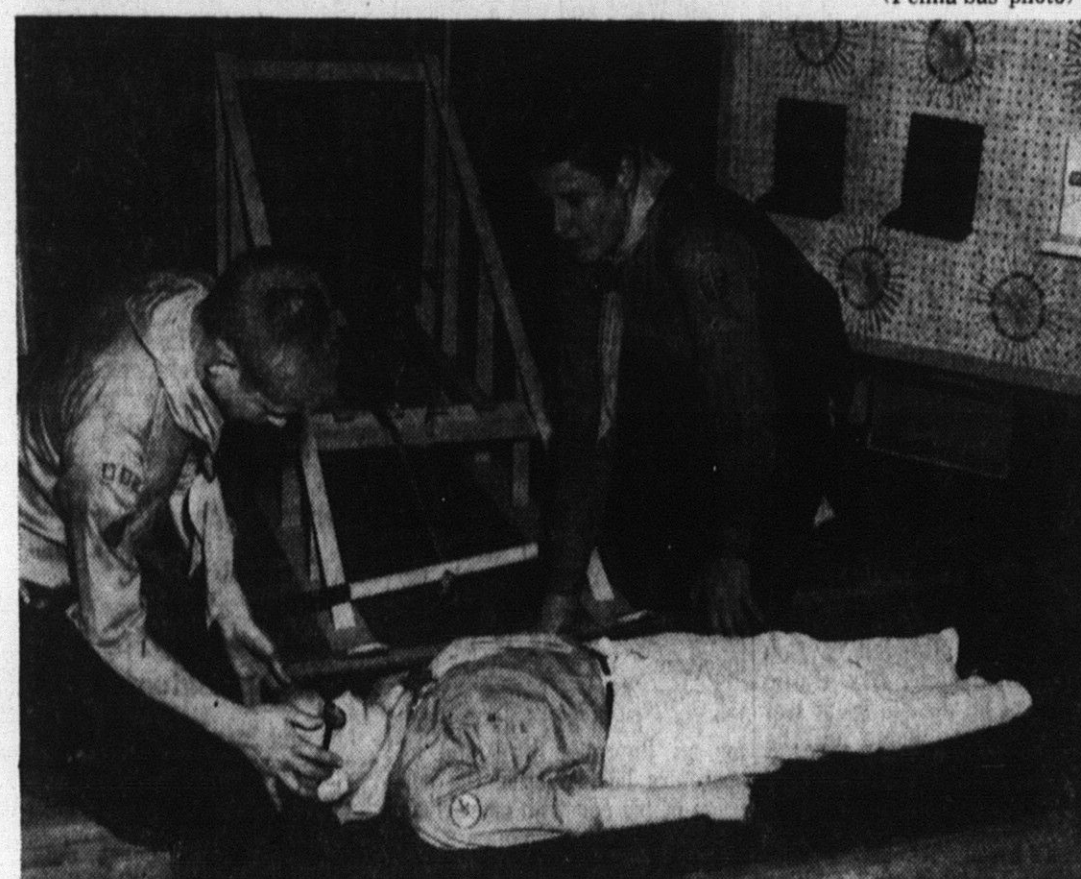

Say Mass of Thanksgiving In New Seminary Building

The Most Rev. Luciano Rubio, Prior General of the world-wide Augustinian Order, offered the Holy Sacrifice of the Mass in Thanksgiving Wednesday to celebrate the culmination of eight months of construction of Hickey Hall at the St. Augustine Seminary near Saugatuck.

Over 160 priests of the Augustinian Order took part in the High Mass which celebrated the opening of the \$1.5 million hall named in honor of the Very Rev. Joseph A. Hickey, the first American to be the world-wide Superior of the Augustinian Order.

The Preacher at the solemn blessing was the Very Rev. Francis Fenton, Prior of St. Clares Church, Chicago, whose sermon began with a quotation from the book of Isaiah and went on to include the religious vocation of the Priesthood, the Augustinian Order, and the love of God and fellow man.

Forty students of Tolentine Seminary College, Chicago, sang the ancient Gregorian chant and other polyphonic liturgical music at the High Mass which began at noon.

Among the dignitaries in attendance were His Excellency Bishop Canisius Van Lierde of the Augustinian Order, Papal Sacristan, who came from the Vatican City in Rome to officially preside at the Mass of Thanksgiving, and his special guest, the Most Rev. Allen J. Babcock, Bishop of the Diocese of Grand Rapids.

Also in attendance were the recently elevated Msgr. John Mc Nabb, Prelate Nullius of Chulucanas, Peru, and Father Francis Cavanaugh, Provincial of Midwestern Augustinians.

Work on Hickey Hall, a high school whose purpose is the education of future Augustinian priests, was begun in March of 1963 and was completed in October at a construction cost of \$1,200,000, with additional furnishings listed at \$300,000.

Completely enclosed within the single building are a temporary chapel, six classrooms and four additional laboratories. There are also eight dormitory wings, a dining area for 250 students and recreational facilities, including a gymnasium.

The hall, which is the focal point of the 670 acre Augustinian seminary, was designed by Stickle and Associates of Cleveland, Ohio, and features an ever-curving main corridor 540 feet in length, twice the size of a football field.

Total enrollment is currently 108, but a full enrollment of 250 students is expected when the building is officially dedicated on August 28, the feast day of St. Augustine.

Views From The Campus

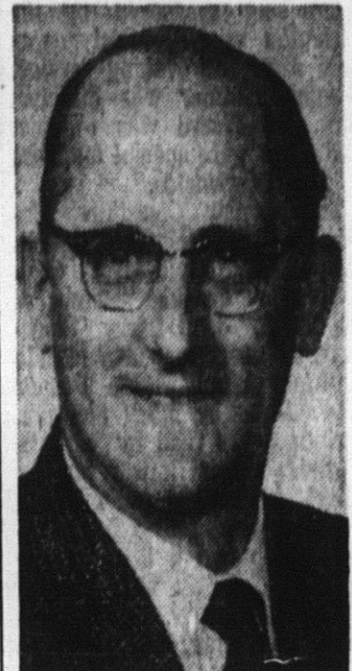

It is clear to most observers that the development of our gigantic defense effort has introduced serious distortions in our economy and in society in general. The following excerpts from my correspondence with Senator Hart examine some of the implications of this fact.

To the Honorable Senator Philip A. Hart:

I want to quote from the enclosed article: "A Strategy for



Dr. Gerhard Megow American Security" by professor Seymour Melman of Columbia University.

1. More crucial is the use of three-quarters of the engineering and scientific talent of the country for these purposes (defense); these men are attracted by the high salaries of military industry. This pressure is undermining our civilian industrial economy.

2. We have developed a new condition in American life, a bureaucracy that rules a military industrial complex in the United States. Highly concentrated in particular states and regions (25 per cent of the industrial work in California, but 2 per cent in Detroit).

This latter statement in parentheses also illustrates the dangerously lop-sided distribution of our nation's productive wealth, about which our government representatives should do some very serious thinking.

To mention just one point from my aspect as a teacher in a private religiously oriented small liberal arts college that in its history of one hundred years has given this country many fine leaders in all walks of life, the lop-sided influx of tremendous financial resources in California, for example, does not only attract physicists, other scientists, and engineers to the military industries there. The tremendous tax base of that state also provides its schools with undreamed of monetary resources with which the top teaching talent in all fields of instruction, not only in the sciences, is siphoned from the rest of the country.

The large research-contract supported public universities are to some extent able to hold on to their top teaching talent by offering them equally attractive incomes from their government contracts. But what about the small independent colleges? How can they possibly survive in such a vicious, shortsighted, and unjust process? Not only are they left behind in the competitive race for good teaching talent, there is also insult and irony added to injury because the loyal constituents of these small independent colleges, who already must pay higher tuitions to order to send their children to these schools of their choice, have to pay the very taxes to the government with which this government established the state schools so lucratively that the private small colleges are choked to death.

I think it would be an action worthy of any legislator to introduce at least a bill which grants parents who send their children to private small liberal arts colleges full tax exemption for the educational costs which they have to defray.

I read that there is a bill (before congress) to grant exemption for all educational costs of all schools, but that the government is reluctant to face such a huge tax loss. Why not then at least do something for the independent small colleges with limited resources up to a certain maximum limit of endowment and wealth? I could not think of any fairer law being passed under the present situation on the national educational scene.

Court Sends Four Men To Prison

GRAND HAVEN — Four persons were given prison terms in Ottawa Circuit Court Friday.

James Allen Hardy, 19, of 3538 Lake Shore Dr., Holland, charged with larceny from a gas station, was sentenced to 18 months to four years at Southern Michigan prison. The court recommended he be sent to Cassidy Lake School for Boys to continue his education.

William Palmer, 33, Muskegon, and Arthur Puls, 35, Muskegon, charged with passing bad checks, were both sentenced to prison terms at Southern Michigan prison. Palmer, charged with forgery and uttering and publishing, was sentenced to 5 to 14 years with no recommendation, and Puls, charged with uttering and publishing, was sentenced to 15 months to 14 years with minimum recommendation.

Dale Konwinski, 23, Grand Rapids, charged with breaking into a drug store at Allendale April 5, was sentenced to serve 18 months to 15 years with minimum recommendation.

Donald Fritz, 22, Conklin, charged with negligent homicide with a firearm in connection with the New Year's eve death of Dale Hein, 28, Conklin, was sentenced to serve 90 days in the county jail. Judge Raymond L. Smith lectured Fritz on the use of intoxicants, and said the fatality would not have occurred if Fritz had not been drinking.

Billie Rae Lawson, 22, formerly of Holland, who pleaded guilty April 7 to removing mortgaged goods from Holland, was placed on probation for two years. He must pay \$100 costs and make restitution.

Some other respondents were arraigned.

Herman Hammond, 20, Grand Rapids, charged with felonious driving, requested the court to appoint an attorney for him.

John L. Meadows, 25, Muskegon, charged with driving on a revoked license, pleaded guilty.

Robert Weesaw, 21, Waterliet, charged with nighttime breaking and entering, pleaded guilty. Weesaw was arrested in Berrien county Saturday and brought here Monday. He was charged in connection with a break in at Jenison Christian Junior High School March 28.

United Fund Meeting Set

Mrs. Joseph W. Lang and David C. Hanson of Holland will represent the Greater Holland United Fund at the annual budget conference of the Michigan United Fund May 5 and 6 in Kellogg Center in East Lansing.

They will be among more than 250 volunteers throughout Michigan who will hear budget requests outlining the programs and financial needs of the 36 state and national health and welfare agencies included in the Michigan United Fund.

In 1963 the combined requests of the 36 agencies was \$4,321,962, but was reduced by the budget committee to \$3,639,182. After these needs are determined, each community in Michigan is asked to accept its fair share of these needs and include the amount in their united fund campaign in the fall.

National agencies included in the Michigan United Fund were reviewed at the national budget conference in New York City in March, and 11 Michigan members of the national budget committee will report on the results of the New York meeting.

'No Cause' Is Ruled In Jury Civil Case

GRAND HAVEN — The first jury case of the April term of Ottawa Circuit Court was heard Thursday. A jury deliberated an hour late Thursday afternoon and rendered a verdict of no cause for action in a civil suit brought by the Wayland Livestock Auction against Walter Schaefer of Georgetown township.

Plaintiff claimed that Schaefer purchased livestock on April 24, 1962, for \$1,435.11. Schaefer served as an agent for the Lowenstein Packing Co. of Detroit which has since entered into bankruptcy.

Plaintiff claimed that Schaefer was responsible for the debt.

Predict Success For Windmill

A promising future for Holland's Windmill Island Recreation Program was forecast at an information meeting of the advisory committee and City Council Monday night in the auditorium of Herick Public Library.

Dr. Eugene T. Petersen, director of historical projects for the Mackinac State Park commission, and Richard Frank, architect for the restoration of Fort Mackinac and Fort Michilimackinac, explained the Mackinac projects and on the basis of interest there felt that there was no question that a restored imported windmill of the type Holland plans to erect here could attract visitors in large numbers.

Dr. Petersen said Project Windmill would have its own variations, but many aspects would resemble the restoration programs on Mackinac Island and Mackinaw City. Both restored forts involved considerable archeological effort and historical research which is different from the local case, and he urged Holland to gear its project to a certain period (perhaps 100 years ago) and develop its program, costumes, etc. to that period.

He pointed out that certain provisions must be made in a program which will attract many, many visitors, such as sacrificing certain points of authenticity in the interest of crowd control, fire hydrants, safety, etc.

As for finance, he said the historical commission started its Fort Michilimackinac restoration in a modest way with the sale of \$125,000 in revenue bonds, slated to run 15 years. These bonds were paid off in three years and encouraged the commission to launch a \$500,000 bond issue which was sold at a much lower rate of interest to run for 20 years. He said that operating the fort only in the summer had yielded enough return in three or four years so that the payment program currently is eight years ahead of schedule.

On Mackinac Island, the peak day for visitors at Fort Mackinac is Tuesday, with Wednesday running second. At Fort Michilimackinac, Sunday is a good day, but not the peak day, Petersen said.

Dr. Petersen showed color slides on restoration and construction on both forts.

He added the admission fee should not be under \$1. Admission to Fort Michilimackinac first was 50 cents, but later raised to \$1 with children under 12 free. The increase did not affect attendance, he said.

Richard Frank, architect for the restoration projects, spoke on the "business end" of taking what archeologists and historians find and putting them into blueprints that can be understood by a modern day contractor. He spoke of many miles of travel involved in painstaking research to have the restoration as authentic as possible. He added that visitors soon can tell "solid" research from the lesser developments.

Henry S. Maetz presided at the meeting which was attended by about 50 persons. Willard C. Wichers introduced the speakers.
