## West Shore Gets Paving Contracts

Tremendous Amount  
Of Business Occupies  
Local Councilmen

City Council processed a tremendous amount of business at its regular session Wednesday night, the first meeting held since April 16.

The West Shore Construction Co. of Zeeland was awarded paving contracts for the 1959 paving program as well as paving a new parking lot on Seventh St. between Central and College Aves.

Contracts were awarded on the basis of unit price bids. In the case of the summer paving program, the total contract price is \$46,720.15 and for the parking lot \$9,927.50.

Council approved leases for developing the parking project which involves Lessors Hertel, Nies, Kobes of Lokker-Rutgers, DuMez and Brooks. The Brooks lease is in the process of being signed. Revised estimate of cost of development is the paving bid price of \$9,927.50 plus \$1,236.37 for the Hertel property which joined the project after bids were advertised. The project provides for 104 parking spaces. Estimated cost of parking meters at \$50 each amounts to \$5,200 or a total cost of \$16,363.77 which will be paid from the parking meter fund.

The leases are much like those signed for the parking development on Ninth St. between Central and College Aves., although the parking area is 107 feet deep instead of 132 feet.

City Manager Herb Holt reported on an option for the city for the purchase of the so-called Mercury garage property. The option will be in effect until Aug. 1 and the city is granted the privilege of purchase on or before that date for \$57,000, subject to a leasehold interest in Maycroft and MacEachron, Inc. Council approved the report.

Council approved a city manager's recommendation to eliminate parking on the south side of 24th St. from Harrison Ave. west to Dunn's east drive. This was done on request of residents in abutting homes and on request of the postmaster. It had the approval of the chief of police.

Council accepted for first reading an ordinance affecting speed and whistle signals of trains traveling within the city. The amended ordinance provides that no train or cars may obstruct any street or sidewalk for more than five minutes at any time or fail, after having obstructed any crossing to clear such crossing for a sufficient time to permit all waiting vehicular traffic to clear the crossing before the crossing is again obstructed. It also provides that no train may travel at a speed greater than 25 miles per hour unless a different speed limit is fixed by resolution of Council. Signaling will be limited to two short whistle blasts at open crossing and none at crossings protected by official signal lighting devices.

The ordinance was tabled until the May 20 meeting.

Mayor Robert Visscher announced the appointment of James E. Townsend as city attorney and Gordon Cunningham as assistant city attorney. The mayor also appointed Councilman-at-large William De Haan to the special charter committee to succeed Raymond Holwerda. John Beltman was named as chairman of the special committee.

Mayor Visscher also announced appointment of the following personnel to serve on a building code advisory committee to work with the building inspector: Donald Strabbing, Edward J. Holkeboer, Jack Leenhouts, Martin Van Hekken, James H. Klomparsen and William J. De Haan as council representative.

## Council Turns Down Lights

Purchase of a \$132 lime marker and two backstops for Maplewood play areas at a cost of \$2,000 were approved by City Council Wednesday night.

A third matter of \$2,500 for metered lights on city tennis courts was tabled, pending further information on neighborhood reaction to such a service.

The three items were introduced by Councilman John Van Eerden of the joint city and school recreational advisory committee. Funds are available in recreational funds in the budget.

Van Eerden explained that coin meters for night tennis playing are more of a control than a revenue item, but Mayor Robert Visscher recalled considerable neighborhood opposition to a lighted softball field some years ago in the 21st St. recreational area.

Later in the evening, Recreational Director Joe Moran gave further information on coin-operated meters. He felt there would be a minimum of opposition to night tennis playing in view of master switches which would preclude playing at a late hour.

Moran said he would be willing to poll the neighborhood and suggested Council pass the measure subject to the neighborhood poll.

But Council was weary. The meeting in which budgets, subdivision ordinances, sewerage matters, safety measures and a host of other items were processed had already taken close to 3 1/2 hours. The lighted tennis court matter will have to be introduced again if the recreational committee wants action.

## Council Studying Request For Sewer Service Charge

A report from the Board of Public Works on proposed sewerage improvements for Holland which recommended that a system of service charges be put into effect as soon as possible was presented to City Council Wednesday night.

After considerable discussion on rates, Council tabled the subject on motion of John Van Eerden until a time when all Councilmen could be present at an adjourned meeting. But when possible meeting dates were discussed, it appeared no convenient date could be set before the next council meeting May 20, so it was decided to table the matter for two weeks.

The BPW report recommended the plan C formula for service charges outlined in the Black and Veatch report for Holland sewerage improvements which would involve a first stage development of \$2,800,000. This figure, which probably would involve general obligation bonds, would provide a new treatment plant and extensions into populated sections of newly annexed areas.

Plan C, which involves a \$24 annual fee for most residential users, would support the maintenance and operation of the system plus a payment of 38 per cent of bonded debt service.

It appeared that Council would be more willing to follow plan B which would involve an annual fee of \$18 for most residential users. Council agreed generally on the necessity of a service charge which would place the cost of sewerage services partially on the user where it rightfully belongs. There were several tie votes, leading to the adjourned meeting idea.

Holland's sewerage system has been under study for several years by the Board of Public Works. The present system is outmoded and overtaxed, and some of the main lines, particularly on Central Ave., have been overtaxed for several years. The Board has said it would cost \$300,000 to lay a new line on Pine Ave. to relieve the Central Ave. line.

The report covering 42 pages as compiled by Black and Veatch, consulting engineers of Kansas City, Mo., was submitted to Council at a joint meeting with the BPW April 17.

In other business, Mayor Robert Visscher announced the appointment of T. Fred Coleman and William Oonk as area representatives of the Lakeview and Van Raalte areas, respectively.

A letter from W. J. Stronks suggesting that the city take immediate steps to acquire title to a playground at Central Park and include it in its park system was referred to the city manager for study and report.

Council granted permission to Roger MacLeod, manager of the Warm Friend Tavern, to close off Central Ave. between Sixth and Seventh Sts. on the evening of July 24 and early morning of

July 25 for displaying 50 to 75 renovated model T cars by the Model T Club of Chicago.

A petition requesting vacation of an alley lying between 20th and 21st Sts. running from Central to College Ave., was referred to the planning commission for recommendation.

A letter was read from the American Legion expressing pleasure in having Legion Memorial Park within the geographical limits of the city. The letter also expressed appreciation for the fine cooperation of the city in making the junior baseball program one of the finest in the state.

A communication from the Holland Lions Club offering to donate sports equipment used in the recent sports show at Civic Center to the city was referred to the city manager for study and report.

Council considered several applications for various licenses, some for rubbish collections, others for bus lines, bowling lanes and permission to stage various Tulip Time events. City officials also were asked to participate in the Thursday and Saturday parades, appearing in formal dress as in past years. Letters also were read from state representatives acknowledging council action on legislative bills.

Several claims on property damage were referred to the city manager and insurance companies.

Requests from Assien Uiterwyk and Gra-Bell Truck Lines to change proposed curb cuts on their properties on Lincoln Ave. were denied, but one from Breuker and Den Bleijer was granted.

## Budget and Subdivision Act Passed

3 1/2-Hour Session of  
City Council Longest  
In Several Years

In one of the longest meetings in several years, City Council Wednesday night passed two important pieces of business — the city budget for the forthcoming year and a subdivision ordinance. The budget had been under intensive study for several weeks and the subdivision ordinance covered several months, particularly by the planning commission.

The budget, calling for a record tax levy of \$810,982.85 was passed as a routine measure. There was no public comment when the public hearing was called, and Council unanimously passed the resolution.

But the subdivision ordinance, which had been tabled previously several times, involved a full hour's discussion in a committee-of-the-whole session. This ordinance was the last item on a particularly long agenda (three weeks since the last meeting) and discussion started at 9:40 p.m. and continued until 10:40 p.m. With routine measures to conclude the meeting, Council adjourned at 10:53 p.m., almost 3 1/2 hours after Council was called to order at 7:30 p.m.

It was the longest meeting in the four years that Mayor Robert Visscher has held office.

The long discussion was set off by representatives of local realtors who objected to some items of the subdivision ordinance which has been under study by the planning commission for many months. As Ward Hansen of the commission put it, the commission has spent 50 hours studying the proposed ordinance.

Former Councilman Robert J. Kouw was chief spokesman for the realtors. Main objection concerned minimum space standards for house lots in limited service areas in new subdivisions. Kouw felt that a minimum requirement of 100 by 122 feet in any area would be sufficient to protect health standards. The two requirements in the ordinance have minimum requirements in one limited service area at 110 by 155 feet and in another potential area at 165 by 212 feet.

Willard C. Wichers, chairman of the planning commission, outlined work of the commission on the ordinance, pointing to a joint session of Council and the commission March 16 and subsequent meetings with realtor representatives. He said the ordinance had been tabled several times and the commission felt it was imperative to take action immediately in view of the fact that several requests for plat approval have come up, and the city at present has no good legal ordinance to deal with these requests.

Participating in the discussion were Kouw, William De Roo, Mayor Visscher, Nelson Bosman and others. Kouw pointed out that after June 1, FHA will not approve a plat without a public source of water or sewer.

## City Moves Steadily Toward New Traffic Accident Record

The major accident toll in the city of Holland remained high during April as the city moved steadily toward a new all-time record for accidents in one year.

Holland police said 33 major crashes were recorded here during the month, just one less than the March total. The score for the year now stands at 171 major accidents in four months, well over half of the record 303 accidents recorded here in 1958.

The 33 accidents caused injury to 17 persons. For comparison, there were just 16 major crashes, with six injuries, during April, 1958. Sgt. Ike DeKraaker, who has been working hard at compiling and keeping the statistics up to date,

said there were 28 minor accidents in this period for a total of 61 crashes, with a total estimated damage to the vehicles of \$11,505.

According to Sgt. DeKraaker, the main cause for crashes during the month was failure to yield the right of way at intersections, with 16 instances.

As previously noted, the month of April also saw an unprecedented number of pedestrians and cyclists hit by cars, with seven injuries.

Police Chief Jacob Van Hoff, rather appalled by the large number of crashes, said officers have been instructed to issue traffic tickets mercilessly in an effort to keep motorists within the law and reduce the possibilities of accidents.



## 6-3-3 School System OK'd For Holland

### School Philosophies Discussed at Meeting In Apple Ave. School

More than 250 persons interested in public school education gathered in Apple Avenue School Thursday night for a discussion on basic needs for education and agreed almost unanimously that the school needs of Holland city would best be served by a 6-3-3 arrangement. This would mean elementary schools to serve kindergartens through sixth grade, junior high schools to serve seventh through ninth grades and a high school program for 10th, 11th and 12th grades for an enlarged city.

While this is essentially the program advanced by the Board of Education, there is considerable work to be done in the way of district reorganization and general planning before financing can be resolved.

Persons attending Thursday's meeting were members of the Boards of Education of districts which have annexed to Holland city, the Holland Board of Education and a large number of representative citizens interested in the best public school program possible. Copies of the educational philosophy of the Holland Public Schools adopted in 1950 were distributed in advance of a symposium on school philosophies by a panel consisting of Dr. Robert De Haan, head of the psychology department at Hope College who discussed child growth and development; Harold Mow, principal of Harrington School who discussed development of children kindergarten through sixth grade; Bernice Bishop, principal of E. E. Fell Junior High School who discussed junior high age; Jay Formosa, Holland High principal, high school age; and Dr. Harry Frisell of Hope College who discussed requirements of a liberal arts college. School Supt. Walter W. Scott presided and gave the summary.

In his introduction, Scott briefly outlined studies already conducted on school needs, projected pupil populations and cooperative studies with the Holland Planning Commission.

After the symposium which took close to two hours, the crowd split into groups of six to consider two specific questions — whether to follow the 6-3-3 program, and whether to recommend a comprehensive high school program. Both questions were almost unanimously approved.

Group discussions brought some other questions, such as emphasis that while a school program may be on a 6-3-3 basis, high school records as they are referred to college cover a four-year term.

A comprehensive high school has been defined by Dr. James Conant as that which at the same time provides a good general education for ALL the pupils as future citizens of a democracy, provides elective programs for the majority to develop useful skills, and educates adequately those with a talent for handling advanced academic subjects — particularly foreign languages and advanced mathematics.

Schut continued his unbeaten string in the pole vault and sailed over 11'6" for first place. He also won the 220-yard low hurdles in 27.6.

## Sunday School Lesson

Sunday, May 10  
Nathan and David  
II Samuel 12:1-7; 9:10; 13:14

By C. P. Dame

Nathan, God's prophet, is the true hero in this lesson. David is the great sinner. Uriah and Bathsheba were sinned against—Uriah much more than Bathsheba who may have been partly at least to blame for the scandal and its tragic consequences. The sad story related in this lesson reveals the real character of sin.

I. God knows about our sins. One day David was walking upon the roof of his palace and noted a beautiful woman taking a bath. He learned that she was Bathsheba, the wife of Uriah, one of his heroic soldiers. He sent for her and committed adultery with her—this was a terrible sin and a violation of God's law. When Bathsheba reported to David that she was pregnant he tried to cover up his sin. He sent for Uriah, her husband, who came and reported on the military situation. David told Uriah to go home and spend the night with his wife but the soldier did not do that but slept with the servants in the palace. David's plan failed, and he tried again. He invited Uriah to the palace, gave him a dinner, got him drunk, but again Uriah failed to go home. Then David sent Uriah back to the army with an order that he be put in the forefront of the hardest fighting and be killed. The brave soldier died in battle. David added Bathsheba to his harem. She bore him a son. "But the thing that David had done displeased the Lord" and He sent Nathan to reprove him. David thought the issue was settled but in this he was mistaken.

II. God has his messengers. "And the Lord sent Nathan to David." The prophet told a simple parable to the king about a rich man who stole a poor man's ewe lamb when guests came to his home. Upon hearing this story David got real angry at the rich man and said that he deserved to die. The sin of another angered David but his own sin did not trouble him. How often we are like David—the sins of others are terrible but our own sins are overlooked. When Nathan said, "Thou art the man" the slumbering conscience of David woke up for Nathan told him how he had killed one of his loyal soldiers and committed adultery with his wife, and sinned against God in committing these two crimes. The prophet asked, "Wherefore hast thou despised the commandment of the Lord..." David confessed his sins, saying, "I have sinned against the Lord." He had sinned against his family, his nation, himself, Bathsheba, Uriah, but primarily against God.

III. Sin has its consequences. The confession of David did not wipe out the results that came because of his sins. Nathan said that the sword would not depart from his house. The story of David's sin is told in detail in the Bible and the consequences are also faithfully recorded. The child born to Bathsheba died. Ammon, one of David's sons, seduced his half-sister, Abigail, and she killed him. Ammon's half-brother, and later on he revolted against David, his father. David violated another man's home, his own son Absalom publicly violated his home. Four of the sons of David died tragically. The king brought a lot of misery upon himself and his family. David was false to one of his loyal soldiers and later on a part of his army was disloyal to him.

Our own sins chastise us. What we sow we reap. Nathan also told David that "by this deed thou hast given great occasion to the enemies of the Lord to blaspheme" and they still do that. After this sad story David became a different man—something slipped out of his life.

Far too many people today think that sexual sins—they do not call them sexual—are personal matters. They bring no lasting happiness—only misery and tragedy and suffering. Clean moral living, loyalty to God and our families and to our best selves pays.

During the course of the alert, Red Cross personnel provided coffee and sandwiches for the CD workers, reserve police, deputies and others manning posts throughout the area.

The Holland Coast Guard station is still flying "small craft warnings" as they have been for the past few days, and advise against small boats venturing out onto Lake Michigan at this time.

May Fellowship Day served to highlight the summer program of Migrant Ministry, with special guests from the state and national levels of Migrant Ministry of United Church Women. Mrs. Carl E. Gladstone, of Paw Paw, the State Director of Migrant Ministry introduced the main speaker of the day, Mrs. Monica Owen, of New York City, the National Director of Migrant Ministry, who travels 33 states in setting up and extending help to migrant families. Mrs. Owen related many anecdotal experiences of her contacts in migrant camps to the theme of the Fellowship Day, "How much is enough?" Her lively stories showed opportunity and challenge in the work to which, she said, "a door has been opened."

She especially praised Holland for its response to the first project of the local Council during last summer's harvest - time Migrant Ministry. She said it was unusual to have the offer of free medical help where needed from four local doctors. Mrs. Owen referred to the report sent from Holland to the National office saying that it will help programs set up in other areas.

To add the local picture to those of the state and national migrant work, Mrs. Morris De Vries, chairman of Holland Council's migrant project, spoke of the doubled needs this summer. She said that when 4,000 needed workers enter Ottawa County this summer to harvest blueberries the Church Women will be prepared to welcome them with a four-member professional staff and volunteers to expand last summer's work and reach as many camps as request the services.

Two Harvesters will be needed. A Harvester is the basic requirement for it is a station wagon equipped to carry all the essentials of worship services, Bible school, playtimes for youngsters, child care and health instruction, and family night programs for all ages. Mrs. De Vries said. She also asked the women to begin gathering Thrift Sale items in their churches which may be brought to the East Church House of Hope Church after June 15.

A training session for volunteer teams from all Council churches will soon be announced, Mrs. De Vries reported, so that help will be available for "Family Nights" as well as some Sunday worship services.

## Mackinac Bridge Film Is Shown

The building of the Mackinac Bridge and the history back of it were told in a 30-minute colored film Thursday at the noon meeting of the Rotary Club at the Warm Friend Tavern.

The film, produced by the U. S. Steel Corp., was obtained by Lee Kleis.

It started by showing how Mackinac was important in the fur trade, how the Upper Peninsula was acquired as a result of the Toledo War, of its importance as a copper, lumber and steel producer, and of the demand which the tourist placed on better connections across the straits.

The rest of the picture showed the actual construction from the sinking of the first massive anchor piers to the final paving of the roadway. ## Junior High Students Write Teenage 'Code of Ethics'

One of the major projects this year of the E. E. Fell Junior High Senate has been the formation of a "Code of Ethics" for teenagers, covering conduct in home life, school life, social life and church life.

The purpose of the code, according to the preface, is to "serve as a guide toward ideals toward which we should strive in our daily living."

Four committees, representing each of the four divisions of the code, were set up, each with a faculty advisor. The document was put together by a central committee, under Mrs. Ed Damson, and copies distributed to the students.

Noting that the family is the strongest union of society, the senators urge that other members of the family be treated with respect, courtesy, tolerance and equality, and require the teenager to live up to his responsibilities as a family member.

Health rules were also included in the code, including bedtime hours. It was decided that seventh graders should be in bed by 9 p.m. on school nights, and by 10:30 p.m. on weekends. Eighth and ninth graders have a deadline of 10 p.m. on school nights and 11:30 p.m. at the latest for weekends.

The code for school life has sub-headings concerning the student's responsibilities in studies, sportsmanship, extra-curricular activities and general conduct. Students are expected to work to the best of their ability, accept the rules of fair play in all activities, participate in school sports and-or functions and conduct themselves as good citizens at all times.

As to social life, the representatives agreed that eighth graders should not date, while ninth graders should have only limited absolutely taboo.

Noting again that one's first obligation is to the home, students are advised to reserve time for family activities. The code stipulates that parents should know who one's date is, where the couple is going, when they are coming home and who is going to be there.

Teenagers are also advised to show respect for authority, to wear clean, neat, well-fitting clothes and to show courtesy and toleration for others.

The code requires loyalty, pride and regular attendance in one's church, with a proper reverence, and tolerance for other religious and racial groups.
