Hope Grads Will Hear Brucker

Rev. Harold Englund
To Be Baccalaureate
Speaker This Year

Hope College will have two outstanding speakers for commencement exercises this year, it was announced today by Dr. Irwin J. Lubbers, president.

The Hon. Wilber M. Brucker, Secretary of the Army and former governor of Michigan, will give the commencement address for the 93rd annual commencement of the college on Monday, June 2, at 10 a.m.

The Rev. Harold N. Englund, Ph.D., minister of the Second Reformed Church of Zeeland, will speak at the annual baccalaureate service in the Hope Memorial Chapel at 2:30 p.m. Sunday, June 1.

Secretary Brucker is a member of the National Presbyterian Church in Washington, D.C., the church usually attended by President Eisenhower when he is in Washington. He is much in demand by church organizations as a government representative and speaker for church and college affairs.

Secretary Brucker became Secretary of the Army July 21, 1955, following his nomination by President Eisenhower on June 22, and confirmation by the Senate on July 11. He had served as General Counsel of the Department of Defense from April 23, 1954, until he assumed his new office.

Secretary Brucker has a background of Army experience extending back to enlistment in the Michigan National Guard in 1915 and service on the Mexican border as a member of the 33rd Infantry, Michigan National Guard, in 1916 and 1917. Following the entry of the U. S. into World War I, he attended the First Officers' Training Camp at Fort Sheridan, Ill., and was commissioned a second lieutenant of infantry.

He served in France with the 166th Infantry, 42nd Division. Cited by General Headquarters, AEF, for bravery under fire, he was awarded the Silver Star. He was discharged as a first lieutenant June 5, 1919.

Born June 23, 1894, in Saginaw, Michigan, the son of Ferdinand and Roberta (Hawn) Brucker, he was graduated from the University of Michigan in 1916 with an LL.B. degree. On Nov. 5, 1930, he was elected governor of the State of Michigan and served until 1933. Thereafter to the date of his appointment as General Counsel of the Department of Defense, he was a practicing lawyer with the firm of Clark, Klein, Brucker, and Naples of Detroit, Michigan. He is a member of the Michigan State, Federal, and American Bar Association; the American Legion, and Veterans of Foreign Wars. He is a Past National President of the 42nd (Rainbow) Division Veterans.

Secretary Brucker is married to the former Clara Hantel. They have one son, Wilber M., Jr., and two grandchildren. The family home is 56 Vendome Rd., Grosse Pointe Farms, Michigan.

Rev. Englund was born in Eureka, Calif., and was graduated from the University of California as an economics major. He also studied music at the San Francisco State College, and math and physics at the University of Oregon. He served during World War II in electronics engineering with the Army Air Force, spending time in the Pacific theater. In 1950, he was graduated from Western Seminary in Holland, and since then has been pastor of the Second Reformed Church in Zeeland.

Rev. Englund studied two years at the University of Edinburgh (1933-35), and has been the Religious Emphasis Week speaker at all three Reformed Church Colleges and at other campuses. He is a regular contributor to the Church Herald, and has recently accepted a call to serve the Midland Reformed Church, Midland, Mich.

Earl Leon Wendel, 63, Succumbs at Hospital

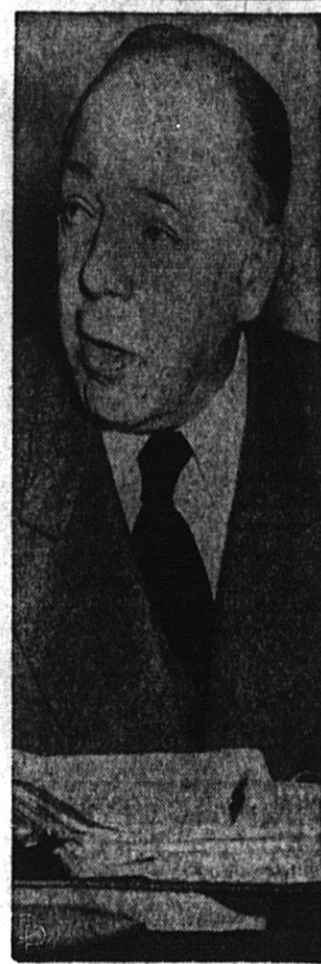
Earl Leon Wendel, 63, of 30 West 22nd St. died at Holland Hospital Thursday night. Only survivor is the wife, Stella.

Hospital Rates Increased in Grand Haven

GRAND HAVEN (Special) — Grand Haven City council Monday night approved a recommended rate increase of the Grand Haven Municipal Hospital board effective June 1.

The following rates have been changed: For private rooms \$18.50 to \$20.50; semi-private from \$15 to \$16.50; wards from \$13 to \$14 and baby care from \$5 to \$7. It is reported this is to conform with the rate in the surrounding areas.

Harvey L. Scholten was appointed assistant city attorney. The city charter does not provide for the appointment and no salary was set. Howard W. Fant, a partner in the law firm of Scholten and Fant, is the city attorney and received a retainer fee of \$600 a year and is paid on a fee basis for the work he performed.

4 Appear In Court

GRAND HAVEN (Special) — Two persons appeared in Municipal Court Monday morning as the outgrowth of a farewell party held Friday night for Robert Eugene Shipp, 47, who was being transferred from the U. S. Coast Guard cutter Woodbine to Connecticut. Early Saturday morning city police found Phyllis Sickman, 17, Grand Haven, who had been among the guests, wandering on the street in an intoxicated condition.

On arraignment, Shipp paid \$25 fine and \$5.10 costs on a charge of furnishing liquor to a minor, and Miss Sickman paid \$10 fine and \$5.10 costs on a drunk charge.

In other cases, Douglas Bronson, 33, Grand Haven, was assessed \$100 fine and \$15.70 costs or 30 days on a drunk driving charge, and committed to jail. He was arrested by city police at 5:45 p.m. Friday on Beech Tree St. shortly after he had left a tavern. Police said he was driving carelessly on the highway.

James Veech, 26, Spring Lake, was sentenced Monday to pay \$25 fine and \$5.10 costs on a charge of assault and battery following an altercation near Seventh and Washington Thursday night. City police said Veech had been driving with a large pole and net extended out of a window of his car. He allegedly assaulted James Easbaggars, also of Spring Lake, who had previously made an uncomplimentary remark about the pole extending out of the window. Both cars had stopped near the intersection.

ZEELAND (Special) — Mrs. Jennie Otting, 64, wife of Benjamin Otting of 81 Lawrence Ave., Zeeland, died Saturday morning at the Zeeland Hospital. She had been seriously ill for several days, and had been in ill health for several years.

She was the daughter of the late Mr. and Mrs. Peter Fongers of Zeeland. Mrs. Otting was a member of the First Christian Reformed Church. She and her husband celebrated their 45th wedding anniversary in 1957.

Surviving besides the husband, are three daughters, Mrs. Alfred Dozeman, Mrs. Alvin Geerlings and Mrs. Howard Redder, all of Zeeland; one son, John B. of Holland; 12 grandchildren; two sisters, Mrs. Gerrit Wolbert of Holland and Mrs. Andy De Wits of Zeeland; one sister-in-law, Mrs. Thomas Fongers of Grand Rapids.

Fell Asleep at Wheel Harvey D. Jalling, 25, of 233 East 11th St., was uninjured Saturday at 12:15 a.m. when his car left the road on M-1 just east of 48th St., jumped a ditch, crossed a small railroad and went through another ditch before stopping. Jalling told Ottawa County deputies that he had fallen asleep. Deputies said 1951 model car was damaged in excess of \$5 value.

Holland Men Admit Two Safe Jobs

Brewer Coal, Reliable
Garage Safecrackings
Solved by Confessions

Holland detectives and Ottawa County deputies Wednesday cleaned up two safecracking jobs and a breaking and entering case in Holland and vicinity with the arrest and arraignment of two local men.

Clive Harrison, 21, of 1212 Waukazoo Dr., and Rex Webb, 19, of 248 West 18th St., signed statements admitting the safecrackings at the Reliable Garage and Brewer's Coal Docks, and a break in at the Hamilton Supply Co. on M-21 between Holland and Zeeland. The two were arraigned Wednesday afternoon in Municipal Court on charges of breaking and entering in the nighttime. Both men waived examination and were bound over to Circuit Court, to appear on June 9.

Bond was set at \$500 for each man, and both were held at the city jail until they raised the bond this morning.

In his signed statement, Webb admitted his participation in the breaking and entering at Sneller's Hardware about a month ago, which Harrison had previously admitted.

Deputies Wednesday recovered some of the fishing equipment and a .22 rifle which had been taken from Sneller's. It was not previously known that a rifle had been taken from the hardware store.

Holland detectives said a third man believed to be implicated in the safecracking is still being sought.

Harrison and Webb had denied any connection with the safecracking at the Third Reformed Church on March 30th and the breaking and entering at the Zeeland Roller Rink and the North End Tavern.

The two men said that at the Reliable Garage job, which they pulled on March 11, they got about \$210, taking cash only. In the Brewer safecracking, which occurred on March 29, the men said in their signed statements that they got about \$200.

In the break in at the Hamilton Supply Co. on April 24, where they jimmied open a door to gain entrance, the men said they took only a trouble light but did not attempt to break into the safe since it was in too conspicuous a place.

200 at Meeting On Consolidation

About 200 persons gathered in Montello Park School Wednesday night to discuss the southside consolidation program involving seven school districts south and east of Holland. A three-page brochure on finding of the Southside Consolidation Organization was distributed.

Richard Streu explained how the committee arrived at these findings and John Teusink presented a question - and - answer period which lasted about an hour and a half. Harvey Scholten, attorney for Spring Lake and Coopersville consolidations, answered technical questions.

Among questions discussed was the position of the Michigan Department of Public Instruction in the consolidation plan, and the financial position in the years ahead for the proposed consolidated area. The latter question dealt with the new need to keep abreast of elementary needs as well as high school needs.

The meeting adjourned shortly after 10 p.m. Meetings in other school districts are planned in the future.

Zeeland Kiwanians Help Paint Park Picnic Tables

Eight members of the Zeeland Kiwanis Club painted more than 75 picnic tables Tuesday evening at Holland State Park in a work-bee session.

The painting was done following a potluck supper by the group. Park Manager Clare Broad expressed his appreciation for the job and said "the tables would not have been painted this summer if it hadn't been for this group."

\$35,000 Suit Is Filed Against Judith Schuler

GRAND RAPIDS, Mich. (UP) — The administratrix of the estate of a seven-month-old Mount Prospect, Ill., boy fatally injured in an auto accident last Dec. 13 near Holland has filed a \$35,000 suit in federal district court.

The suit charged negligence on the part of Judith K. Schuler, 17, Grand Haven, caused the three-car crash in which Michael J. Wcislo, was injured. He died Dec. 14.

Miss Schuler was involved in an accident with cars driven by circuit judge Raymond L. Smith of Holland and the victim's father, Julian S. Wcislo of Mount Prospect.

Mrs. De Vries Dies At Holland Hospital

Mrs. Elizabeth De Vries, 65, of 272 West 18th St., until recently of 870 Woodbridge, Holland Heights, died Monday at Holland Hospital after a lingering illness.

De Vries of Glenview, Ill.; three daughters, Mrs. Edgar Holkeboer of Transcona, Canada, Mrs. August Van Dam of Grand Rapids and Mrs. Erwin Essenberg of Holland; 12 grandchildren and one great grandchild; also two brothers, Harry Rieminga of Rockville, Md. and Charles Rieminga of Chicago; three sisters, Mrs. Grace Bergsma and Mrs. Pearl Wagner of Chicago and Mrs. Gertrude Ostlie of Albuquerque, N. Mex.; one sister-in-law, Mrs. Peter Dykstra of Chicago.

Mrs. De Vries was born in Chicago and had lived in Holland the last 12 years. She was a member of Sixteenth Street Christian Reformed Church and the Ladies Aid.

Deer Breaks Into Library

ZEELAND (Special) — A deer Tuesday evening visited Lincoln Elementary School, smashing through one window into the library and crashing back out through the other.

It seems he only came in to browse around. No books were taken.

The deer dropped in between 7 and 8 p.m. when the school was locked up. The only witnesses to the visit were three or four children who were playing in the schoolyard.

School officials said the deer evidently was cut while jumping through the window, since there were spatters of blood in the library. The door to the library was closed, so the deer did not get to see the rest of the school.

Mrs. John Van Eden of West Lawrence St. said that she had seen a fawn running through her yard in the direction of the school shortly before the "breaking and entering."

The deer got away and is probably doing his browsing elsewhere today.

He is survived by his wife, Emma; one son, Elmo of Holland; two daughters, Mrs. Alvin Tanis of Grand Rapids and Mrs. Carl Frens of Zeeland; seven grandchildren; one brother, Louis, of Zeeland.

Man Admits Kidnap Story Was Made Up

GRAND HAVEN (Special) — After being questioned most of the day, James Richard Lukins, 28, route 2, Nunica, finally admitted to State Police Detective William Chandler Wednesday that his kidnap story was a hoax.

Earlier, he had told police two men forced him at gunpoint to take a six-hour 300-mile crisscross tour of the state.

Arraigned before Justice Eva Workman Wednesday night on a charge of making a false report to an officer, Lukins was sentenced to pay \$100 fine, \$4.90 costs and serve five days in jail. If fine and costs are not paid, he will serve an additional 30 days.

Lukins' first story was that he was flagged down by two men at 1:15 a.m. Wednesday en route to work at a Grand Haven bakery and then forced at gunpoint to drive the men to East Lansing, Ludington, Muskegon and St. Joseph.

Employees Of City Ask Pay Raise

A fairly light agenda faced City Council at its regular meeting Wednesday night, and although the city fathers spent considerable time on some fine points of two ordinances that came up for final reading, the meeting adjourned in exactly an hour and 10 minutes.

Unscheduled on the agenda was a presentation for pay increases and the like on behalf of city employees and employees of the Board of Public Works who were represented by some 30 persons in the audience.

Leo Salisbury, a BPW employee, introduced Richard Kemp as representing state, county, municipal and state employees. Mayor Robert Visscher informed Kemp that Holland's Council does not recognize a union as representing city employees whereupon Kemp quoted public acts, rights of public employees, etc.

City Attorney James E. Townsend clarified this question by saying that Council is not obligated to deal with a union to the exclusion of other representatives.

Not arguing the point further, Kemp presented a lengthy list which he asked Council to consider: (1) any wage agreement effective July 1, (2) all city employees be put on a 40-hour week for same take home pay now received, (3) unused sick leave be included in terminal pay, (4) respect wishes of union members in deducting union dues, (5) three-week vacations after 10 years, (6) a longevity program to recompense old and faithful employees, (7) a 5 per cent increase on pay scale.

"We're aware this is a long list of requests but most of these have been granted to the majority of employees in like communities in the state. We also are most aware of unemployment but in view of rising costs, this is not an adequate excuse to penalize employees who have no control over this situation. This is a problem of all taxpayers, not just employees, and we suggest a committee be set up to negotiate these requests with a representative of the employees. This can be done under law," Kemp said.

Mayor Visscher pointed out that the 1958-59 budget already has been adopted and the tax levy computed. He said Council had carefully considered all the things mentioned, but that after hours of study felt it was not the thing to raise taxes at this time with the economic situation as it is today.

"Every dollar spent for services must come from the tax dollar, and with 1,500 unemployed people in this area, we cannot increase the tax load on people, many of whom already are working shorter hours or living on unemployment checks. All of us, the city manager, the council and the BPW deliberated long on these problems, and Council felt it was not in the best interests of the people to boost city costs. Consequently no pay increases were granted this year, except those merit increases which are a part of the pay schedule," he said.

No Councilmen ventured motions and no further action was taken. The two ordinances which involved considerable discussion dealt with changes in the electrical code for Holland and one dealing with dangerous weapons concealed on the person. Discussion on the electrical code involved the need for at least two circuits in each kitchen without specific mention of whether one circuit could be for an electric stove. The ordinance was rewritten to supply at least two 110-volt circuits terminating in a split-type receptacle. Split-type receptacle was carefully defined as differing from a duplex receptacle. This ordinance will become effective June 15.

In other business, Council accepted low bid of Hardy Bros. Electric for additional lighting and loud speaking equipment at the band shell at Kollen Park. The Hardy bid of \$381.69 was lowest of six bids submitted.

Holland Boy Fatally Hurt In Accident

Jerry De Ridder, 10,
Dies After Being Hit
By Car on Saturday

A 10-year-old Holland boy died Saturday evening of injuries received when he was struck by a car swerving out of control from a collision at the corner of 28th St. and Central Ave. Saturday at 12:05 p.m.

Jerry De Ridder, son of Mr. and Mrs. Gerard De Ridder, 47 East 30th St., died at 5:45 p.m. in St. Mary's Hospital in Grand Rapids. Hospital officials said death was caused by multiple fractures and head injuries.

Holland police said the boy was sitting on the curb on 28th St., 10 feet east of the Central Ave. crosswalk, when a car and a panel truck collided at the corner. The car then veered out of control, police said, and struck the youth.

The victim was first taken to Holland Hospital and then transferred to St. Mary's Hospital.

Police said the panel truck, driven by Allen Gene Buurma, 18, of 292 West 18th St., was headed south on Central Ave. while the car, driven by Anton Seltzer, 22, of South Bend, Ind., was going east on 28th St., along the Tulip Lane.

The two collided, police said, and the Seltzer car then bounced backward into the boy. Both drivers said they did not see each other in time to avoid the collision.

Mrs. Violet Seltzer, 26, was treated at Holland Hospital for a back injury and released.

The fatality is the second in Holland within one week. An elderly cyclist, Albert G. Raak, was dead on arrival at Holland Hospital a week ago Saturday evening, May 10, after being struck by a car at the corner of 13th St. and Washington Ave.

Surviving are the parents, Mr. and Mrs. Gerard De Ridder; two brothers, Charles Jon and Robert, at home; and the grandparents, Mr. and Mrs. Herman Bontekoe and Mrs. Dick De Ridder, all of Holland.

Funeral services were held Tuesday at 2 p.m. from the Bethany Christian Reformed Church with the Rev. William Brink officiating.

An election school for all election workers will be held Monday at 7:45 p.m. in Council chambers in City Hall. This instruction session is for all election workers in Holland city and Holland and Fillmore townships. The school will be in charge of the county clerk.

Ottawa Lands Up for Bids

U.S. Rep. Gerald R. 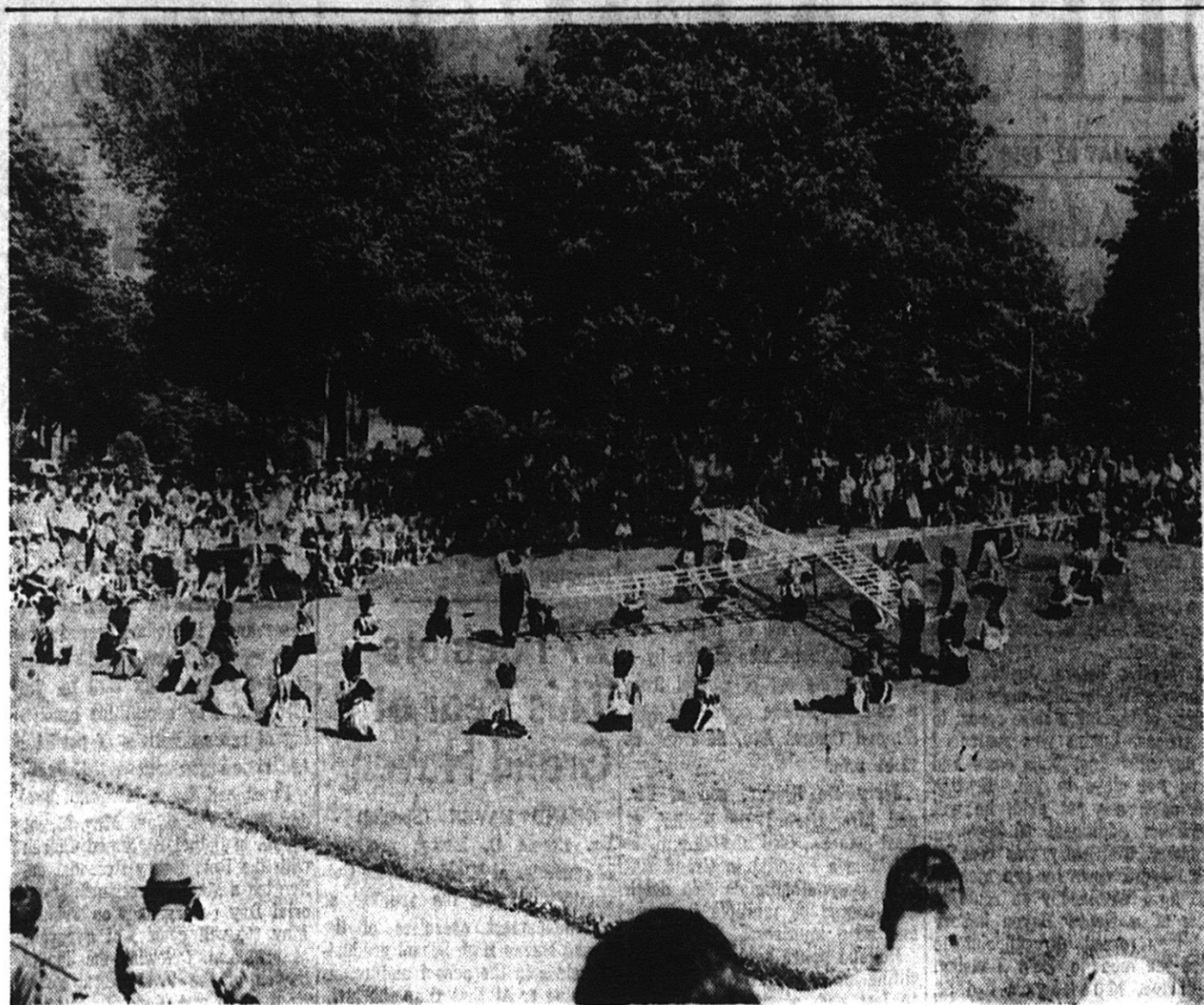

Martin Hacklander Succumbs at 65

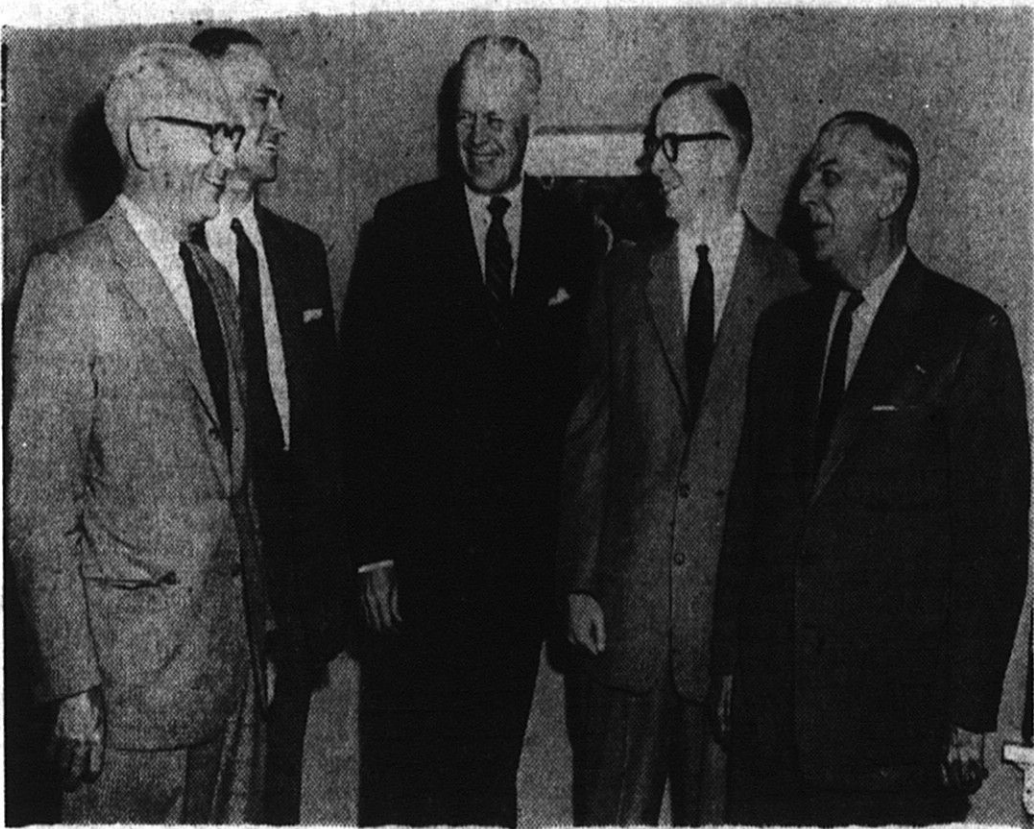
Martin Hacklander, 65, of 303 Pine Ave. died shortly before noon Friday at Holland Hospital where he had been seriously ill since May 9.

Concern Over Education Not New, Dr. Hatcher Says

"There's nothing new about evaluating America's educational system," Dr. Harlan H. Hatcher, president of the University of Michigan, told more than 400 educators and citizens who gathered Tuesday night in Grand Haven High School for a session on "Ottawa County Looks at Its High Schools."

Speaking on the subject, "My View of High Schools," Dr. Hatcher said for 300 years on various occasions Americans have taken a good hard look at what is taking place in their schools—something which is essential in a democracy.

"When the pioneers decided on free public education three centuries ago, it was one of the greatest decisions in American history. And when Benjamin Franklin promoted the Latin grammar schools, it was another great step. Then as this country spread to the west coast in the 1800's, the need for land grant colleges and vocational and technical training became evident in the great industrial revolution," Dr. Hatcher said.

"Unquestionably the American system of education for all is the greatest contribution America has made to the world. Every country including the Soviet union is attempting to copy it. For 40 years, Russia has had a concerted program to educate its young people, but the interesting thing about the Russian program is that it does not concern itself with moral and spiritual education, music or the arts. Rather, the total concentration seems to be in the area of science, which is an area in which America always thought itself to be supreme."

Dr. Hatcher expressed concern that the American high school is educating its youth for a world of peace, and the result has been a relaxed atmosphere for learning, devoting many programs and courses for leisure time activities related to a happy life.

While Dr. Hatcher felt the importance of this theme should not be lessened, he felt the Soviet union was educating its youth for a world of chaos, confusion and war, and that is the kind of world that people live in today.

"American students trained for a world of peace are at a disadvantage in meeting people in a world that is not peaceful. If all people and institutions would accept their fair share of responsibility, this could be solved. It is not for the school alone. Citizens should give greater financial and moral support to the schools," he said.

Dr. Hatcher spent the afternoon in Holland. Dr. John Hollenbach, vice president of Hope College, and Dean Emma Reeves escorted Dr. Hatcher on a tour of the campus and arranged a tea for him in Gilmore cottage where he met University alumni. Dr. J. R. Mulder, president of Western Theological Seminary, escorted Dr. Hatcher on a tour of the seminary and introduced him to the seminary board of trustees who were holding their annual meeting.

Earlier in the evening meeting, three brief addresses were given by Richard Cheverton, Grand Rapids radio and television news director; E. V. Erickson, executive vice president of Gardner-Denver Corp.; and Dr. Clyde M. Campbell, professor of school administration at Michigan State University.

Cheverton, who visited Russia last year, said the Russian type of education is not for America because Russia selects only the top 25 per cent of the class to continue schooling for a degree. Besides that, all these privileged students must be members of the Communist party, he said.

Campbell emphasized the prime responsibility of American schools is to provide a literate citizenry that knows how to vote intelligently. Erickson said industry is not demanding that the school train its pupils in technical details. Rather, it is more important that they read, write, speak intelligently and know how to get along with one another. After that, industry will take care of the technical training, he said.

There were several well organized discussion groups, and reports of recorders are now being compiled.

Promote Land Forestation

After touring government waste land rebuilt by the West Ottawa Soil Conservation District operations, the Lower Michigan Chapter, The Society of American Foresters went on record urging maintaining such land in a forested condition.

A letter from chapter Chairman, R. G. Auble of Roscommon stated "The Chapter feels that it is imperative that these lands be in large maintained in a forested condition if the disastrous effects of land misuse are to be avoided."

The foresters convened in Grand Haven last Friday and Saturday for their spring session. They saw picture slides of the forestation programs here involving 6,237 acres of waste land purchased by the U. S. under the Bankhead Jones Act.

In his letter Auble further stated "The chapter wishes to express its congratulations to the West Ottawa Soil Conservation District on the exemplary manner in which the District, as administrator of the L. U. (land utilization) land, has transformed a land condition of such nature and magnitude as to constitute a major problem to the welfare of individuals and the general public into a condition which makes these lands today an economic asset of great value to the area."

Agnew Probes Annexation

GRAND HAVEN (Special) — Superintendent of Schools Ralph Van Volkburg has received a letter from the Agnew board of education, requesting the local school board's attitude toward annexing the Agnew school district to Grand Haven before it makes a proposal to its school district.

If the Agnew district votes to annex, the local board of education would have authority to approve or reject the offer. This would not require a vote of Grand Haven school district residents, provided no school debt obligations are involved.

Agnew operates a two-room, relatively new school, for 63 students. The school census lists 113 and there are 20 students of that district attending Grand Haven High School.

The unusual part of Agnew's request is that usually annexation action originates with larger districts seeking addition of smaller ones. Supt. Volinkburg, feels that it is a credit to the Agnew residents that they are interested enough in educating their children to seek to join the Grand Haven district for improving instruction possibilities.

The local board has also been advised by St. Patrick's Catholic school officials that they are discontinuing their first grade for the 1958-59 school year, due to overcrowded conditions. Formerly, only kindergarten pupils from the Catholic school attended the local public schools and would re-enter the public schools at the ninth grade.

Last year 24 enrolled in the fall, and this year, 27 are expected in the junior high. St. Patrick's School last fall had an enrollment of 287, or 22 more than the previous year for the eight-grade institution.

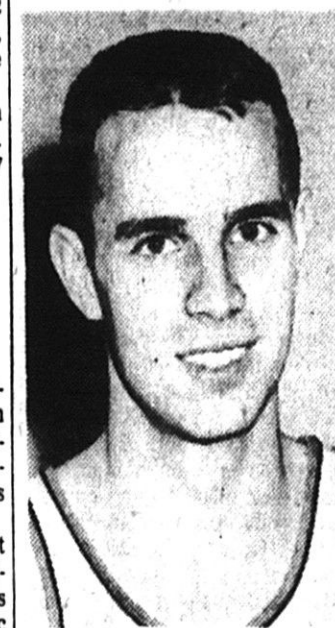

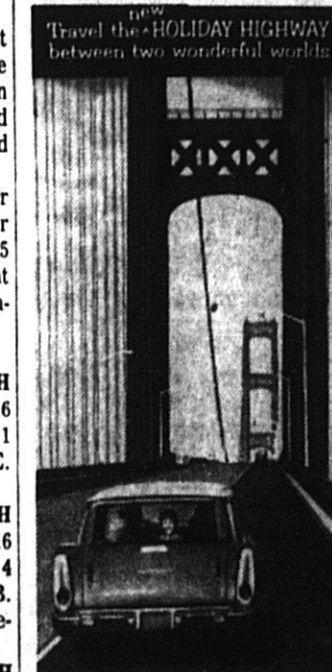

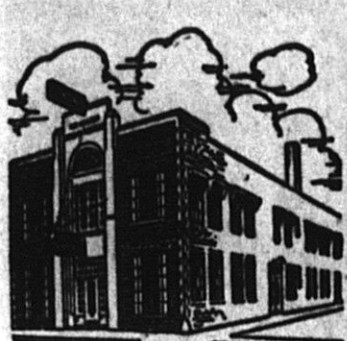

A BATTLE WORTH WATCHING

The opening phase of a battle
has just been announced that may
mean more to Michigan than many
other movements of far more dra-
matic appeal. From Muskegon, in
the upper peninsula, comes word
that the war against the deep sea
lamprey has just begun. The U. S. Fish and Wildlife Service
have treated the Muskegon River
with a lamprey-killing chemical.
During the next five years every
creek and stream running into
the Great Lakes is to be similarly
treated.

It will take the United States
longer to win the battle against
this pest than it took to win the
Civil War. It will cost millions up
on millions of dollars. But it is
now fairly certain that the battle
against the lamprey will result
in victory.

That being the case, the years of
effort and the vast sums of money
will not be in vain. For the lamp-
rey — a blood-sucking sea eel that
destroys edible fish — has already
fronced the commercial fishing in-
dustry to the brink of bankruptcy;
if not controlled, it will eventually
also kill the whole sport of fishing
in the Great Lakes. What that
would mean to Michigan alone in
dollars and cents anybody can im-
agine.

The battle against the sea lamp-
rey is rightly considered to be the
concern not of a single state but of
the United States. It is proper that
it should be manned by the U. S. Fish and Wildlife Service, because
it concerns the American people.
But a state like Michigan, lying
in the arms of three Great Lakes,
is naturally more intimately con-
cerned than some other sections
of the nation. Michigan would lose
one of its greatest assets if the
sea lamprey were allowed to go
unchecked.

The new chemical used in the
destruction of the lamprey is said
to be harmless to other water life
than the eel it is designed to des-
troy. If this expectation proves to
be true, the people of Michigan
can look forward to the restora-
tion of its once great fishing in-
dustry within the coming decade.
Tax money on both the state
and national levels is sometimes
appropriated for things that are of
doubtful value. If the sea lamp-
rey can be eliminated, it is hard
to see how the cost of the ven-
ture could be unwise. It will be
an investment, not an expense. It
will be bread cast upon the waters
that will return manifold after
many days.

Sunday School Lesson

Sunday, May 25
Living by God's Laws
Deuteronomy 6:1-3; 11:13-21;
11:26-28

On the Day of Pentecost when
we commemorate the coming of
the Holy Spirit upon the disciples
gathered together in the upper
room in Jerusalem we hope to
study about keeping the command-
ments of the Lord. If the Holy
Spirit controls us we will try hard
to keep the Lord's commandments
always and everywhere.

I. It pays to keep God's laws.
After Israel wandered around in
the wilderness for forty years the
nation was on the point of entering
the Promised Land. All the ma-
ture men who had left Egypt, with
the exception of Joshua and Caleb,
had died. Moses was still alive but
he knew he could not enter Can-
aan. A new generation was about
to leave the wilderness and enter
the land promised them. It was
for the benefit of this new genera-
tion that Moses repeated the mes-
sage of the past years. The book of
Deuteronomy from which the les-
son text is taken means "second
law" and Moses taught the will of
God set forth in his law to the
nation.

God gave commandments, sta-
tutes and judgments to Israel in
which he revealed his will. Since
God is our Creator he has the
right to make demands upon us.
In his laws God sets forth his de-
mands which are intended to in-
still fear, that is reverence for
God in the heart. Our generation
is sadly in need of a big dose of
sincere reverence for God, a rever-
ence that will express itself in
the keeping of God's command-
ments. Some people will keep the
commandments which please them
but others, they quietly ignore.
The little word "all" tells us that
God wants his people to honor all
his commandments and not just a
few. God seeks man's best and
therefore he wants him to keep
his commandments — note the
words, "that it may be well with
them, and that ye may increase
mightily."

II. Parents teaching is highly
important. Both parents and chil-
dren have a responsibility. The
parents should lay the Lord's
precepts in their hearts and souls.
Parents will not be effective teach-
ers if they are not gripped by the
truth they are called upon to
teach. Moses told these parents to
bind God's commandments on their
hands and between their eyes and
to write them on their doorposts.
The Jews took these words liter-
ally, the real meaning is that the
parents should take God's Word
seriously.

Whenever parents take God and
his Word seriously they will teach
their children about him and his
Word. This teaching should not be
sporadic but consistent and con-
stant which is taught in the words,
"when thou sittest in thine house,
and when thou walkest by the
way, when thou liest down, and
when thou risest up." It is the duty
of the home to teach. It is not
enough to hang texts or mottoes
in the home. The Word of God
must be taught and lived. The
parents that are concerned about
the future of the church and the
nation will teach the children
about God and his will. The very
conversation of these parents will
reveal to the children their inter-
est in the work of the kingdom.
There are parents that talk about
everything but God's work.

III. Choices are important. Mos-
es confronted the Israelites with
a blessing or a curse. The blessing
would come if they would obey the
Lord's commandments, the curse
if they would disobey. God still
gives us the opportunity to choose.
Israel choose wrongly. Today there
are parents and families that
choose amiss. It pays to obey the
Lord. If we know the law of the
Lord and disobey it judgment will
come upon us.

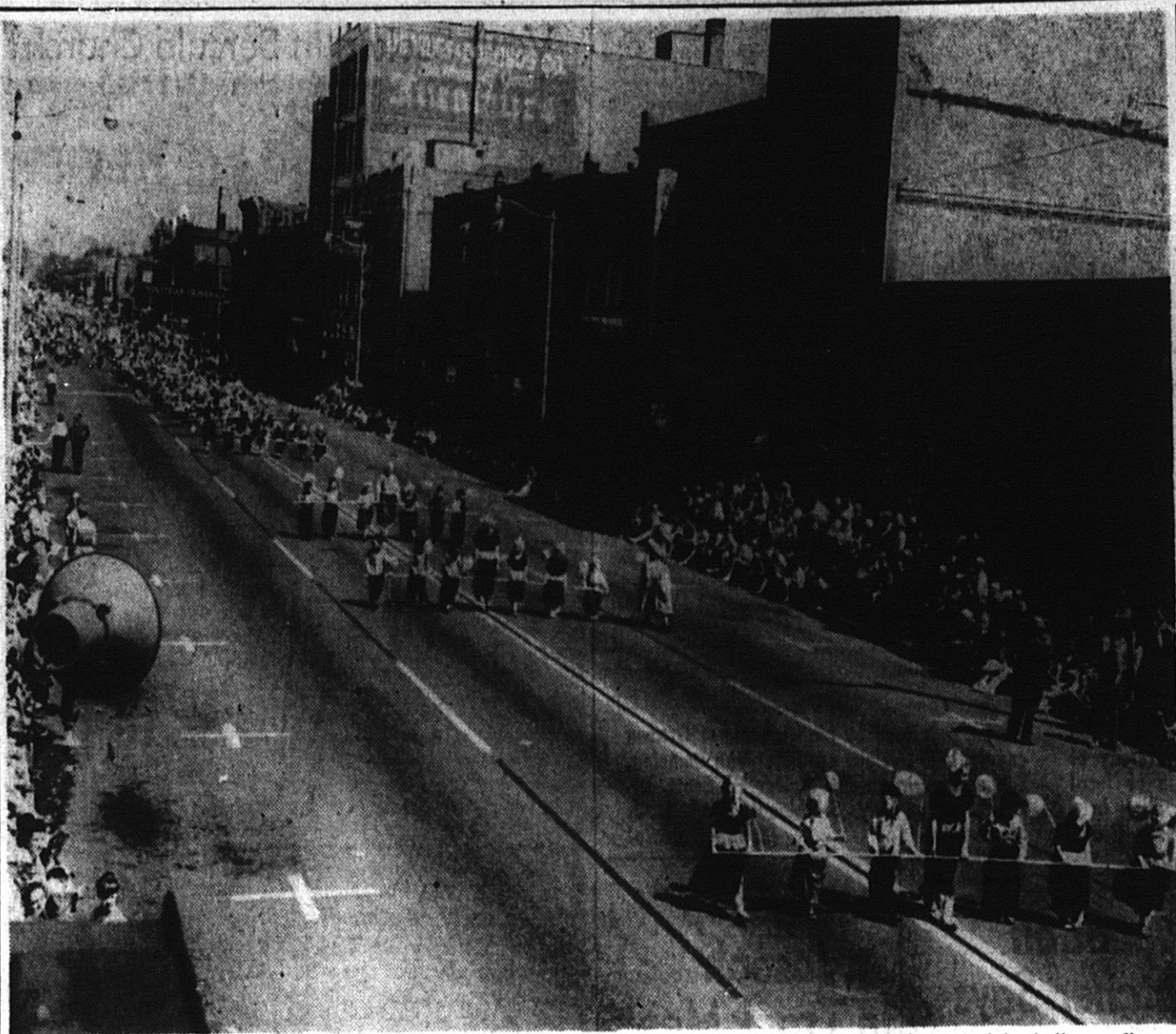

Hope Finishes 2nd in League Track Meet

KALAMAZOO (Special) — Competing in track for Hope College for the first time this spring, sophomore John Kleinhessel broke a 20-year-old MIAA broad jump record with a leap of 23' 6" here Saturday as Hope finished second to Albion College in the annual league track and field meet at Angell Field.

Kleinhessel sailed to the new mark on his first jump in the finals. On his last jump, he went out 23' 3", also to better the previous MIAA record set in 1938 of 23' by Howard of Kalamazoo. Prior to the meet, Kleinhessel's best jump this season was 20' 8".

The broad jump record was one of five MIAA records smashed in the meet conducted during intermittent rain showers. Two other field event records were broken and two running events, both by Albion's Jim Tapp.

The Birmingham junior covered the mile in the record time of 4:23.9 to slash a record of 4:28.2 set by Thomas of Olivet in 1937. Tapp ran the two mile in 9:53 to smash a record of 10:10 set in 1949 by Larsen.

Kalamazoo College sophomore Casey Clark leaped 6' 3/4" to set a new MIAA high jump record and Albion senior Bruce Foulke pole vaulted 13' 3/4" for a new league record.

Albion accumulated 82 and 13-15 points to win its 20th MIAA title and its fifth straight crown. The Britons have won every meet since World War II with the exception of 1952 and 1953 when Hope was first.

Hope, coached by Gord Brewer, rang up a total of 57 and two-fifths points to be a strong second in the 66th annual event. Calvin came home third with 28 and five-sixths points to nose out Kalamazoo with 24 1/2. Alma was fifth with 16 and one-fifth; Hillsdale, 11; Olivet, 4 and one-fifth and Adrian, 0.

Jim Mohr, Hudsonville sophomore, picked up a first for Hope in the 100-yard-dash, nosing out senior Paul Wiegink in the time of 10.4. Hope senior Dave Spaan led all the way to win the quarter mile title for the third straight year with a 50.5 performance.

Hope's mile relay team set a new Hope school record in sailing to victory in 3:30.8. The quartet consisted of Mohr, Jim Vander Lind, Bob Hilbelink and Spaan. This group set a school mark of 3:31 against Ferris.

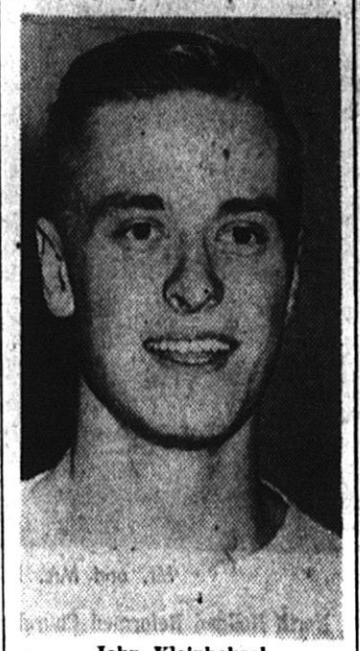
Keith Lepard of Albion was the only double winner in the meet taking first in the shot put and

discus. Larry Ter Molen of Hope followed him in the shot and Jim Hilbert was second in the discus with a heave of 122' 6".

Albion freshman Jim Krieder ran the 800-yard-run in 2:00.9 to just miss the MIAA record of 2:00.3 which was set in 1920 and equaled in 1938.

Hope's Rolland Schut vaulted 11' 9" to finish second behind Foulke and Ray Ritsema high jumped 5' 10" to be second behind Clark. Jack Kemper, baseball pitcher, competing for the first time took a third in the javelin.

Other Hope pointmakers included Wiegink, who took seconds in the 220-yard-dash and 220-yard-low hurdles; Mohr, third in 220; Jim Rozeboom, third in mile; Ritsema, fifth in discus and Rich Bakker and Bill Vander Blit, tied for fifth in high jump.

Varieties, Band Review Also Jammed

Pleasant Weather Helps
Swell Total; Thousands
In City on Sunday

Holland residents were almost back to normal today following one of the most successful Tulip Time festivals in the 29-year history of the event. Record crowds were present for the four-day festival which drew the largest crowds on Saturday.

The festival's biggest spectacle, Saturday's parade of bands, was witnessed by one of the largest crowds ever to gather in Holland for Tulip Time. The long line of march was banked with spectators 12 deep in most places.

Local residents agreed that the weather this year was the most pleasant in many years. Saturday proved a bit warm with temperatures climbing to the 80-degree mark, but a refreshing breeze kept the huge crowd fairly comfortable.

Holland Hospital treated seven heat cases, most of them band members or parade spectators. The Red Cross maintained a first aid station at headquarters at 10th and Central.

The biggest crowds in years attended the band review and Tulip Time Varieties Saturday afternoon and evening. Crowds were estimated at 6,000 at each event.

Although it was not evident to the large crowd that gathered in Riverview Park Saturday night, the program operated under a tornado alert. Varieties Chairman Harold J. Karsten kept in contact with Civil Defense quarters every 10 minutes. The City of Holland was not included in the tornado area, but first reports set a line within two miles of Holland. Later the area was revised to bypass most of Ottawa county.

Holland's 300 klompen dancers scored a real ovation in their final performance Saturday night at Tulip Time Varieties. New formations included two huge concentric circles and then a huge windmill which revolved with dancers in eight spokes. On the finale the girls formed a huge wooden shoe which walked off the field.

Tulip Time Manager Sipp H. Houtman was not available today for crowd estimates, but it was generally agreed attendance was up over festival figures for several years past. Police Lt. Ernest Bear estimated 120,000 visitors for the weekend, but other estimates placed Saturday's crowd at over 200,000. In general, it was agreed that crowds this year are not far from the half-million figure usually associated with Holland's Tulip Time.

Snappy formations in Saturday afternoon's band review ran more this year to exploding rockets than the usual windmills and wooden shoes. There was a preponderance of tunes like the Borgey march from "The Bridge on the River Kwai" and the swing "76 Trombones" from "The Music Man." There also was a generous sprinkling of dance steps in the many presentations, and numerous allusions to TV shows.

All class A bands and class AA bands won first division ratings. Class A bands were St. Johns and Charlotte. Class AA bands were Owosso and Royal Oak.

Class B bands winning first division were Mt. Pleasant, Zeeland and Dowagiac; second division, Belding, Hudsonville and Ludington. Class C bands winning first division were Brooklyn, Vandercook Lake of Jackson, Ida, Jonesville and Quincy. Receiving second division were Napoleon, Saranac and Bellevue.

Biggest thrill at the review was the massed band formation in which the three review judges each directed a selection. Judges were Ernest Caneva of Lockport, Ill., Everett D. Kisinger of the University of Illinois and Lawrence Fogelberg of Bradley University.

The crack Royal Oak Dondero band performed both afternoon and evening. It was not among the 46 bands in the parade, since it spent that time practicing its intricate maneuvers for the evening program which consisted of seven formations with colored lights outlining the band on a darkened field.

Crowds this year seemed happier than usual, due no doubt to bright sunny weather. The four days with temperatures in the 70's was in direct contrast to the cold, rainy weather last year with temperatures in the 40's and 50's.

Varieties, Band Review Also Jammed

Pleasant Weather Helps
Swell Total; Thousands
In City on Sunday

Holland residents were almost back to normal today following one of the most successful Tulip Time festivals in the 29-year history of the event. Record crowds were present for the four-day festival which drew the largest crowds on Saturday.

The festival's biggest spectacle, Saturday's parade of bands, was witnessed by one of the largest crowds ever to gather in Holland for Tulip Time. The long line of march was banked with spectators 12 deep in most places.

Local residents agreed that the weather this year was the most pleasant in many years. Saturday proved a bit warm with temperatures climbing to the 80-degree mark, but a refreshing breeze kept the huge crowd fairly comfortable.

Holland Hospital treated seven heat cases, most of them band members or parade spectators. The Red Cross maintained a first aid station at headquarters at 10th and Central.

The biggest crowds in years attended the band review and Tulip Time Varieties Saturday afternoon and evening. Crowds were estimated at 6,000 at each event.

Although it was not evident to the large crowd that gathered in Riverview Park Saturday night, the program operated under a tornado alert. Varieties Chairman Harold J. Karsten kept in contact with Civil Defense quarters every 10 minutes. The City of Holland was not included in the tornado area, but first reports set a line within two miles of Holland. Later the area was revised to bypass most of Ottawa county.

Holland's 300 klompen dancers scored a real ovation in their final performance Saturday night at Tulip Time Varieties. New formations included two huge concentric circles and then a huge windmill which revolved with dancers in eight spokes. On the finale the girls formed a huge wooden shoe which walked off the field.

Tulip Time Manager Sipp H. Houtman was not available today for crowd estimates, but it was generally agreed attendance was up over festival figures for several years past. Police Lt. Ernest Bear estimated 120,000 visitors for the weekend, but other estimates placed Saturday's crowd at over 200,000. In general, it was agreed that crowds this year are not far from the half-million figure usually associated with Holland's Tulip Time.

Snappy formations in Saturday afternoon's band review ran more this year to exploding rockets than the usual windmills and wooden shoes. There was a preponderance of tunes like the Borgey march from "The Bridge on the River Kwai" and the swing "76 Trombones" from "The Music Man." There also was a generous sprinkling of dance steps in the many presentations, and numerous allusions to TV shows.

All class A bands and class AA bands won first division ratings. Class A bands were St. Johns and Charlotte. Class AA bands were Owosso and Royal Oak.

Class B bands winning first division were Mt. Pleasant, Zeeland and Dowagiac; second division, Belding, Hudsonville and Ludington. Class C bands winning first division were Brooklyn, Vandercook Lake of Jackson, Ida, Jonesville and Quincy. Receiving second division were Napoleon, Saranac and Bellevue.

Biggest thrill at the review was the massed band formation in which the three review judges each directed a selection. Judges were Ernest Caneva of Lockport, Ill., Everett D. Kisinger of the University of Illinois and Lawrence Fogelberg of Bradley University.

The crack Royal Oak Dondero band performed both afternoon and evening. It was not among the 46 bands in the parade, since it spent that time practicing its intricate maneuvers for the evening program which consisted of seven formations with colored lights outlining the band on a darkened field.

Crowds this year seemed happier than usual, due no doubt to bright sunny weather. The four days with temperatures in the 70's was in direct contrast to the cold, rainy weather last year with temperatures in the 40's and 50's.

Maplewood Information Meet Held

Sixty-seven persons attended the first of three area meetings in Maplewood School Monday night called by the Maplewood Area Citizens committee to explain the annexation program which Maplewood district residents and those from three other school districts adjoining Holland will vote on June 3.

Information covering a wide range of subjects was given by a panel consisting of Committee Co-chairmen Arthur Schwartz and George Bishop, Treasurer Andrew Naber, Lloyd Anderson and Bill Lamb. This group emphasized that a seven-district consolidation, if it could be effected, would be more expensive than municipal annexation.

Under consolidation, these leaders said, the tax bill could be reduced only by offering a school program inferior to that now offered by Holland High School. A 10th grade student at Holland High now takes three required subjects and selects three more from 16 that are offered.

Co-chairman Bishop developed a tax structure for a minimum consolidated high school in which the 10th grader would have his three required subjects and a choice of three of only five other subjects. This minimum educational solution would cost the taxpayer \$8 per \$1,000 assessed valuation less than municipal annexation and would provide no plan for solving future water and sewage problems, Bishop said.

Treasurer Naber presented figures on 1958 taxes just obtained from the Allegan county clerk. These figures revealed that if Maplewood area does not annex and does not consolidate, the 1958 tax bill will be 21 per cent higher than 1957 without arranging for additional school facilities.

The meeting adjourned at 10 p.m. Monday's meeting was for residents living in that area between 32nd and 40th Sts. from Central to Lincoln Aves.

Districts seeking annexation to Holland city are Montello Park, Maplewood, Apple Ave. and Federal. All elections will be held June 3 in Holland City, Holland and Fillmore townships.

Grand Haven Hosts Workshop For Industrial Development

What communities can do to establish and carry forward sound programs of industrial development will be the subject of an all day industrial development workshop at Grand Haven today.

The Grand Haven workshop is for Ottawa, Muskegon and Allegan Counties. Nearly every city and village in those counties will be represented at the meetings by municipal officials, representatives of Chambers of Commerce or industrial development groups.

The workshop is sponsored by the Michigan Economic Development Department and the Grand Haven Chamber of Commerce. The sessions will bring together representatives of railroads, utility companies, chambers of commerce, educational institutions, local, county, state and federal governments and others interested in industrial development.

In announcing the workshops, Don C. Weeks, director for the Economic Development Department said: "Industrial development depends more on what is done in the local community than anything else."

In the workshops it is emphasized that with all interests working together, much more can be accomplished in any community than can be done by any group working on the outside.

"These workshops, started in 1955, are planned to assist all communities in organizing or improving their own programs of economic development," Mr. Weeks said.

Each workshop will include seven panel discussions including community organization and the making of an industrial survey of the community; Analyzing the community's potential; Raising funds for industrial promotion; Developing sites for industry; Forming an industrial development corporation; Assisting local industry; Looking for prospects and selling them on the community.

Calvin has 26 points, Adrian, 8 and Olivet 3 and are far out of the running.

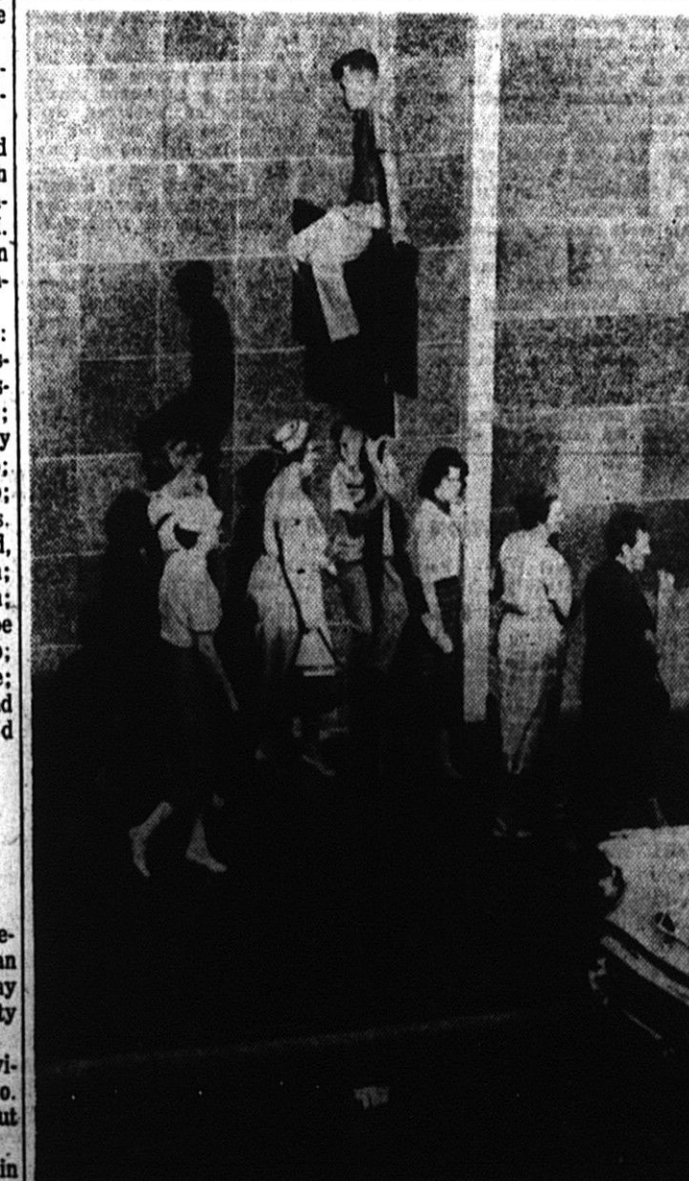
