Coopersville Pair Drown In Creek

Neither Could Swim;
Bodies of Jacqueline,
Timothy Fordham Found

GRAND HAVEN (Special) — Two members of a Coopersville family were drowned about 8 p.m. Sunday while at a swimming party of a group of young people in Crocker Creek a mile inside the Muskegon county line.

Victims were Timothy, 19, and Jacqueline Jean, 18, children of Mr. and Mrs. Irvin Fordham, of 7718 Wilson Rd., Coopersville.

The tragedy occurred when Jacqueline stepped off a dropoff. Her brother attempted to save her and both were drowned. Neither could swim.

The girl's body was recovered at 9:40 p.m. by State Police Trooper Charles Austin and Deputy Willis Bos. Her brother's body was recovered at 10 p.m. by the Fruitport Rescue Squad. Both were in water 20 feet deep.

Scene of the double drowning was a mile west and a mile south of Sullivan Reformed Church. Both bodies were taken to Throop Funeral Home in Coopersville.

Jacqueline was secretary to Assistant Prosecutor Asa Kelly, Jr., in Coopersville for the last three months and was planning to attend college in the fall. She was with a group of girls attending a Circuit Court trial in Grand Haven last Wednesday so she would be more familiar with court procedures. Her brother had attended Junior College in Muskegon the past year.

Surviving are the parents; four sisters, Carolyn, Barbara, Janice and Debra; and two grandmothers, Mrs. Anna Fordham of Coopersville and Mrs. Otto Rolsch of Allegan.

The bodies will remain at Throop Funeral Home in Coopersville until Wednesday morning when they will be taken to Trinity Lutheran Church in Conklin to lie in state until funeral services at 2:30 p.m. A private service for the family is scheduled at 1:45 p.m. in the church. Burial will be in the church cemetery.

Traffic Plan Tentatively Approved

The Holland Planning Commission and Traffic and Safety Commission, in joint session Tuesday night, approved in principle a long-range plan of the Michigan Highway Department for trunk lines within the city for a five-year program starting in 1963.

The local groups have reserved judgment on some items and are asking for a joint review on such subjects as elimination of parking and truck routes.

Included in the program are plans for one-way traffic eventually on Seventh and Ninth Sts. and Pine and River Aves.

Tentative approval followed two joint meetings of the two commissions with representatives of the Michigan State Highway Department.

Special Sheriff's Patrol Urges Safety on Water

With the biggest boating weekend of the year on tap for Holland residents, the Ottawa County Water Safety Patrol today issued a warning for boaters to take it easy and to observe boating laws over the long Fourth of July holiday.

Leo Salisbury, Ottawa County water safety patrol officer, today asked for the cooperation of all persons on the water during the weekend to prevent any accidents.

Lake Macatawa will be crowded with fishermen, water skiers, sail-boaters and other pleasure craft and with the upsurge of the popularity of boating the past couple of years, more boats are expected out this weekend than ever before in history.

Salisbury will have his crew out patrolling the waters. He is assisted by Bill Wenzel, assistant patrol officer and aides Roger Beekman, Henry Wolff, Jack Zwiers, Gerald Goshorn, Bernie Borgman, Bill Kurth and Harold Dorr.

The group has completed a course, conducted by Coast Guard, in how to administer artificial respiration and a course in federal regulations.

They learned to administer the mouth-to-mouth artificial respiration, regarded as the most effective and conducted by E. N. 3rd class Dale Stricklin of the Holland Coast Guard Station. Chief Paul Stone, commanding officer of the Holland Coast Guard, gave the federal regulations course.

With the additional staff, the patrol group will have two men in the boat at all times to answer calls. The patrol boat is equipped with a radio, first aid and life saving equipment.

Salisbury reminded boaters that there is no anchoring of fishermen in the channel of Lake Macatawa. The channel extends the length of the lake from off the breakwaters to Brewer's City Coal dock and is marked by buoys.

Persons fishing and water skiing must remain on either side of the deep shipping channel. Skiers must remain in the designated areas.

Salisbury said that any boat 16 or more feet must have a state license plate. He said that sailboats have the right of way all of the time except when a sailboat is under power with an auxiliary motor.

In order to prevent accidents, Salisbury pointed out a few suggestions for boaters. He asked that all boaters have approved life preservers, a fire extinguisher and some kind of a bailer in the boat.

"Something as small as a coffee can will serve as a bailer," Salisbury said.

He warned that the water patrol, a branch of the Ottawa County sheriff's patrol, will be on the lookout for recklessness. Any persons guilty of recklessness in the boats will be apprehended, Salisbury said.

Running too close to moorings and docks was the chief cause of recklessness, Salisbury reported.

Salisbury will be at the Holland branch of the license bureau at 87 West Eighth St. Tuesday morning, July 5 to answer questions on the rules and regulations of licensing of boats.

Young Cyclist Hurt — Five-year-old Vincent Gerber of Spring Lake was treated in Municipal Hospital for abrasions and body bruises after his bike collided with a car on North Shore Dr. at 9:15 a.m. today. Driver of the car, Alfred C. Becker, 39, Kankakee, Ill., was traveling slowly and was in the process of passing the boy when the bike swerved into the right front of the car. The driver was not held.

Dog Owners Get Warning

Reports of three children having been bitten by dogs in the Holland area during the past week have prompted officials to issue a warning to all dog owners to keep their pets tied.

The Holland City Health Department, Ottawa County Sheriff's Department and Allegan County deputies have each reported one child bitten by dogs.

City Sanitarian Sam Stephenson said that the City of Holland has a "leash law" which makes it mandatory that dogs be under control of their owners at all times.

Should a child be bitten by a dog running loose, the dog's owner could face civil action and wouldn't have much of a leg to stand on, Stephenson said, since an untied dog indicates a violation of the city's "leash law."

Stephenson cited the large number of children playing outdoors as a reason for the increased number of children bitten by dogs in the last week. Children also are unprotected by heavy clothing during the summer, he said.

Dog owners are reminded of this fact and urged to make a special effort to keep their dogs tied.

Ottawa County deputies said that if dog owners fail to cooperate in keeping their dogs under control, more strict enforcement will be necessary.

2 Animal Trucks Offered to County

GRAND HAVEN (Special) — Richard L. Cook, of Grand Haven, chairman of the Sheriff's committee told the Board of Supervisors Tuesday afternoon that Mrs. P. T. Cheff of Holland has offered two panel pickup trucks to be used for handling animal complaints, one for the south and the other for the north end of the county. The donor would have the body built on each truck to conform to the specifications required by the sheriff's department.

Cook cited that on a 26 week basis, the expense for maintaining this type of work would cost \$3,000 in salary, \$150 insurance and \$500 operating costs, or a total of \$3,650 for a half year, or part time basis. Such a request was previously turned down by the board, mainly because there was no provision for such a item in the 1960 budget, a condition exists at the present time.

The board took action to thank Mrs. Cheff for her generous offer and to give further consideration at the October session.

Four Injured as Car Rolls Over

GRAND HAVEN (Special) — Four persons were admitted to St. Mary's Hospital in Grand Rapids as the result of an accident on Lincoln St. in Tallmadge Township at 10:30 p.m. Tuesday.

Lawrence Apple, 20, Grand Rapids, lost control of his 1953 car on Lincoln St. which is a gravel road. The car skidded a considerable distance before rolling over. The car was demolished.

Apple received head lacerations. Therese Bliss, 17, Grand Rapids, received body bruises and was scheduled to have x-rays and her sister, Sharon, 13, received shoulder and body bruises. Fred Tusch, 16, also of Grand Rapids received shoulder injuries.

Sheriff's officers are investigating.

Saugatuck Race Attracts 35 Yachts

SAUGATUCK (Special) — More than 35 sleek sailing craft will leave the Chicago Yacht Club Friday night at 7 p.m. in the 40th annual Chicago to Saugatuck Yacht race.

The boats will sail the 90-mile course and are expected in the Saugatuck harbor Saturday morning. The race ends at the mouth of the Kalamazoo River in Saugatuck and results will be compiled at the Hotel Butler.

The race will be divided into four divisions and some of the top Chicago boats are expected to compete along with boats from Milwaukee, South Haven and Michigan City, Ind.

Following the completion of the Chicago to Saugatuck race, many of the boats will head for the Macatawa Bay Yacht Club to compete in Sunday's Lake Michigan Yachting Association Regatta.

After the regatta, the Chicago boats will compete in the annual race from Macatawa Bay to Belmont Harbor in Chicago on Sunday night and will arrive back in Chicago Monday morning, July 4.

Illinois Man Dies When Boat Flips

Two Others Rescued
When Motorboat Hits
Log in Grand River

GRAND HAVEN (Special) — A 68-year-old Lisle, Ill., man was drowned in Grand River near Fisher's Boat Livery on Mercury Dr., about 10 a.m. Sunday morning.

The body of Ernest Troutman was recovered at 1 p.m. in 50 feet of water near the center of the channel in the area of Mercury Dr.

Two relatives, Robert Kempfer, 14, and his brother, Larry, 10, were rescued after their 12-foot fiberglass boat equipped with a 10 horsepower motor hit a submerged log and capsized, throwing the three occupants into the water.

James Davis, 40, Grand Rapids, standing on shore, heard the cries for help and went to their rescue in a boat. The two boys were clinging to the overturned boat and Troutman was hanging onto a life preserver. Davis took the two boys ashore but when he returned for Troutman, the man had disappeared.

Mr. and Mrs. Troutman had arrived Friday morning to visit their nephew, Leroy Kempfer.

Troutman's body was found about 50 feet from where the man was last seen clinging to the life preserver. It was recovered by Frank Vrablic, Grand Haven fireman, and Deputy Willis Bos, the sheriff's department's harbor control, the firemen and Conservation Officer Harold Bowditch engaged in resuscitation efforts to no avail.

Dr. Peter A. MacArthur, medical examiner of Grand Haven, attributed death to accidental drowning.

Holland Youth Gets Probation

GRAND HAVEN (Special) — Dennis Ray Allen, 17, of 212 West 19th St., who pleaded guilty June 13 to nighttime breaking and entering, was put on probation for two years when he appeared in Circuit Court Wednesday.

Conditions of the probation are that he spend the next 15 days in jail, pay \$100 costs on a monthly basis and observe an 11:30 p.m. curfew. Allen told the court he would like to enter the armed forces but the court informed him he could not enter the service with a felony against him.

Allen, one of four charged with breaking into a storage shed at the rear of Parkway Tavern in Park Township April 24, was subjected to an additional reprimand for his action in speeding home at the rate of about 80 miles an hour last Wednesday after being in Circuit Court to witness disposition against his three buddies, all of whom were put on probation for 18 months.

Ex-Olympic Star Jesse Owens Visits Here

Jesse Owens, world renowned as a track star, proved Wednesday, while playing golf at the American Legion Memorial Park, that he is not a one-sport man.

Owens, who is vacationing this week at The Mooring on Lake Macatawa, shot a 77 for his first try at the 18-hole course. Par at the Legion is 70. Owens had a 37 on the first nine and 40 on the back nine.

The only athlete to ever win four gold medals at the Olympics games, Owens is presently living in Chicago. He works with the Illinois Youth Commission, and has a daily disk jockey show.

Owens, who set world records in the 100 and 200 meter races, the running broad jump and the 400 meter relay team race in the 1936 Olympics at Berlin, says there are several American tracksters who have a chance of breaking his records at the Rome Olympics in August.

He commented on the fine work of Greg Bell of Indiana University and Robinson of Syracuse University in the running broad jump, and of California's Ray Norton in the 100 meter competition.

In talking about the athletes of the present day, Owens mentioned

that they are in better health and have better coaching, equipment and competition than those of 25 years ago, when he was setting his records.

It was just 25 years ago that he accomplished the remarkable feat of breaking three Big Ten track records and tying another at the Ann Arbor meet while suffering from a bad back. Owens, a student at Ohio State University, hurt his back three weeks before the big event when he fell downstairs.

Jesse said the pain was so severe that he couldn't even run 200 yards on the warm-up track. It looked as if he might not be able to enter the meet, but Owens refused to be defeated without trying.

Being determined to compete and to win, Jesse got ready for the 100 yard dash, and as soon as the starter called "set," the pain vanished. He was off to tie the world record of 9.4 seconds for 100 yards, and set new marks of 20 feet, 8 1/2 inches for the running broad jump, 20.2 seconds for the 220 yard dash and 22.6 seconds for the 220 low hurdles.

All this took an hour and 30 minutes, during which, Jesse says, his back was fine. But as soon

as he completed the last event, the pain returned and he had to be carried off the field.

The greatest event of Owens' career, the Berlin Olympics, was marred by an insult from Adolph Hitler, which, ironically, was known to most of the world before Jesse was aware of it. The story of the German dictator's refusal to congratulate Owens on his victories soon reached American newspapers, but Jesse didn't learn about it until several days later when a reporter friend asked him about the incident.

Owens said he had been too busy concentrating on the competition to pay attention to anything else. And, undoubtedly, his concentration had paid off. He set a record of 26 feet 5 1/2 inches in the broad jump, 10.3 seconds in the 100 meter and 20.7 seconds in the 200 meter races, and was first in the U.S. 400 meter relay team which set a record of 39.8 seconds.

Owens said he had gone to Berlin to compete in the Olympics, not to shake hands with Hitler. The important thing for him was the meet, in which he performed better than any other athlete, before or since 1936. He had his gold medals, and he was not especially disappointed by the absence of Hitler's congratulations.

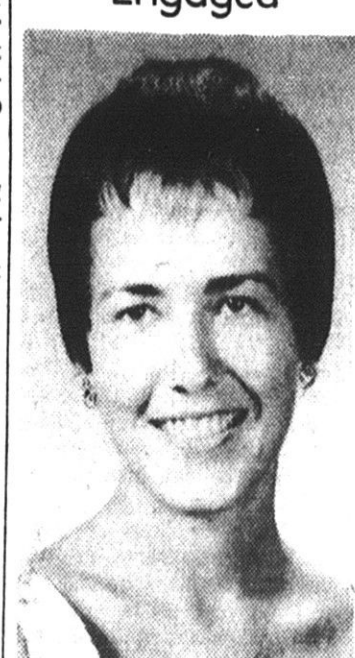

Right now we are hearing a lot about the expenses of our traveling Congressmen and also the problems of the income tax, tax on dividend payments and the method of reporting them.

Big business is being looked at along with the small taxpayer. Recently Senator Douglas publicized some examples such as the Navy had paid \$21.10 for items valued at 25 cents and the Air Force had obtained 25 cent items at a cost of more than eight dollars.

In any number of cases all of these investigations find many of these costly mistakes in many branches of the government. The duplication starts right back at home. We have many branches of government where there is duplication and waste. We think that the more investigation that is carried on the better. First it is nice to have ones own house in order. Waste, in most cases, happens because of our huge government and the number of people it takes to make the government work. There is bound to be waste all along the line. This is an election year and if you have ideas on how we can reduce the continued waste of our tax dollars then we suggest that you write to your elected officials. We have many problems and we are going to need all the help we can get.

Government procurement for the armed forces that allow the payment of high prices does not jibe with the American ability to drive a good bargain. Just think how much we could have if it were only possible to stop some of the government waste.

The time may come when we will need every dollar that we can muster for the increases in our economy. Therefore it is our business to take steps to come up with the answers. We do not think that we can continue the way we are now operating. We have millions of fine people in government service. They should think about these problems starting right back at the township level.

Sunday School Lesson

Sunday, July 3
Century of Great Prophets—
Men Who Spoke for God
Divine Judgment
Amos 7:1-15
By C. P. Dams

The lesson about Amos is timely. We will study him and his message on the Sunday before a national holiday. Our nation needs men and women with the religious fervor, patriotic ardor and staunch convictions of Amos.

I, God is concerned about nations. Amos lived in a small town named Tekoa which was located not far from Jerusalem. A goodly number of famous men have come from small towns. Amos was a herdsman, and a dresser of sycamore trees, a man who worked hard for his living. Although he had no special training God called him to preach and sent him to the northern kingdom in spite of the fact that he was a citizen of the southern kingdom. His ministry was from 780 B.S. to 752. During his ministry two able kings were in power.

Uzziah was the successful king of Judah. Recall that he died a leper because he wanted to usurp the office of the priesthood also. Jeroboam II ruled in the northern kingdom and he too was aggressive and successful from the material standpoint. Although the nations seemed prosperous there were many signs of decay. There was a great gulf between the rich and the poor. Religion was cold, formalistic; morality was at a low ebb and getting worse. God called Amos to preach to the northern nation, where conditions were more deplorable than in the southern nation.

In the first verse of the lesson text the prophet pictures the Lord who "stood upon a wall made by a plumbline, with a plumbline in his hand." The wall had been built to the line but now it was crooked. The plumbline revealed that the wall was sagging. The plumbline preached a sermon without a word. The point stressed is that Israel was failing as a nation. The Lord told the prophet that he would not spare the nation any more. God, the Judge of nations, was about to judge Israel because of its sins. Nations are responsible to God.

II. Prophets and priests do not always agree. Amos preached in Bethel where Jeroboam I had placed a golden calf. The priest, Amaziah, objected to the preaching of Amos and reported him to the king, saying that Amos had conspired against the king which was not true. The priest objected to the fact that the prophet had predicted the death of the king and the captivity of Israel. The priest told the prophet to go home and make his living in his own country. The words of the priest were a revelation about himself.

The prophet boldly replied to the priest by saying that he was not a prophet, nor the son of a prophet—he did not belong to the prophetic order and had not been trained in the schools. However, the prophet was sure of a divine call. He was an herdsman and a dresser of sycamore trees but God had called him to preach. "Go, prophesy unto my people Israel." Those words made him leave the country and begin his preaching ministry. When the call of God came he responded and left his daily work and preached the message God gave him.

What a contrast between Amaziah the professional priest who was only interested in his social standing and in making a living and Amos who was deeply concerned about the nation which was heading for ruin! The primary purpose of Amos was to persuade the nation to repent and save itself but his message failed to arouse the nation and not many years afterward, Israel was carried into captivity as Amos predicted.

Amos was a layman. There are many consecrated laymen in our churches. Many witness boldly for the Lord. Laymen can do much for the Lord in these days. They need the courage and faith of Amos.

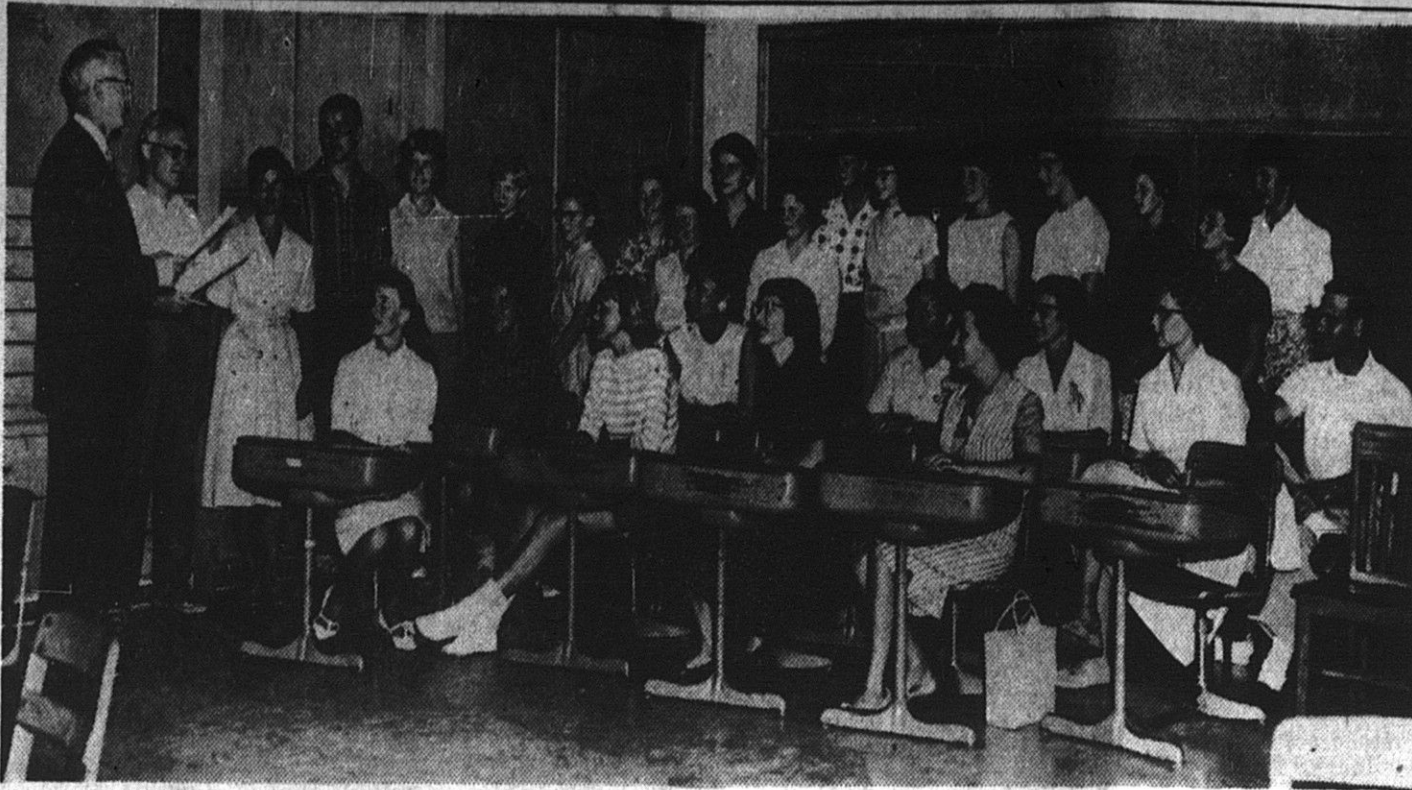

Road Starts Near South City Limits

Two Exits-Entrances Scheduled for Douglas and Saugatuck Areas

LANSING — A public hearing concerning a 38 mile long section of Interstate 96 freeway from the vicinity of the south Van Buren County line north to a connection with the Holland bypass will be held July 7 by the Michigan State Highway Department, Commissioner John C. Mackie announced today.

The new section of freeway will be a relocation of existing US-31 and is estimated to cost \$25,531,000. The hearing on the project will be held at 2 p.m., Thursday, July 7, in Central Auditorium, South Haven High School in South Haven.

The route of the proposed section of freeway begins by connecting with the US-31 Holland bypass and US-31 business route at 146th Ave. in Allegan County. It swings west of US-31, extends south to 136th Ave. where it crosses the existing highway. The freeway then continues south, bypassing Saugatuck and Douglas.

The highway proceeds southwesterly, passing about one-half mile east of the village of Glenn and again crossing US-31. It goes south, about one-half mile east of 31, bypasses South Haven and continues to one-half mile south of the southern line of Van Buren County.

The section of controlled access freeway will be a part of the interstate route which links Detroit, Lansing, Grand Rapids, Holland, Benton Harbor and St. Joseph. Near the St. Joseph-Benton Harbor area, Interstate 96 will connect with Interstate 94, another freeway carrying traffic from Detroit to the Indiana line and Chicago.

Freeway interchanges (entrance and exits) are planned for 32nd Ave.; M-140, Phoenix Road, and North Shore Drive in the vicinity of South Haven; 109th Avenue; US-31 northwest of Glenn; 124th Avenue (M-89); Adams Road (US-31) south of Douglas; Washington Road (US-31) and at the US-31 Holland Business route and Bypass connection.

Structures for carrying traffic over or under the freeway are planned for 44th Avenue (County Road 376), 20th Avenue (County Road 380), M-43 71st Street, 107th Avenue, 114th Avenue, 118th Avenue, 130th Avenue, Richmond Road, 140th Avenue and 60th Street. Bridges at railroads and over streams will be at Brandevine Creek, Deerlick Creek, Chesapeake and Ohio Railroad and South Haven, Black River and New York Central Railroad, a creek in Section 5, Ganges Township, Allegan County and the Kalamazoo River.

At the hearing the Highway Department will present data it has prepared about the economic effect of the proposed freeway and its influence on the surrounding area. Engineering and location data will also be discussed.

Testimony will then be taken from interested citizens concerning the location of the proposed freeway and a record will be kept. A transcript of the proceedings will be studied by the Highway Department and the U. S. Bureau of Public Roads before final plans for the new freeway are approved.

Supervisors Hear Report Of Surplus Property Program

ALLEGAN (Special) — Allegan County's surplus property muddle—a subject for gossip for more than a year—became a matter of public record during the current session of the board of supervisors.

The situation first looked like a full-fledged scandal but in a public airing by supervisors, it shaped up as a typical governmental snafu.

Supervisors failed to take definite action in the matter, tabling until their October 10 session the controversial report of the civil defense committee with its three-point solution.

The committee, headed by John H. Scholten, of Laketown, favors complete withdrawal from the surplus property program. Their report also recommended that Ganges Township refuse to pay long-delinquent service charges, totaling \$902.75, on grounds that the material on which the charges were levied was seized by officials of the state civil defense office last August. Several thousands of dollars worth of tools and equipment originally obtained by Ganges township civil defense volunteers from the surplus property depot at Jackson has been stored at the county road commission garage near Fennville ever since it was seized nearly a year ago.

As a result of the seizure, Allegan County was denied further participation in the program. Last Monday, when the board of supervisors convened, they heard a letter from the State Office of Civil Defense indicating the office was "anxious" to re-allocate the seized property and put the county back on its approved list for additional surplus material.

However, the state office indicated they would insist on appointment of a new surplus property officer in place of Allegan city Supervisor Gerald L. Beetley and arrange for payment of \$1,107 in delinquent service charges levied on Ganges Township and the Zone Eight civil defense organization, which includes Otsego, Gunplains, Watson and Martin Townships.

State civil defense officials will not be getting an answer by the July 1 deadline they imposed in their letter. Action on the county's civil defense committee report—recommending withdrawal from the program, refusal to pay charges on material seized in Ganges, but payment for the Zone Eight equipment by cities and townships in the zone—was tabled until October by an 18 to 14 vote.

The present surplus property program was drafted to eliminate the excesses of the post-World War II surplus disposal setup and prevent the sale of material in competition with private business.

Under the program, the federal government retains title to equipment distributed to schools, governmental units and civil defense organizations. Units qualified to obtain the property can use it for any purpose they see fit, but it is supposed to be kept in readiness for emergency use.

In 1958, civil defense officials in Illinois discovered that a highway contractor—active in volunteer CD work—was using hundreds of thousands of dollars worth of heavy equipment obtained through the surplus program in his own business.

Late last spring it appeared that the Illinois scandal was being repeated on a smaller scale in Ganges Township. A Ganges fruit grower approached Beetley, county surplus property officer since 1957, if he could get a fork-lift truck like his neighbor had for use in his orchard. Beetley said "no" and did his best to outline the regulations and intent of the surplus program.

Evidently the explanation did not satisfy the Ganges orchardist. He went home and wrote a letter to the State Police charging that his neighbors were using surplus government property on their farms for their own use.

As a result, state and federal civil defense officials converged on Ganges Township, with Beetley in town, and took possession of every government-owned item.

As Beetley explained to the board of supervisors Friday, Ganges had an active civil defense unit. Several times its members had gone to Jackson to pick up various items of emergency equipment. Since they had no centrally located building to store the material in, according to Beetley,

the township's CD volunteers kept the equipment at their own homes, spent a lot of their own money to get it in working order.

"It may have been," Beetley told the board, "that some of the equipment was occasionally used on the farms, but only to determine whether it was operable and in 'readiness' as the government required."

In fact, according to Beetley, while state civil defense officials insisted on seizing all of the equipment, at least one federal official felt the Ganges Township set-up was quite proper and a "practical approach" to civil defense under the circumstances.

Seizure of the property naturally brought an end to volunteer civil defense activity in Ganges and similar misunderstanding this spring promises to finish off the county's Zone Eight organization.

Fred Carroll, Otsego, zone coordinator, told his side of the story to supervisors last week. He recounted the hundreds of volunteer man hours and out-of-pocket money spent to get surplus equipment in operating condition. The zone—cited by both state and county for its work—has an auxiliary police department frequently called on to police special events, accidents and other emergencies.

Carroll told the board he had been assured by David Weston, Allegan county CD coordinator, that the county would reimburse cities, villages and townships for money spent for surplus property. But when the bills were presented to the board's finance committee, payment of some was denied.

As it developed, both the board and Weston had reason to believe they were right.

When the board budgeted in 1957, 1958 and 1959 for the civil defense program, a sum was allocated each year "for the purchase of surplus property for distribution to townships, villages and cities." That's the way it appeared in the record and that's the way Weston and other civil defense workers understood it.

But most supervisors had understood the annual allocations as a "revolving fund" to provide for immediate payment of surplus property service charges and assumed that the cities and townships would reimburse the county. In fact, most units obtaining the surplus equipment did reimburse the county.

But Zone Eight, assured by Weston that county funds were available, went ahead, obtained emergency gear. When the board refused to approve the bills, they even went around to the cities and townships in the zone for contributions to pay off the delinquent \$204.50 bill. The civil defense committee report, now tabled until October, recommended that Carroll, and his co-workers try again to get the money from governmental units in the zone.

Thieves Damage Boat In Early Morning Ride

Fun-loving thieves early Saturday stole a boat from Earl's Marina on Ottawa Beach Rd., near Holland State Park, drove it for a couple of hours and returned it, battered and somewhat the worse for wear.

Ottawa County deputies said the 18-foot runabout, owned by Ernest Van Dam of Grand Rapids, was taken about 3 a.m. today and returned about 5 a.m.

A two-by-four board had been driven through the hull, and the sides of the boat had been skinned, deputies said.

Four Juveniles Caught Riding in Stolen Car

GRAND HAVEN (Special) — State police Saturday took into custody four Grand Rapids juveniles who were riding in a stolen car.

The three 15-year-olds and one 14-year-old, who were turned over to Kent County juvenile authorities, were apprehended at 3:55 a.m. on M-50 east of the US-16 bypass in Walker Township. The car in which they and two other youths who were not caught, had been stolen in Grand Rapids.

Install Corner Barrier As Safety Measure

The Ottawa County Road Commission has recently made several improvements, including the installation of a barrier at the corner of Lakewood Blvd. and North River Ave.

The barrier was commended by County Safety Director Avery D. Baker who said that the intersection had been the scene of many near accidents and several actual collisions. He also said it is hoped that the "V" intersection at the east city limits will receive attention soon.

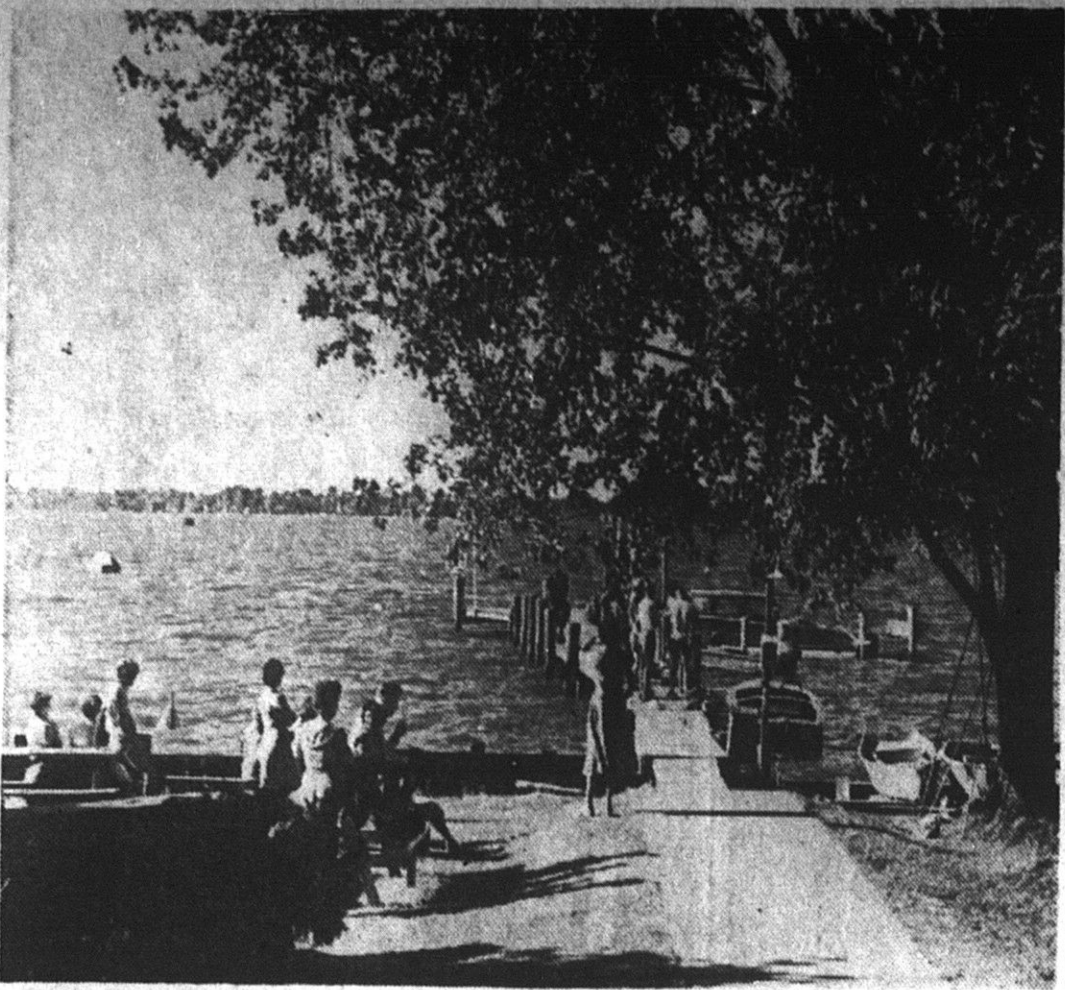

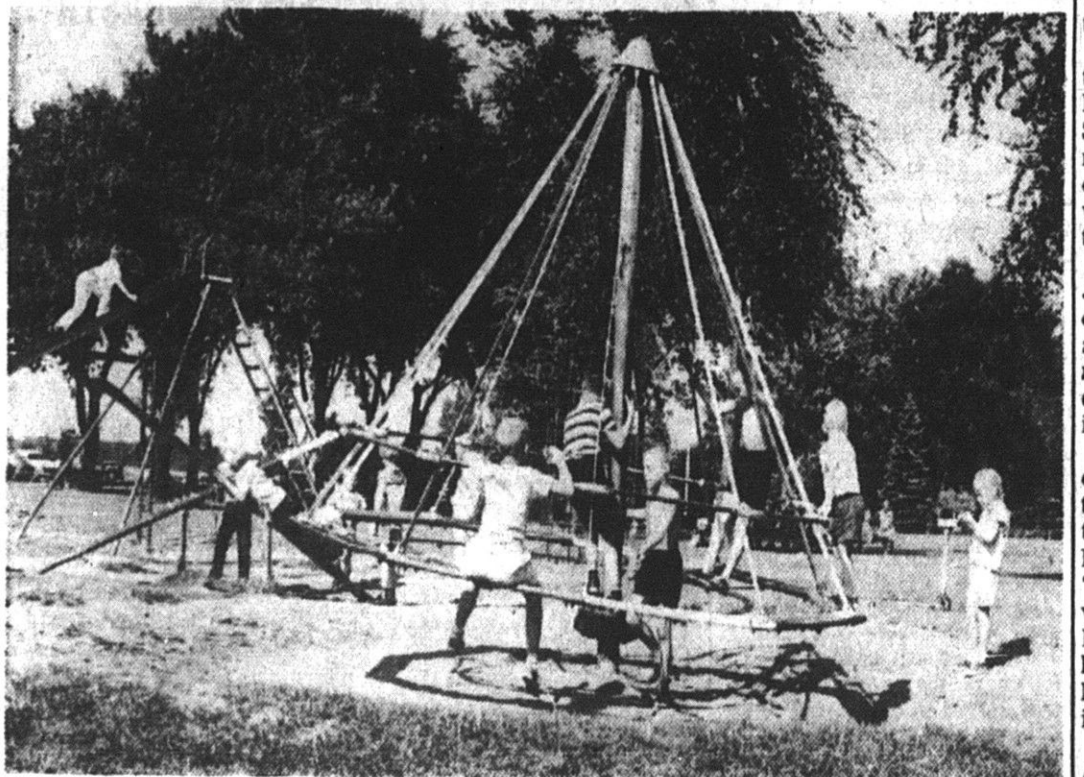
Boy, 4, Has Sore Nose After Dog Bites Him

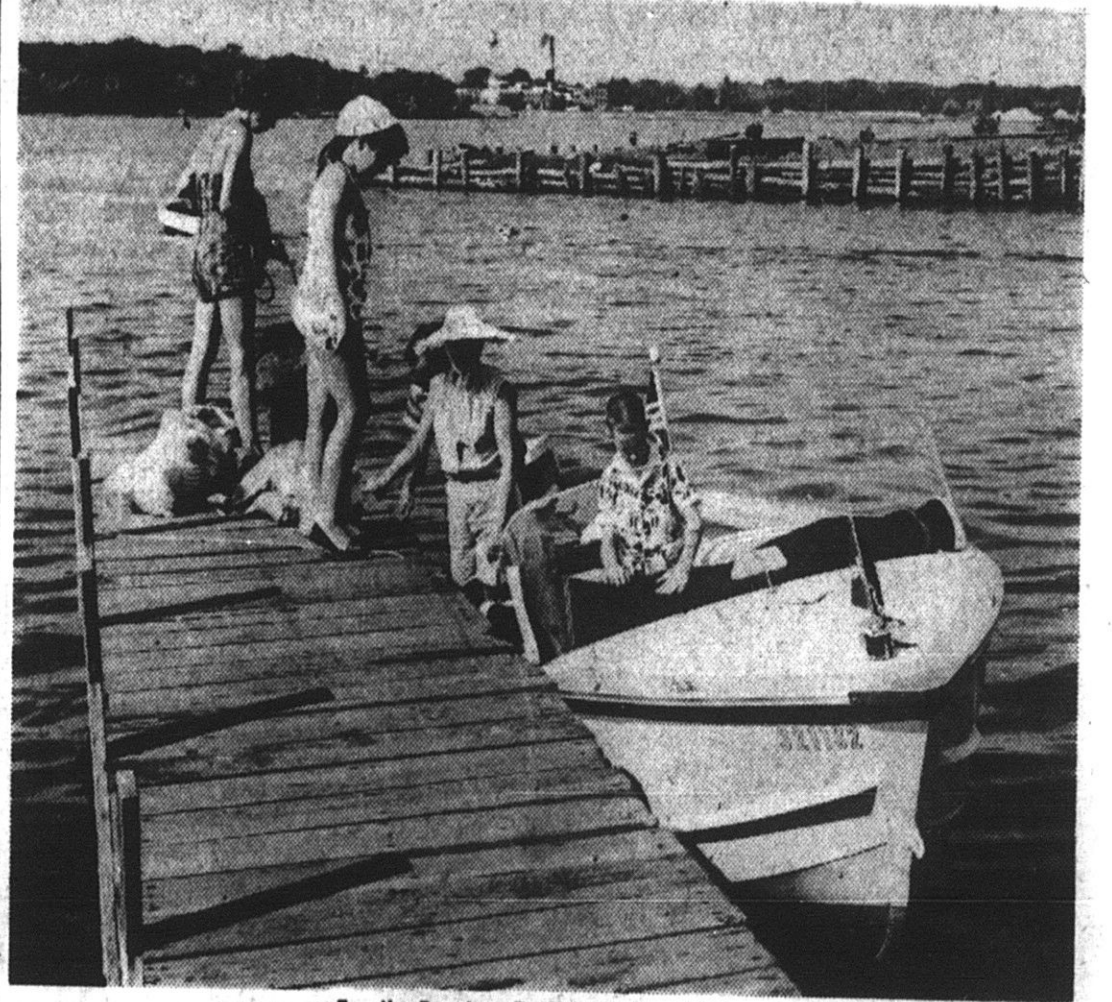

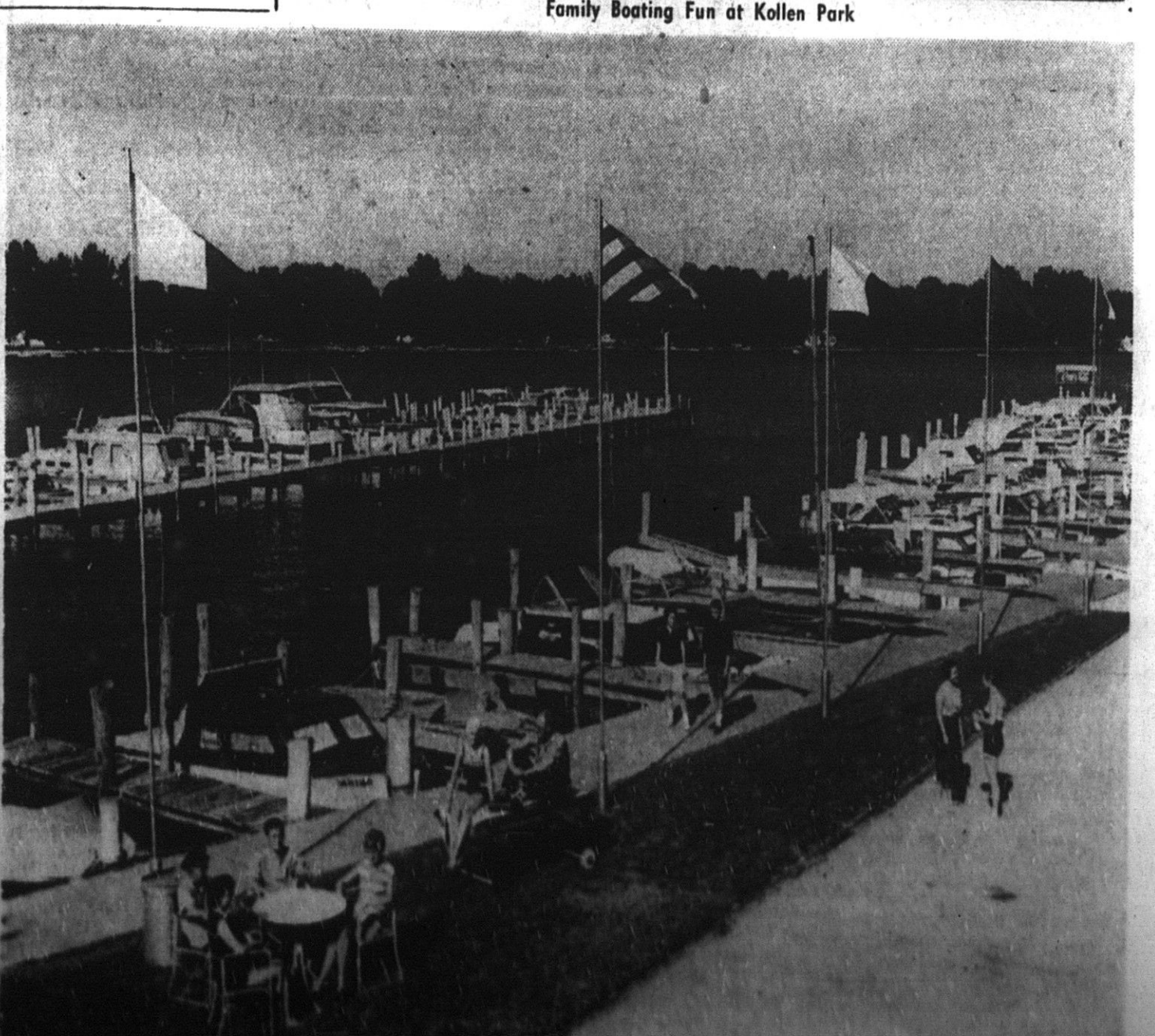

Remodeling Of Old Jail Considered

Board of Supervisors Seeking Quarters for Two Departments

GRAND HAVEN (Special). — With a new jail under construction for Ottawa County, the Board of Supervisors Monday afternoon discussed possible changes in "courthouse square" with emphasis on the possibility of remodeling the present jail building for occupancy for the education and welfare departments.

Herman Windemuller of Park Township, reporting for Buildings and Grounds Chairman Case Szopinski who is awaiting surgery in Grand Haven Municipal Hospital, quoted a figure of \$7,597.21 for altering and repairing the present jail building, but the board debated whether such a sum should be spent on an old building when there is a possibility a new court house or court house addition may be erected in the next few years. There was some discussion on an alternative to purchase other property and to place the two departments in temporary quarters.

Henry Slaughter of Talmadge Township said it would be five or six years before the county could consider a court house addition. He said unless the board arrives at a different way of raising funds, the new budget will not include fees since these fees will be needed for the building fund.

Upshot was that the buildings and grounds committee and the ways and means committee was to make further recommendations at this afternoon's meeting.

Windemuller also reported that Bud's Wrecking Service of Muskegon was low bidder for the demolition of the boiler room and garage next to the jail at a cost of \$1,389. Work was to have commenced a week ago but since demolition has not yet started, the committee may award the project to another bidder since it is imperative that the old building be taken down. The new jail is expected to be ready Jan. 1.

Hans Suzenaar of Holland, Civil Defense director for the county, presented a semi-annual report on CD activities with emphasis on literature on fallout shelters, the new county operational survival plan, training in radiological work, and reports on finances and equipment.

The county's CD budget for 1960 was \$15,500, plus matching funds from the federal government of \$9,000 and federal surplus properties valued at more than \$15,000. More equipment is expected later this year. The department maintains its control center in the county branch building with direct two-way teletype with the U. S. weather bureau, direct lines to radio stations and Red Cross, and direct two-way radio contact with many points in the state of Michigan, which can be extended to Battle Creek or Washington, D.C.

Gerrit Veenboer of Zeeland was welcomed as a new member of the board.

John Hassold of Chester Township invited all board members and heads of departments to attend a session at Camp Potawatomi today preceding the afternoon session.

The board set aside Wednesday, Aug. 17, as the day for the annual county picnic at Camp Potawatomi. The court house will be closed that day.

A communication from Engineer-Manager Hank Stafseth of the Ottawa County Road commission thanked supervisors for their participation in the dedication of Hager Hardwood Forest. Stafseth hoped the gift of this land would serve as a precedent for other land owners to donate property for park purposes.

A communication from Hon. John R. Dethmers, chief justice of the Michigan Supreme Court, thanked supervisors for the afternoon of sociability on John R. Dethmers Day last month and expressed appreciation that his portrait is hung in the court house.

The board is considering installation of a public telephone in the court house in an effort to eliminate long distance calls made out of various offices having no connection with the county.

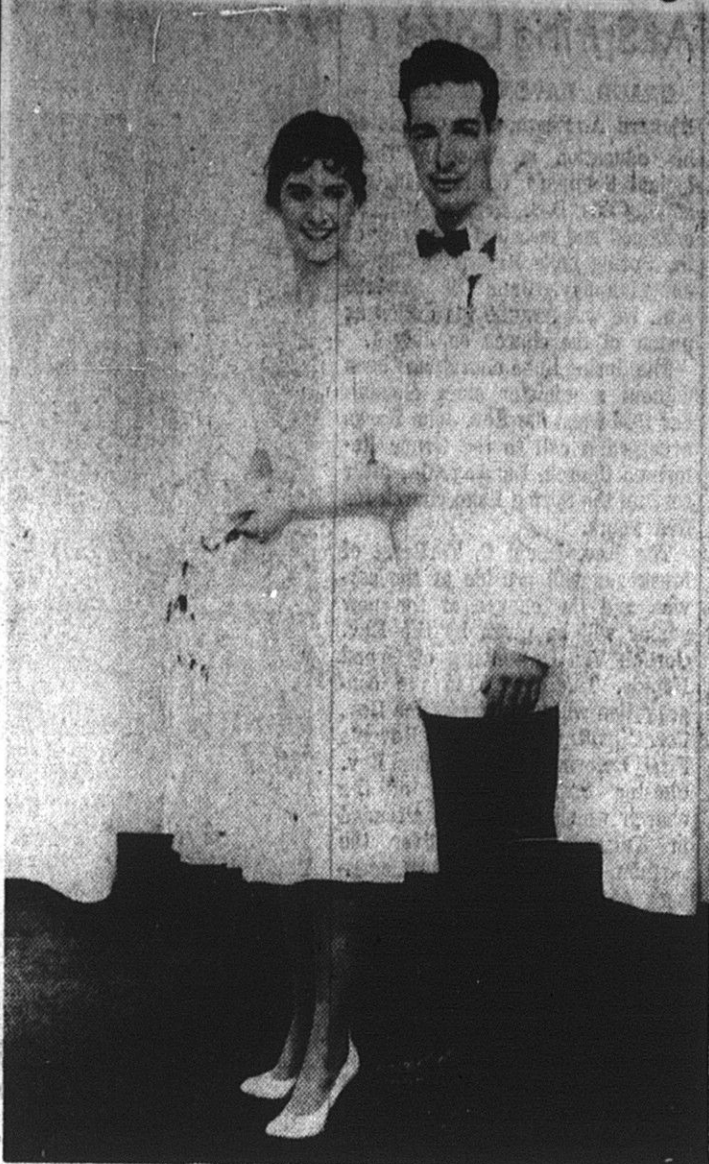
The board may act today on a resolution presented Monday on selling property on Hiawatha Dr. to Consumers Power Co. for \$6,600. The board approved a resolution to negotiate with the federal government for exchanging property in Olive Township for LU lands suitable for park purposes in Spring Lake Township.

The board delayed action on an offer to lease for oil and gas purposes county-owned land in Grand Haven Township near Agnew until more interest in this particular parcel is shown and more requests for drilling received.

Lawrence Wade, chairman of the officers and employees committee, reported on a restudy of the classification plan and pay schedule and said Ottawa County is seventh on the list of the Michigan Municipal Personnel Service, thereby delaying work here until Sept. 15. This time schedule would not allow completion in time for the budget for next year. Estimated cost of the reclassification is \$2,500.

The board reappointed Cornelius vander Molen of Holland, Justice, Eva Workman of Spring Lake, Edward Dinkel of Marne and Edward Weisman of Hudsonville to serve another year as a four-member administrative board for

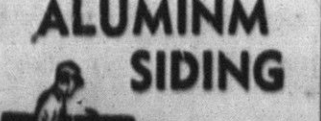
