Colored Utility Post Cards Eliminated

BPW to Change Billing System

Those familiar yellow, white and salmon colored post card bills received from the Holland Board of Public Service for electric, water and sewer services are becoming a thing of the past.

The manually operated billing machines used to produce those cards are being replaced by a computer system which will issue a single monthly bill for the three utility services. The bill will appear on a buff colored card.

Preparation of bills on the manually operated billing machines was ending this week. Postcard billing began by the BPW in 1942 with the use of a National Cash Register Co. utility billing machine. The original machine was used until 1957 when it was replaced with a newer model in use until the present time.

The continued increase in customers and number of bills being processed made it necessary to add a second billing machine in 1966. More than 1/2-million bills have been turned out on the two billing machines being taken out of service this month.

A buff colored bill is replacing the familiar yellow electric bill which has been issued monthly for the past 34 years. In addition to charges for electricity, the new bill will also include charges for water and sewer service with all three utilities appearing on one bill. Water bills were formerly issued on white bills and in 1959 billing began for sewer service using a salmon colored bill. Water and sewer service bills are issued quarterly and will be included on the new computerized bill four times a year.

Combining electric, water and sewer service bills on one bill has meant a rescheduling of meter reading routes. Water meters will now be read at the same time electric meters are read.

The BPW service area is divided into three reading sections.

All the electric meters are read each month and approximately one-third of the water meters are read each month.

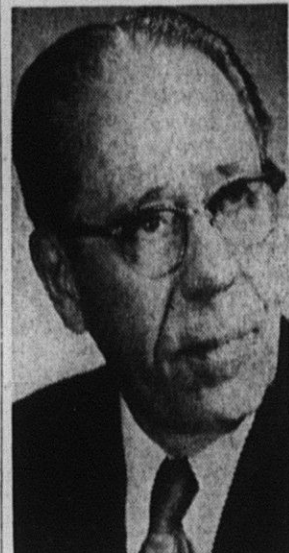
A fire marshal from the Paw Paw state police post has been called into the investigation. The loss to the vehicle was placed at \$14,000.

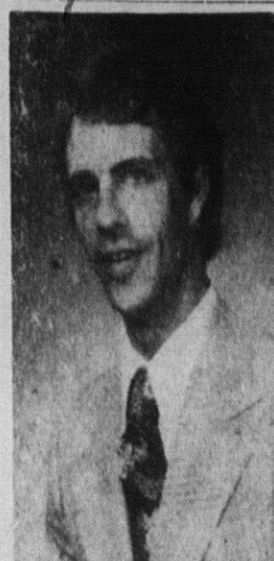

Delay Action On Women's Ordination

MADISON, N. J. — The issue of women's ordination to the ministry surfaced at the Reformed Church in America's General Synod, which ended Friday at Fairleigh Dickinson University.

While the issue had failed to win the regional approval needed to bring it to the General Synod for action, the Christian Action Commission included the question in recommendations dealing with human rights and social issues, submitted to the Synod.

Strong reactions on both sides resulted in action being postponed until some future time.

Other Christian Action Commission recommendations affirmed by the Synod included active opposition to state lotteries; support of the United Nations and concern for Vietnamese refugees.

A 10-point recommendation for combatting world hunger through simplified life-styles was affirmed, including a section calling for a reduction in the consumption of grain-based alcohol and use of tobacco, to provide more grain and acreage for its growth.

The just-completed General Synod is the 170th session of the Reformed Church in America, also referred to the Dutch Reformed Church, the oldest Protestant body in the country with a continuous ministry. The first congregation was organized in 1628 in New Amsterdam, now New York City.

Dr. Louis H. Benes of Grand Rapids was elected president of the Synod. Dr. Benes retired two years ago after 29 years as editor of the *Church Herald*, official Reformed Church magazine.

Consumers Halts Construction At Port Sheldon

Construction of a new generating unit at the Consumers Power Co. James Campbell plant at Port Sheldon was being suspended today as a result of a continued strike by pipefitters.

The strike by Pipefitters Local 70 began June 1.

A spokesman for Townsend & Bottom, Inc., of Ann Arbor, general contractors, said construction was being phased out this afternoon and the remaining 60 employees idled. An additional 50 tradesmen from other crafts have been idled since June 1.

Construction of the third generating unit was described as in the "basic stages" and circulating water pipe were being installed in the below-ground levels of the unit.

Construction began in October, 1975, and was scheduled for completion in May, 1980.

Zeeland Locks Doors To City Hall

ZEELAND — After repeated and extreme cases of vandalism, the Zeeland City Council approved the locking of City Hall doors except during regular weekly office hours. The decision was made at the meeting of the council Monday evening.

The City Hall's doors had remained unlocked since it was built in 1934 in order to allow citizens to use meeting rooms and restroom facilities. However, since the Zeeland Police Department has begun closing their offices in the building at 5 p.m., the problem of vandalism has accelerated, City Clerk Leon Van Harn said. Incidents such as broken mirrors and stolen supplies in the restrooms and damage to pop machines have been occurring, he said.

The council also approved engaging the firm of Gabriel, Roder, Smith and Company of Detroit to prepare an actuarial evaluation of the city's present employee retirement program and several proposals for revised pension programs.

The council approved contributions of \$250 to the Holland American Legion for its July 4 fireworks display, \$2,445 to the Zeeland Bicentennial Committee and \$500 to Zeeland Environmental Action Leadership for community service programs.

The council also accepted a \$200 contribution from Meijer Inc. on behalf of Jon Morren, a Meijer employee and resident of Zeeland. Morren had won the "Fred Meijer Community Service Award" and requested the money be given for the city's municipal center programs.

Woman Loses Foot Climbing on Train

Judith Snow, 24, of 8095 112th Ave., attempted to climb across a freight train stopped on a crossing at Lincoln Ave. south of Eighth St. Thursday at 11:54 p.m. when the train started to move.

Police said the woman was climbing between cars of the train when the train lurched as it started and she lost her footing and fell. The wheels of the moving train apparently ran over her left foot and severed it.

She was taken to Holland Hospital where her condition Friday was listed as "fair."

Officers said the woman was attempting to cross from east to west and the train was northbound.

Ottawa County deputies said the two were traveling along trails when Kluitenberg fell and both cycles came together and overturned.

Coast Guard Asks End To False Calls

Holland Coast Guard officials, faced with an increasing number of distress calls monitored over CB radio channels, today urged CB users to refrain from making false reports.

Coast Guard officials from Holland, Muskegon and Chicago responded to two such calls naming the same boat Tuesday and no sightings resulted.

CB radio calls were monitored early Tuesday by the Ottawa County sheriff's department and a resident in Wyoming which claimed the boat *Yellow Jacket* was in distress off Holland Harbor.

CB radio calls were monitored again Tuesday night by a CBer in Muskegon listing the boat *Yellow Jacket* in distress off Bronson Park at Muskegon.

The Muskegon Coast Guard launched a search at 9 p.m. Tuesday and terminated the search at midnight.

Holland Coast Guard Chief Ronald Perry said the Holland search cost the taxpayers \$56,000 for the 9.6 hours of searching Lake Michigan from Port Sheldon south to Saugatuck and ten miles into the lake.

The search involved ten men from the Holland station and one boat and three crewmen from Chicago along with a Coast Guard helicopter.

Perry said the apparent false reports of boats in distress on CB radios has increased along with the popularity of the radios.

"Boaters in distress usually continue on the radio until help arrives and give more accurate information about location," Perry said. In the recent CB reports the caller has failed to remain on the air after contact by other CBers, has been established.

Perry said use of CB radios is under the FCC jurisdiction and making false emergency reports is subject to a \$10,000 fine and jail term.

Holland Man, 22, Waives Exam In Armed Holdup

GRAND HAVEN — David Anthony Thomann, 22, of 143 James St., Holland, waived examination in Ottawa Circuit Court Monday to a charge of armed robbery in a holdup June 2 at the Mini Store West, 220 West Eighth St., Holland.

A plea of innocent was entered by the court for him.

Thomann was arrested along Graafschap Rd. minutes after a police radio broadcast with a car's description. Police said a male subject entered the store and demanded a clerk fill a bag with money. Thomann's bond of \$25,000 was continued.

Bassardet, 19, of 326 North 143th Ave., Holland, and Tony Ray Bakker, 18, of Zeeland, pleaded guilty to attempted forgery and Arthur J. Stickney, 23, of Holland, pleaded guilty to larceny of a bicycle.

Bassardet and Stickney are to be sentenced Aug. 2 and Bakker on Monday.

CD Siren Test Planned Friday

Civic Defense warning sirens in Ottawa County will be tested Friday at 11 a.m., according to Glen Timmer, county CD director.

The tests are run periodically to test the equipment and to acquaint the public with the warning procedures. A one minute steady tone will be sounded followed by a minute pause and then a minute of a wailing tone.

In actual emergency situations the steady tone would alert residents to tornadoes or other local disasters while the wailing tone would be used to warn of an attack against this country.

GRAND HAVEN — Three persons were injured in the collision of two cars Sunday at 7:57 p.m. along Lincoln Rd. southeast of 136th Ave. in Robinson Township.

Taken to North Ottawa Community Hospital for treatment were Thomas A. Snyder, 23, of Grand Haven; his passenger, Ruth E. Taylor, 18, and Larry R. Schippers, 24, all of Grand Haven.

Ottawa County deputies said Snyder and Schippers were traveling together westbound along Lincoln when the Schipper car was struck in the rear by Snyder.

West Ottawa Approves New Budget

A tentative 1976 - 77 budget of \$6,307,421, which includes a reduction of \$186,000 was adopted by the West Ottawa Board of Education Monday night. The board will adjust the reductions in various operational divisions at a workshop session.

Business manager Gordon Scheerhorn reported that the high school drain field is not functioning properly and preliminary testing indicates that an additional and larger septic tank and complete new drain field may be indicated. The administration emphasized that the projected \$30,000 cost figure is based strictly on initial testing and the actual cost may be higher or lower.

Supt. Brad Henson also indicated that the high school may be mandated to operate under a new water system soon.

The board indicated its desire to merge with the Holland adult education program to form a Holland area community education program. A letter stating this desire is to be sent to the Holland Board of Education.

Henson reported that the board of canvassers has certified the recent election as official.

Approval was given to a schedule adjustment for girls track for both the varsity and assistant varsity coaches.

Appreciation for service was adopted by the board for retiring teachers Bernice Cook and Evelyn Joyner.

The board approved the change of general auto mechanics to automotive fundamentals which will be a prerequisite for vocational center classes.

Henson also informed the board that a quota system for each high school utilizing the operation. The skills center was constructed with the philosophy that many of the skills courses offered throughout the area will be continued, thus making the quota system necessary.

Board member Don Ladewig questioned the feasibility of spending money to transport singular students or just a few to courses in Grand Haven and Fennville. I am recuperating well but am still limited in my activities. I don't like the idea of missing my last West Ottawa board meeting. I want to express my appreciation for the many years of pleasant and progressive association with the many board members, administrators and staff members."

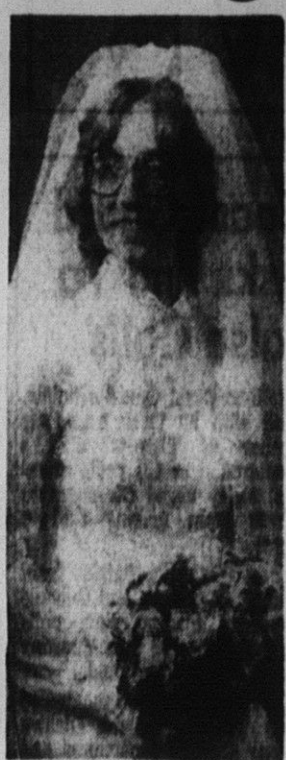

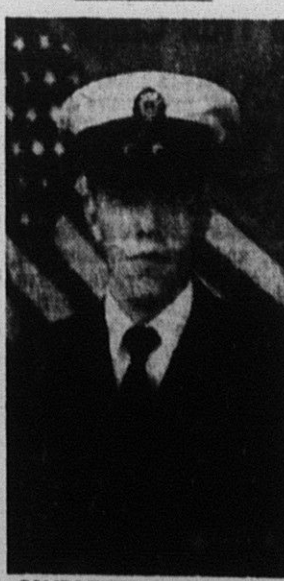

A few minutes later, after pulling himself together, Spoelman replied, "Now, I just hope we can play in the finals like we have all season."

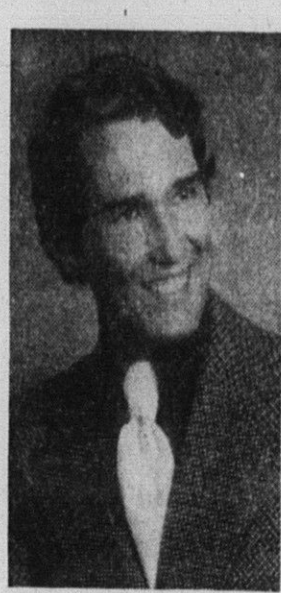

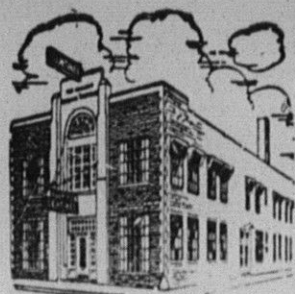

IN THE COURIER'S FOOTSTEPS

Arguably the most dazzling event of the summer Olympics is that melange of skills known as the pentathlon. As is fitting, the event has its origin in the imaginary ordeal of a military courier in Napoleonic times — a dashing fellow who plunges through the enemy lines on a horse he's never seen before, gets into a sword fight when the horse is shot out from under him, draws his pistol to deal with more of the enemy, escapes and swims a river, then runs cross-country to deliver his message to an officer.

Hence, the modern pentathlon. First the competitor strides a horse unfamiliar to him, and puts it through a course including tough jumps. Next he fences in succession with all the other competitors — maybe 50 or 60 of them — in a one-touch bout. After that he gets 20 shots at a target, swims 300 meters, runs 4,000 meters cross-country — and collapses.

Happily, not all these feats must be accomplished in one mad burst of activity; the pentathlon spans five consecutive days. Even so, it is demanding. Which lends special point to what happens at the end. Following his ordeal the mythical courier swigs water from a canteen. His modern counterparts wind up with a party at which they, too, do some swigging — but not water.

And what momentous conclusions do we draw from all this? None. It just struck us that this Olympic event, serious enough yet carried off with such zest and panache, could do with a bit more attention than it usually gets.

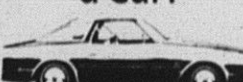

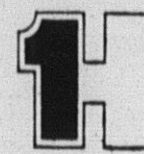

Schools To End Report Card System

The Holland Board of Education Monday adopted a revised elementary grades report card system, authorized a bond application for the new junior high school, bought an insurance package and a boxcar load of paper and sold some property during a two-hour meeting.

Procedures for reporting to the parents in elementary grades call for parent teacher conferences each year in November and March. The conferences along with write-ups of the procedures are to replace report cards.

Academic reports and personal growth summaries are to be sent home with children on the last day of school in June. The procedures have been under study 18 months by a committee of elementary teachers and personnel directed by Dennis Van Haitsma, principal of Maplewood school, and Don Rohlek, principal of Harrington school.

The board authorized an application for a bonding proposal for the new junior high school be submitted to the Municipal Finance Commission. Lee Van Aelst, assistant superintendent for business, said the bonds would be repaid in 26 years instead of the original 30 years with increased debt retirement during the middle years of the bond issue resulting in a savings in interest and taxpayer money.

Planning for the new junior high school in the area of 24th St. and Plasman Ave. continued but Van Aelst said attorneys were working with Wolverine Pipeline Co. which has an easement on the property for an underground oil pipeline.

The line runs toward Lake Macatawa and the old Montello oil docks. Agreement is being sought for the removal or relocation of the pipeline away from the site of the school.

The board adopted a resolution of "tribute and commendation" for Mrs. Abby Price and Charles Armstrong, chairpersons of the Citizens Campaign for a junior high school.

A contract for school district insurance was awarded the Holland Insurance Agency for a package with Continental Insurance Co. on the recommendation of the Insurance Audit and Inspection Co. which reviewed all bids.

The Graham Paper Co. was awarded a contract for paper for the school district for the 1976-77 school year on a bid of \$10,498.20 for a boxcar load.

The paper is for use in duplicating machines in the school system and amounts to 4,075,000 sheets.

School district property in the area of 25th St. and Washington Ave., declared surplus, was sold on the high bid of \$6,105 to Hazen Van Kampen.

The board accepted a \$4,204 grant from the Holland Community Foundation and awarded a contract to Martin Dyke and Sons of Holland for construction of a metal canopy at Jefferson elementary school for special education students arriving by bus. The covered walkway would be at the west entrance and allow special education buses to drive beneath the canopy and load and unload students.

The board authorized a number of staff appointments. John R. Olsen, a graduate of Western Michigan University and a residential builder, was hired for high school woodshop; Mary Pollock of Grand Valley State Colleges was hired under the college's intern program for high school hearing impaired; Debra Ensing Musse, a GVSC graduate, hearing impaired at Jefferson school, and Dan Goodwin was named director of vocational education.

A recommendation to create a position as Title I coordinator was tabled for additional study.

Mrs. Nancy McNiven was granted a maternity leave from Longfellow school. Mrs. Emily Mouw retired after ten years in the school system, the last nine at Longfellow and Mrs. Karen Gee resigned from teaching.

The official vote tabulation in the June 14 school election was submitted by the county board of canvassers and showed 5,121 votes were cast in the bond issue of which 2,593 were in favor and 2,528 against.

In the school board election 4,106 votes were cast of which 4,099 were for candidate Charles L. Bradford; two for Ken O'Meara and one each for Randall Vande Water, Bob Goselar, Ann Moore, Roger Doolittle and Jessie Dalman.

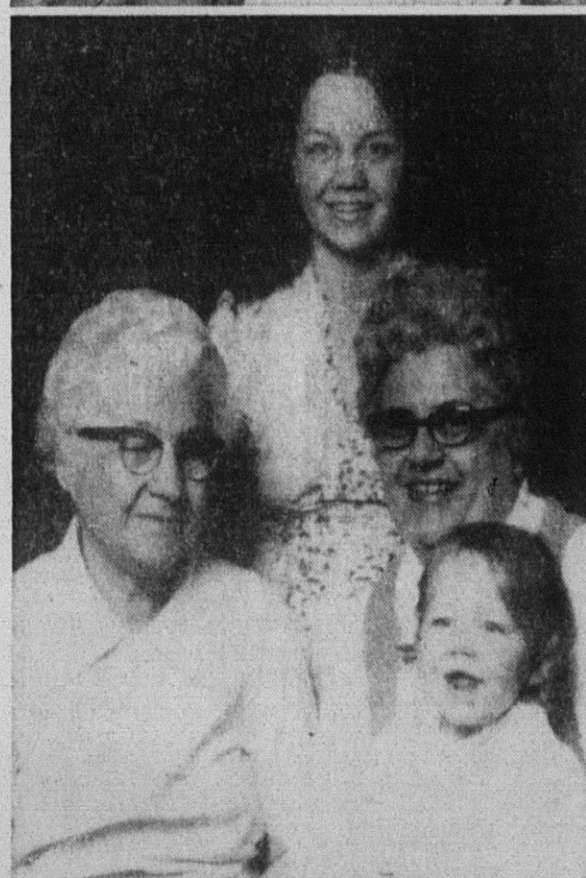

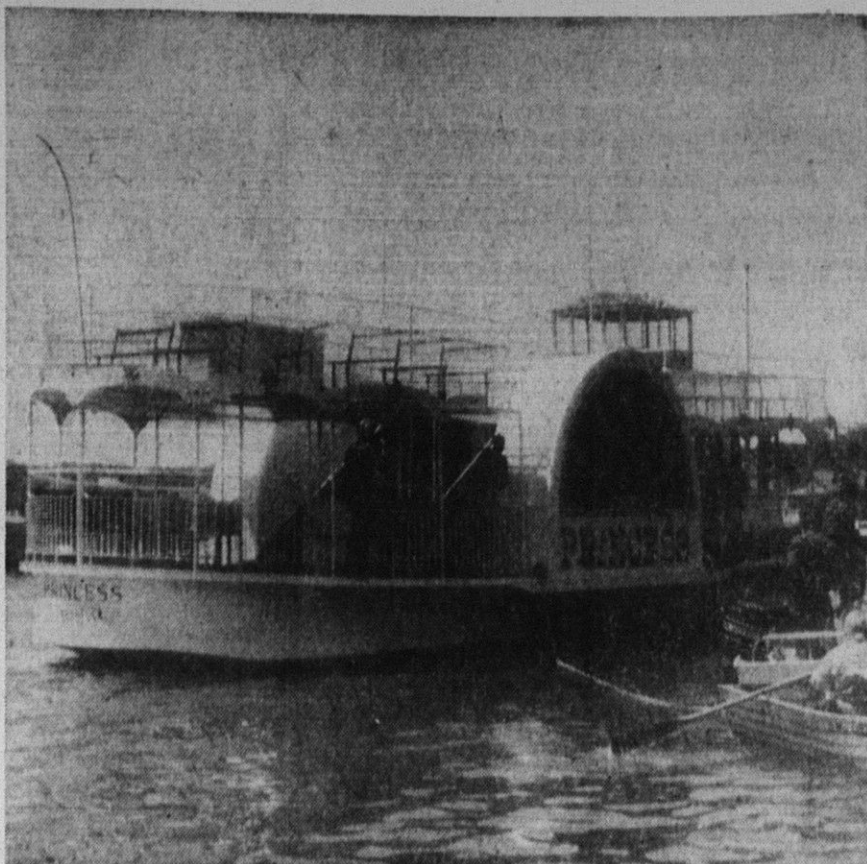

Launch Princess At Saugatuck Site

SAUGATUCK — With more than 300 friends and well-wishers on hand to help — by keeping their fingers crossed and, in more than one case, to step in and push — Dick and Debbie Hoffman launched their fourth and largest family - built river excursion boat Saturday afternoon.

The Princess, first side-wheeler to be built by Hoffman, was designed to carry 165 people, nearly double the capacity of the last Island Queen. The "queens" all have been stern wheelers.

Saturday's launching ceremony marked the end of nearly four years work by the Hoffmans, with construction delayed for a time by a shortage of steel.

Burr Tillstrom, originator of the Kukla, Fran and Ollie television puppet show and friend of the Hoffmans, spoke at the launching. The Rev. Verne Hold, pastor of the Saugatuck Episcopal church, delivered the blessing and the actual christening was handled jointly by Kate and Anne Hoffman, daughters of the builders.

The launching was not entirely without incident. A jack slipped and hit Dick Hoffman as he was greasing the ways with 30 pounds of lard. His wife, pushing the boat while standing knee - deep in water, slipped and went under briefly just as the boat eased into the waters of Lake Kalamazoo.

The two tugs which were pulling from mid - stream then lost their lines and there were a few tense moments as the boat drifted without steerage or power toward shallow water. Finally the tugs regained control and The Princess was eased back to the bank where outfitting will be completed this

week preparatory to Coast Guard safety checks.

The Princess is 64 feet long and 24 feet wide at the paddle wheels. Power is provided by diesel operated hydraulic motors so each wheel can be controlled independently. Hoffman said top speed will be about 10 miles per hour. The boat has a draft of a little more than two feet.

The Hoffmans hope to have the boat operating on a regular scheduled by the Fourth of July weekend.
