New Library Won't Open On Sundays

Board Received Many Protests, None in Favor

Herrick Public Library will not be open Sunday afternoons, it was determined at a meeting of City Council Wednesday night.

Technically, City Council took no action at all, other than to receive for information a report from the Library Board recommending that the library remain closed on Sunday afternoons after considering costs, protests, personnel problems and other phases. The determining factor appeared to be a number of written communications, all protesting the proposed opening. There were no communications favoring the opening.

The Library Board report stated it would require three trained personnel to operate the library for such a program and the cost was estimated at \$2,500 a year. The report also stated that no staff members now employed wished to work on Sunday.

Attached to the report were communications from organizations and persons protesting the opening. Added to these communications was one received by Council this week from the consistory of Central Avenue Christian Reformed Church protesting the proposed opening of the library on Sunday, mentioning among other things that this would be contrary to the Ten Commandments.

In other business, Council decided to retain the services of John Vander Meulen, Chicago architect and son of Municipal Judge Cornelius Vander Meulen, in connection with remodeling former library quarters on the second floor of City Hall for Council and Municipal Court facilities.

The architect's services will consist of the necessary conferences, planning and design, working drawings and specifications, securing of proposals, handling of contracts and the necessary supervision of construction for a fee of \$1,000 which is 10 per cent of the proposed total cost of \$10,000. Vander Meulen's letter stated that Arthur Read, local building consultant, would assist in supervision, with payment for his services included in the above fee.

A letter from Mrs. H. C. Fairbanks and H. E. Kooker pointed to problems on erecting a fence at a parking lot at 540 Michigan Ave. in which the required height is protested by adjoining neighbors. Mr. and Mrs. Clarence Bouman, of 533 Pine Ave., who already have constructed an 18-inch log fence on the lot line which they feel should be sufficient. The matter was referred to the city attorney for study and possible redrafting of ordinances that a power to deal with such cases be vested in the Board of Appeals. Under present law, the board has no power to waive such requirements.

A communication from Mary Jo Lang, secretary of the citizens committee for the promotion of decent literature, informed Council that the committee is now organized and operating under a constitution. The letter requested recognition, endorsement and financial support. Council adopted a resolution recognizing the committee, endorsing the purpose of the organization but tabled consideration for financial support until such time as a request in definite form is submitted by the organization.

On recommendation of City Manager Herb Holt, Council okayed a request from Park Township for \$1,800 for airport support, and also granted permission to Park Township residents on the south side of Lake Macatawa to use the city dump for an annual fee to the township of \$500. In studying the dump request, the city engineer felt that while \$500 will not compensate for all nonresidential use of the dump, it is a reasonable amount for that area in Park Township south of the lake.

Council approved the manager's recommendation to delay sidewalk construction on the west side of Pine Ave. between 26th and 28th Sts. for one year on request of Mrs. Fred Dorgelo, 103 West 28th St., and Mr. and Mrs. Harold Chaddock, 105 West 27th St.

Council approved the manager's recommendation for a building permit to enlarge and remodel an existing gasoline service station at 581 State St., subject to curb cuts and that a frame garage at the rear of the property be used for no purpose other than parking of cars connected with the use of existing living quarters.

A letter from Holland Tulp Time Festival, Inc., requesting permission to use the Ferris and Wagner lots on West 12th St. for tulip display planting was referred to the city manager for study and report. A communication on a public hearing of the Michigan State Highway Department today in South Haven High School on the proposed Interstate 96 route was accepted for information.

The oath of office of Kenneth J. Weller as a member of the Library Board was filed. The following hospital gifts were accepted with thanks: Margaret

Hammer guild, supplied for expectant mothers classes, \$19.50; Ebelink Florists, magazines and magazine covers for lobby for one year; East Saugatuck Girls Society, 14 pillow dolls for pediatric department; Hospital Children's Guild, one rocking chair for pediatric department, \$24.95; Hospital Auxiliary board, two oxygen tents with high humidity, \$1,216.75, and 12 folding tablet arm chairs for practical nurse students classroom, \$99; Abraham Leenhouts guild, wheel chair for admitting office, \$72.98.

A liability claim from Gertrude Lievense, of 6 West 19th St., for injuries incurred when she fell on a sidewalk in front of Dairy Maid Milk depot on West 19th St. May 6 was referred to the liability company and city attorney.

A petition requesting that the remaining portion of 34th St. be blacktopped between Pine and Central Aves. was referred to the city manager for study and report.

C. Piersma, of 11 West 14th St., appeared before Council seeking water service for property at 577 South Shore Dr. After considerable discussion in which it was determined that the property is fairly close to existing water lines, Piersma was instructed to get in touch with the city manager to work out arrangements.

Councilman Ernest Phillips presided at the meeting in the absence of Mayor Robert Visscher and Mayor Pro Tem John Belman. Also absent was Councilman Henry Steffens. Councilman John Van Eerden gave the invocation. The meeting lasted an hour and 50 minutes.

Many Cases Processed in Circuit Court

GRAND HAVEN (Special) — Several persons appeared in Circuit Court Wednesday, some for arraignment and others for disposition of their cases.

Glen Vernon Holtzlander, 38, Sparta, waived the reading of the information, stood mute and a plea of not guilty was entered on a manslaughter charge arising out of an altercation May 24 at a car auction sale at Coopersville in which Earl Welcome, 52, Muskegon, was injured and died several days later. Holtzlander's bond was continued. Trial will be held during the October term.

Jerry Lee Jackson, 19, Clare, who pleaded guilty June 21 to enticing and soliciting two little girls in Marne, was sentenced to serve six months in the county jail. He will be given credit for 24 days already served while awaiting sentence.

Ferd Reynolds, 44, Coopersville, who pleaded guilty June 24 to a drunk driving appeal, was sentenced to pay \$100 fine, \$30 costs and five days in jail. He was given credit for one day already served. At a nonjury trial before Justice Lawrence De Witt May 22, Reynolds was sentenced to pay \$100 fine and \$34.80 costs and serve five days, and he immediately filed a \$100 appeal bond to the higher court.

William Young, 48, Spring Lake, who surrendered his operator's license for 90 days, following conviction of drunk driving June 16 in Municipal Court, had his license restored at a hearing today. He is a salesman for a Grand Rapids firm.

Prosecutor James W. Bussard has filed a petition and Circuit Court has issued an order for a bench warrant in the case of Frank D. Lorenz, 29, Allendale, charged with nonsupport of his wife and six children.

Probe Breakin At Local Dairy

Holland police today are investigating an early morning break-in at Maple Grove Dairy at 676 Michigan Ave. in which \$75 worth of cigarettes was taken.

Police said the break-in apparently occurred between 1 and 7 a.m. Wednesday. The burglars, believed to have been youngsters, entered the building through an unlocked rear window.

The thieves spilled a bottle of ink in one of the dairy's trucks, and what was first believed to have been the work of pranksters led to the discovery of the break-in when employees found ink smears inside the building.

Owners Gerald Mannes and A. J. Helder said that the cigarettes appeared to be the only items missing.

Calls for Outstanding Con - Con Petitions

Avery D. Baker, con-con petition chairman for the Holland area, issued a call for all outstanding petitions today in order to have them filed in Lansing by the Friday deadline.

Persons with petitions properly notarized may mail them to the Michigan Junior Chamber of Commerce in Lansing, or telephone Baker at EX 2-9271 to have them picked up and taken to Lansing on Friday.

Baker said that although the petitions already filed appeared to be enough to qualify the issue for the ballot, all outstanding petitions were needed to serve as insurance in case too many petitions are thrown out for various reasons.

ZEELAND (Special) — Three-year-old Alice Mc Mullin, daughter of Mr. and Mrs. William Lee Mc Mullin of Bastrop, La., was reported in good condition Wednesday at Zeeland Hospital with head injuries suffered in an auto accident at 10 p.m. Monday on 96th Ave. near Tyler St. north of Zeeland.

The child's mother, Esther, 19, and brother William Jr., 9 months, were released after treatment for abrasions and contusions. Mc Mullin was not injured in the crash. Ottawa County deputies said the Mc Mullin car rolled over several times when Mc Mullin swerved to avoid hitting a car driven by Nelson Jay Gebben, 29, of route 1, Zeeland, which had turned left in front of the McMullin car. Deputies said McMullin's 1960 foreign model car was demolished.

Lansing Youths Plead Guilty to Charges

Three Lansing youths pleaded guilty today in the Justice Court of Wilbur E. Kouw to charges of entering without breaking and malicious destruction of property following their arrest by Ottawa County deputies Wednesday night for entering a house under construction in Maricoba subdivision about two miles northwest of Holland.

Robert J. Stetson, 17, Kenneth R. Williams, 20, and Louis M. Kulpa, 21, were each fined \$15 and \$4.90 court costs and sentenced to three days in the county jail. Stetson and Williams paid their fines. Kulpa is attempting to raise the money. If his fine is not paid, he will receive an additional seven days in jail.

Harrington Voters Turn Down School Annexation

Voters in the Harrington school district Tuesday turned down a proposal to annex to the Saugatuck school district by a vote of 417 to 177. A total of 599 votes were cast, and there were five spoiled ballots.

It was the first election as a registration district for Harrington which lies partly in Laketown Township of Allegan County and Park Township, Ottawa County. Legal difficulties had forced the cancellation of two previous elections on the issue.

Mrs. Claire Allen, president of the Harrington school board, said that no further school or political alignment issues are in the immediate offing, although Tuesday's election leaves the district's problems still unsolved.

Mrs. Allen expressed confidence that Harrington's ninth graders would be able to attend the West Ottawa School north of Holland for the coming school year. West Ottawa Superintendent Lloyd Van Raalte said there has been no such agreement worked out yet, but that the West Ottawa board will meet to consider the question.

Van Raalte said it is the policy of the West Ottawa board to offer its assistance to the people in those districts which are earnestly trying to solve their school problems.

Both Mrs. Allen and Van Raalte emphasized that the West Ottawa acceptance would be only on a temporary basis, since state school officials have indicated they could not approve a consolidation of the two districts.

If West Ottawa does accept the Harrington students, it will place Harrington high school pupils in three different high schools — two classes at Saugatuck High and one each at Holland and West Ottawa.

The outcome of the election means that the Harrington school board election set for July 11 will be held.

The terms of Mrs. Lambert Van Dis and John Reimink are the expiring board memberships.

Funeral Services Held For Ex-Ford Official

Funeral services were held Tuesday at the Langeland Funeral Home for Norman C. Heeter, 88, of 635 Byers St., NE, Grand Rapids, and formerly of Holland.

The Rev. John O. Hagans officiated and burial services were held Wednesday at 2 p.m. at the Pleasant Grove Cemetery in North Manchester, Ind. Mr. Heeter died Sunday morning at the Grand Rapids Osteopathic Hospital following a short illness.

Surviving are one son, Herschel of Grand Rapids; four daughters, Mrs. Nina Beye of Los Angeles, Calif., Mrs. Emma Hulbert and Mrs. Vera Toohy, both of Grand Rapids, and Mrs. Lura Smith of Cedar Springs; 22 grandchildren; 51 great grandchildren, and seven great, great grandchildren.

Zeeland Police List June Accident Figures

ZEELAND (Special) — Zeeland police today reported seven property damage accidents in the city during June. There were no persons injured in accidents last month.

Property damage resulting from the mishaps was estimated by police at \$1,290 as compared with \$675 damage resulting from two property damage accidents for the entire month of June 1959. Police listed speeding and disobeying traffic signals as the two biggest traffic violations.

City Council Adopts New Ordinance

City Council Wednesday night adopted a new public safety ordinance governing civil defense and disaster control, to take effect July 27.

The new ordinance provides for a department of Civil Defense within the executive department of city government with the city manager or such other person as he may appoint as CD director.

There will be five deputy directors with responsibility for financial services, law enforcement, fire control, engineering services, and health and medical services to be appointed by the city manager. These appointments will so far as possible be additional duty assignments to existing personnel. It is the intent of the ordinance that civil defense and disaster assignments be as nearly consistent with normal duty assignment as possible.

In event of actual or threatened enemy attack or natural disaster, the mayor will declare a state of emergency within the city, thereby placing in effect the civil defense and disaster control plan, and City Council will convene to perform its legislative and administrative functions as the situation may demand. Council will have the power to terminate the state of emergency. The mayor may request the state or other political subdivisions to send aid if the situation is beyond the control of the regular and emergency city forces.

The city manager will maintain general supervision over the planning and administration for CD organizations and the execution of CD and disaster plans. He may take all necessary action to conduct tests of civil defense and natural disaster plans, as well as assemble and utilize civil defense forces.

The CD director will be responsible for public relations, information and education regarding all phases of Civil Defense. He also will coordinate the recruitment and training of volunteer personnel and agencies to augment personnel and facilities of the city for CD purposes.

As soon as practicable a comprehensive Civil Defense and disaster control plan will be adopted on recommendation of the city manager. It is the intent that the services, equipment, facilities and personnel of all existing departments and agencies be utilized to the fullest extent possible.

Persons willfully obstructing or hindering CD organization will be subject to punishment under existing ordinances.

Council vote on the ordinance was unanimous. Council Nelson Bosman presided at a meeting of the committee of the whole for informal discussion.

Bicycle Riders Create Problems

Recent cases of bicycle riders running into automobiles in Holland have prompted Ottawa County Safety Director Avery D. Baker to urge parents to make sure their children can handle their bikes before allowing them to ride in traffic.

Often bikes are purchased too large for the child, with the idea that he can grow into it, and the result is that the child takes many spills.

Baker said that his office has received several complaints in the past few weeks about children riding at night without lights, sidewalk bikes on the streets and carrying passengers on the handlebars.

Since the problem is almost too widespread for only police correction, Baker has urged all parents to re-examine their children's bike habits in an effort to prevent more serious accidents.

R.C. Bosch Heads BPW

Randall C. Bosch, president of the Board of Public Works since 1954, was re-elected to another one year term Tuesday at a meeting of board members.

Bosch was first elected to the BPW in 1945. Adrian Klaasen, a member of the BPW since 1947, was re-elected vice president for his sixth one-year term.

Other members of the BPW are Henry S. Maentz, Don Vink and William De Long, Guy E. Bell is superintendent of the BPW.

The Board awarded Ted Brink of East Saugatuck the job of tearing down and clearing the site for the new Holland sewage disposal plant.

Brink will tear down homes at 24, 24 1/2 and 28 West First St., and homes at 17, 23 and 27 West Second St. Brink's low bid was \$825.

Local Police Place Second

The Holland Police Department's first team shooters surpassed all local records in placing second at the West Michigan Law Enforcement Association pistol shoot in Grand Rapids Thursday afternoon.

Sgt. Ralph Woldring and patrolmen Clarence Van Langevelde and Paul Niebor teamed up to shoot a total of 1,640 points out of a possible 1,800 to cop second place honors among Class A competition. Previous high for a Holland team was 1,610.

Woldring led the Holland first team shooters with a 552 score. Van Langevelde and Niebor each fired a 544.

The Grand Rapids first team fired a total of 1,666 to place first in Class A. The Grand Rapids second team finished third behind Holland.

Holland's second team of Sgt. Ike De Kraker and patrolmen Marvin Petroeje and Donald Piers collected a total of 1,470 points to win fourth position in Class B competition.

Petroeje led the second team with 515 points, followed by De Kraker with 507 and Piers with 443.

Teams from the Kent County Sheriff's Department and the Wyoming and Muskegon Heights police departments also competed in the meet. Each of the departments entered several teams, bringing the total number of teams competing to 14.

Antique Show Set At Saugatuck

SAUGATUCK (Special) — The Saugatuck Woman's Club is sponsoring the fifth annual Antique Show on July 8 through 11 at the Gray Building on US-31, south of the bridge. The show was formerly held in the Big Pavilion, which burned to the ground on May 6.

There will be 30 exhibitors this year the exhibit will be open from noon until 10 p.m. each day of the show.

Preparations are being made to show the antiques to the best advantage in the former Gray Gables building. Holland and Saugatuck antique collectors as well as others will show their collections at the affair. Refreshments will be available.

Among the exhibitors are Mr. and Mrs. J. Clevering of Niles, who travel to most antique shows with their Boston terrier, Pug.

Holland Youth Gets 15 Days

GRAND HAVEN (Special) — Reed Allen Kuite, 17, of 99 East 31st St., Holland, who was placed on probation June 22 for 18 months out of Circuit Court on a nighttime breaking and entering charge, had his probation modified by Judge Raymond L. Smith Wednesday to include a 15-day jail sentence.

Kuite admitted in court this morning that after leaving Grand Haven June 22 he drove in excess of 65 miles an hour. This was considered a violation of his probation.

Dennis Ray Allen, Jr., of 212 West 19th St., one of the four youths involved in the breaking and entering case April 24 in Park Township, also is serving 15 days in the county jail for the same offense. Both he and Kuite were driving different cars in a race home June 22. Allen was put on probation for two years June 23.

Jim Harthorn Dies in Car Train Crash

Auto Smashes Into Train at Riley St. Crossing North of City

A 40-year-old Holland father of three was killed early Friday evening in the first fatal traffic accident of the long Fourth of July weekend anywhere in the nation.

Mariusus (Jim) Harthorn of 169 East 27th St. died instantly after his car slammed into the side of a Chesapeake and Ohio freight train at a crossing on Riley St. about two miles north of Holland at 6:20 p.m.

Harthorn was thrown out of his car and crushed between the car and the train, according to Ottawa County Sheriff Bernard Grysen. Death was due to head injuries, according to medical examiner Dr. William Weststrate Jr.

Grysen said Harthorn was headed west on Riley St. when he struck the side of the diesel engine pulling the eight-car freight train. The train was headed toward Holland from Muskegon and was traveling about 45 miles per hour, according to engineer Russell Marsden of Muskegon.

The entire front end of Harthorn's 1959 model station wagon was ripped off by the impact. Harthorn's body was found 49 feet from the point of impact, Grysen said.

Grysen, who was about one-half mile from the accident scene, said that when he arrived, Harthorn was lying along the tracks. Grysen said there were no signs of life.

The car was spun around after the collision and thrown 40 feet from the road. Wreckage was scattered for several hundred feet down the right of way.

Grysen said Harthorn had tried to stop his car before hitting the train. Skid marks 74 feet long indicated he saw the train as it entered the crossing.

Persons living in the area said they heard the train's warning whistle. The train's crewmen said they did not see the car until the engine was at the crossing. All of the train's crewmen were from the Muskegon area. Crewmen said only four trains per day, traveling in each direction, use the Holland-Muskegon line.

Ottawa County Safety Director Avery D. Baker said that Harthorn was the ninth traffic fatality in Ottawa County this year. On the same date last year six persons had been killed, Baker said.

Harthorn was born in Holland and was a 1939 graduate of Holland High School. He was manager of the Zeeland Woodturning Works.

He was a member of the First Presbyterian Church. On Wednesday he had been installed as the new president of the Holland Breakfast Optimist Club. He was a veteran of World War II.

Surviving are his wife, Elaine Mae; three sons, James C., Steven W. and Mark Allen, all at home; his parents, Mr. and Mrs. John Harthorn of Holland; four sisters, Mrs. Richard Streur, Mrs. Harvey Weighmink, Mrs. Roland Van Dyck, all of Holland, and Mrs. Howard Jalving of Placerville, Calif.; two brothers, Cornelius H. and John H. Harthorn Jr., of Holland.

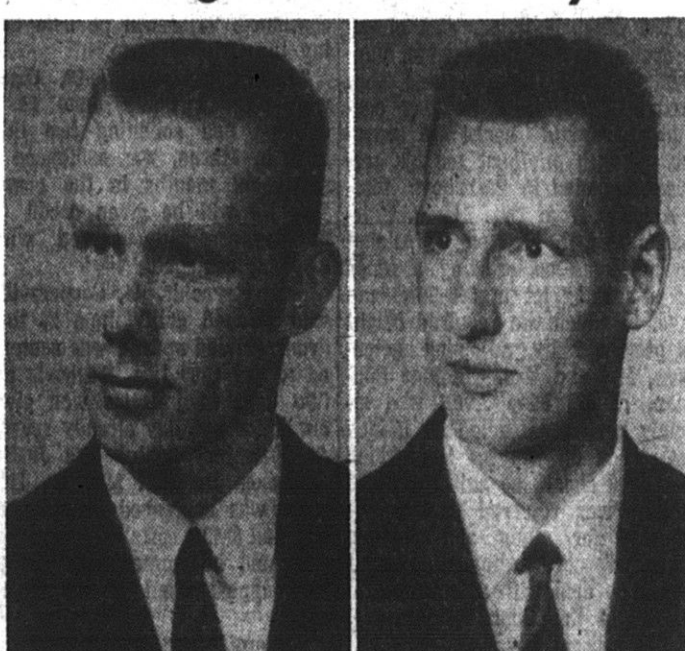

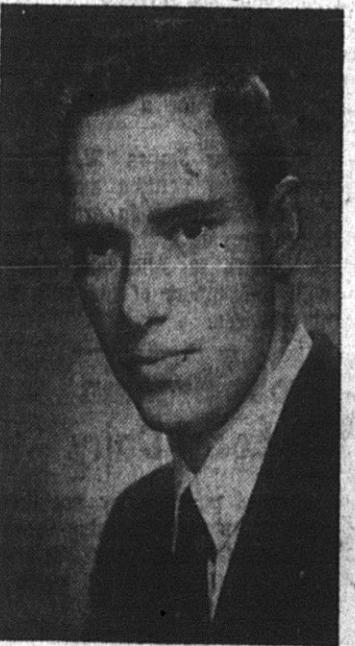

MICHIGAN CONSTITUTIONAL ISSUES

We have recently received a booklet, report number 201, dated June 30, 1960 from Citizens Research Council of Michigan.

This booklet has an introduction that lists the major constitutional issues and states "This publication discusses briefly, and without comment, those questions which appear to constitute the major points at issue."

As the necessary signatures must be acquired by the July 9, 1960 deadline, so that the proposed amendment will appear on the November, 1960 ballot, we are quoting the major issues from the booklet for your information.

"There are two basic issues which transcend others to the extent that they would appear to be controlling in the decisions that the voter must make at the several steps in the process of revising the constitution.

"One of these basic issues deals with the apportionment of the senate and, to a lesser degree, the apportionment of the house of representatives. The issue is both political and sectional. Politically, it involves what some feel to be present constitutional assurance of Republican control of the senate as apposed to the senate more evenly divided politically if elected on a strictly population basis. Sectionally it involves the question of increasing the legislative power of the three southeastern Michigan counties of Wayne, Oakland and Macomb, which have about 48 per cent of the state's population, but only 28 per cent of the senate seats. An increase for these counties would have to be at the expense of the other 80 counties, which now have the other 53 per cent of the state's population with 74 per cent of the senate seats and 57 per cent of the house seats. It cannot be assumed that the political and sectional interests are necessary identical. Crosscurrents are strong.

"The second basic issue is whether the people wish to relax the constitutional restrictions they have placed on the executive and legislative branches of government. In respect to the legislature the following questions seem more important. — Should the legislature be allowed to impose (or be prohibited from imposing) a graduated income tax?

—Should the legislature be freed of the restrictions on its taxing and spending powers that have been imposed through dedication of funds? (Sales tax diversion primary school interest fund, gas and weight tax dedication, etc.)

—Should the state's fiscal capacity be increased through increasing or eliminating the limitation on state borrowing?

—Should the legislature's control over spending be increased by removing from the civil service commission the power to fix salaries?

In respect to the executive, the major questions are these:

—Should the governor be given a four-year term? — Should the administrative structure of state government be integrated under the governor, with subordinate officials appointed rather than elected.

"The Research Council takes no position on the question of calling a constitutional convention. It is hoped that this discussion of Michigan Constitutional Issues will promote discussion of vital issues and assist the citizen in his deliberations."

"Tomorrow we will continue with 'The Process of Constitutional Revision' as published in the booklet. Everyone should make it a point to understand our governmental affairs. We are all part of the government and we pay the bills.

Sunday School Lesson

Sunday, July 10
Amos Demands Social Justice
Amos 5:10-15; 5:21-24
By C. P. Dame

Amos preached to God's people who had been favored in many ways. His book reveals that this elect nation was guilty of many sins. It was the aim of Amos to bring the nation to a realization of their sins and cause them to repent. However this did not happen for the nation went into exile on account of its disobedience.

1. No one can hide his sins from God. Amos knew God and he also knew the people to whom he preached. These people hated any one who reproved them in the gate and they abhorred "him that speaketh uprightly." The words "hate" and "abhor" are strong words but they truly applied to the hearers of the prophet. Most people do not like to be rebuked—it hurts their pride. Amos, who came from Judah, incurred the hatred of the northern nation because he preached publicly in the gate against their sinful ways. In ancient times the gate of the city was the place where justice was administered and where all manner of public assemblies were held and social gatherings took place—here Amos preached.

Amos had done some travelling in the nation and he knew much about the sins of the people. The rich oppressed the poor in various ways. They used their ill-gotten riches for luxurious living, building houses of hewn stone and planting pleasant vineyards. The poor were denied justice because the wealthy bribed the judges to give verdicts in their favor. When justice is tampered with, a nation is in a bad plight.

II. God tells us to hate evil and love the good. Conditions were so bad in the nation that the prudent people kept quiet because they were silenced by the wicked. It is charged today that in some labor unions honest workmen are not permitted to speak. When godly people are denied freedom of speech, conditions are deplorable. The prophet told his hearers what not to do and what to do. They were seeking the evil, he told them to seek the good. Evidently some loved evil, he commanded them to hate evil and love the good. The more a person loves the good, the more he will hate evil. The best place to begin hating evil and loving the good is in one's own home and heart. Evil has to be watched all the time for it gets dominion in life by degrees.

III. God demands sincerity. In the days of Amos people were religious. On feast days the temple courts were crowded. People even brought costly gifts to the temple. God said, "I hate, I despise your feasts"—they disgusted Him. There were two reasons why God hated their religious services. The first reason was due to the fact that their religion was corrupted. Jeroboam the king had corrupted the true worship of God in order to keep the people from returning again to Judah and therefore he had established two new religious centers in the nation. The king used religion in order to bolster up the state. The second reason why God hated their religious activities was because the people had the idea that God was pleased with their religious ceremonies regardless of how godlessly they lived. Some people today go to church on Sunday and on Monday they live like pagans. A profession of religion must be followed by performance. God wants love and obedience seven days a week.

The last verse of the lesson, "But let judgment run down as waters, and righteousness as a mighty stream" is a call to repentance which will reveal itself in the life of the people in terms of fairness and honesty. God wanted justice to run through the life of the nation, unhindered by selfishness, greed or injustice as a stream which refreshes everything it touches.

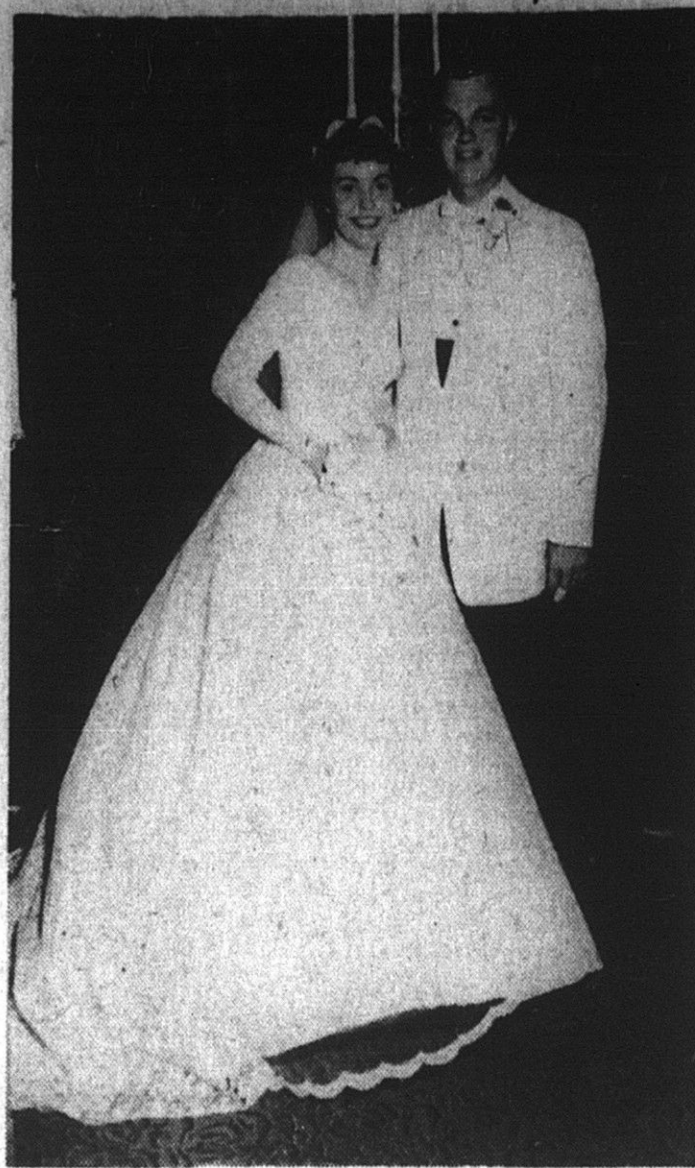
Travel Photographer Spends Weekend Here

Weather in June Close To Normal

The weather in June was close to normal with temperatures slightly warmer and rainfall slightly less than usual, according to statistics compiled by Weather Observer William De Boer.

Average temperature was 65.6 degrees or 1.2 degrees above normal. Although there seemed to be a super-abundance of rain whenever anybody staged a picnic or an outdoor affair, the total measured 2.40 inches or .46 inch below normal. Rain fell on 14 days, compared with 20 days during May. Lightning and damaging winds were noted June 16 with more lightning on June 22. Fog was noted June 29.

The maximum was 87, compared with 92 in 1959, 86 in 1958, 93 in 1957 and 95 in 1956. Minimum was 43, compared with 43 in 1959, 36 in 1958, 42 in 1957 and 36 in 1956.

Average maximum was 77, compared with 81.9 in 1959, 74.1 in 1958, 78.3 in 1957 and 81.4 in 1956. Average minimum was 54.1, compared with 58.1 in 1959, 51.4 in 1958, 58.4 in 1957 and 59 in 1956. Average temperature was 65.6, compared with 70 in 1959, 62.8 in 1958, 68.4 in 1957 and 70.2 in 1956.

Rainfall measured 2.40 inches, compared with 1.29 inches in 1959, 2.68 inches in 1958, 3.54 inches in 1957 and .44 inch in 1956. Rain fell on 14 days, compared with 8 in 1959, 8 in 1958, 12 in 1957 and 5 in 1956.

Greatest precipitation in a 24-hour period was .40 inch, compared with .44 inch in 1959, 1.17 inches in 1958, 1.01 inches in 1957 and .24 inch in 1956.

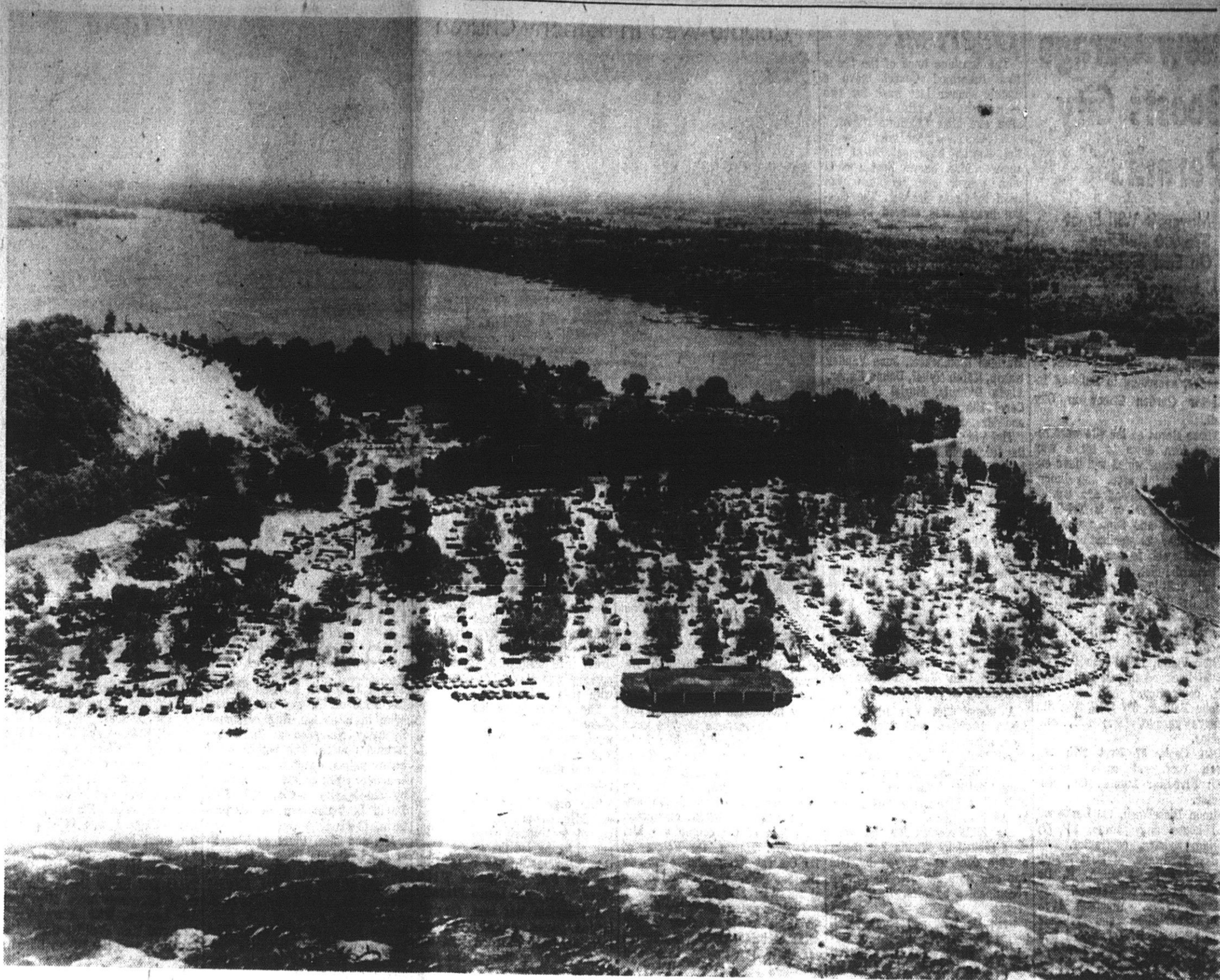

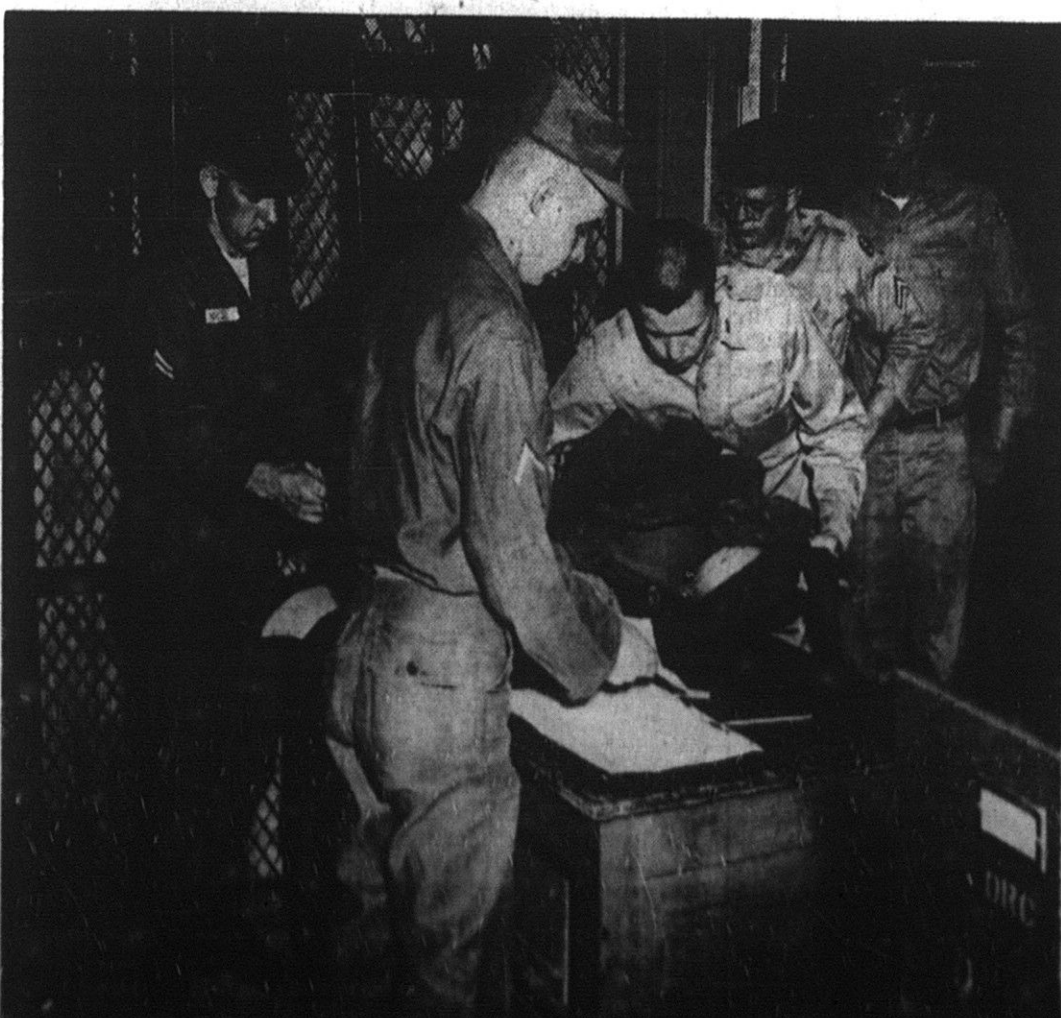

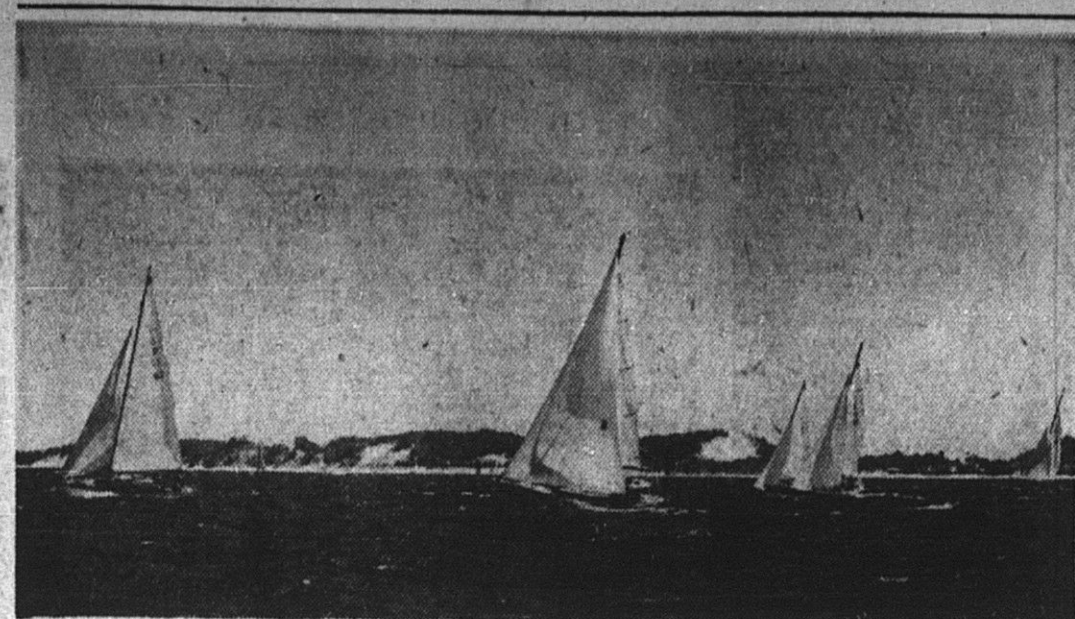

New West Ottawa Budget Is Geared to 22.04 Mills

West Ottawa School District will levy 22.04 mills on state equalized valuation for the school year 1960-61, it was announced Saturday by the Board of Education.

The new figure is .48 mill less than the 22.52 mills levied the past year, but Supt. Lloyd Van Raalte said it could not be determined immediately what effect it would have on assessed valuations since these figures have not been completed in all four townships covered in the district. West Ottawa property owners will receive tax bills late in the year.

The decrease is due mainly to increased state equalized values. Because of these boosts, the board was able to reduce bonded indebtedness on the new high school from 7.7 mills to 6.7 mills the coming year.

The 22.04 mills is broken down as follows: special operating, 2.75; debt, 4; high school and swimming pool, 6.7; operating, 8.59. Last year's 22.52 mills was broken down as follows: special operating, 2.75; debt, 4; high school and swimming pool, 7.70; operating, 8.07.

The new total is geared to the total budget for the coming year of \$857,634.47, compared with \$789,667.11 the past year. The new budget will care for an additional 310 students, covering an additional high school class and an influx of elementary children, and provide the necessary capital outlay for temporary classrooms. The administration does not anticipate using the new high school facilities during the coming year, although there is a possibility of using some of the rooms.

The budget has been under study for several months. According to Supt. Van Raalte is represents the maximum of economy in terms of educational value. It is geared to a per capita cost of \$288.23 per student, compared with \$254.86 the past year. The new budget earmarks \$98,000 more for teachers' salaries the coming year. This covers several new teachers as well as the normal increments. All costs listed in the budget are figured according to state prescribed formulas. Teachers' salaries represent 67.2 per cent of the net operating budget, compared with last year's figure of 68.3 per cent.

The Board of Education adopted millage figures at a meeting Thursday night but withheld public announcement pending a check by the school attorney, completed late Friday afternoon.

The board also made final arrangements for the annual school election July 11 involving three ballots for district voters. Polls will be maintained in the fire station on North River Ave. from 8 a.m. to 8 p.m.

One ballot will be for electing two board members, one for a three-year term and one for a one-year term to fill a vacancy. Harvey Knoll is seeking reelection to the three-year term. William Sanford, who was appointed last August to fill a vacancy after Gerrit Van Kampen resigned, is a candidate for the one-year term. No other candidates have filed petitions.

The second ballot will be voting special operating millage of 2.75 mills, the same figure approved in a special election last year. Budget figures are geared to this 2.75 extra millage.

The third ballot will be on whether West Ottawa district shall provide transportation for students in its district. A public vote on this issue was recommended by the school attorney because of certain technicalities in the setup.

The 1960-61 budget for Holland school district calls for an operating budget of \$1,652,613.11. This amounts to \$17.70 per \$1,000 assessed valuation or 9.663 mills on state equalized figures. Debt on the new Holland High School calls for \$5.96 per \$1,000 assessed valuation or 3.25 mills on state equalized. Holland district has no special operating millage or consolidated debt. Total school taxes in Holland district for the 1960-61 school year will be 12.913 mills on state equalized, compared with 22.04 for West Ottawa.

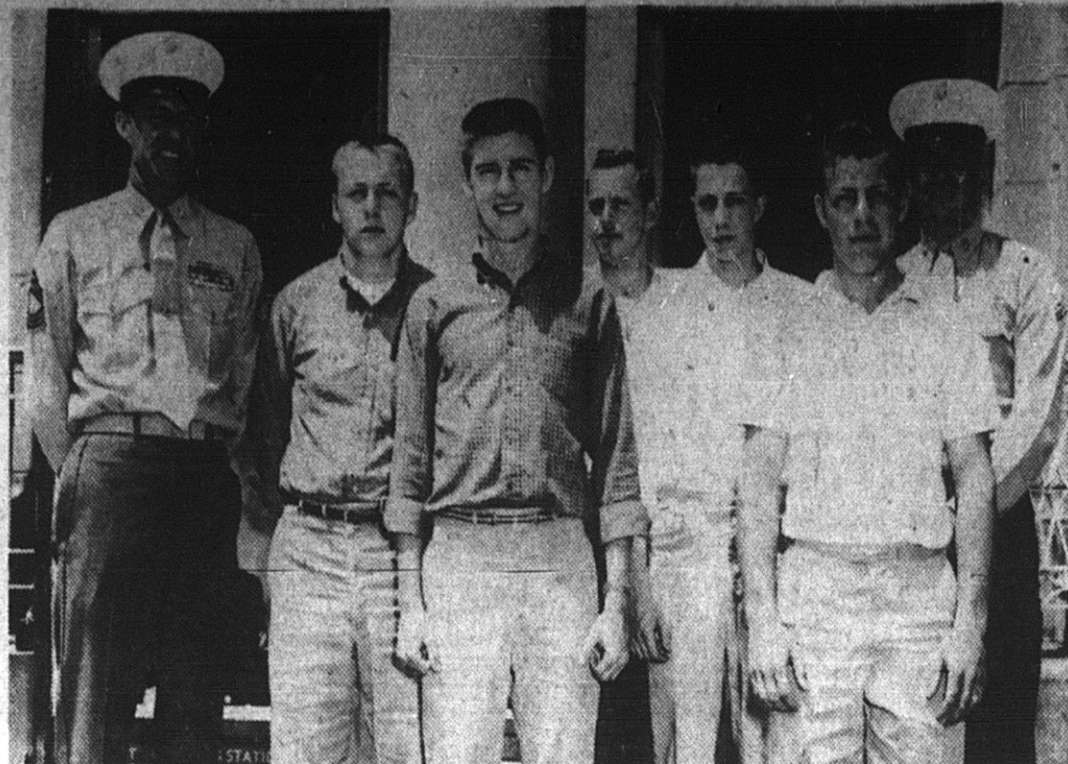
