City Council Processes Lots of Work

In a 53-minute meeting Wednesday night, City Council processed considerable business, much of it of a routine nature.

At 8:23 p.m. Council adjourned until next Wednesday at 7:30 p.m. to consider bids for the sale of \$4,000,000 in bonds for financing the addition to the city light plant.

A full 15 minutes was devoted to a discussion in a public hearing for vacating an alley between 20th and 21st St. running from Central to College Ave. Opposing the closing of the alley were Mr. and Mrs. Ed Ten Brink. Speaking for vacating was Marvin Dobben. It was pointed out the subject had come up two or three years ago. After the discussion, Council voted unanimously to close the alley.

Considerably less time was spent on the hearing on application of Montgomery Ward and Co. to extend a frame building with sheet metal at 25 East Eighth St. Council denied the application after both the building inspector and the fire chief recommended it be denied.

A letter from Henry Bult, of 545 Elm Dr., requesting permission to maintain an existing dock at the end of Hillcrest Dr. was referred to the city attorney for recommendation on procedure. Bult said the dock is shared by two other residents and he promised to keep the shore and beach in good condition.

A letter from George E. Bishop tending his resignation from the Planning Commission due to being transferred to California was accepted with regret.

Council granted permission to the Disabled American Veterans, chapter 15, to sell forget-me-nots on local streets Aug. 23.

Approval also was given an application for a building permit from Leo Beem for an addition to his service station and car wash at 24 North River Ave.

A petition signed by property owners of zone B protesting the special assessment plan for development of a parking lot on the Lincoln-Mercury garage site on West Seventh St. was received. City police noticed the drop in water pressure at 5:05 a.m., and investigation revealed a break in the main line below the water storage tank on Five Mile Hill. A communication from the Board of Public Works informing Council of an offer from Holland Motor Express, Inc., to buy a parcel of land in the vicinity of Fourth and Fifth Sts. west of College Ave. was referred to the city manager for study with instructions to consult the Planning Commission as to possible future uses and to obtain appraisals on the property from two independent firms. The BPW informed Council that it has no use for this property in the foreseeable future but that the board will request an easement over present Holland Motor Express property.

The Hospital Board reported receipt of a \$60 tonometer from the Lions Club to be used in eye tests. Uses of such equipment resulted from the glaucoma clinic carried on here some months ago.

A letter from Jacob and Dale Fris proposing that funds collected from property owners for the proposed parking lot on Seventh St. be in the form of a loan at no interest to be repaid when parking meter funds are built up was tabled. The Frises felt this plan would accomplish the same purpose as the special assessment program at less expense than bonding and would create less hardship on property owners.

Council adopted a resolution opposing an amendment to the Municipal Employees' Retirement Act boosting compensation for plan B members consisting of police and fire departments which do not come under Social Security coverage, thereby increasing their retirement allowance.

Council approved a city manager's recommendation for a change in the Lake Shore bus route. The report said this agreement was reached at a joint meeting of bus representatives and the chief of police, pending further recommendations of the Traffic and Safety Commission.

Council approved transfers of two 1959 SDMs, one from Harry Tys to Donald Kingley, Jr., and the other a tavern and SDM license from Raymond and Estelle Schipper to Edward C. Yeomans of Cadillac. Yuts is located at 331 West 17th St. and Schippers' at 192 East Eighth St.

Council tabled an offer from the Veterans of Foreign Wars for leasing unoccupied VFW property on the south side of Seventh St. between River and Central Aves. for public parking purposes. The VFW offered to lease the area for 15 years in return for an amount equivalent to real estate taxes on the entire property. It was estimated that gross revenue would be \$900 a year with taxes currently at \$52.

Councilman William Heeringa inquired into an old subject which had advocated a study on filtration

for wading pools at Smullenburg Park. City Manager Herb Holt said the plan had been abandoned after it was found such costs would be equal to that of a full-fledged swimming pool.

Mayor Pro Tem John Beltman presided in the absence of Mayor Robert Visscher who is vacationing at his cabin up north. All Councilmen were present. Richard Smith gave the invocation.

Several Arraigned In Court

GRAND HAVEN (Special) — Several persons were arraigned in Circuit Court Monday and a few appeared for disposition.

Edward John Vander Meiden, 24, Grand Haven, who pleaded guilty July 22 to nighttime breaking and entering, was sentenced to pay \$50 fine and costs. Judge Raymond L. Smith referred to the case as a conscience deal since it dates back to Sept. 21, 1954, involving entrance into Seifert Bowling Alley. Vander Meiden admitted the old job when he was questioned July 20 in connection with a reckless driving charge for which he paid \$50 fine and \$10 costs in Municipal Court.

Jerry Seidelman, 17, of 2004 East Eighth St., Holland, pleaded guilty to nighttime breaking and entering and will return for sentence Sept. 11. The alleged offense occurred Aug. 4 at Bennett's Radio and Television store at 202 East Eighth St. in Holland.

Robert John Rutkowski, 18, Grand Rapids, who pleaded guilty July 22 to larceny from a trailer, was put on probation for two years. Conditions are that he serve 60 days in jail (credit for 25 days already served), and pay \$100 fine and \$100 costs.

Harold C. Chaney, 37, Fruitport, pleaded not guilty to a negligent homicide charge and trial will be held during the October term. The alleged offense occurred Feb. 18 when his car hit the vehicle of Hio Dornbas, 71, Grand Haven, who was fatally injured. Bond of \$500 was furnished.

Ronald Ralph Drew, 18, Spring Lake, pleaded guilty to a charge of nighttime breaking and entering and will return Sept. 11. He allegedly broke into the Leonard service station on Water St. April 8 and took a dozen or more quarts of oil from a shelf. A 16-year-old companion has been referred to Probate Court. Bond of \$200 has not been furnished.

Shirley Ann Ott, 22, Grand Haven, pleaded guilty to a charge of larceny from an apartment and was released on her own recognizance to return Sept. 11. Mrs. Ott allegedly removed \$20 from the apartment of Ann Williams in Grand Haven July 20.

James Lee McLean, 39, Jenison, pleaded not guilty to a charge of indecent liberties and requested a court-appointed attorney for his case. The alleged offense occurred on or about May 29 and involved an 11-year-old girl. Bond of \$1,000 has not been provided.

Robert Charles Warner, 21, Grand Rapids, pleaded guilty to two counts of forgery, and will return for sentence Sept. 11. Bond of \$500 was not furnished. On Aug. 10 he was placed on probation by Grand Rapids Superior Court for two years for violation of the check law involving issuing a check with no account.

City Council Studying Plan To Eliminate Angle Parking

City Council has taken under consideration a recommendation from the Traffic and Safety Commission recommending a series of steps whereby existing angle parking would be eliminated within two years.

Miss Anna Vespa's Body Located 1/4 Mile North Of Holland Harbor

The search for the body of 21-year-old Anna Vespa of Detroit, who fell from a cabin cruiser off the Holland channel on Lake Michigan Sunday night, ended today when the body was recovered from the lake by Coast Guardsmen and Ottawa County deputies at 11:05 a.m.

Medical examiner Dr. Warren Westrate ruled death by accidental drowning. The body was fully clothed, even to the glasses the young woman wore when she toppled overboard from the cruiser owned and driven by John Arbaugh of Lansing at 8:30 p.m. Sunday.

Ottawa County deputies said P. T. Cheff, president of Holland Furnace Co., spotted the body while flying over the lake just north of the channel at 10:15 a.m. Cheff landed and telephoned the sheriff's department. A Coast boat manned by Coast Guardsmen Gerald Ohmer, Henry Hippler and Dale Stricklin and deputy John Hempel recovered the body.

Hempel said the body was floating 1/4 mile north of the north pier of the channel, and 1/2 mile out from the shoreline. It is believed the accident occurred about 1/4 mile southwest of the channel.

Recovery of the body ended a search which began Monday morning. Coast Guardsmen had patrolled the beaches north and south of channel both by boat and on foot, and dragged all four days off the channel.

Deputies and Holland police reserves had also dragged the spot, and a plane piloted by local pilot Art Peters flew deputies over the area to try to spot the body from the air.

Miss Vespa had been one of ten passengers on board of the cruiser, Vi-Jon III, headed for Holland from Saugatuck. Authorities said she apparently lost her balance when a swell rocked the boat as she walked along the port side toward the bow.

An attempt by another passenger, Dave Schrauben, 23, of Lansing, to rescue the girl, failed when Schrauben, who dove into the lake after Miss Vespa, tired and lost his hold on her in her violent struggling.

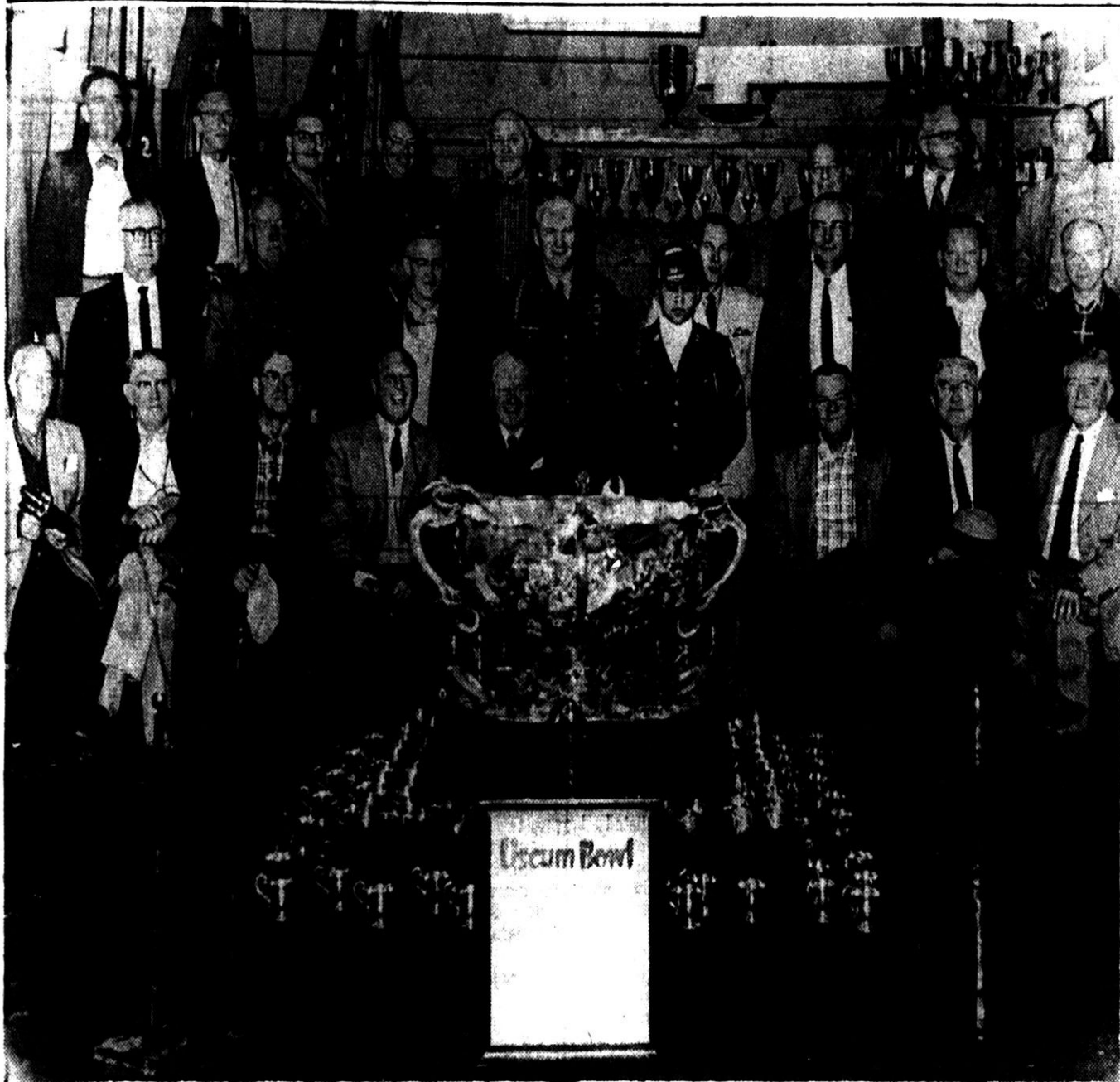
The victim was the daughter of Mr. and Mrs. Frank Vespa of 8965 Armour St., Detroit, and was secretary of the Catholic Youth Organization in Detroit.

The body was taken first to the Dykstra Funeral Home, and was to be transferred this afternoon to the De Santo Funeral Home in Detroit.

Funeral services are scheduled for Saturday, with burial in Mount Olivet Cemetery.

U.S. Publishers View Famed Liscum Bowl in Alaska

EILSON AIR FORCE BASE, Alaska—A highlight of the Alaskan tour taken by a group of U.S. publishers sponsored by the National Editorial Association and other agencies was a visit to the famed 9th Infantry trophy room at Eielson air force base and its prized treasure, the Liscum Bowl, made of solid silver.

The bowl stands as a monument to Col. Emerson H. Liscum, former regimental commander killed in action at Tientsin, China, July 13, 1900.

The background of the bowl lies in the American Relief expedition to China. Shortly after arriving in China, the American regiment was engaged in the conquest of Tientsin and in the course of an assault on the walls, Col. Liscum was struck by Chinese fire and succumbed to his wounds.

When Tientsin fell, it was divided into districts. Portions of the city were in flames and private looting occurred periodically. Two days after the fall, a government mint was discovered in the American sector and the area was immediately placed under guard to prevent looting. Silver bars valued at \$376,000 were ordered placed in compounds quartering the Marine battalion, but when the bars were removed from the mint it appeared that the heat had caused the metal in a number of bars to fuse, resulting in large molten masses. Capt. Frank W. Ramsey, regimental quartermaster and representative of the 9th infantry, was present with two formations by Prince Li Hung Chang.

In 1901 an informal meeting was called to explore possible courses of action in use of the ore and

it was then that the idea of a trophy similar to the existing Liscum bowl was conceived. Before leaving Pekin 52 cups forming part of the collection were designed from a portion of the silver by Chinese silversmiths.

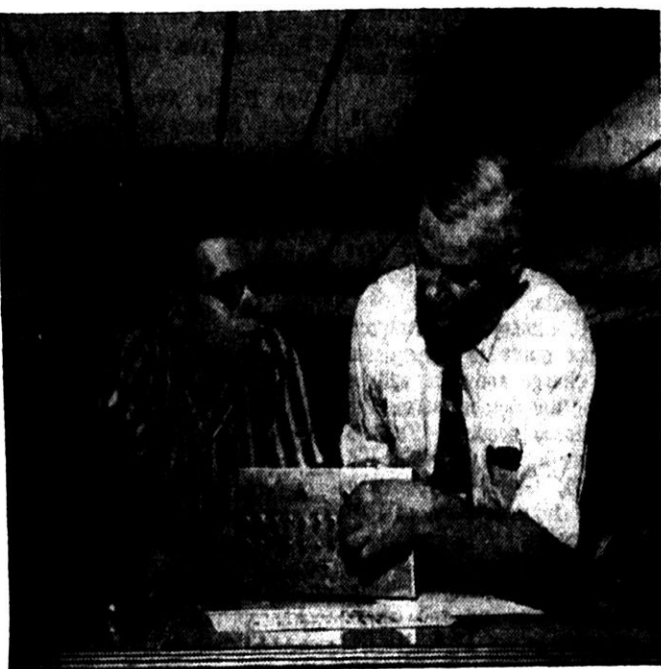
In 1902 after returning to the Philippines, the regiment shipped the silver ore to Yokohama, Japan, where Arthur, Bond and Co. smelted the ore and performed the delicate task of formulating the body of the bowl, the ladle and heavy circular tray. The ensemble, received a year later, conformed to the instructions forwarded by the regiment.

The ornate bowl of large dimensions has four handles consisting of the torsos of four imperial dragons peering over the edge of the bowl. The exterior of the bowl contained several five-clawed dragons. Work on the bowl took eight months.

Customs immediately began to develop. The first of these was centered around the original cups. In an attempt to perpetuate the memory of commissioned personnel, an individual cup was engraved with the name and rank of each officer present at the battle. As a replacement entered the regiment, his name was inscribed under the name of the officer he succeeded. When World War II terminated, two cups bearing the names of officer personnel killed in action were added as a memorial to their sacrifice.

Another group of cups with an individual design enlarged the collection subsequent to the Korean conflict.

The original Liscum bowl is valued at over \$50,000. It weighs 90 pounds and has a capacity of 14 gallons.

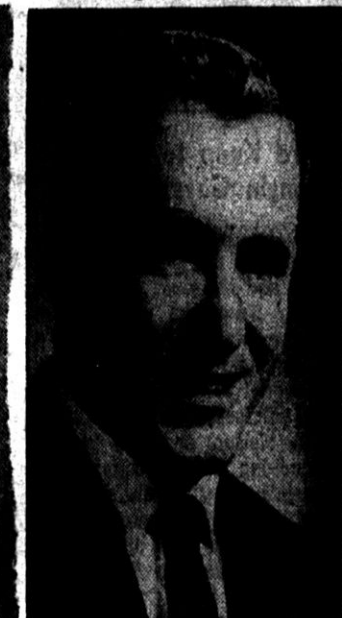

Hope Chapel Renamed For Dr. Edward Dimnent

The executive committee of the Hope College Board of Trustees Tuesday approved a change in the name of Hope Memorial Chapel to Dimnent Memorial Chapel honoring the late Dr. Edward D. Dimnent, president of the college from 1918 to 1931, who died July 4 at the age of 82.

It was during Dr. Dimnent's administration as president that the campaign for funds for the \$400,000 chapel was carried on, and it was largely due to his efforts that the program was accomplished. It is estimated that it would cost \$1 1/4 million to replace the chapel today.

The chapel, by far the most outstanding building on the campus, was dedicated June 7, 1929, in conjunction with a meeting of General Synod of the Reformed Church in America.

Its main auditorium seats 1,340 persons. The basement has classrooms for the study of Bible and religious education. The pulpit furniture upstairs and chairs used in basement classrooms are of solid rosewood and were made by the Reformed Church industrial school in Katpadi, India. The organ in the main auditorium was installed at a cost of \$25,000, an echo organ off the balcony at \$15,000, and the harp and celeste components above the main arch at \$10,000.

The rose window, donated by the class of 1916 is centered with an anchor, symbol of Hope College, and surrounded by seals of Protestant-founded colleges in the United States, alternated with symbols of liberal arts schools. Outer circles show ancient symbols of man's living, plus Biblical history.

Court Grants Several Judgments

GRAND HAVEN (Special) — A number of judgments were granted in the Ottawa Circuit Court Monday.

A judgment of \$915.20 was awarded the Ver Hage Milling Co. of Zeeland against Robert E. Wyngarden, and \$850 against Robert and Mary Jane Wyngarden, route 3, Holland, the amount against Wyngarden, individually, represents feed, including oats and corn, allegedly sold by plaintiff to Wyngarden from July 27, 1954 to October 18, 1954, amounting to \$1,215.20, upon which \$300 had been paid. The judgment against Wyngarden and his wife, was for turkey gourd pellets purchased from September, 1954, through Oct. 12, 1954.

In two suits, one brought by Thomas De Mull, Jr., by Thomas De Mull, Sr., against Fred Roelofs, all of Hudsonville, and the other by Thomas De Mull, Sr., against Fred Roelofs, a consent judgment of \$2,000 with no costs, was awarded in the first case, and a consent judgment of \$4,000, with no costs in the second case.

The suits were the result of an accident Oct. 21, 1955, when the De Mull child, then five years of age, was struck by the Roelof car on Main St. in Hudsonville. It is claimed the child suffered permanent injuries to the right leg and will be handicapped.

The Interstate Motor Freight System was awarded a judgment of \$652.78 plus costs of \$30.75 against Jerry Hammond of Conklin. The amount represents the balance due on freight charges on material transported by plaintiff for defendant.

Leendert Riensma, also known as Leonard Riensma, was awarded a consent judgment of \$1,500 plus \$28.20 costs against Albert H. Stegenga of Olive Township. The amount represents the balance due on a promissory note dated April 11, 1953, for \$1,500 with interest at 7 percent.

The Coopersville State Bank was awarded a default judgment of \$2,099.25 plus costs of \$33.55 against Clarence and U. Alice Vladika, of Coopersville. The amount represents the balance due on a promissory note dated Jan. 25, 1957, for \$2,332.50.

In another suit, Donald M. Dykhouse, William Dykhouse, Robert C. Bowen, Thomas C. Fullerton, Clarence Welling and Jerry Weavers were awarded a default judgment of \$2,640 plus costs of \$29.10 against Dale M. Leonard, Grand Rapids. The suit was the result of an agreement between the parties dated Aug. 3, 1957, that plaintiffs, in consideration of \$600 for each person, would put up money so as to assist defendant in a drilling operation upon land in this area in pursuit of oil or gas or mineral deposits in connection with the drilling operations. Plaintiffs claim defendant failed to commence any drilling in connection with the agreement.

Dr. de Velder Accepts Call To Grand Rapids Church

Dr. Marion de Velder, pastor of Hope Church for almost 20 years, announced to his congregation Sunday morning that he has accepted a call extended him by Central Reformed Church of Grand Rapids. Central Reformed is a large congregation of 508 families. Its new church at Fulton and College was completed in 1957.

Dr. de Velder is a graduate of Central College in Pella, Ia., and of New Brunswick Theological Seminary. He received an honorary doctor of divinity degree from Central College in 1950. He took graduate study at the University of Chicago Divinity Schools the summers of 1944, 1945 and 1956.

During the past year he served as president of General Synod of the Reformed Church in America, the ruling body of the denomination. The previous year he served as vice president. He was director of the United Advance Fund 1946-49, chairman of the Commission on United Approach to the Church 1949-52, and is currently vice president of the Board of Education of the Reformed Church and a trustee of Central College.

Dr. de Velder served Hope Church from 1939 to 1951, was associate minister of First Church in Albany, N.Y., in 1951-52, and was recalled to Hope Church in 1952. Before 1939, he was student pastor at Griggstown Reformed Church in Griggstown, N.Y., and was minister of the North and Southampton Reformed Church in Churchville, Pa.

During his ministry, Hope Church has grown from 233 families and total contributions of \$14,000 in 1939 to 424 families and total contributions of \$84,000 in 1958. Central Church has 508 families and a total budget of over \$200,000. The Rev. Maurice Marcus left the church last January for Second Reformed Church of Somerville, N.J.

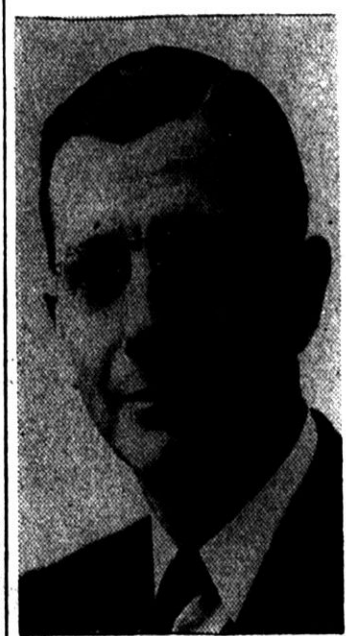
Army Doctor, Family Leave for African Post

It stems from a telegram sent last Aug. 6 by Joseph L. Hudson, Jr., of the J. L. Hudson Co. in Detroit, in which he stated, "Any additional taxes on Michigan busi-

ness will stifle expansion, make Michigan unpopular to new industry and will speed movement of Michigan companies to other states."

State Sen. Clyde H. Geerlings of Holland at that time urged Hudson and other industrialists to make their feelings known to other legislators. Since then, Geerlings has queried Gov. Williams' 200 industrial ambassadors. (See story on page 10.)

In Detroit, S. D. Den Uyl, board chairman of Bohn Aluminum and Brass Co., said, "Banks and utilities can't move but manufacturing firms which provide a higher percentage of jobs in Michigan can—and will—move if Michigan's climate gets bad enough." Den Uyl has a summer home at Macatawa Park.

Sunday School

Lesson

Sunday, Aug. 23
Prayers of the Captives
(Book of Daniel)
Daniel 9:4-10, 17-19
By C. P. Dame

(International Bible Lessons of Christian Teaching, lesson material based on International Sunday School Lessons by International Council, Religious Education, used by permission.)

We have studied about the fine purpose of Daniel, about his loyalty to God and his courage to stand up by his principles but we are not too familiar with the prayer of Daniel. This lesson gives us a fine opportunity to study the inner life of Daniel which is revealed by his prayer.

I. There is always a need for praying statesmen. Daniel was a great statesman. The words, "And I prayed unto the Lord my God and made confession" were uttered by Daniel who occupied a position of Great importance in the nation. If ever the world needed praying statesmen it is now. Daniel knew God and he knew himself. He stated that God is great and dreadful, and in addition, merciful and loving. In our times we say too little about the greatness of God - we stress His love so much that we forget His severity. Daniel first mentions the greatness and then His grace and Paul first names the severity of God and then His goodness. Our age needs to recover the sense of awe and reverence for God. A wholesome fear keeps people from sinning.

Much is made of prayer today. However, in most instances prayers are simply requests. Daniel confessed his and his nation's sin. One of the hardest things to do is to confess sin. The nation was in exile because of its sins. "We have sinned, and have committed iniquity, and have done wickedly, and rebelled, even by departing from Thy precepts, and from Thy judgments." The people were not in ignorance for God had given them His laws and had sent them prophets to explain these laws but they had rejected both God's laws and His prophets. God had given extra privileges to His people but they had shown no delight in them.

II. Penitence is praiseworthy in sinners. And we are all sinners. The words, "we have sinned" and "Neither have we hearkened" reveal a penitent spirit. Daniel recognized the justice of God in His dealings with Israel. The nation had been sent into exile, Jerusalem and the glorious temple had been destroyed and to the nation "belonged confusion of face." Undoubtedly not all the exiles felt the way Daniel did but when leaders see the true situation there is hope. The nation was in the wrong and therefore it needed pardon which comes after penitence. Nations are responsible to God as well as individuals, families, churches, labor unions and corporations. This sense of responsibility is rather faint in these times. How wholesome it would be if a genuine penitent spirit would appear amongst us!

III. The pleading note is always in order. "Now therefore, O our God, bear the prayer of Thy servant, and his supplications. The pleading note reveals deep earnestness. Daniel did not base his pleading upon the goodness of his nation nor did he offer any excuses but he called attention to God's mercies. We are all inclined to mention our goodness and the fine things we have done and what we as a nation are doing all the time but we overlook the fact of our many sins and shortcomings. We need to recover the spirit of Daniel and say, "O Lord, hear; O Lord, forgive; O Lord, hearken and do; defer not, for Thine own sake, O my God; for Thy city and Thy people are called by Thy name." The penitent and the pleading notes are much absent in the prayers of most of us. Today sincere believers plead for forgiveness which God gives because of the merits of Christ who died that we might obtain pardon.

The \$15 bond was entreated on the speeding charge.

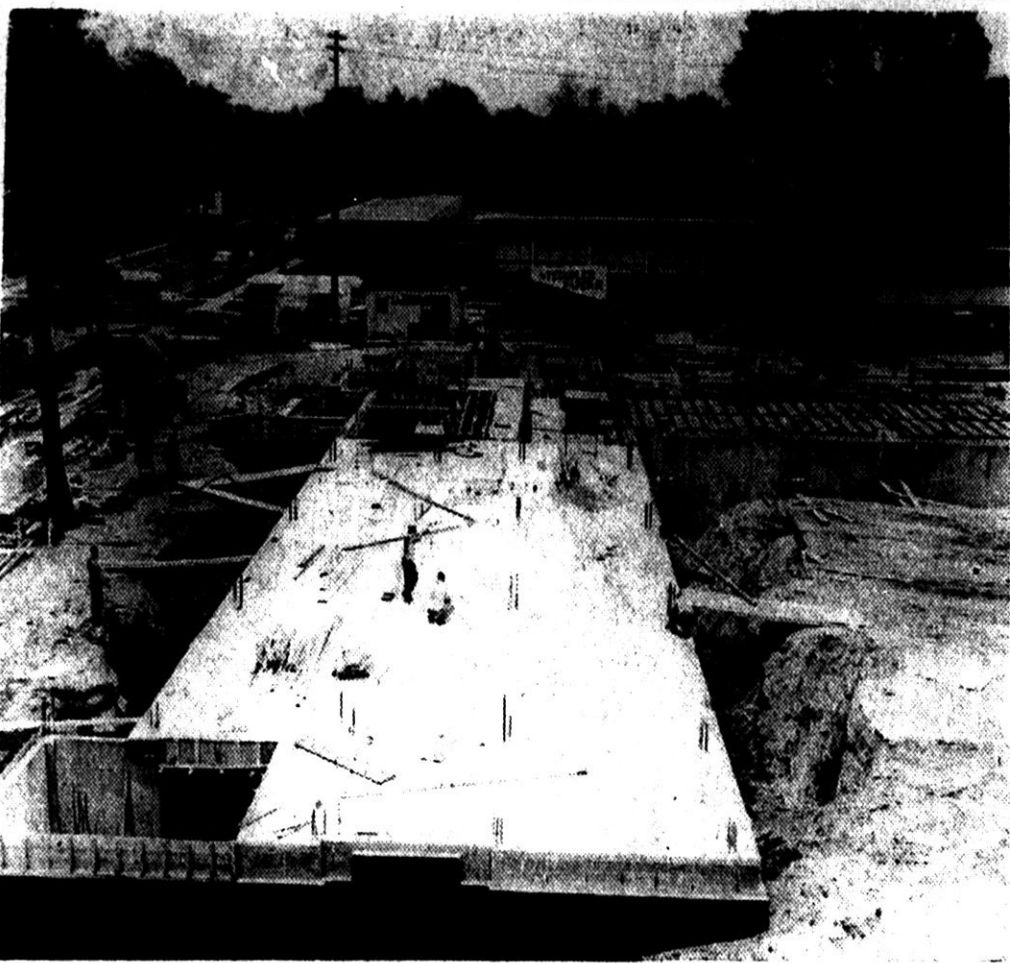
Park Attendance Cut By Rain, Rough Water

Anchorage Has Same Kind Of Problems as U.S. Cities

ANCHORAGE, Alaska, Aug. 9.—We arrived here by plane in the late afternoon after some delay. Nome has trouble keeping air schedules on time. Lots of freight and mail are handled and this takes a lot of time. The airlines need this revenue to keep their planes flying. This is a big country and flying is about the only way for the people to get anywhere.

The Anchorage Chamber of Commerce had the red carpet out for us. Chamber members and their wives drove us to the Country Club where we had a chance to visit the people before dinner. Then we went to our quarters in officer's guest house at Elmendorf Air Base, a fine place with all modern conveniences. We had breakfast across the street at the officers mess where the food was low priced.

On Saturday morning we were briefed by General Terry and some of his staff and for lunch we were guest of the two daily newspapers, the Times of which Bob Atwood is editor and publisher and the News edited by Mrs. Brown. Also present at the luncheon in Westward Hotel were the city manager, the chief of the petroleum industry and the Chamber of Commerce planning commissioner.

We learned a lot about Anchorage as well as Cook inlet where the people expect to develop a harbor. Anchorage has the usual city problems—growth both inside and outside the city, water, schools, pavement, parks, hotels, hospitals—in fact, all the problems that come when a place of 3,500 develops into one of 40,000. Lots of people are with the federal government and the military. Land area of 20 miles square takes in air force and army installations of Fort Richardson.

The Alaska railroad provided official automobiles with drivers to take us to Portage. The route went through tunnels constructed during World War II so that we could visit the port of Whittier. This harbor does not freeze over during winter. Army personnel briefed us on handling the port. A ship was being unloaded at the time. This unloading is a self-contained operation in charge of the Army. Col. Eugene Elliott distributed copies of briefings and a complete file of pictures.

Dinner in the officers club featured seafood all caught in the vicinity. The meal was Dutch treat. We were fully aware we were to pay for food and lodgings in all places we visited. After dinner, our hosts engaged in quite some story telling and some of the editors joined in too.

We had to wait for a passenger train to depart before automobiles again could be placed on the rails for our return to Elmendorf Base. Then some of the party went on a fishing trip and others took a bus trip to Palmer and through the Matanuska Valley where we visited some of the better farms, saw the fine vegetables and the cattle, as well as some of the cooperatives which handle produce and dairy products.

One farm of 160 acres which had about 45 acres under cultivation grew fine crops of potatoes, carrots, lettuce, cabbage and broom grass. The owner told us he had a surplus of head lettuce and he had disked some under. He also dug a hill of potatoes so that we could see the number and size. He has an irrigation system but hasn't used it since June since rainfall has been adequate.

We noticed some 59's were loading some of their badly used trucks and equipment. The people said it was a rough deal and already six persons have left. Others are trying to get ready for the winter. Some are working on other jobs.

We had lunch at Willow Restaurant. The \$4 meal had crab, shrimp, salmon and chicken, plus essert and seconds if you cared or them. Two young women aboard the bus had just arrived

for a year's work with the Northwest Orient Airlines. Two other women were touring Alaska on their own, one from Alabama and one from Mississippi. They asked a lot of questions about hotels, reservations and the like. We also talked to some people from Johannesburg, South Africa.

Most rivers are muddy with glacier silt. We were told at times there are real floods along the Matanuska River in Matanuska Valley. This river is wide in places with a great deal of gravel and dead trees.

Alaska has some good gravel roads and a few blacktop roads, but some side roads are very dusty. People who remember when roads were not passable do not seem to mind the dust. Most flowers have passed their peak. Oats and peas planted together are being harvested. Wheat and rye have short stalks.

Holstein and Red Danes seem to be the best cattle for the territory. Holsteins are increasing because of milk production.

We leave tomorrow for Kodiak Island, remaining that night with the Navy. Then we will fly back to Seattle, Wash. Some of the party are flying to San Francisco, Calif., and Hawaii.

We have had fine weather all the way. The sun has shone every day which has been just fine for camera fans. No Sunday papers published in Alaska so far as I can determine. Only Sunday papers available seem to be two Seattle papers which sell for 60 cents. All weeklies and dailies are 15 cents a copy. Costs are high and delivery costs also are high. I think there is possible use for the Vacationland from the Straits of Mackinac up here. Many cities could use such a ship.

Allegan County Well Shows Good Yield In First Week

ALLEGAN (Special) — Allegan county's oil industry, which has been playing second fiddle to the Calhoun county boom for more than a year, was back in the picture Saturday.

Seventy-four-year-old Louis Zellman, president of the Zellman Oil Company of Allegan announced today that the Graczyk No. 3 well in section 19 of Dorr Township looks like the best well ever brought in in the Salem-Dorr area.

And he added that another well, the Helmer No. 4 in Section 25 of Salem township, completed Friday, looks just as good.

The Dorr Township well, which taps the lower Salina formation at a depth of 2,775 feet, was reported flowing at the rate of 250 barrels a day Friday with 800 pounds of gas pressure. Zellman said the well had been plumbed with an electric logging device which indicated that the oil bearing formation was 30 feet in depth.

The well was fractured earlier this week. After the oil bearing formation was shot with a rifle-like device lowered into the hole, 400 barrels of oil and a special porous sand was pumped into the well, under 2800 pounds of pressure. All of the oil used in the fracturing process had been recovered by the following morning.

ALLEGAN (Special) — Conservation in Downtown Allegan was "all mall" last weekend as thousands of bargain hunters — in town for the annual sidewalk sale — tested out the idea of a traffic free shopping mall on Locust St., the town's main business block.

School System in Brazil Differs Greatly From U.S.

During my last two weeks in Brazil, I have been getting acquainted with the public and parochial schools here. While students in the United States are enjoying the final month of their summer vacation, Brazilian children are back at their books after having a month's vacation in July. Their long vacation comes in December, January and February, which is the summer season in Brazil.

Brazilian children begin school when they are seven years old, and the law requires that they attend school for at least four years. But the law is not enforced, and many youngsters never set foot inside a classroom. In the Bragança area, where I have been staying, only about one-third of the school-age children are attending classes.

After five years of primary school and four years of ginasio, which is somewhat comparable to our junior high school, students may attend one of three types of special schools. Those wishing to become primary school teachers go to normal school for four years. Scientific, for those planning to enter a university, and classic, for future lawyers, are both three-year courses. To teach in the higher grades, one must complete a four-year university course. There is no tuition for the state-supported universities,

only a small fee of a few dollars each six months.

Although the state provides free education, many of the lower class families do not take advantage of it, resulting in a large percentage of illiteracy among the population. Many parents who can't read or write fail to see the necessity for education, and keep their children at home. They also want the youngsters to get jobs as soon as possible, to help increase the small income of the family.

The days are flying by, and when this letter arrives in Holland, I will also be flying — back home. Although I am anxious to return and tell of my wonderful summer in Brazil, I am reluctant to leave all my friends here. I hope that the Brazilians will have pleasant memories of the North American who lived with them for two months, and learned to love them and their country.

In this, my final letter to the people of Holland, I want to thank everyone who made this wonderful experience possible for me. The Brazilians know so much about us, through studying our history and geography, through newspapers and movies. But Americans know so little about Brazil, that I have been "on the spot" when people have asked me what impressions Americans have of Brazil. I am glad that I will have the opportunity, through my speeches, to acquaint some Americans with the Brazilian people who have been so kind to me.

Zeeland

Three exchange students from the Netherlands have spent the summer in Zeeland at De Witts Hatchery to learn the business from start to finish. They are Douwe and Jaak Ehlhardt and William Wentzel.

Douwe Ehlhardt attends the Agricultural University of Wageningen in the Netherlands. He is taking a practical course in poultry breeding and husbandry at De Witts Hatchery. He is planning after his graduation at Wageningen University to return to the U.S.A. to study at Cornell University in Ithaca, N. Y.

The Ehlhardts' grandfather was the only one out of a family of eight to stay in the Netherlands in 1880. The relatives living in Michigan spell their name Ehlhart. Jaak Ehlhardt came to Zeeland in January, 1959 to take a practical course in poultry equipment. He is a student at Technical Engineering College at Leeward. He came to work with De Witt's Big Dutchman factory for poultry equipment and went back to the Netherlands last week to continue his studies in September. They are staying with their great aunt, Mrs. Tillie De Witt.

William Wentzel came to the U. S. with Jaak Ehlhardt. William's father is the owner of a large feed mill in Aalsmeer, near Amsterdam.
