No School In Holland This Week

Supt. D. L. Ihrman
Cancels Sessions
In Public Schools

There was no school in public schools in Holland today.

In fact, there will be no school the remainder of the week.

A temporary injunction issued in Ottawa Circuit Court late Wednesday afternoon ordered striking teachers back to work, but action initiated by the Michigan Education Association and the Holland Education Association resulted in a suspension of the order by the Michigan Court of Appeals.

This suspension was ordered at 3 a.m. today and the necessary documents were served on the Board of Education and others associated in legal action.

At this point, Supt. Donald L. Ihrman cancelled school sessions for the remainder of the week.

Members of the Holland Education Association continued its meetings today at the Enterprise Development grounds north of Holland and will meet there again on Friday. Ted Boeve, chief negotiator for the HEA, outlined details of night-long developments involving the signing and serving of numerous documents.

"Fortunately, or unfortunately, this no longer is a Holland problem. It is bigger than Holland and the crusade has fallen on our shoulders," he said, adding that Holland is receiving firm support of the Michigan Education Association and the National Education Association.

He said all local teachers are invited to the hearing on the injunction which has been scheduled at 11 a.m. Saturday in the Exhibit Hall opposite Civic Auditorium in Grand Rapids. The hearing is to be conducted by the Michigan Court of Appeals.

"If the court rules in favor of the injunction, we will operate within the framework of the law," he said.

Both the Board of Education and HEA are preparing for a fact-finding session at 10 a.m. Friday in Grand Rapids conducted by the State Labor Mediation Board. The meeting is scheduled in the mediation office on the ninth floor of the Michigan Trust Building. It is expected John Frederick, Muskegon attorney who was appointed by the State Labor Mediation Board as fact-finder in the Holland negotiations, will be present.

James O. Lamb, president of the Board of Education, said the board had hoped schools would open today and that all differences could be resolved as the educational program continued. He said the board feels that irreparable harm may be done to the children if the delay continues.

He again explained the board's firm stand against deficit spending, stating that this is not good business practice, nor does the board feel it is the will of the citizens or that deficit spending is legal.

He added that the board had had 16 negotiating sessions with the negotiating team of the HEA involving a total of 50½ hours, and that many more hours were spent in separate sessions.

Paul Klomparsen, new HEA president for the coming year, presided at this morning's session of the teachers at the picnic grounds, and Mrs. Ernest F. Penna, current HEA president, led the flag salute. The Rev. William Hillegonds gave a brief talk on education.

In Holland to assist the HEA are S. P. (Chip) Tassone, public relations director of the MEA; Bill Hodge, regional director of six midwestern states for the National Education Association; and Pat Dolan, field representative for region 9 of the MEA.

Tassone announced that emergency loans were available to local teachers without interest from the MEA. Boeve announced possibility of an assessment for HEA members to carry on a public relations program.

Marine Pilot Flies After Near-Fatal Vietnam Wounds

A Marine helicopter pilot, the son of Mr. and Mrs. Ben Jansen of 20 West 21st St., Capt. Randall J. Jansen, is back in the cockpit again, after being told he would never fly again.

Wounded after a round from an automatic rifle nearly tore off his left arm in Vietnam a year and a half ago, doctors

on by a sniper's automatic rifle.

Capt. Jansen was flown to the base hospital at Chu Lai where he underwent surgery on his left arm and shoulder. A few days later he was transferred to the Hospital Ship where another operation was performed on the dislocated shoulder. After this operation the doctor said his flying days were over and he would be lucky if he ever used his left arm again.

The Captain left for home after this and was taken to Great Lakes Naval Hospital on May 18, 1966 where he was met by his parents, brother and sister and his fiancée, Miss Diane Maloy. After 2½ months in the hospital he was transferred to Cherry Point, N.C. and was assigned to Marine Training Squadron.

In January and February this year he was at Camp Lejeune where he received physical therapy for his arm. In March he was told he could fly again and that same month began flying transport planes.

Capt. Jansen, who holds 12 Air Medals, married the former Miss Maloy of Pensacola, Fla., last July and they are living aboard the Air Station at Cherry Point. He is a Holland Christian High graduate and attended Calvin College before service.

aboard the Hospital Ship, USS Repose told Capt. Jansen the bad news.

Capt. Jansen is not only back flying, but he has transferred to the largest aircraft in the Marine Corps' arsenal — the KC-130F "Hercules."

The Marine, a Reserve since 1961, was sworn in as a Regular Marine officer at Marine Aerial Refueler-Transport Squadron 252 at Cherry Point, N.C., on Aug. 17, 1967.

While serving in Vietnam, Capt. Jansen received three Purple Hearts in 1966 — the first on Feb. 23, the second just 10 days later, on March 5 when his helicopter was fired on by Viet Cong snipers and on April 29, 1966, when he received the third and almost fatal wound. This time the helicopter piloted by Capt. M. Banning, was fired

Relatives will meet in the church basement at 1:45 p.m.

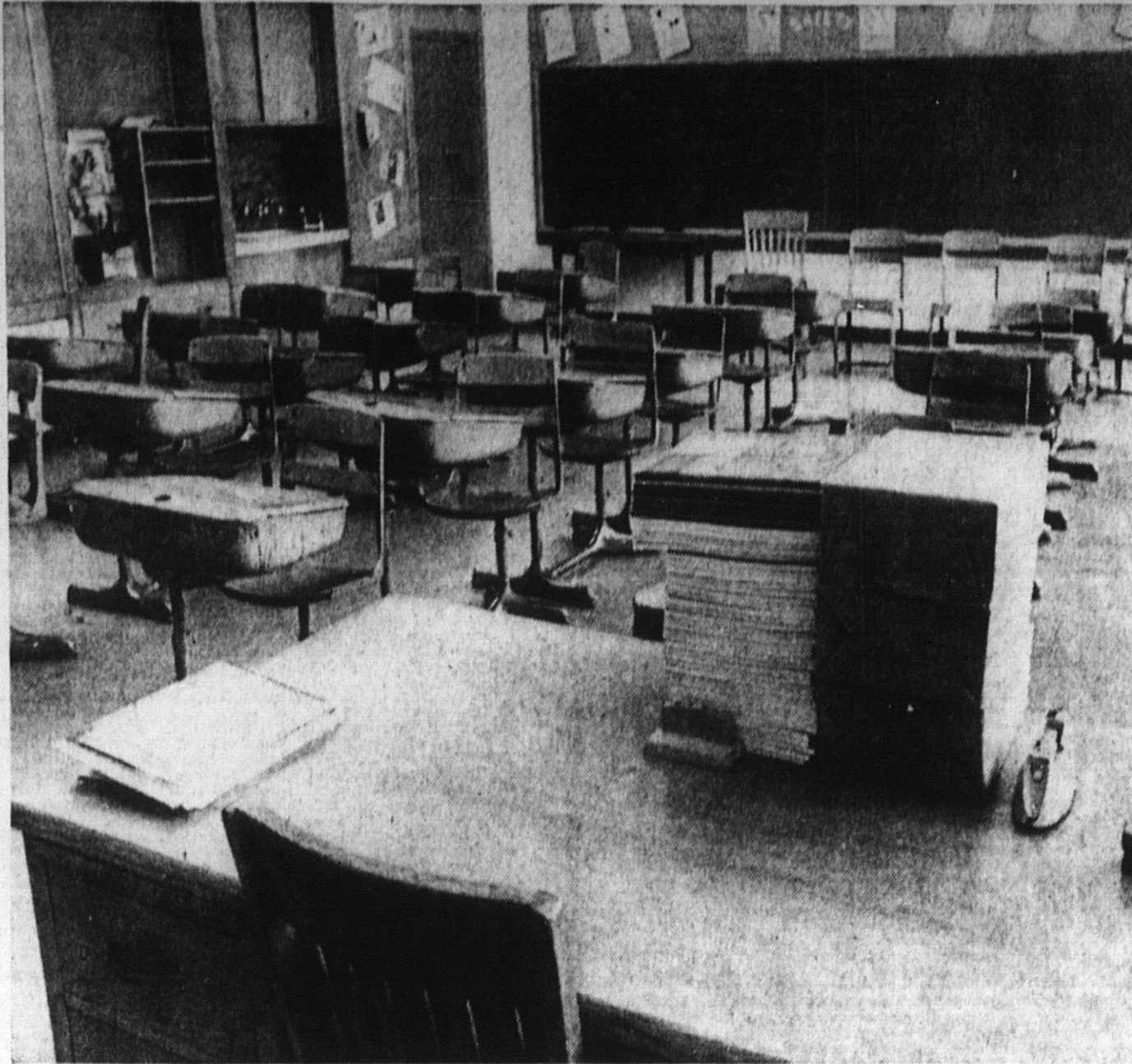

Historic Pageant to Mark Third Church Centennial

"Voices of a Century" is the name of an historic pageant which will be presented Saturday night in Civic Center in connection with a dinner commemorating the 100th anniversary of Third Reformed Church of Holland.

The dinner is scheduled at 6:30 p.m. in Civic Center for all persons associated with the church and for those who have family interest or personal interest in this institution which has ministered to the community for a century. Such persons interested in sharing this centennial experience with Third Church members may make dinner reservations by calling the church office.

Centennial events will continue Sunday with two services, one at 10 a.m. in Dimment Memorial Chapel on Hope College campus and the evening service at 7 p.m. in Hope Reformed Church with past pastors participating.

Dr. Jacob Sessler of Grafton, Vt., who served as church pastor in Holland from 1946 to 1949, will deliver the sermon at the morning worship and the Rev. Christian Walvoord, secretary of the Board of Education for the Reformed Church with headquarters in New York City, will preach in the evening.

The Rev. Russell Vande Bunte, present pastor of Third Church, will preside in the morning and the Rev. William Van't Hof, who served Third Church from 1936 to 1944 and Mark Walvoord, present associate minister of Third Church, will assist in the evening. Rev. Van't Hof is making his home in Holland.

Third Church is departing from the usual week-long centennial observance and plans a number of special gatherings throughout the year, climaxed with a service of rededication in the sanctuary of the newly restored church. This \$350,000 res-

toration project currently is in progress.

Third Church also will be featured on a radio program at 5:30 p.m. Sunday with Willard C. Wichers as moderator. Participating will be Dr. Elton J. Bruins, Harvey Buter and Mrs. Gerrit Vanden Berg.

Saturday night's pageant was written by Dr. and Mrs. Bastian Kruitthof. With Mrs. Robert H. Dykstra as narrator, it tells the story of the early church and knits into the script the old-time names of Schaddelee, Van Putten, Pessink, Van Raalte, Verbeek, Spietsma, Te Roller and De Boer.

It starts with a scene in the old First Reformed Church, now known as the Pillar Church, with Dr. A. C. Van Raalte citing the need for another church due to the influx of new Dutch families in the community. A second and third scene place the church on its present site and reveals plans for a \$5,500 structure. Generally all persons living west of Market St. (Central Ave.) were to attend the new church.

An organization meeting on Sept. 9, 1867, revealed 97 communicant members of whom 55 were men and 42 were women. Elders were J. Labots, Robert De Bruyn, E. Van Zee and J. Kerkhof, and deacons were F. Kieft, Derk Te Roller, Isaac Cappon and C. De Jonge. The new church was completed Feb. 14, 1868, and two days later the Rev. Jacob Vander Meulen was installed as the church's first pastor.

By the end of the first year the members added the luxury of a steeple to the church and also planned a brick parsonage for the young preacher.

Other scenes reveal the destruction of the church in the big Holland fire of 1871 as well as the homes of many of its families, the rebuilding of the church and parsonage, the final

MEA Aids Teachers In Fight

'Stay' Obtained
On Board Action;
Hearing Saturday

The Michigan Education Association moved swiftly today to assist local teachers in their fight with the Board of Education in the third day of a teacher boycott which has assumed proportions of a full scale strike.

Late Wednesday afternoon, the school board obtained a temporary injunction in Ottawa Circuit Court ordering teachers back to work today, but the Holland Education Association, with the assistance of the MEA and NEA, obtained a stay of the injunction at 3 a.m. today in the Michigan Court of Appeals.

The Court of Appeals has scheduled a hearing in Grand Rapids at 11 a.m. Saturday on a motion setting aside the temporary injunction issued by Circuit Judge Raymond L. Smith.

The stay was approved by the three judges of the northern district, Michigan Court of Appeals. They are Judge Robert Burns of Grand Rapids, Judge Donald Holbrook of Clare and Judge John Fitzgerald of Grand Ledge.

The case promises to be of significance to school districts all over Michigan which have yet to sign master contracts.

UPI quoted E. Dale Kennedy, executive secretary of the Michigan Education Association, as saying: "If we break their back here it may hasten the settlement of all these disputes."

In his summation, Judge Smith said the case deals with a dedicated group of teachers and it is a shame that a truck driver and other workers earn more than teachers. "But I will not concern myself with the economic side of the question," he said.

He said the law spells out the meaning of the word "strike" and clearly says that public employees may not strike. The primary question, he said, seems to be whether Holland teachers are still employees of the district, and he said teachers consider themselves to be employees of the district.

"The welfare of society," he said, "demands that public services be performed in order that society be preserved. The poor be cared for, the sick must be helped and the children must be taught."

He declared that arguments of lawyers have not changed his opinion that the law is clear and he held that the activity of the teachers was in violation of Public Act No. 379 of 1965, known as the Public Employees Relations Act.

Judge Smith defined strike as any concerted failure to report for duty, or willful absence from one's position or stopping of work, and he felt "withholding services" came under such a category.

It is Judge Smith's 10-page opinion that will be debated at the Court of Appeals hearing in Grand Rapids Saturday. Technically, it is a hearing on a motion setting aside Judge Smith's order.

At a meeting of teachers this morning, Ted Boeve, chief negotiator, said the local association has high regard for Judge Smith and for his integrity "but we disagree with him in this case."

MEA's Kennedy was more outspoken. After the decision was announced Wednesday he wired: "We are shocked by the decision of the Ottawa County Circuit Court Wednesday denying teachers equal negotiating status with the Holland Board of Education. In this decision, the court ignored the obvious fact that neither teachers or the HEA have agreed to work for this employer."

"The decision flouts the constitutional rights of teachers by forcing them into service without agreement on salaries, hours and other conditions of employment. This, of course, is involuntary servitude, and is immediately being appealed with full support of Holland teachers by the MEA."

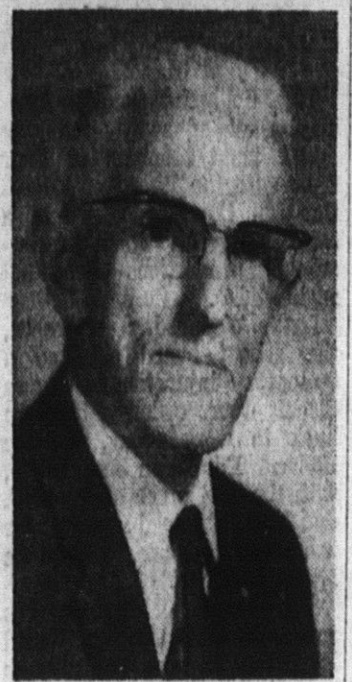

Name Chairmen For United Fund

Appointment of Carl Harrington as campaign chairman and Charles Kupsky as vice chairman of October's Greater Holland United Fund - Red Cross drive was announced Tuesday by Jack I. Dykstra, president of the United Fund.

Harrington, who is owner of Harrington Fuel Co. and Kupsky, general manager of Parke-Davis and Co., are active in various civic activities. In the 1966 United Fund-Red Cross

campaign Harrington served as vice chairman and Kupsky was a member of the industrial division's solicitation committee.

This year's goal of \$149,312 was established at a meeting of the United Fund directors Thursday, Aug. 17. On Aug. 14 members of the admissions and budget committee held indi-

vidual meetings with representatives of the participating UF agencies to consider their individual financial requirements for 1968. Atty. James E. Townsend, budget committee chairman, presented the committee's recommendations.

The goal is an increase of 13.7 per cent over last year's "target" of \$131,250. In commenting on the increase, Dykstra said requests totaled \$161,000 and that the approved campaign goal represents the minimum requirements for the continuation of adequate health, welfare and youth guidance services.

Of the \$18,062 increase over last year's goal \$6,500 goes for the first time to Kando Industries which operates a "sheltered workshop" program for the handicapped. The program is presently carried on in facilities in Grand Haven. Persons participating from the Holland area are provided transportation in the agency's bus which was purchased by funds provided by the Michigan Cerebral Palsy Association. Plans call for the establishment of a sheltered workshop in the Holland area within a few years, Dykstra said.

The balance of the increase over 1966 of some \$11,000 is due to increased cost of doing business plus the population expansion in the Greater Holland area and its accompanying requirements for increased services.

Harrington's father, the late Capt. Austin Harrington, founded the Harrington Fuel Co. in 1888. Harrington is president of The Century Club, which gets its name from the fact that members, and past president of the Michigan Fuel Merchants and the Holland Lions Club.

Kupsky before coming to membership is limited to 100 Parke-Davis at Holland was associated with the company's plant at Rochester, Mich. He is also active in the Holland Rotary Club and the First Presbyterian Church of Holland. He and his wife and three children reside at 754 Central Ave.

First responsibility of the two chairmen will be to recruit leadership for the campaign's eight divisions. Division chairmen in turn will recruit section and district majors.

Upon completion of recruitment, over 800 volunteers will be engaged in the solicitation of contributions and pledges, Harrington stated.

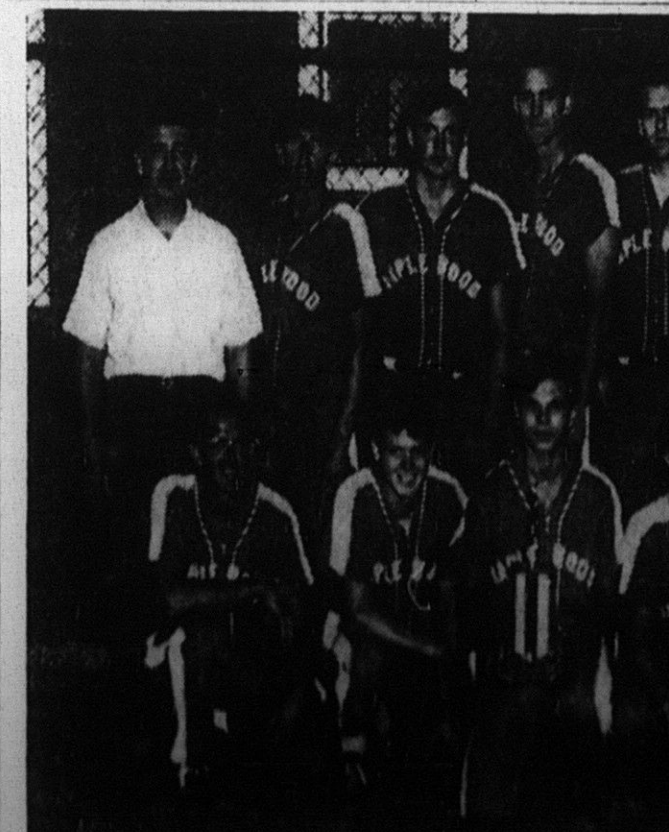

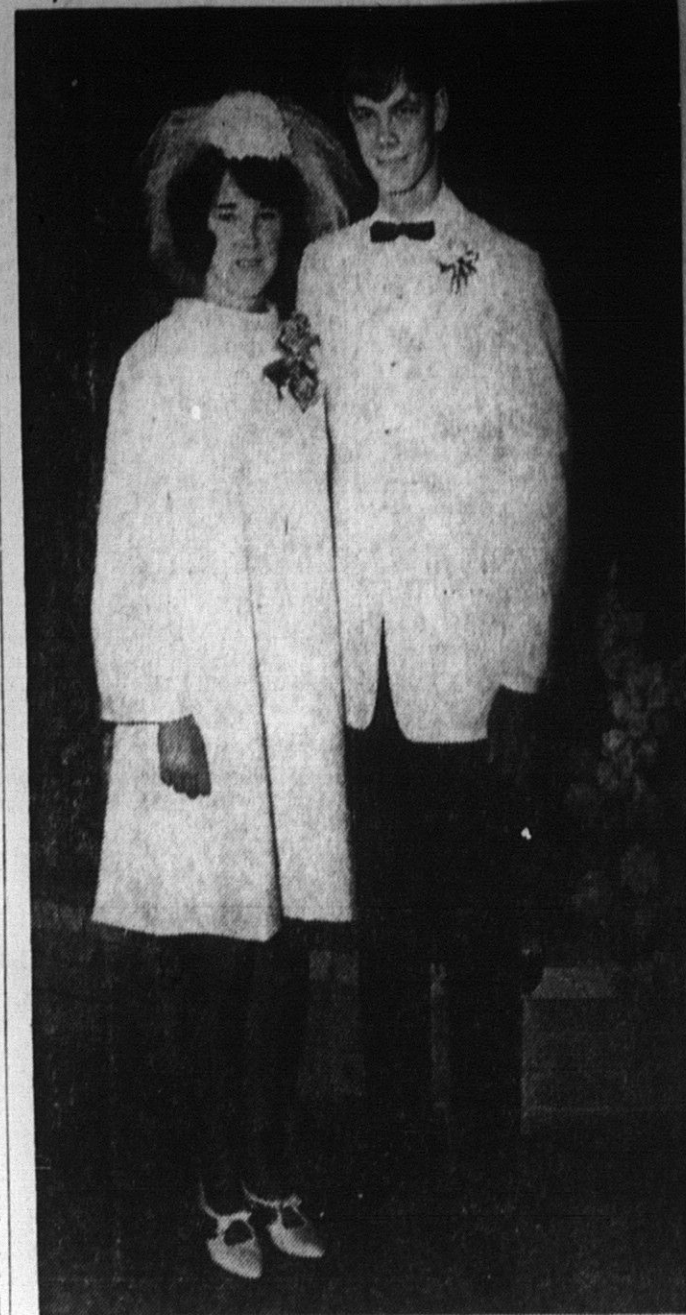

Sunday School Lesson

Sunday, Sept. 10
Ambassador in Chains
Acts 26:24-32
By C. P. Dame

If all Christians would witness as faithfully as Paul did the cause of Christ would progress much faster today. In our times Christians have many opportunities to witness for the Lord. May this lesson teach us all to witness more faithfully.

I. A personal witness counts much. In last week's lesson we studied about Paul and Felix who had lost his post. Three days after his arrival in Caesarea, Festus went to Jerusalem where the Jewish leaders asked him to send Paul to Jerusalem for trial. They planned to kill him if he would come. Festus refused and told the Jewish leaders to come to Caesarea which they did. When Festus asked Paul whether he was willing to go to Jerusalem he refused and appealed to Caesar.

Paul's appeal put Festus on the spot for he did not know what charges to make against Paul. Just then something took place which helped Festus — King Agrippa and his sister came to pay respects to the new governor. Festus told the king about Paul who said that he would like to hear the prisoner. On the next day Paul spoke in the palace before Festus, Agrippa, Bernice, and the military and civil notables of the city.

Paul's address was somewhat biographical and directed primarily to Agrippa. The apostle made it clear that the Old Testament messianic prophecies had been fulfilled in the death and resurrection of Jesus. We are sure that Paul spoke with passion and purpose.

II. Pagans misunderstand Christians. In the midst of the address Festus said with a loud voice, "Paul, thou art beside thyself; much learning doth make thee mad." Quick as a flash Paul replied, "I am not mad, most noble Festus, but speak forth the words of truth and soberness." Some moderns think Christianity is madness. The people who sacrifice for the faith are tagged fools by the pagans of today. Our day needs madmen of the type of Paul. We have too many who stand for the things Paul opposed. There are two ways of living—the way of the Pagan who lives for self, fun and pleasure and the way of the Puritan who feels deep in his heart that life is a trust and he is here to glorify God.

III. Being almost a Christian is not enough. Paul made a personal appeal to the king and asked, "King Agrippa, believest thou the prophets?" The king's reply, "Almost persuaded me to be a Christian," still puzzles the readers of the Bible. These words made Paul say that he wished that all who heard him "were both almost, and altogether such as I am, except these bonds." One of the saddest words in the English language is the word "almost" when it applies to our Christian persuasion. It is not enough to be almost a Christian—a person is a Christian or he is not one.

Paul's address convinced the notables who heard him that he had done "nothing worthy of death or of bonds." If Paul had not appealed to Caesar he might have been set at liberty. God had a plan for Paul—He wanted him to witness in Rome which he did.

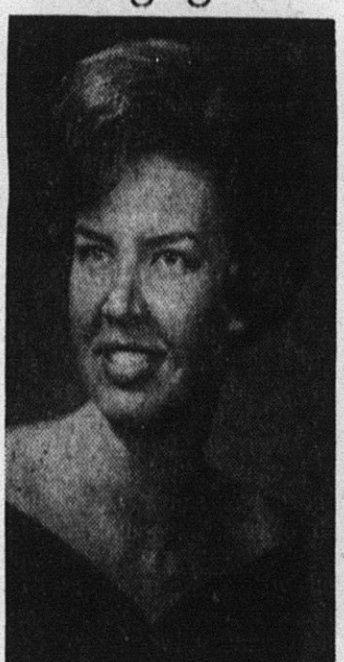

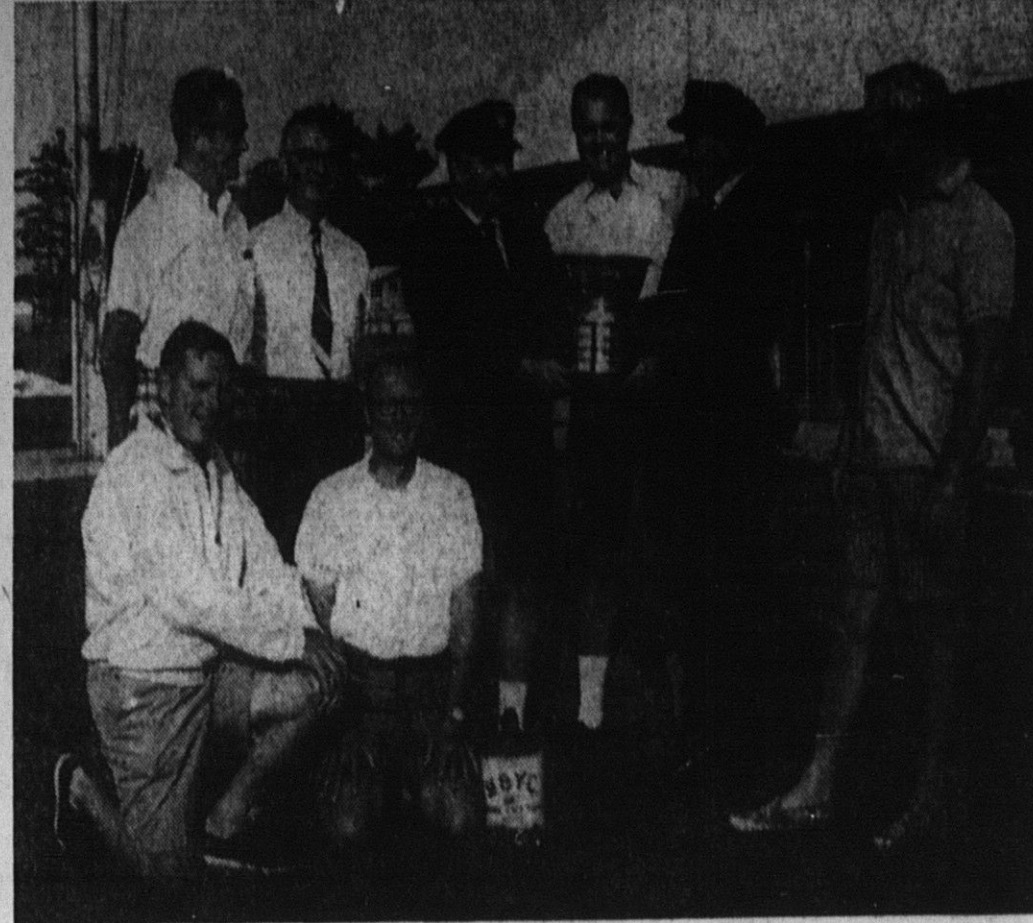

However, they have stipulated the trophy be awarded each year to the winner of a series of races rather than a trophy for a single event.

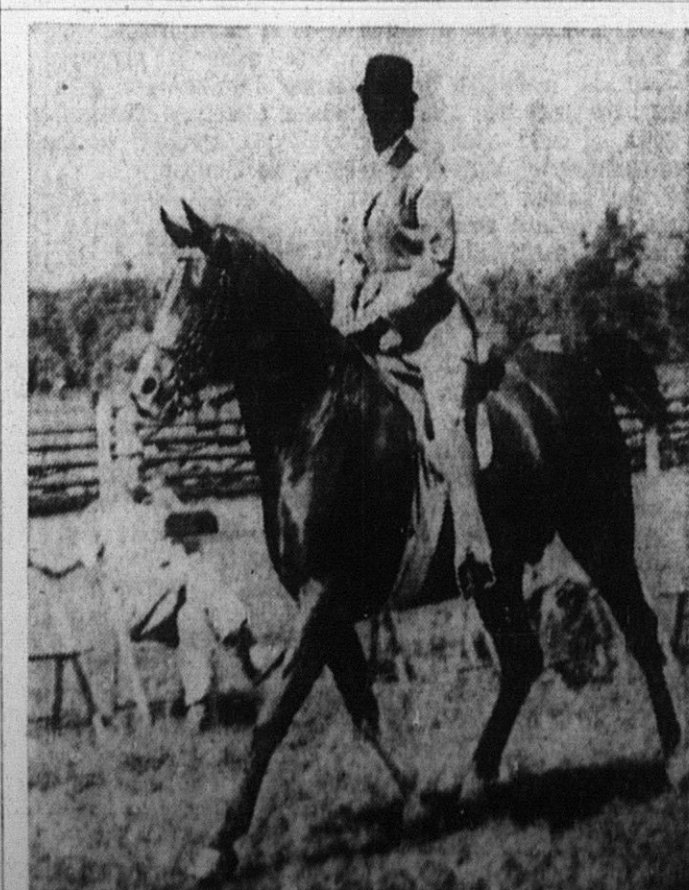

MEA Offers Support in Local Crisis

For a second day, members of the Holland Education Association met at the Enterprise Development grounds north of Holland, formerly the Holland Furnace picnic grounds, for a full day meetings Wednesday.

The meetings featured talks, discussion groups, curriculum study and organization for the 1967-68 school year.

Featured speaker this morning was E. Dale Kennedy, executive secretary of the Michigan Education Association who pledged full support of not only the MEA but also the NEA (National Education Association) in the current crisis in Holland.

He said there is nothing unprofessional about teachers wanting good working conditions or good salaries, and pointed to the need to demonstrate professional courage and stamina.

"In the final analysis," he said, "the persons having the greatest impact on all children of the community are the teachers."

He said the MEA is a firm believer in the legal approach and is concerned that everything of a legal nature be pursued. To this end, he said, the MEA has attempted to anticipate all legal action on the school front and has notified every circuit judge in Michigan that both sides should be present at hearings before any temporary injunctions can be granted.

He pointed to the legislature's bill in 1965 which provided that teachers be a full partner with the board, and urged all districts to take full advantage of such negotiations. Out of 516 MEA districts, all but 30 have found amicable solutions, he said.

Kennedy also pointed to the need of teachers having good public relations in their communities and urged old, young and middle-aged teachers to accept responsibility in seeing that communities are properly informed.

He said the MEA would be working with the state legislature in the October session on school matters but would be reserving the "vigorous campaign" in January.

Communities may think they are hit hard by special millage elections, he said, but not half as hard as some other countries. He noted some communities have had to hold six elections before passing millage for schools.

"Make your efforts visible, tangible and readable," he told HEA members. "Children want to be in school, parents want them in school, and you want to be in school, but let us not be diverted from our program."

He added there is nothing sacred about any particular opening date and the needed 180 days can easily be made up "even if negotiations continue to Oct. 1."

Harold Derks, city engineer of Holland, also addressed the teachers, speaking as a parent and citizen.

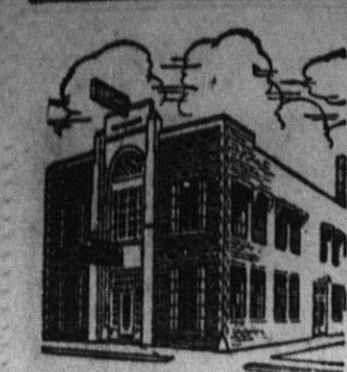

HOW TO MAKE A HIPPIE

The phenomenon of the non-conformist youth — the hippie — is a growing one in this country. In New York alone there are said to be upwards of 15,000 of them. Any large city can show you its colony and every university has its hippie heaven. Where do hippies come from? What makes them?

Various studies, by Harvard University, the New School for Social Research, and other organizations, have shown a number of stable ingredients in the recipe for a hippie. One of these is an upper middle-class background; a family in which the parents are college educated and broadminded but without very definite convictions on anything from politics to religion. This provides the potential hippie with a sense of aimlessness and a purposelessness. Another factor is a lack of deep affection among the members of the family, a feeling that nobody is really paying attention. This results in behavior that calls attention to itself in an appeal to get some real love and affection. Love-ins and that sort of thing is the result. Again, it is notable that most hippies come from families in which the father is not a very important person. He is too busy with his job and acquiring the symbols of success to give attention to his children. They reject him as being materialistic, frustrated, and dominated by forces beyond his control.

All this results in a complete permissiveness which obliterates all limitations on behavior and gives the impression that one kind of behavior is as good as another — that no one cares enough about his children to rear them in the way they should go.

The cure seems self-evident. Young people need the attention and discipline of their elders when it can be shown that these are given in recognition of the value of children. In other words, kids need a good dose of old-fashioned love from parents who know what they're living for. It looks as though this puts the burden for solving the problem squarely on the parents. What they need is enough sense of purpose and affection to gain the respect of their children.

Two Sought In Assault

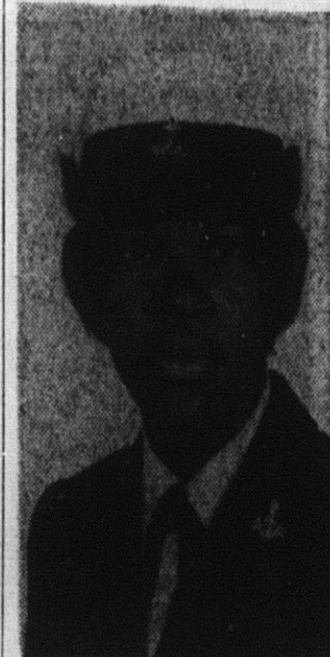
ALLEGAN — A Florida resident has reported he was assaulted and robbed late Saturday night at his Swan Creek camp site in Allegan State Forest.

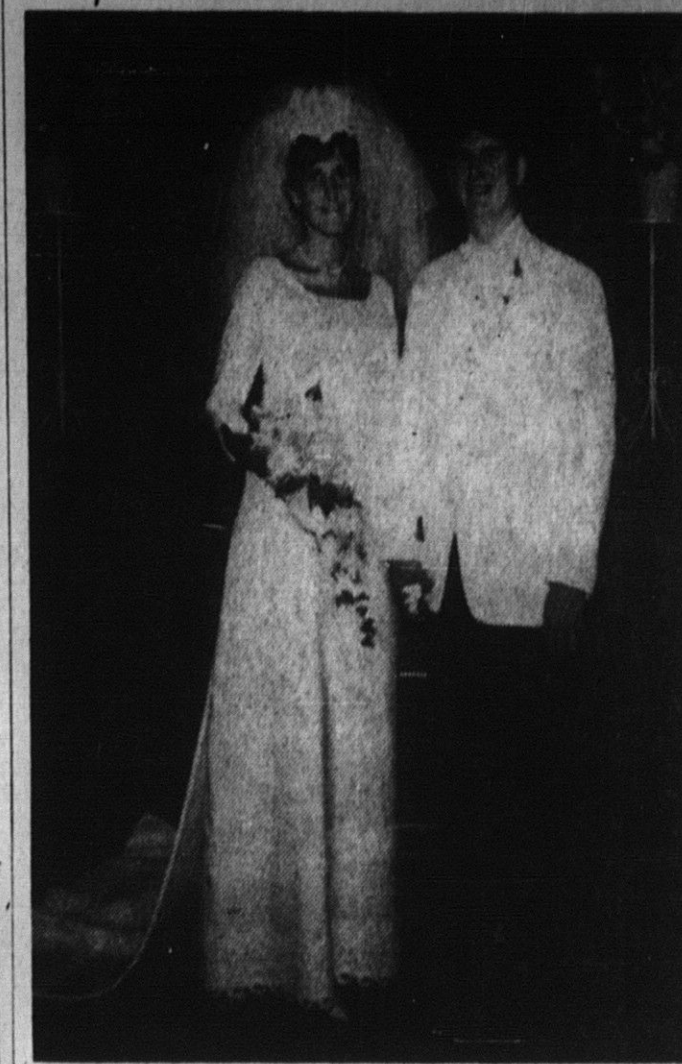

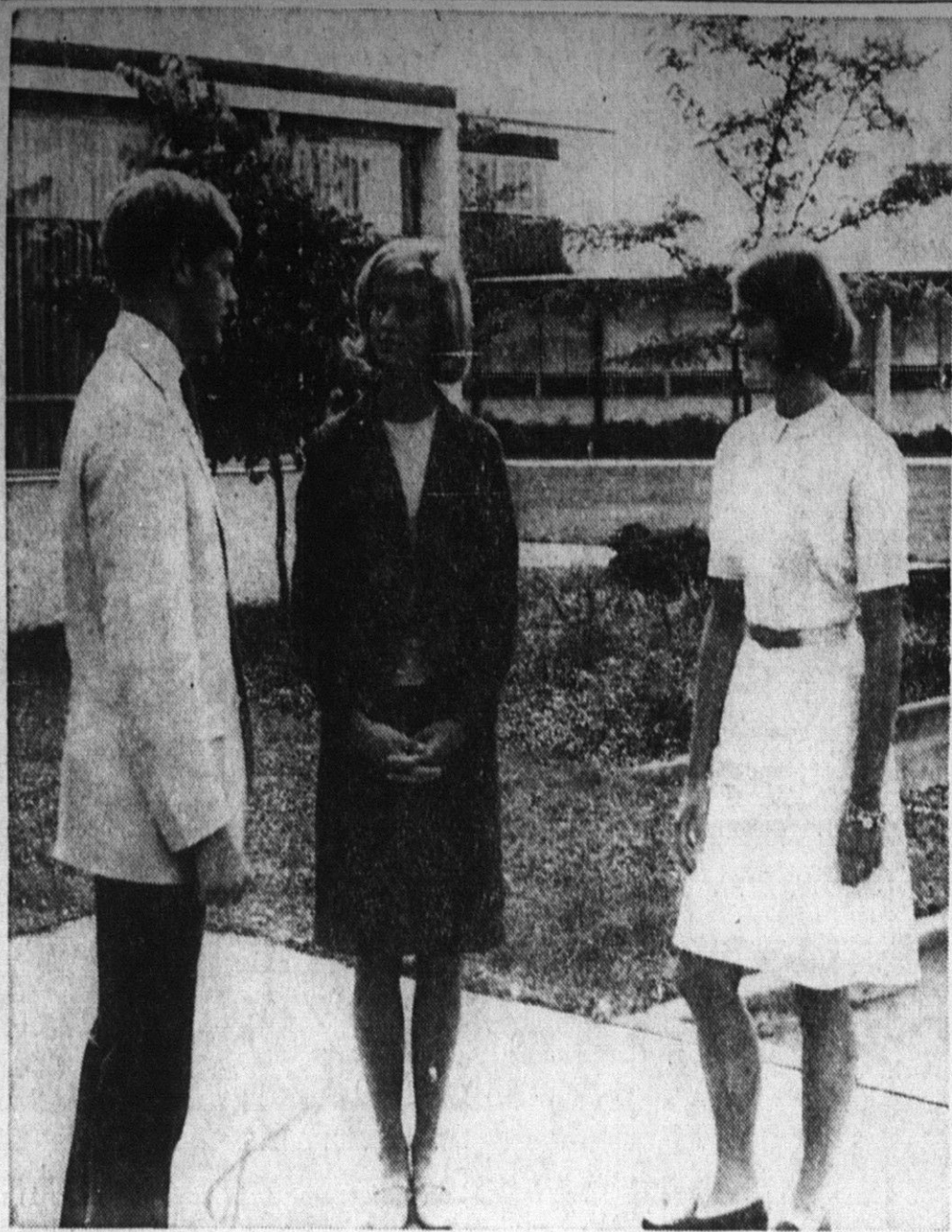

Red Cross Christmas Gifts Sent to Vietnam

Autumn is approaching in Holland, but it's "Merry Christmas" time at the Red Cross.

The Red Cross project of "Operation Shop Early," a program to provide Christmas gifts to every American serviceman in Vietnam, is being carried on in each of the 3,400 Red Cross chapters across the nation.

Volunteers in the Ottawa county chapter have filled 302 bags and prepared them for shipment so that they will be ready for delivery Christmas morning.

For two months, volunteers all over the chapter area have been busy sewing and filling red or green denim drawstring bags for the men in service.

Into the bags went such items as ballpoint pens, terrycloth wash cloths, paperback books, tissues, writing paper, envelopes, nail clippers, unfilled cigarette lighters, playing cards, snapshot holders, vacuum-packed cans of candy or nuts. The bags measure 11 by 13 inches.

Last year, the Ottawa chapter sent 236 bags in a similar project. Many thank-you notes were received.

Chapter leaders today expressed appreciation to the many volunteer workers who brought the project to a successful conclusion.

The "Shop Early" project is but one of several production projects for Vietnam in which the chapter is engaged. The chapter previously sent 100 filled friendship kits for South Vietnamese children for their three-day holiday early next year, a project of Red Cross Youth.

Other Red Cross groups and residents are working on 200 unfilled ditty bags for hospitalized servicemen in the Far East and layettes for distribution by the South Vietnamese Red Cross. These shipments will be made at a later date.

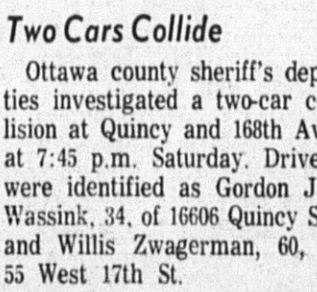
These projects are one of the chapter's 17 services, all supported by the United Fund.

Coach Russ De Vette will be starting his 13th season as head coach at Hope. His teams have compiled a record of 53-48 while winning two MIAA championships.

Members of the Hope squad actually reported on campus Thursday. They were issued equipment, underwent physical examinations and participated in a picture taking session. A "kickoff" banquet was held in the evening.

Classes on the Hope campus start on Friday, Sept. 14. Until then, football players will participate in two-a-day drills.

The Flying Dutchmen open their 1967 campaign on Saturday, Sept. 16 against Augustana College at Rock Island, Ill. The first home game is Saturday, Sept. 23, against Lake Forest College.

Hope has two new faces on its coaching staff this fall. Assistant Gordon Brewer with the linemen will be George Kraft while helping end coach Kenneth Weller will be William Vanderbilt.

Vanderbilt, a 1961 Hope graduate, earned seven letters while competing for the Flying Dutchmen. He lettered three times in basketball and track and once in baseball. He comes to Hope from New Trier High School in Winnetka, Ill. where he was a physical education teacher and coached tennis and freshman basketball. Vanderbilt will also assist in basketball and track at Hope.

Kraft, who will also be head coach of Hope's wrestling squad, was graduated from Wheaton College in 1962 where he earned varsity letters as a guard on the Crusaders' grid squad. He has served as a teaching associate at Indiana University since 1965.

Brewer, who is also Hope's athletic director, is entering his 12th season as line coach while Weller has been on the coaching staff for 16 years.

"Our football team has a real challenge," spoke De Vette as he looked ahead to the 1967 season. "We must improve a losing record with a squad depleted of some 13 underclassmen."

The biggest rebuilding task rests with the Hope line. "Our line coaches have an unbelievable job; reserves from last year's squad, some boys playing football for the first time, and incoming freshmen must do the job if it's going to get done," said De Vette.

Hope's strength can be found in the backfield. "It is the only place where we have both quality and quantity and the situation may dictate a change of position by some backs," De Vette added.

Heading the list of returnees are senior halfback Keith Abel of Jenison and Junior quarterback Gary Frens of Fremont.

Abel was the second leading rusher in the MIAA last fall with 522 yards and earned a berth on the all-conference team. For the season he rushed 599 yards and scored 18 points.

Frens, meanwhile, led the Flying Dutchmen in scoring with 27 points while completing 31 of 89 passes for 368 yards.

August Was Cold Month In Holland

August was one of the coldest months on record in Holland.

The monthly average of 63.8 degrees was 6.1 degrees below normal, according to Lynn P. Wheaton, official weather observer.

A high of 83 was registered on the first two days of the month, and a low of 41 was registered Aug. 11.

At no time has the mercury hit 90 officially in Holland this year, according to Wheaton's records. The high in July was 85, in June 87 and in May 84.

Rainfall in August totaled 2.05 inches or .65 inch below normal. Greatest precipitation in a 24-hour period was .92 inch on Aug. 30. Thunder was noted on six occasions and fog on three.

The maximum was 83, compared with 84 in 1966, 89 in 1965, 95 in 1964 and 85 in 1963.

The minimum was 41, compared with 42 in 1966, 38 in 1965, 36 in 1964 and 36 in 1963.

Average temperature was 63.8, compared with 66.5 in 1966, 66.3 in 1965, 66.6 in 1964 and 64.2 in 1963.

Average maximum was 75.7, compared with 77.5 in 1966, 76.1 in 1965, 78 in 1964 and 75.8 in 1963.

Average minimum was 51.8, compared with 55.4 in 1966, 56.6 in 1965, 56 in 1964 and 52.8 in 1963.

Precipitation measured 2.05 inches, compared with 2.85 inches in 1966, 5.13 inches in 1965, 4.63 inches in 1964 and 3.26 inches in 1963.

Precipitation fell on 11 days, compared with 11 days in 1966, 17 days in 1965, 7 days in 1964 and 9 days in 1963.

Greatest precipitation in a 24-hour period was .92 inch, compared with .80 inch in 1966, 1.76 inches in 1965, 1.43 inches in 1964 and 1.22 inches in 1963.

In 1959, the August average in Holland was 76.5 degrees or 6.6 above normal. In 1947, a high of 101 was recorded here in August.

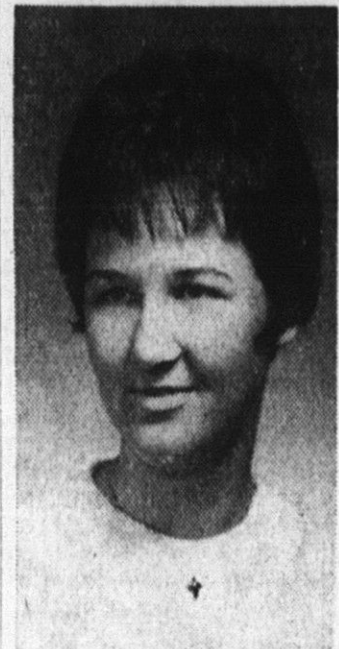
