R.G. Rescorla Dies at Scene Of Injuries

Kalamazoo Woman Dies At Hospital; Three Others Seriously Hurt

A Holland father of three was killed and a Kalamazoo woman died later of her injuries following a two-car collision Saturday at 5:10 p.m. in the intersection of Eighth St. and 112th Ave.

Rescorla, who was alone in the car he was driving, was pronounced

ed dead at the scene of multiple fractures by Medical Examiner Dr. William Westrate Jr.

Mrs. Nederhoed was taken to Holland Hospital where she died at 7:45 p.m. Saturday of multiple injuries.

Nederhoed, husband of the dead woman, is in Holland Hospital with chest injuries and lacerations. He is in good condition.

Mrs. Kuiper received a dislocated left hip and facial lacerations. Doctors were forced to amputate the big toe on her left foot. Mrs. VandeLaare received a fractured jaw and facial fractures. Both women are in fairly good condition.

Ottawa County deputies said Rescorla was traveling south on 112th Ave. and the car, driven by Nederhoed, was heading east on Eighth St. when the vehicles collided. Rescorla was returning from the American Legion Memorial Park after taking part in a General Electric golf outing.

Deputies said the Nederhoeds had taken a long ride from Kalamazoo and were on their way to Zeeland but apparently missed the turn because the detour on Eighth St. at the US-31 bypass does not have any signs pointing to Grand Rapids or Zeeland.

Rescorla's car smashed broadside into the Nederhoed vehicle. Both cars spun out of the intersection ending up on the southeast corner of the intersection.

Deputies said Rescorla was thrown from his vehicle. His vehicle apparently ran over him as deputies found a large portion of his shirt sleeve jammed between the rim and wheel of the right rear tire.

The Nederhoed car continued east, went off the road, turned on its side and then ended up on its top 65 feet from the intersection. All four occupants were trapped inside and deputies had to pry open the doors to remove the injured.

Relays of ambulances shuttled back and forth between Holland Hospital and the accident bringing in the injured. The wall of sirens from ambulances and cruisers attracted hundreds of curious motorists.

Law enforcement officers said the resulting jam tied up traffic for dozens of blocks around the accident scene. Holland police were called to Holland Hospital twice to clear the parking lot to allow ambulances to enter when dozens of cars jammed the emergency entrance.

Morbid motorists had Eighth St. so tightly clogged that ambulances were forced to use the left hand side of the road to get to the accident.


Adding to the tieup was M-21 traffic, which is now detoured down Eighth St. to the US-31 bypass. At one time cars were lined bumper-to-bumper on the US-31 bypass past Russ' on Eighth St.

The same problem confronted deputies at the accident scene when drivers parked their cars on the shoulder and in the middle of the road completely blocking 112th St., north and south.

Ambulances were forced to jockey back and forth when they attempted to leave the scene, deputies said, because autos were parked within a few dozen feet of the crash.

Police were also forced to direct traffic at the US-31 bypass to relieve the jam and at 16th and 17th St. intersections on River Ave. to get the ambulances through.

Rescorla was born in Grand Haven, educated in Grand Haven

Holland Man Jailed, Fined On 4 Counts

A Holland man today was fined and jailed on four counts arising from an accident Wednesday at 3 p.m. at the corner of 24th St. and Washington Ave.

Bobbie G. King, 26, of 94 West Seventh St., was charged by Holland police with driving while his license was denied, failure to yield the right of way to through traffic, leaving the scene of an accident and driving with his vision obscured by a dangling ornament on his rear view mirror.

Municipal Court Judge Cornelius vander Meulen fined King \$10 on the first count, plus four days in jail to be served on two weekends, \$15 on the right of way charge, \$50 for leaving the scene and \$5 for the dangling ornament.

King was also assessed \$4.70 in costs, and Judge vander Meulen said that if the fine and costs are not paid, King must serve an additional 45 days in jail. The fine on the dangling ornament charge was the first in Holland, but police are checking for other violations of this new law.

According to police, King, headed west on 24th St., collided with a pickup truck and trailer, driven by Vernon E. Boneck, 38, of 83 Burke Ave., headed north on Washington Ave.

King left the scene of the accident, officers said, but was halted at the corner of 21st St. and Maple Ave. by a Board of Public Works employee, Cornelius Caauwe, 33, of 711 Riley St., who saw King leave, followed him and brought him back.

Police estimated the damage to Boneck's 1941 model pickup truck and trailer at \$100 and the damage to King's 1952 model car at \$60.

Zeeland Farmer Fights Birds With Fireworks

ZEELAND, Mich. — Blackbirds that land in farmer John Wolfert's cornfield are in for a bang of a reception.

Wolfert, with help from Ottawa County farm agent Richard Macchiele, inserted firecrackers on a special rope fuse designed to explode one firecracker every four minutes.

He said he tried scaring birds away from a test plot of corn which they especially like with a shotgun but they came right back as soon as he left. He hopes the firecrackers will keep them away for good.

Four Injured, One Seriously, In Two-Car Collision in City

Four persons were injured, one seriously, in a two-car collision Wednesday at 11:46 p.m. at the corner of 16th St. and Maple Ave., in which one car rolled over several times and came to a stop on its top.

Miss Ellen Van Eerden, 32, of Grand Rapids, is reported in serious condition at Holland Hospital with a possible fracture of the skull, a concussion and multiple lacerations.

Mrs. Jeanette Vanden Bosch, 27, of 256 West 16th St., is listed in good condition at the hospital with a fracture of the pelvis.

Both were passengers in the car which tipped over after the impact, driven by Mrs. Vanden Bosch's husband, Corie, 38, who was treated for bruises at the hospital and released.

Bobby Trosper, 22, of 181 West Ninth St., the driver of the other car, is listed in good condition at the hospital with lacerations of the scalp and knee and multiple bruises.

Central Ave. 'Islands' Are Tabled Again

Traffic Problem To Be Studied by New Traffic And Safety Commission

After a 45-minute discussion in which several persons in the audience expressed their views on traffic "islands" and other possible safety solutions, City Council Wednesday night again tabled the Central Ave. traffic problem in the hope that a newly appointed traffic and safety commission would study the situation and come up with recommendations . . . or new solutions.

The subject had been brought up two weeks ago when City Manager Herb Holt submitted a recommendation making the two traffic islands at 26th and 30th St. permanent. The recommendation called for eight-inch curbs and rounding off corners drawing them in a foot. Council decided to delay action for two weeks to allow public expression.

This expression came in the form of two petitions, one with 104 signatures expressing appreciation for help and effort put forth by Council and the Planning Commission in solving the traffic problem, and the other with 290 signatures opposing the islands and asking that Central Ave. be made a through street from 22nd and 32nd Sts. with a four-way stop at 28th St.

As the discussion progressed, Council had a tendency as Mayor Robert Visscher said to "go far afield." This confusion became more and more evident as Council sought to amend the original recommendation by stopping east-west traffic in intervening blocks. The first amendment which passed called for stop signs at 27th, 29th and 31st, and a second amendment which was defeated 5-4 called for making east-west traffic on all other blocks stop.

By that time, Mayor Visscher said he would entertain a motion to table the subject until the new safety commission could study it. This motion passed unanimously. Councilman Henry Steffens expressed the hope that the commission could come up with solutions other than diversers, and Councilman Raymond Holwerda hoped Councilmen would give the new commission a clear field and not prejudice the new members with current ideas.

A water color depicting a landscaped traffic island painted by Mrs. Arthur Read was on display in Council chambers.

About 30 persons were in the audience, some of whom expressed opinions. These included Al Kalkman, Frank Van Alsburg, Mrs. Harvey Kronmeyer, Gustave Vanden Berg, Gordon Zuverink and Mrs. Lloyd Gunther.

Kalkman who lives at 28th and Central definitely likes the present arrangement with traffic islands at 26th and 30th and a four-way stop at 28th. Van Alsburg asked whether such programs could become standard policy in Holland's traffic pattern and Mayor Visscher replied that each situation must be evaluated on its own merits, and that he personally would favor diversers in other areas.

Mrs. Kronmeyer who lives at 27th and Central felt that much of the 26th St. traffic had been diverted to 27th St. and felt that stop or yield signs at 27th St. would help avoid accidents. She said cars generally do not keep right in making left turns. She said she had obtained 80 signatures on her petition to take out the islands.

Of other persons she contacted, seven liked it and three preferred to remain neutral.


Vanden Berg who lives on another corner at 27th and Central said four or five persons preferred to remain neutral of those he had contacted. He advocated a 15-mile one at Southside School on 29th St.

Councilman Holwerda asked whether the islands would pose any problem for snowplows during the winter, and City Engineer Lavern Serne said the plowing program naturally would be different but he considered it a minor problem, not a major problem.

Councilman Ernest Phillips pointed out that the Central Ave. program to slow speed is only a part of a proposed five-point program to protect residential areas in the triangle bordered by State and Michigan.

Zuverink who circulated petitions favoring the islands said he had obtained signatures with not too much effort. Should Central Ave. become a through street, he felt the next thing would be an invitation to trucks, eventually widening the street and then devaluing the property. He said he was opposed to the original diagonal divider but favors the islands.

Mrs. Gunther said no full scale program was used to get signatures on petitions retaining the islands but she felt that every parent who has a child attending school at Central Ave. and 29th St. would sign a petition which would slow speed on that thoroughfare.

Neal Held Without Bond

ALLEGAN (Special) — Linford Neal, 33-year-old farm worker, accused in the July 26 bludgeoning slaying of Erwin Schoenmaker, 46, West Olive, stood mute on arraignment in circuit court Monday and Judge Raymond L. Smith entered a not guilty plea in his behalf. Judge Smith refused to set bond in the case and denied a motion for adjournment made by Neal's attorney, Mrs. Elizabeth Ramsey of Plainfield. Trial was set for Sept. 25-26.

Also in circuit court Monday, two Plainwell brothers, Theodore, 23, and Howard Boss, 17, were placed on probation for two years and sentenced to 30 days in the county jail. The pair admitted to a charge of larceny from a car and were ordered to make restitution.

William P. Babbitt, 17, Plainwell, who admitted to theft of a car, was given three years probation, 30 days in jail and ordered to make restitution totaling \$918.

Donald Bennett, 20, Benton Harbor, also admitted to a car theft charge and was sentenced to serve from two to five years in Southern Michigan Prison at Jackson.

John Graham, 17, route 4, Allegan, admitted to breaking and entering in the nighttime after being implicated in last week's break-in attempt at the Allegan high school. Sentence was postponed.

Jerry Johnson, 17, of Allegan, was given two years probation and thirty days in jail for forging a check.

The case of Fred Psivda, 37, of Allegan, charged with larceny from a building, was adjourned to Nov. 10 and the \$1,000 bond continued.

Deputies Investigate Three-Vehicle Crash

Ottawa County deputies today continued their investigation of an accident involving two cars and a three-quarter-ton truck Wednesday at 5 p.m. at the intersection of M-21 and 120th Ave.

Deputies said the truck, driven by Fred Bosma Jr., 33, of 15 South Wall St., Zeeland, and a car, driven by Amos L. Malone, 22, of Ft. Riley, Kansas, were both headed east on M-21 while a car driven by Wallace T. Kempfers Jr., 17, of 122 East 16th St., was going south on 120th Ave.

Kempfers and Bosma collided, deputies said, and Malone, following Bosma, then collided with the Kempfers' car. Deputies estimated the damage to Kempfers' 1956 model car at \$150, the damage to Bosma's 1957 model truck at \$100 and the damage to Malone's 1952 model car at \$25.

Wandering Goat Returned to Home

The wandering goat which was picked up by Holland police about midnight Monday in the downtown area returned home Wednesday, "baited out" of the County Humane Shelter by its owner, John Wiggers, of route 1.

The goat had traveled quite a distance, since Wiggers lives south and west of Graafschap. Wiggers said he believes someone turned the goat loose as a prank, since the animal's chain was not broken, but unsnapped.

Safety Commission Appointed

John Ver Lee Named As Member of Allegan Board of Supervisors

Mayor Robert Visscher appointed nine members to the newly created traffic and safety commission at a regular meeting of City Council Wednesday night. The new commission, made possible by passing a special ordinance two weeks ago, will function in an advisory capacity much the same as the planning commission. The commission's action will consist of making recommendations to Council.

Appointed to serve three-year terms are Dale Van Lente, A. G. Sall, Russel Fredericks; two years, Sandy Meek, Merle De Feyter, Don Cudworth; one year, Vern Schipper, Robert Strabbing and Henry Vander-Plow.

Perhaps the first subject to be studied by the new commission will be the matter of traffic on Central Ave. with consideration to traffic islands, diversers, stop or yield signs and possibly four-way stops. This subject was tabled by Council Wednesday night following a 45-minute discussion.

Another Council appointment was that of John Ver Lee, now living in the Allegan county portion of Holland city, as a second city supervisor on the Allegan Board of Supervisors. Ver Lee, a local mortician, has relinquished a share of his responsibilities through a new partnership.

After the necessary hearings, Council adopted three resolutions. One vacates an alley between 19th and 20th Sts. running west from Michigan Ave. to the closed portion. Another vacates River Ave. between 27th and 29th Sts., and a third authorizes construction of a water main on East 24th St. from Lincoln Ave. 554 feet east.

Petitions for street lights on West 35th St., also at Pine and 40th, and 40th and Central were referred to the city manager with power to act. On suggestion of Councilman Raymond Holwerda, the city manager was authorized to make an overall study on needed street lighting in the newly annexed areas.

Petitions for water service on several sections of the Montello Park area were referred to the city manager for study. Listed were 29th St., Graafschap Rd. one block east of Plasmans; 30th St. from Sandy Pl. to one block east of Plasmans; 31st from Plasmans to one block east of Plasmans; 32nd from Graafschap Rd. to one block east of Plasmans.

A personal injury claim filed by Mrs. Angeline Westerhof was referred to the city attorney and the insurance company.

Council approved a recommendation of the Hospital Board to construct an 8 by 12 foot building to house emergency generator, cost not to exceed \$1,100. Also approved was request to purchase five dressers, \$317.25; 10 pair siders, \$480; total \$797.25.

Council accepted with thanks the report of a gift from Holland Hospital Auxiliary of six recovery room stretcher beds valued at \$2,130.

The city assessor presented three paving and improvement special assessment rolls for work completed during 1958: paving Cleveland Ave., 16th to 22nd Sts.; cost to be assessed, \$22,596.68; paving College Ave., 30th to 32nd Sts.; \$7,484.75; opening and improving alley between Eighth and Ninth Sts., running from River to Central Aves., \$11,682.59. Objections may be heard at a public hearing Oct. 1 at 7:30 p.m.



Dawn Kuker Dies 10 Hours After Mishap

Girl Had Been Playing With Sister; Believe Matches Started Blaze

A four-year-old Holland girl died shortly after midnight Friday at Holland Hospital of burns received while playing with matches at her home Friday afternoon.

The victim was Dawn Marie Kuker, daughter of Mr. and Mrs. Henry Kuker, of 169 East Fifth St.

Hospital officials said the little girl had suffered burns of the abdomen, both legs and right arm.

"She came running into my bedroom screaming, with her clothes on fire," the mother said. "I tried to beat out the flames, and then I wrapped her in a blanket and smothered her."

The distraught mother bundled her daughter into a car and drove her to Holland Hospital, where her condition was first described as "fair."

Mrs. Kuker said Dawn had been playing with her sister, Gayle, 3½, in the backyard of their home when the tragedy occurred, about 1:30 p.m. Friday.

The mother, who works nights, said she was taking a nap when she was awakened by the screaming, and then Dawn ran into the room, her little cotton dress in flames.

Gale later told the mother the two had been playing with matches, and produced the paper matchbook. Holland fire authorities and detectives are investigating.

The victim, who would have been five years old on Nov. 21, had just started school at Lincoln School.

Surviving besides the parents are two sisters, Gale and Cindy, both at home; one half-sister, Judy Rotman; and a half-brother, John Rotman, both at home; and the maternal grandparents, Mr. John De Witt and Mrs. Cy Hoezee, both of Holland.

Funeral services were held Monday at 2 p.m. at the Dykstra Funeral Home Chapel with the Rev. E.M. Ruhlig officiating. Burial was in Rest Lawn Memorial Gardens.

Annexation Brief Filed With Judge

Townsend Studying 29-Page Document, Drafting Answer

City Attorney James E. Townsend said Friday he would request a few days to study a 29-page brief which he received Thursday from Allegan Attorney Leo Hoffman who is representing 71 persons living within the annexed Maplewood area seeking to have the June 3 Maplewood annexation election declared unconstitutional. The original brief was filed with the judge.

At a hearing in Allegan Aug. 22, Circuit Judge Tom Robinson of Benton Harbor had granted a two-week delay to allow Hoffman to file a brief. The time was up last Saturday and early this week Hoffman was granted a few more days.

Townsend said he expects to file an answer after studying the 29-page brief which he said appears to be a thorough research job dealing mostly with the reasonableness of including agricultural land in annexing programs. A good share of the brief is devoted to cases in Kansas, Missouri and other states.

The Aug. 22 hearing was called on Townsend's motion to dismiss the case brought by the 71 plaintiffs whose property in the annexed Maplewood area, according to Hoffman, accounts for some 1,500 acres of the more than 3,000 in the Maplewood area. The Maplewood area is located in Fillmore township in Allegan county. Two other areas annexed in the June 3 election, Apple Ave. and Montello Park, lie in Holland township.

At the brief 32-minute hearing in Allegan court house Aug. 22, Judge Robinson allowed Hoffman two weeks to prepare a brief and said he would allow Townsend a few days for an answer after which he would rule on Townsend's motion to dismiss.

Following a reception in the church parlor, the couple left for a honeymoon trip through Michigan.


Upon their return, the newlyweds will make their home at Sparrow Village, East Lansing, while Mr. Schaap completes his studies at Michigan State University.

The widow of Jerry Dykhuis, she was a member of Ninth Street Christian Reformed Church and had been a member of the Ladies Aid Society.



IS THE U. S. "GOING BROKE"?
A former dean of the law school of Notre Dame has expressed the passionate warning that the United States is "going broke by leaps and bounds."

This seemingly sensational pronouncement was made by former Dean Clarence E. Manion in an analysis of the increase in the national debt limit to 288 billion, asked for by the President and granted by the 85th Congress.

Now Dr. Manion is not a mere sensationalist trying to get a little free advertising for himself by making shocking assertions. He is a cool-headed jurist who believes that the American people should be told in plain words that, in repeatedly authorizing the increase in the debt limit, their representatives in Congress are leading them to the very brink of economic disaster.

Dr. Manion is by no means alone in his warning. Some of the most powerful voices in the nation have made similar protests. President Eisenhower himself, some months before the debt limit was raised, suggested that one of the most deadly menaces the American people face is the economic menace. But in the end he felt forced to ask for a "temporary" raising of the debt limit. But everybody knows, of course, that such a raise is never "temporary." The President also felt forced to veto one revenue measure because Congress had insisted on appropriating more money than the administration had asked for, doing so of course because appropriations can be translated into votes, and this is an election year.

Dean Manion addressed his warning not to the President alone or to Congress but to us, the Americans. We must develop a public opinion that will make further increases impossible. This is how Dr. Manion put it:

"If we are to win this life or death struggle with Communism, we must think of something to do other than to spend money, and this for the very simple reason that we haven't any more money to spend."

"When we arrive at that fateful breaking point and then and there completely crack up financially, the Communists will have won their war against this country in the only way that they have ever planned to win it, namely, through collapse into chaos from the inside."

That is not sensationalism, it is simple economic sense. The most shocking feature of the public reaction to the work of the 85th Congress was the almost total indifference with which this further step toward national bankruptcy was met by the American people. Dr. Manion's warning comes near to being a voice crying in the wilderness.

This should give citizens something to talk about when they see Congressmen who are home campaigning. We have requested many times a reduction in the tax dollar waste.

The husband, Raymond J., 41, waived examination when he was arraigned Tuesday before Justice Eva Workman on an aggravated assault charge. Unable to furnish \$1,000 cash bond, he was committed to county jail to await appearance in Circuit Court Sept. 22.

Sunday School Lesson

Sunday, Sept. 21
Justice for People in Need
Isaiah 58:6-8; Luke 4:16-22;
Hebrews 13:1-3

There are still needy people in our land. The Bible teaches us that we Christians should show concern for the needy and neglected people. We are debtors to all people in view of the fact that we have received the gospel.

I. Real religion is more than mere ritual. God gave certain ceremonies to Israel which the people were told to observe. The purpose of these religious ceremonies and rituals was to help the people to grow spiritually. Many people in Israel concluded that the keeping of these religious ceremonies was sufficient. If they observed these they had done their duty to God and man. Some church members think that if they go to church now and then they have done their duty. Worship should be followed by good works. That truth Isaiah teaches in this lesson — he calls upon believers "to loose the bands of wickedness, to undo the heavy burdens and to let the oppressed go free and that ye break every yoke. Those who have advantages should share them with others."

In the days of Isaiah there were hungry people, poor people, those in need of clothing and of shelter. In our world there are a billion people who have never seen a doctor or a dentist and who probably will never see one. In Asia there are a million blind people to whom we could give sight with the medical techniques at our disposal. We may not be able to help all needy people but we at least can show concern and begin to do what we can for those in need. Everyone knows that there are problems involved in getting help to the needy especially those living in foreign lands but it is also possible that we have not thought hard enough about this problem.

II. Jesus was much concerned about needy people. In the town of Nazareth Jesus had helped his foster father Joseph as a carpenter and learned the trade. He left his home town and preached and healed and taught and then after a year he returned home again and preached in the synagogue which he most likely attended as a boy and young man. It was the custom of Jesus to worship in the synagogue. Jesus was invited to read the Scripture — he read from the book of Isaiah. Some think it was the lesson for that day, others think Jesus purposely chose that passage. After reading the Scriptures Jesus handed the scroll to the attendant and sat down and spoke to the people.

The passage from Isaiah foretold about the ministry of Jesus. In this passage various kinds of people are mentioned — the poor, the broken-hearted, the captives, the blind, the bruised, and Jesus said that he had come to minister to those people. It is the business of the church to minister to these people too if the church wishes to be true to Christ. The kind of people Jesus described are still with us. When Jesus pointed out to his hearers that God in times past had shown special favors to Gentiles his hearers got angry and pushed him out of the synagogue and took him to the brow of a hill to throw him down headlong but he escaped.

III. Brotherly love should lead to service. Hospitality is praised in the New Testament. Inns and hotels were few and accommodations poor. To show hospitality indicated brotherly love. Some Christians suffered imprisonment for their faith and others met with adversity — these all should be remembered. Anyone in need ought to be helped.

Ottawa County Farm News

By Richard Machiele

Red banded leaf rollers are appearing in orchards and represent a real threat to the fruit growers. Infestation, however, is spotty and control can only be determined by observation. Apples are usually hardest hit in Michigan and injury continues after harvest unless the fruit is promptly and properly taken care of. They are now in the larvae stage and the worm lives inside of the webbed leaf and often attacks the fruit. The material to spray with is Phosdin. However, all precautions should be taken when using this highly toxic material.

There has been some problems in connection with fumigating nematodes in celery crops. It has been found that the damage was not due to the fumigant but due to the high ammonia content in the soil. Soils that had severely damaged plants in them had little or no nitrogen. This was due to the chemical used in the fumigant destroying the bacteria that converts ammonia to nitrates. As a result this fertilizer in ammonia form injured the celery roots. It is recommended anyone planning to treat for nematodes in celery fields do so in September so that there would be ample time for the nitrates forming bacteria to reestablish themselves before the crop is planted in the spring.

The July report from the Missouri State Poultry Experiment Station on the random sampling egg laying test arrived. We find that Ottawa County hatcherymen who have entered this contest are doing very well for themselves.

The local hatcherymen who have entered this contest are the Townline Poultry Farm, Zeeland; De Witt Hatchery, Inc., Zeeland; Dirkse Leghorn Farm, Zeeland, and the Ford Poultry farm, Coopersville. Income over feed and chick costs range from \$3.83 to \$3.43. We think this is one good way for our hatcherymen to compare their line of chicks with others in the country. Anyone interested in seeing results of this test can do so by checking at our office or writing to the Missouri State Poultry Station, Mountain Grove, Mo. for the monthly reports.

With the cool weather coming on it is time for the clover mites to be showing up on the sides of our buildings. The clover mite is a very small insect the size of a pin point and they are dark reddish brown in color. They are found on clover, grass, apple, peach, raspberry, forest trees, shrubbery, and some other plants. They are usually found on the underside of the leaves. Eggs are laid in the fall on the twigs and branches of infested plants and are also on the foundation and other parts of the building. They pass the winter as eggs. They do cause a slight damage to the plants on which they are found but they are more of a nuisance than anything else.

Here are some control measures: First, tighten or caulk the building especially around the windows. Keep an 18 inch strip of grass-free soil around the foundation. For chemical control outside the house sulfur and any one of the lawn spray treatments can be used. Band the foundation with sulfur applying a 6 to 10 inch band being careful not to apply sulfur to flowers or shrubs as it will burn them. Thoroughly spray a 30-foot strip of grass and clover next to the foundation with one of the following materials: Oxex, Malathion or Chlorobenzilate.

Just one word of caution to farmers who are contemplating on taking the third cutting of alfalfa or pasture it, September is the month in which the food material is stored in the roots. You are taking a chance by pasturing alfalfa fields during the month of September. They can be pastured in October without damage to the root system.

They will be accompanied by two of the children of the late minister, Danny and Janelle. His wife, the former Mary Van Wynen, will arrive in Holland the end of this month with their daughter, Beth Ann.

Rev. Lemmen said a memorial service was held Sunday at the Lynn Lake mission chapel with Pastor John Goodrich in charge.

A small group of men from the area succeeded in getting to the Vanderkerchov Lake area Monday. Because of the rocks and brush they tore their shoes and ripped their clothes. Upon arriving they held a memorial service.

In reconstructing the drowning which occurred on a camping trip, Rev. Lemmen said the boat in which Wilbert and two boys, Bill and Paul Roberts, were sitting, was swamped in the rough waters. The group was in the water about 15 minutes before the boys swam to shore. Because of Wilbert's heavy clothing he struggled in the water for a half-hour before he went back to the boat and was lost under a wave.

"God bless you, boys," were the last words the young minister said to the boys, they said. They waited about two hours and then started out for help. They were spotted the next day by plane and hospitalized. They were later released.

The Lemmens, accompanied by their son, Leonard, were flown to Duluth, Minn., by Irville Harrington of Holland. Because of bad weather, they drove by car to Crambury, Manitoba. They were joined at Bagley, Minn., by the Van Wynens and the Rev. Phil Van Wynen, who serves a church in Bagley. The group took a train from Crambury to Lynn Lake and arrived Saturday night. The Lemmens left the area Wednesday.

Holland Makes Fairly Good Showing in Safety During 1957

Holland made a relatively good showing in the annual inventory of traffic activities for 1957 despite three fatalities during the year involving children under five years old.

The report on Holland's traffic activities was presented Tuesday afternoon in City Hall by Sgt. Edward Mc Garvey of the Michigan State Police who was accompanied by Sgt. Milton Swingle. Holland was one of 442 cities in its population group participating in this program which is sponsored by the National Safety Council.

Data for Holland's report was compiled by Garth Newman, local public safety technician. This involved detailed data on all the separate fields of safety endeavor plus exhibits.

A series of recommendations listed in the report will serve as a good starting point for the newly created Traffic Safety Commission provided in a new ordinance which Council adopted last week. Mayor Robert Visscher will make appointments soon to this commission which will serve much like the Holland Planning Commission which submits its recommendations to City Council after studying and investigating various subjects.

Another starting point for the new traffic commission will be the AAA survey, a \$6,000 traffic engineering study conducted in Holland some months ago by the

The two-man Grand Haven No. 1 team came in first in Class D with a total score of 542, with Chief Richard Klempe shooting a 274 and Patrolman Bob De Weese contributing a 268. Chief Klempe also won the first-place trophy in the special Chiefs of Police match

with a 190 out of 200. A total of 120 teams from 64 police and sheriff's departments and State Police posts around the state entered the meet, with 407 individual marksmen competing for prizes. Gov. G. Mennen Williams made the presentations.

The Ottawa County Sheriff's department's two-man team of Sheriff Gerald Vanderbeek and Deputy Ed Kampen, competing in Class D, finished in sixth place, with Vandereek posting a 264 and Kampen a 251.

Honorable Mention Goes To Band Shell

Kammeraad and Stroop, local architects who designed the band shell for Kollen Park in Holland, have received honorable mention for their entry on the local band shell at a meeting of the Western Michigan Chapter of the American Institute of Architects in Lansing Monday.

Their presentation consisted of a 30 by 40 inch mount showing plot plan, floor plan, exterior photos and a statement of the problem. It came under the category of religious and public buildings, and was the only entry in that category to be recognized outside of a first prize for a church.

Other categories were residential, commercial and industrial, and schools. Top prize went to G. J. Daverman, Grand Rapids architect, for an entry on schools. The local band shell is described as pure structure with particular emphasis on economy and functional aspects. The arches of laminated fir are structural support for the deck, and the deck itself acts as a stabilizing force to keep the arches in place. The cedar deck also carries the roof and lights and acts as an acoustical reflecting surface.

Local leaders are highly pleased with acoustical effects of the band shell which was placed in that section of Kollen park for best advantage of heights, wind and other factors. Under fair conditions, concert music can be heard clearly all over the park and neighborhood without public address systems.

Kammeraad and Stroop will receive three certificates for this honor, one for the architects' office, one for the owner and one for the general contractor.

City Manager Herb Holt said he had received a letter this week from the mayor of Greenville, Ill., for information on Holland's band shell. There have been many such inquiries since the band shell was completed last Tulip Time.

School Buses Must Install New Signs Required by Law

Ottawa County Safety Director Len Verschure and City Safety Technician Garth Newman Friday started an extensive check of all school buses in Ottawa County and those of Allegan County which come into Holland, checking on the installation of the new signal system and the painting of new signs on the buses.

An estimated 70 per cent did not have the proper signals and signs on yet, Verschure said, although he reported that many have promised to comply with the new state and city laws by Monday.

The new school bus law went into effect Monday, requiring motorists to stop both facing and behind a stopped school bus which has the newly-required red lights flashing both front and back.

The signs required on school buses by the new law read, "Stop on Signal When Bus Stops." Buses which do not have the proper signs and manually operated signal lights by Monday will be in violation and subject to possible action, Verschure said.

Verschure said it is the duty of the Superintendent of Public Instruction and the board of each school district to see that school buses comply with the new law. The Holland city council recently passed an emergency city ordinance conforming to the state law.

It is emphasized that stops must be made at least 10 feet in front of or from the rear of a stopped bus, and motorists may not proceed until the school bus resumes motion or the visual lights are no longer actuated.

Verschure said there are two exceptions to the rule. Cars traveling on the opposite side of a divided highway are not required to stop when meeting a stopped school bus. Stops are also not required at intersections controlled by a stop-and-go signal or a police officer.


