Charge Board With Bad Faith

Zeeland Teachers Cut Extra Duties

ZEELAND — Zeeland teachers Tuesday cut off all extra duties to Zeeland Public Schools, charging the Board of Education with continuing to bargain in bad faith.

But the Zeeland Board of Education said its negotiators have met regularly with the teachers since last spring in an effort to reach a new agree-

ment, and that its last salary proposal would provide an average wage increase of more than \$1,000 for most teachers and at least \$833 for everyone else.

In addition, the board has offered to pay the full cost of increased insurance premiums for the coming year, amounting to an average increase of \$200 per teacher.

For the past two weeks, Wheeler Witte, a state mediator, has been attending meetings of ZEA and board representatives.

Dale Lathers, Michigan Education Association director, said the board's last offer was substantially less than other Ottawa county schools. He said it was apparent after a mediation session last Friday that the board had no intention of being fair and equitable in reaching a settlement.

In cutting off all extra duties, teachers will be in the classroom providing basic instruction. The action taken this morning by the ZEA deals only with such extra duties as coaching, lunch room supervision, etc. Safety patrol sponsors will continue on duty to insure the safety of the children, but all other services have been cut off.

The Zeeland board, disappointed at actions taken by the ZEA, said it remains willing to meet with teachers in an effort to arrive at an acceptable agreement.

"We are prepared to participate in the advisory 'fact-finding' process provided under state law which already has been requested by the teachers."

"The ZEA's decision to 'put pressure on the board' by a public relations barrage is unfortunate. We do not like being subjected to this kind of thing, especially when we are simply trying to do our best to represent all interests in the community. The ZEA's companion tactic of depriving our students of extra curricular activity is deplorable. We sincerely hope that ZEA leadership will reconsider the wisdom, the fairness and the long term impact of such action," the board statement read.

The ZEA says basic issues remaining under dispute are insurance protection, seniority rights, representation fees and salary.

West Olive Man Killed In Crash

GRAND HAVEN — Craig Joseph Yaros, 18, of 17083 Arbutus, West Olive, was killed Tuesday at 3:37 p.m. when his motorcycle collided head-on with a car on Butternut Dr. near Blair in Port Sheldon Township.

Ottawa County Sheriff's deputies said Lee Thomas Ninness, 27, of Grand Haven, was traveling south on Butternut attempting to overtake two vehicles when he collided with Yaros who was traveling north on Butternut.

Yaros was pronounced dead at the scene by medical examiner Dr. Alfred Vander Waa.

The accident remains under investigation.

The fatality is the 14th in Ottawa County this year.

A 1976 graduate of Grand Haven High School, Yaros was to enter Michigan State University on Friday.

Surviving are his parents, Mr. and Mrs. Mitchell Kaplon; a sister, Shama at home; the grandparents, Mr. and Mrs. Ernest Rich of Merryville, Ind., Mr. and Mrs. Peter Yaros of Gary, Ind., and Bernice Kaplon of Gary, Ind.

In 57th District Court Primary

Printing Error Allows City Votes for Judge

ALLEGAN — A series of "printing errors" allowed Holland City residents in Allegan county to vote in error for a 57th District Court judge candidate in the Aug. 3 primary election, Allegan County clerk Russell Sill explained today.

But Sill said the Holland City votes did not alter the outcome of the election for District judge and no appeals have been filed by the candidates.

Sill said no one in clerk's offices in Allegan County or Holland city caught the error and City caught the error and neither did the Allegan County Board of Election Canvassers.

In the primary, 374 Holland residents living south of 32nd St. voted in the 57th District judge race and 285 went for

City Council Kept Busy In Hearings

City Council spent a full hour Wednesday night on a series of public hearings in which subjects were discussed at length, yet given relatively prompt disposition.

Two hearings were related to a proposed development at 31st St. between Ottawa and Homestead Aves. One dealt with vacating portions of Homestead Ave. and West 31st St. to allow a modern-type cul-de-sac, and the other called for rezoning an area on 31st St. from A-1 residential to A-2 residential as requested by Gerald Klein, developer.

Both requests were granted although considerable time was spent on a small area 33 feet wide on Homestead Ave. which would be landlocked by the action. This strip is owned by Russ Homkes who more or less had to agree with Council that such a slender strip which would have been part of Homestead Ave. if it were dedicated would be impossible to develop or put to reasonable use.

"I'll bury the hatchet if you will," Homkes said at the conclusion, bringing a laugh all around.

Another hearing was an ordinance amendment which would eliminate the rigid floor area requirement and allow flexibility in the consideration of development of regional shopping centers as recommended by the Planning Commission.

It was explained that C-4 commercial areas exist at present only at Waverly and M-21 and at Waverly and 16th St. The basic ordinance calls for 100,000 square feet under roof at such developments. The new ordinance amendment, which Council passed, will permit consideration of areas less than that. Mayor Lou Hallacy pointed out most regional shopping centers are located in and near Grand Rapids, and to date such centers have not developed in Holland city.

Also approved was an ordinance to rezone approximately 14 acres lying southeast of 24th St. and Diekema Ave. from D-1 industrial to A-2 one and two-family residential as requested by the Holland School district for a Junior High School.

Dale Wyngarden of the Planning Commission, who presented sketches of all properties involved in the public hearings, was assisted in the school presentation by Lee Van Aelst, assistant superintendent for finance, who explained plans for bus ingress and egress, also the possibility of extending 24th St. in the future. The industrial part of the school site is bordered by Texaco and Standard Lumber. Christ Memorial Church lies to the west.

No objections were voiced in reviewing the sanitary sewer special assessment roll for a sanitary sewer in Maple Ave. from 34th to 35th Sts.

All Councilmen were present at the meeting which lasted an hour and 25 minutes. Mayor Hallacy presided. The invocation was given by the Rev. Robert Schut, assistant pastor at Sixth Reformed Church.

Emergency Funds Melt In County

GRAND HAVEN — Ottawa County Commissioners transferred funds from the contingent account to cover deficits in three areas and found themselves with only \$880.12 in the account for emergencies through the end of the year.

Normally several thousands of dollars is in the account at this time.

Of the transferred amount, \$300 went to the jury board for postage, \$38,000 to cover a 40 per cent hike in hospitalization insurance rates and the remainder to cover a deficit in the plumbing inspection budget where fees are not meeting expenses.

Finance committee chairman Eunice Bareham said the outlook for the 1977 budget was not much brighter since retirement funds paid by the county will be increased \$103,000 next year and contracts with county employees are to be negotiated next year.

A contract with John Kistler Associates, a Grand Haven engineering firm, for plumbing inspections in the county, expires this year and commissioners said they would seek bids from other sources for the inspections.

Commissioners defeated attempts to enter an executive session closed to media and citizens for discussion of alleged personnel problems in the county mapping and property description department.

Instead they voted six to five to adopt the recommendation of the county administration committee to bring the department under the supervision of the register of deeds for one year.

Commissioners have met with township assessors regarding alleged difficulties between the property description department and the county equalization department regarding property tax assessments.

Commissioner Donald Stoltz and members of his administration committee declined to be more specific on the "personnel problem" at the meeting claiming it would be solved under the register of deeds.

Commissioner Kenneth Northhouse objected to the move, claiming the department was one of the few under direct control of the commissioners and if commissioners cannot handle the department it would be a "cop out" to shift the department to an elected official.

Fear of School No Longer Valid

Apprehension saturated the air in Lakeview School's room 14 Thursday afternoon.

But it wasn't from the expected source.

Mothers nuzzled wide-eyed kindergartners under their arms, coaching youngsters with names and brief exchanges with the teacher.

The 18 five-year-olds joyously scattered through the large room in search of sand box, sink and slide.

Anxious mothers lingered at the doorway, introductions and instructions long since ceased, their eyes focused on a single child.

"She's taking it well," one mother sighed as her daughter assuredly scampered into the cloak room. The youngsters were indeed taking it better than their nervous parents.

Michelle Batema, a take charge lass and her friend, Joy Nykamp, bounded from activity to activity.

"Are you afraid?" Michelle was asked. With an icy glare of near disgust at the very idea, she retorted immediately, "Of course not."

Joy too replied with equal amazement at such a question. "Why would we be afraid? We've been here before."

Most kindergartners attend a day of orientation in the preceding spring, teacher Mary Veele explains.

Today with day care centers, nursery schools, and Sunday school classes all of which indoctrinate children into the more regimented routine of school life, the first day of school has lost its aura of mystique.

The Holland school district also attempts to formulate kindergarten classes on geographical boundaries allowing many youngsters to attend with backyard friends.

The theory that pals lessen the initial adjustment of school life was borne out Thursday afternoon.

Missy Ricketts perked up when her chum Stacie Stelk appeared at the doorway and hand-in-hand the two swept through the room.

Holland Man Sentenced In Infant's Death

GRAND HAVEN — Manuel Fuentes, 19, of 117 West 15th St., Holland, charged in connection with the death of his infant daughter, Raquel, Dec. 19, 1975, was referred to the State Corrections Commission for 2 to 10 years when he appeared in Ottawa Circuit Court Monday. He must pay \$250 costs.

Fuentes was first charged with manslaughter after the child was taken to a Grand Rapids hospital where she died Dec. 19. He pleaded guilty to a second count July 6, assault with intent to do great bodily harm.

Following an investigation, Holland officers obtained a warrant for Fuentes' arrest. Police alleged the father had dropped the infant on the floor of the home. Fuentes had said the infant fell from his arms while he was attempting to quiet her.

In other cases, three Holland residents had their jail sentences reviewed and were ordered released from jail this week. Donald Baylor Jr., 23, of 427 East Eighth St., charged with unlawfully driving away an auto without intent to steal, had been sentenced to jail July 12 and will be released Sept. 16.

Patrick Coldren, 19, of 542 1/2 East 14th St., Holland, charged with passing checks without an account, had been sentenced Aug. 16, and will be released Sept. 17.

Richard Hardy, 28, of 104 East 21st St., charged with uttering and publishing, was sentenced Aug. 16 and will be released Sept. 18.

Daniel Posma, 18, Zeeland, charged with larceny from a building, was placed on delayed sentence status and must pay court costs of \$150.

Cynthia Stevenson, 19, of 4173 136th Ave., Holland, charged with receiving and concealing stolen goods valued at more than \$100, was placed on delayed sentence status and must pay \$200 costs.

Jesus Marreno, 56, of 300 West 14th St., Holland, pleaded guilty to a charge of sexual contact, fourth degree, and will return for sentence Oct. 4.

Carol Gross, 18, of 196 West 14th St., charged with larceny from a building, stood mute and a plea of innocent will be entered.

Council Irked By License

City Council spent considerable time Wednesday night discussing a communication of the Liquor Control Commission on a request of Herbert and Patricia Kammeraad for a new SDM license (beer - wine takeout) at 494 East 32nd St. The communication had been read at the previous Council meeting and referred to the city manager for report.

The city manager's report, was ready Wednesday night. It offered no objection on the part of police, environmental health and other departments, but Council was "put out" to learn that the license already had been issued.

Councilman Russ De Vette moved that a response be sent the Liquor Control Commission without recommendation in view of the fact that Council action under the circumstances would be meaningless. His motion eventually passed but not unanimously since Mayor Lou Hallacy and Mayor Pro Tem Donald Oosterbaan cautioned against hasty action because the time may come when Council would deal with an undesirable applicant.

Hallacy explained that the legislature some time ago removed takeout licenses from local control and put it into the hands of the Liquor Control Commission. City Manager Terry Hofmeyer said the communications from the commission regarding takeouts are form letters with blanks filled in and are more a matter of information to cities rather than requests for action, although it was stated that strong opposition might have a bearing on the outcome.

Mayor Hallacy said the city still has control of tabletop service of spirits, and that the Michigan Municipal League favors returning all tabletop and takeouts back to the cities.

In other business, Council accepted for first reading a zoning ordinance amendment which would allow the establishment of a paint manufacturing company in the industrial park, in answer to a request by Inmont Corp. and recommended by the Planning Commission.

The amendment deals with permitted use and standards in D - 2 industrial zone. A public hearing is scheduled Oct. 6.

A city clerk report revealed that Keith Kleis of the police department received the highest number of votes in an election among city employees to attend the Michigan Municipal Employees Retirement System annual meeting at Boyne Falls Oct. 14. Dave Poskey of the hospital was the next highest and the two were certified as delegate and alternate.

Council confirmed a certification from Councilman Vande Pool for recent purchases by the Recreation Department from Superior Sport Store totaling \$322.16.

Claim against the city from Rynlen Flieman was referred to the city insurance carrier and city attorney.

Council accepted for study a city manager report on a new state law entitled "Downtown Development Authority Act" which, among other things, is designed to stimulate the economic growth of downtown areas and implement development plans. It was stated that the Downtown Merchants Association has indicated a definite interest in establishing this type of authority to further promote the welfare of the Central Business District. The information will be reviewed and a required notice of intent will be presented for consideration at a subsequent meeting.

Council tabled for two weeks a recommendation by the city manager to remove three parking meters on the north side of Eighth St. opposite fire station No. 2 at 108 East Eighth St. The report stated that vehicles parked there made it extremely difficult and dangerous for fire equipment to exit during emergencies, especially the aerial tower truck.

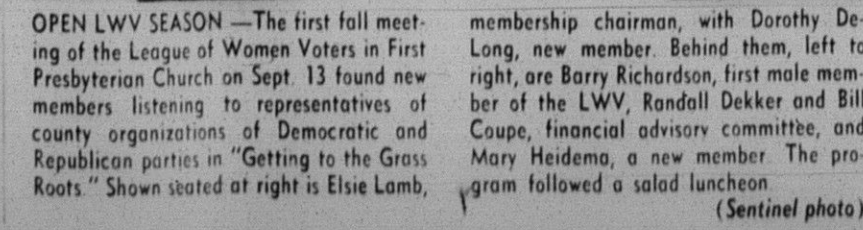
Two requests for sanitary sewer were granted, Frances Boerman, 480 West 40th St., and James Lamb at East End Dr. and South Shore Dr.

Mayor Hallacy appointed Wayne Woody to the Police Community Relations Commission for a one - year term.

Reserves To Collide On Thursday

This year's annual Holland-West Ottawa season opening football game Friday at Riverview Park shapes up as being another exciting clash.

The Panthers of Coach Deb Nolan are big and experienced and the Dutch of Coach Ray Backus are quick and aggressive.

The two reserve teams will meet Thursday night at 7 p.m. at Riverview Park while the freshmen will collide Friday at 4 p.m. at Riverview.

Since this year's game is considered a home game for West Ottawa, only Panther season tickets will be honored. Tickets for the game can be obtained at the athletic director's office of both schools.

"I expect another close ball game this year," said Backus. "West Ottawa has to be considered the favorite because of its size and experience. One of the keys to our attack will be the performance of our interior line."

Nolan commented, "Holland looked good in its scrimmage against Lowell last Friday, especially the quarterbacks, fullbacks and receivers. Their defensive backs showed they liked to hit."

Expected to start at quarterback for the Dutch is Dan Moleenaar. John Hosta or Kirk Emerman will open at tailback with Duane Berkompas or Rick Schutt at fullback. Mike Hernandez will probably start at the other halfback position.

Steve Van Tongeren will be at tight end with Kevin Beerthuis at split end. The tackles will be Brian Brunzell and Mike Gray or Linn Boerman. Tom VandenBosh will open at one guard spot with Fred Lamb of Bob Boersma at the other side. Garry Visscher will start at center.

On defense, the Dutch will start with Van Tongeren and Berkompas at ends, Jamie Hinojosa and Brunzell at tackles and Schutt at middle guard. The secondary consists of Craig Kuipers, Kurt Droger, Hernandez and Emerson or Jon Lunderberg.

"We expect to play a lot of people this season, definitely more as the season progresses," Backus stated.

Dave Conklin, who broke his hand in last year's opener, gets the call at quarterback again for the Panthers. Brian Shaw will be at the slot with John Witkowski at tailback and Jeff Van Dyke and Jamie Bloemendaal at fullback.

Greg Ferrel will open at center with Rick Brink and Brian Driesenga at guards. Ron Allen and Scott Vander Meulen will start at tackles and Mark Haltenhoff and Mike George at ends.

Bill Strauss and Bruce Pateron will start on defense at ends with Vander Meulen and Driesenga at tackles. The nose man is Rub Hunter. Tom Knowles and Ferrel are expected to start at linebackers and Bloemendaal at monster back.

Bill Monhollen will open at halfback, Shaw at safety and Witkowski at cornerback. Last year the Panthers turned back the Dutch, 14-0 as star Scott Tubergan scored both touchdowns. Game time Friday is 7:30 p.m.

Allegan Board Approves Merger On Drug Abuse

Mather's figures, based on the latest financial bulletin published by the Michigan Department of Education, list: Grand Haven, \$14,699; Coopersville, \$13,249; Holland, \$12,718; West Ottawa, \$12,779; Spring Lake, \$12,531; Jenison, \$12,448; Hudsonville, \$11,964; Zeeland, \$11,855; Allendale, \$10,917. Statewide Lathers said, the average Michigan teacher earning is \$14,059.

Besides the salary issues, fringe benefits, representation fees, and seniority are in question, according to the Zeeland Education Association.

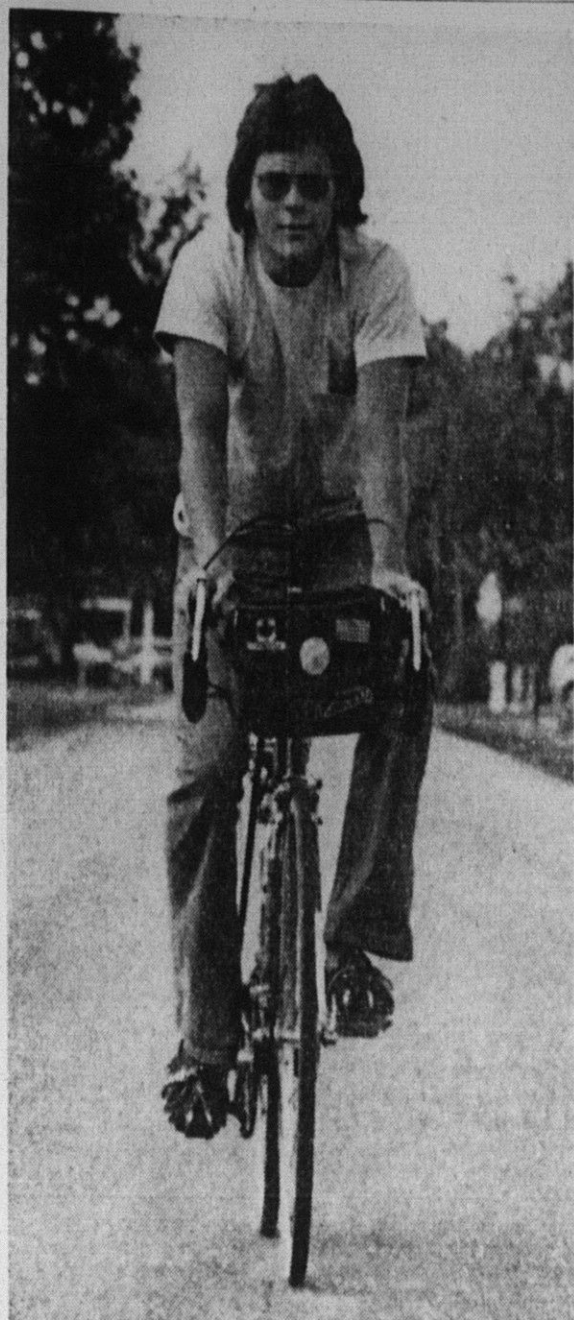

Bicyclist Travels USA and Canada

Somewhere between Williams, Arizona and the Grand Canyon with almost 4,000 miles behind him, Rick Nagelkirk decided he had had enough. He had been traveling alone almost two months — he was hot, tired and lonely.

His bicycle had worn out 18 tires, used up 14 spokes on the rear wheel and his chain had become so stretched at one time that it had been two links longer than normal.

Rick began his 4,000-mile solo bicycle trip June 14 when he rode his bicycle from his hometown of Drenthe to Ludington. Rick took the ferry across Lake Michigan to Wisconsin and continued biking across Wisconsin and Minnesota into North Dakota.

"People were really friendly in North Dakota and Canada," the athletic 21-year-old said. "I got a lot of free meals and places to stay over night."

Long-distance bicycling is harder mentally than it is physically, Rick said of his trip which took him through 8,000 miles of the United States and Canada. Rick rode his bicycle a total of 4,300 miles.

"Once you're in shape, anyone can ride a hundred miles a day," Rick maintains. "Anybody can do it physically, it's a mental thing."

Breaking the monotony becomes difficult, Rick said. "You look at a lot of things, think about where you're going where you've been, the next town. You think about back home and the good meals you're missing."

Riding through the prairies of Manitoba, Saskatchewan and Alberta proved to be the most boring and lonely part of the trip, Rick said, but he also found the friendliest people in prairies.

After going as far north as Edmonton, Alberta, Rick began heading for the Rocky Mountains.

Climbing the passes through the Rockies in Jasper National Park, Banff National Park and Glacier National Park was one of the biggest thrills for Rick as he headed out for Vancouver and Victoria Island on the Pacific Coast of British Columbia.

As Rick left Canada and headed down the Pacific Coast, he abandoned the use of the tent he had brought along and slept under the stars in his sleeping bag until he reached Los Angeles.

"A lot of people said, 'You're going to get knocked over the head, but nobody ever bothered me,'" Rick said of his nights under the stars.

Rick said he traveled in spurts, hitchhiking rides through the dull and hot flatlands and staying longer at places he enjoyed or where he made friends.

Since Rick is an employee of Herman Miller Inc. in Zeeland, he stopped by and visited the Herman Miller plant in the Los Angeles area. Herman Miller Inc. gave him a three-month leave of absence in order for him to make the trip.

After spending a few days in San Diego with a cousin, Rick hitched a ride with a Herman Miller Inc. semi-truck to Williams, Arizona. "I didn't want

to ride across the desert," Rick said.

Rick decided to begin heading back to Michigan on his way to the Grand Canyon, but not before flying up to Wyoming and bicycling through the Grand Tetons and Yellowstone National Park. After bicycling through the parks for a few days, Rick flew back to Michigan on Aug. 26.

Rick feels his adventurous journey was well worth it. "I learned a lot — I don't know what, but I learned a lot," he joked.

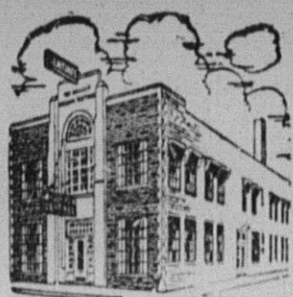

DECLINE IN HEART DEATHS

The National Center for Health Statistics reports that for the first time since 1967 there were fewer than a million deaths from heart disease in the United States last year. The reasons for this phenomenon naturally are of great interest. This is all the more true because improvements in personal lifestyle appear to have something to do with the decline.

The proportionate number of deaths from cardiovascular disease in this country has been going down for a quarter of a century. The significance of the latest figures is that the pace of decline has — at least for the present — overcome the effect of rising population.

A combination of research and more widespread application of improved methods and facilities is thought to be largely responsible for this advance. Dr. Robert I. Levy, director of the National Heart, Lung and Blood Institute, notes that the intensive care unit now found in most medium-sized to large hospitals "has substantially increased prospects for survival among heart attack patients who reach the hospital alive." Also, more patients get to the hospital in better shape "because of ambulances or other emergency vehicles specially equipped and staffed to cope with" potential heart death cases. Better diagnosis of conditions likely to lead to trouble also is an important factor.

The lowered cardiovascular death rate may have come about in part, says Dr. Levy, because of people's shifting to "more prudent patterns of diet," exercising more, and smoking less. This re-emphasizes recent findings as to what individuals can do about their own cardiac health. If enough of us make such an effort, that may do much to continue the reduction in heart disease deaths.

Cystic Fibrosis, which causes life-threatening lung damage and severe digestive complications, is the number one genetic killer of children, according to Robert D. McCreery, president of the Cystic Fibrosis Foundation.

Although no cure has yet been found for the disease, there are effective methods of treating cystic fibrosis. GREENCASTLE, Ind. — Hope College didn't lose a football game in 1975 but the Flying Dutchmen opened the 1976 campaign on a losing note here Saturday as a fired up DePauw squad took an exciting 28-22 triumph.

The loss was the first in the last 11 games for Hope. It was also the most points scored against a Coach Ray Smith outfit since the fourth game of the 1972 season.

"At times I had to hurry to keep up with dad," the younger Boutwell said.

"Yes, I'm a good walker," the older Boutwell said. "I've walked all my life and enjoy it."

In fact, walking, good food and good friends are the non-agenarian's secrets for good health and long life.

He is well into his 91st year and will mark that anniversary Oct. 4.

While on the Big Mac, the two Boutwells glimpsed Gov. Milliken from a distance and walked past that well publicized wedding in the middle of the bridge. The best man thought a bridge wedding was such a good idea he asked his fiancée if she would like to be married there too, and she agreed. 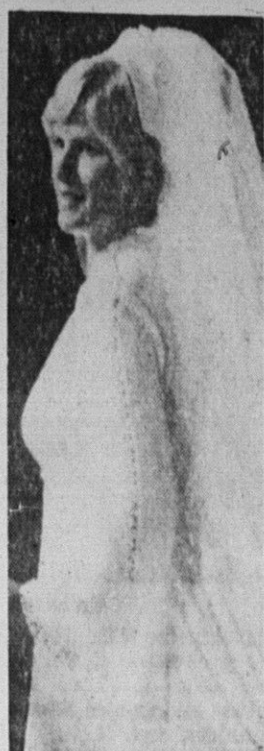
