Chamber To Hear MSU President

Dr. Clifford R. Wharton Jr., president of Michigan State University, will be the speaker at the annual dinner meeting of the Holland Chamber of Commerce at Point West Monday, Oct. 25, at 6:30 p.m.

Reservations are limited to 250 and should be made not later than Oct. 18 with Chamber headquarters in Hotel Warm Friend.

Because Dr. Wharton has other commitments, members are asked to be prompt since his talk will start at 6:45 p.m. Dinner will be served later.

Dr. Wharton, 45, was elected president of Michigan State Oct. 17, 1969, and took over his duties Jan. 2, 1970.

A leading figure in helping developing nations, Dr. Wharton had previously been with the Agricultural Development Council, Inc., a nonprofit organization headed by John D. Rockefeller III since 1957. He is also distinguished in American educational and research activities.

The 14th president in MSU's 112-year history, Dr. Wharton succeeds Dr. Walter Adams who served as acting president and briefly as president following Dr. John A. Hannah who left MSU after 28 years as president to become director of the Agency for International Development (AID) in the U.S. State Department.

Born in Boston Sept. 13, 1926, Dr. Wharton is the son of America's first Negro career diplomat and ambassador, the Hon. Clifton R. Wharton Sr. Until his retirement in 1964, the senior Wharton was ambassador to Norway and also had served as ambassador to Romania. He was the first Negro to head a U.S. foreign service mission to a white European nation.

Dr. Wharton spent six years of his youth in the Canary Islands of Spain where he learned fluent Spanish. He also speaks French. He attended Boston Latin School, America's first public school, and entered Harvard University at age 16.

While an undergraduate student at Harvard, he was a founder and first national secretary of the U.S. National Students Association. He received a B.A. in history from Harvard in 1947.

He was the first Negro to be admitted to Johns Hopkins University School of Advanced International Studies and the first to receive the M.A. in international studies in 1948. He received an M.A. in economics from the University of Chicago in 1956 and in 1958 received a Ph. D. degree in economics from Chicago.

In 1970, he was awarded honorary Doctor of Laws degrees from the University of Michigan, Johns Hopkins University, Wayne State University and Central Michigan University.

Dr. Wharton was recently elected of the Equitable Life Assurance Society, the first Negro to serve on the board of one of the 10 largest U.S. corporations. He is a trustee or director of several other organizations, including the Asia Society, the Overseas Development Council, the Rockefeller Foundation, the Public Broadcasting Service and the Museum of Modern Art.

76 Bridges Inadequate In Ottawa

GRAND HAVEN — Faced with an emergency situation as to the unsafe condition of most of the bridges over local roads in Ottawa county, the Board of Commissioners Monday approved a financing program as presented by Engineer-Manager Ronald Bakker of the road commission.

The county board held its first meeting of the long October session Monday and took Tuesday off to tour the county parks, bridges, roads and other facilities. The board will meet again at 1:30 p.m. Wednesday.

Bakker reported that of the 89 local bridges in Ottawa, all but three of them over water, 76 are reported to be dangerous and of less than 15-ton safe carrying capacity. Some of the most dangerous bridges already have load limits on them.

The county board yesterday passed, with a "no" vote, a resolution of intent to approve a financing program as outlined and approved by the road body. Bakker said that engineers recently completed inspection of all bridges and cost of the program, including the 76 inadequate spans, was estimated at \$2,776,475.

The engineers' report shows that all 11 bridges in Crockery township, all four in Robinson, all eight in Blendon, all nine in Olive and all 10 in Zeeland township are inadequate.

Under the road commission's plan, the townships would pay the equivalent of two mills for five years, not to exceed 75 per cent of the cost of the bridge construction in their township.

The road commission would transfer primary road funds to pay for 50 per cent of the balance of the cost of the program and the other 50 per cent would be appropriated by the county board. The road body's share and the county share would be \$106,147 in 1972 and this amount was appropriated for the county-at-large budget by the county board for next year. The county board is to have a hearing on the 1972 budget at the October session.

The townships, under the plan, would submit their shares in five annual equal payments and the road commission and the county board would pay their shares over a period of seven years. Nine of the townships have been contacted by the road commission and have passed resolutions supporting the program, Bakker said. Fifty-six of the bridges that must either be replaced or repaired are in these nine units, he said.

Road officials claim that the bridge situation in Ottawa present is causing alarm. School buses and fire trucks in some areas must change routes because of limits on some of the spans. The road commission will have difficulty in snow removal in some areas. The road commission plans to have its own crews replace or repair small bridges, under 40 feet long, but work on the larger bridges will be let out on contracts.

The newly organized Holland Concert Association got off to a roaring start Thursday night with a full house in Civic Center cheering the Goldovsky Grand Opera Theatre's "La Boheme," the Puccini opera which has been a great favorite throughout the years.

In fact, Thursday's opera was three shows in one. Boris Goldovsky, who founded the Opera Theatre more than 25 years ago, greeted the audience in the inimitable style he uses in his "Opera News of the Air" at Saturday afternoon Metropolitan Opera broadcasts.

Goldovsky said a Dutchman, Francois Huysbrecht, would be the conductor but Goldovsky always conducts one act, and he chose the colorful second act with its lively street scene highlighted by Musetta's Waltz, a favorite of all opera fans.

There was open curtain staging, and concert lovers were treated to intricate maneuvering by skilled stage hands of artistic sets which appeared elaborate but were really quite simple, allowing a adequate space for easy movement. Props fitted easily in different combinations for the three acts, an attic studio, a French cafe, and the city toll gate.

The opera itself was a thoroughly enjoyable experience, demonstrating the talents of talented singers, most of them young American musicians on the rise. Through the years, Opera Theatre has trained many young Americans in its repertoire of 30 operas in which all were painstakingly transplanted into contemporary idiomatic English.

Goldovsky productions (the company appeared twice in Holland in the late 1950s) with their high gloss of perfection always have close rapport with their audience. Holland's audience applauded many times (Goldovsky welcomes things like that) and not a few rose for a standing ovation. Backstage, Goldovsky said it was a good audience.

His artists work as a team in exciting, colorful productions, but heaviest applause went to

Carol Courtman as Mimi, Henry Price as the tenor Rodolfo, and Katherine Kaufman as Musetta the coquette. 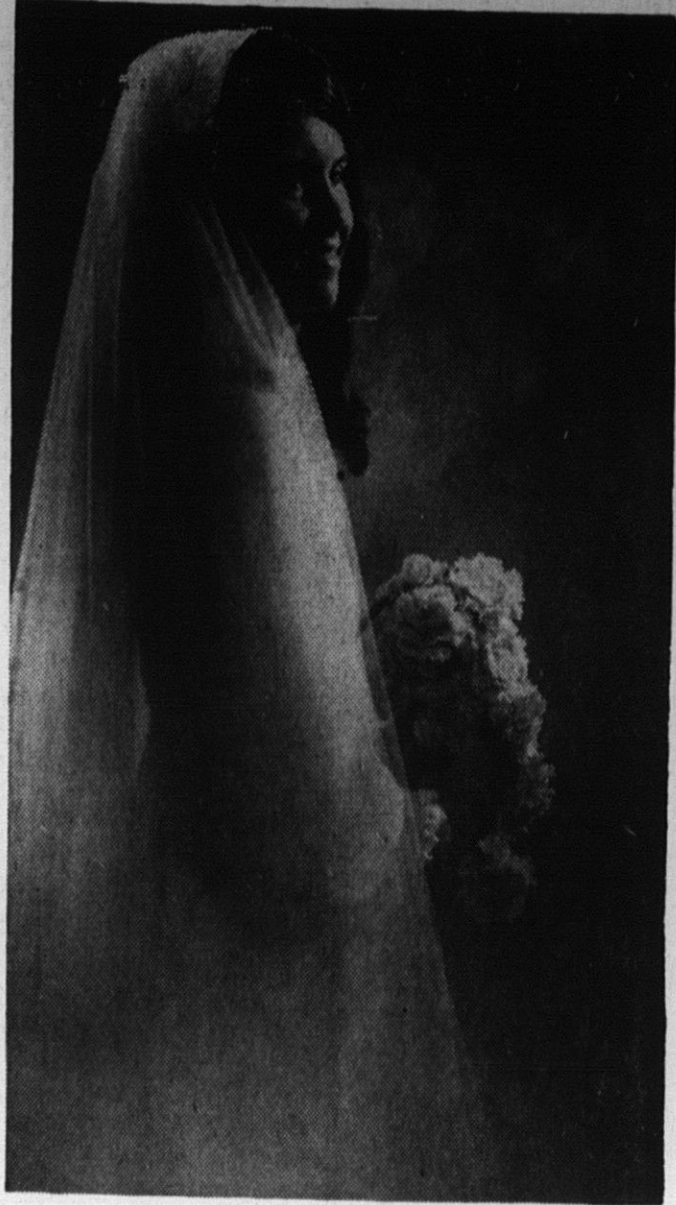

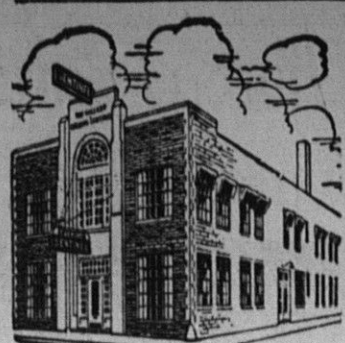

PERILS OF MIGRATING ROBINS

We have just received a release from the National Geographic concerning the robins flying south for the winter and the particular hazard in Florida. The release follows:

"By the time they (robins) reach the Merritt Island National Wildlife Refuge, within the giant Kennedy Space Center, the ground is littered with well-fermented fruit from palm-trees.

"The hungry birds gobble up the potent berries and soon are 'staggering all over the place,' according to a refuge official. The befuddled robins wander onto highways and don't bother to fly off when cars bear down on them.

"The palmetto berry menace is just one of the perils migrating birds face. Others include hunters, hailstones, skyscrapers, television, and even sharks.

"Night flyers sometimes collide with lighter structures — television towers, lighthouses, the Empire State Building, the Washington Monument. Since 1964 the Empire State Building has turned off its powerful floodlight during fall and spring migrations, but flocks still crash into it, killing hundreds.

"Casualties for one night at television towers have been estimated as high as 20,000 birds.

"Attraction toward light seems to be a common reaction. Caged migrants turn to face a falling star, the moon, city lights.

"Celloimeters, powerful mercury-vapor lamps used by airports and weather stations to measure the height of clouds, are a serious hazard. Sometimes birds fly round and round in the beams as though trapped in a cage of light.

"Occasionally they seem to become confused or blinded; then they power-dive into the ground. One night some 50,000 birds were killed at a celloimeter in Georgia.

"Natural disasters, however, apparently take the greatest tolls, according to the National Geographic Society's book, 'Water, Prey, and Game Birds of North America.'

"Birds migrating over water may tire or be driven off course by winds and fall into the sea. Fisheries biologists have slit open sharks and found song-birds inside.

"One night hailstones as large as hen's eggs bombarded migrants passing over Baton Rouge, leaving the campus of Louisiana State University littered with dead and dying birds.

"In 1904 a blinding, wet snowstorm caught Lapland Longspurs over Minnesota and Iowa. More than a million died.

"Despite the dangers, migration offers birds benefits. In spring, and summer the temperate latitudes of North America afford plenty of plant and insect food, long days to gather it, and ample living space. But many birds would starve or freeze in a northern winter; they must fly south.

"The birds find Florida and the tropics a nice place to spend the winter, but they don't want to live there year-round.

"Hot climates swarm with predators that prey upon eggs and young birds. So the winter visitors leave their palmetto berries and other treats and return to northern nesting sites.

We have noticed that there are many kinds of birds and other wild creatures that people seem to spoil by feeding. Some people are of the opinion that feeding is the right thing. We sometimes wonder.

This is the time of year when Michigan and many other states are showing off their fall colors. This year they no doubt are earlier because of the long dry season.

So if you like the great outdoors, we are sure you will like the colors.

Sunday School Lesson

Sunday, Oct. 17
God Responds to Prayer
Hebrews 11:6; Matthew 7:7-12;
I Cor. 12:7-9; Romans 8:26-27
By C. P. Dame

Four passages from the New Testament comprise our lesson text and all deal with prayer. Many more passages could be found in the Bible, for that Book has much to say about the subject of prayer, which is a timely subject, and always has been. May the study of this lesson cause us to pray more than we do.

I. Faith in God inspires us to pray. Faith implies knowledge. We can't have faith in a person if we have no knowledge of him. To have faith in a person implies accepting him with the mind. The person who prays to God believes that God exists and that it is really worth while to find Him. These two facts praying people accept.

II. Jesus urges us to pray earnestly. Jesus prayed very much and said much about prayer. Note the words, ask, seek and knock, which Jesus used. We ask, but we do not demand. We ask realizing need, and we are conscious of God's superiority. Seek implies intense action. The word knock implies real fervor and action. The person who knocks at a door wants to get in. The words of Jesus are addressed to persons who are serious. Most of us are not serious enough.

The promise of Jesus is encouraging; no one prays in vain. Jesus does not say that we will get what we ask for. God is a Father who when a son ask for bread will not give him a stone. If earthly fathers do not mock then surely the heavenly Father will honor a son's request.

III. God does not always answer our prayers according to our wishes. Paul had a thorn in the flesh from which he wanted to be relieved and he prayed three times about it but God refused to grant him his wish but did say that His grace is sufficient for his handicap. The thorn became a beneficial to Paul; it kept him humble and led God to give him special grace and extra power and offered him the opportunity to magnify Christ more than ever.

IV. God's Spirit teaches us how to pray. We do not know how to pray as we ought because we do not know enough about tomorrow and because we do not know what is right for us. The Holy Spirit knows our conditions and needs and prompts us to pray aright. Most of us forget or slight the Holy Spirit and thus we hurt ourselves. All that is spiritual in us is due to the presence and power of the Holy Spirit.

Parke-Davis Women Golfers Hold Banquet

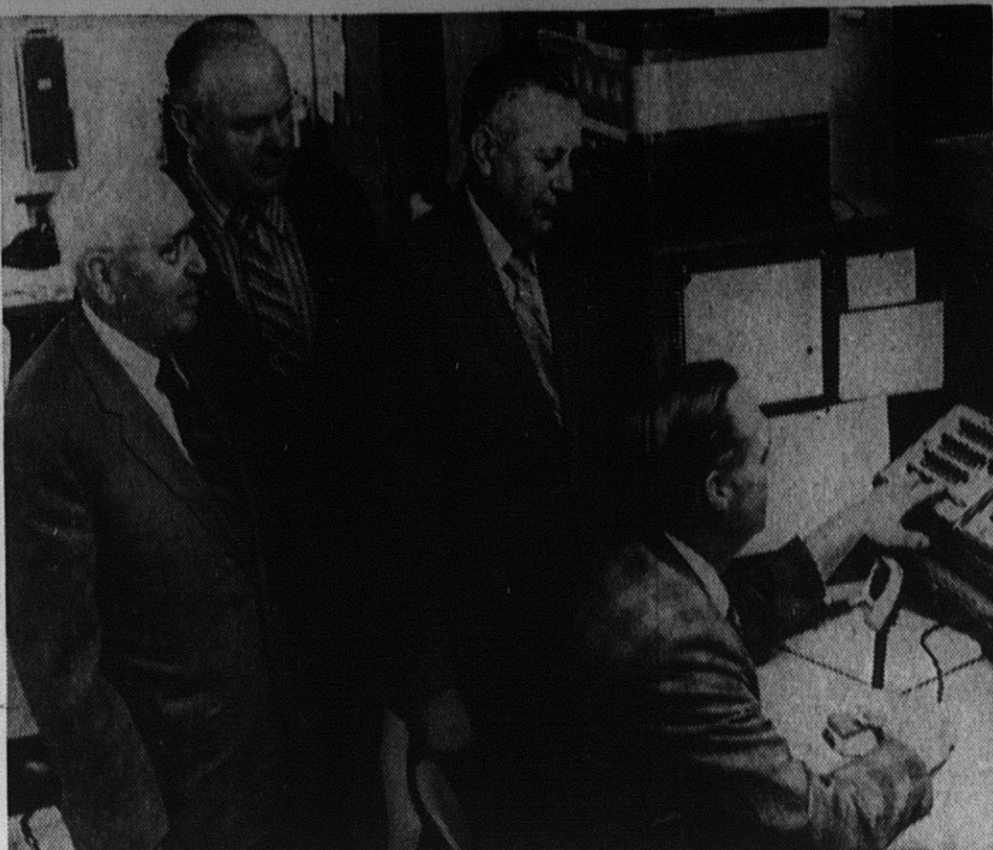

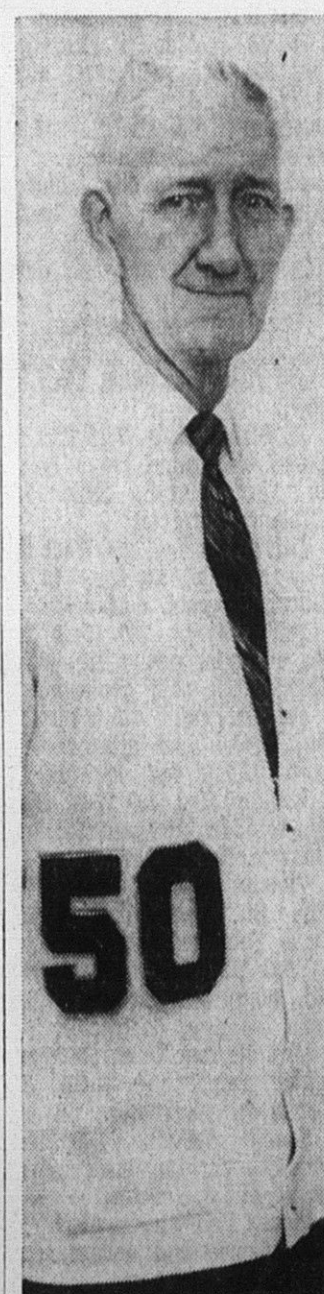

Ottawa county's application for Section 6 funds is awaiting approval and the county has requested 54 additional positions from that section.

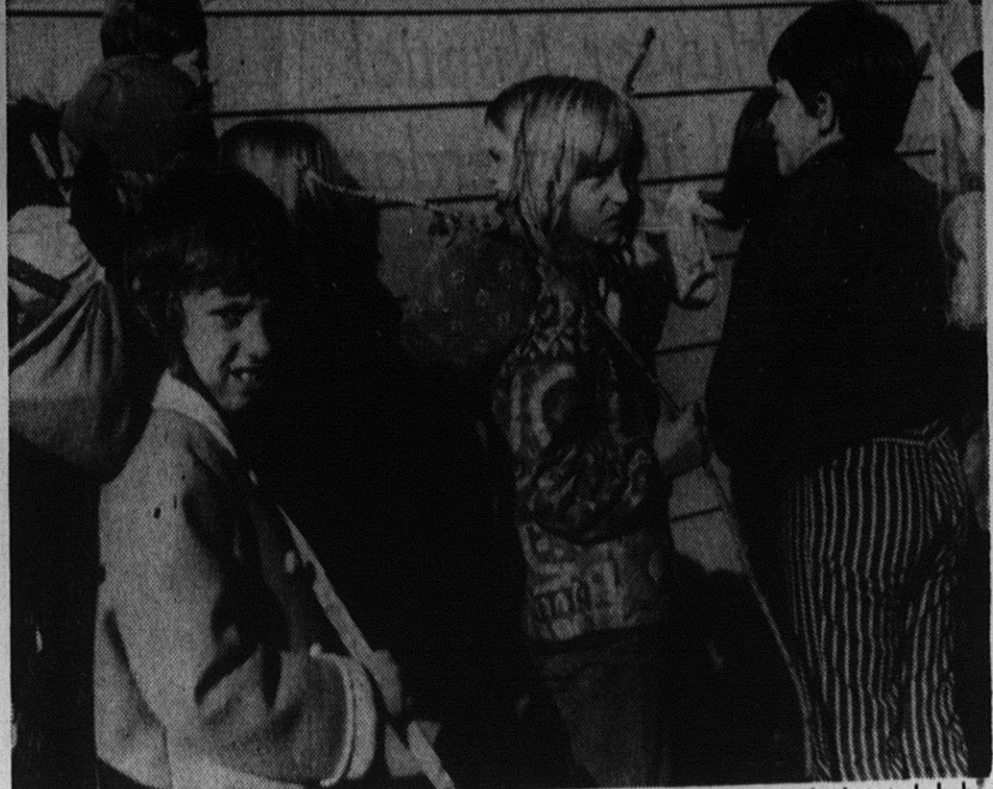

"It is quite appropriate," Kennedy said "that the first person taken into the program will reduce our welfare rolls in Ottawa county by at least 1. We hope this will set the example to be followed by other agencies in the county."

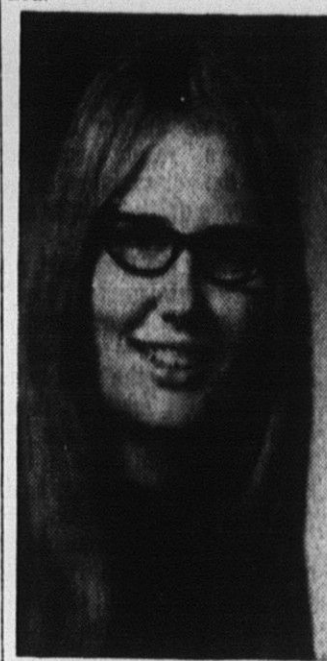

Frosh Dunk Sophs In Hope's 73rd Pull

The Hope College "Pull" is replete with many of the elements of pre-modern warfare. The traditional event dates from the days of battling from the trenches.

Hope's freshman class won the 73rd annual tug-of-war Friday afternoon by dragging their sophomore rivals into the frigid Black River after a struggle of two hours, two minutes. It marked only the fifth time the freshman class had won the Pull

since the first one in 1898. Friday's battle climaxed more than two weeks of preparation for the more than 100 members of the two classes who had a hand in the Pull. After two weeks of rigorous training, each team was reduced to 18 starters and two alternates. Freshmen Bill Walters of Fennville and Greg Slenk of Fennville and Steve Mancinelli, both of Holland, plus sophomore Dave Maatman of Hamilton were among the pullers Friday.

Each participant chose a coed classmate to serve as his "morale girl." The 36 morale girls spent Friday afternoon taping blistered hands, shouting encouragement and otherwise aiding their weary charges. Freshmen Jean Boven and Nora Bauman, of Holland, and Tracey Paquin of Fennville served as morale girls Friday. More than 1,000 students, alumni and other spectators braved the chilly weather and occasional rain to watch the teams struggle with the 385-foot-long, 2½-inch rope. The teams tugged from trenches (called "pits") dug earlier in the day, in order to gain leverage. Coaches used a variety of hand and arm signals to convey a number of different strategies to their team members.

Tree-top sentries watched the opposing teams and tried to warn their comrades of impending "heaves" and other maneuvers. The sentries' jobs were made necessary (and difficult) by blankets, tied to saplings placed in the ground, which prevent either team from seeing the other from ground level. There were also spies who tried to infiltrate enemy lines, but they are rarely successful, since the classmates of the pullers are quick to chase aliens from their river bank.

On Friday the freshmen, after an early stalemate, steadily gained ground — or, more accurately, rope — during the second hour of the Pull with a series of effective double-heaves, during which the team pulled, in unison, twice in rapid succession before resuming the defensive "lock" position.

Paced by their coaches to preserve energy, the freshmen "popped" the first of the 18 sophomores from his pit after one hour, 44 minutes. The Pull concluded when all 18 sophomores had been removed from their pits and the freshmen dragged the slack rope across the river. Rarely, if ever, has a team come back to win after having had a man "popped." Friday proved no exception, as half the sophomore team had been pulled from its pits after two hours. The Pull ended two minutes later.

Despite the hard-fought struggle, the opposing coaches and pullers waded in the shoulder-deep water to meet and embrace at mid-stream after receiving consolations and congratulations from their classmates.

After two weeks of rivalry solidified class unity, the post-Pull period promises to produce closer ties between the Hope College classes of 1974 and 1975 — even if the freshmen didn't lose, as tradition would dictate.

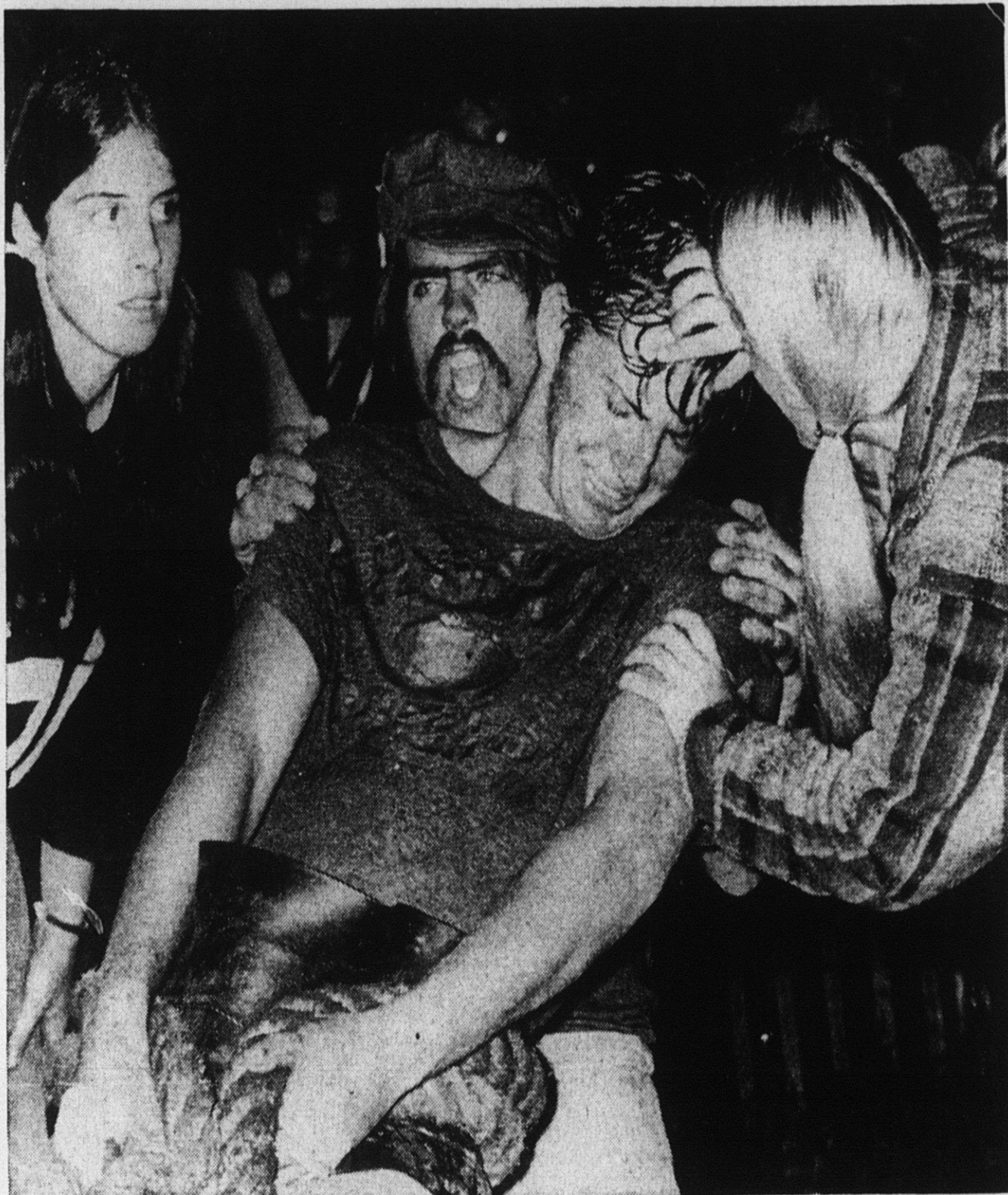

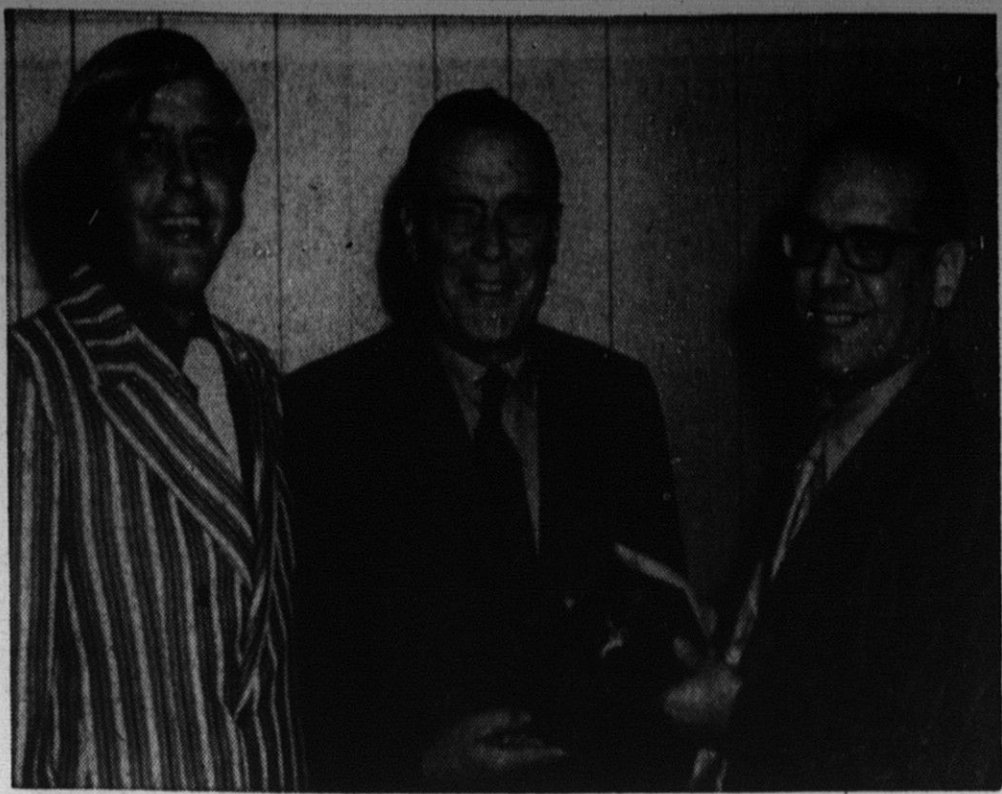

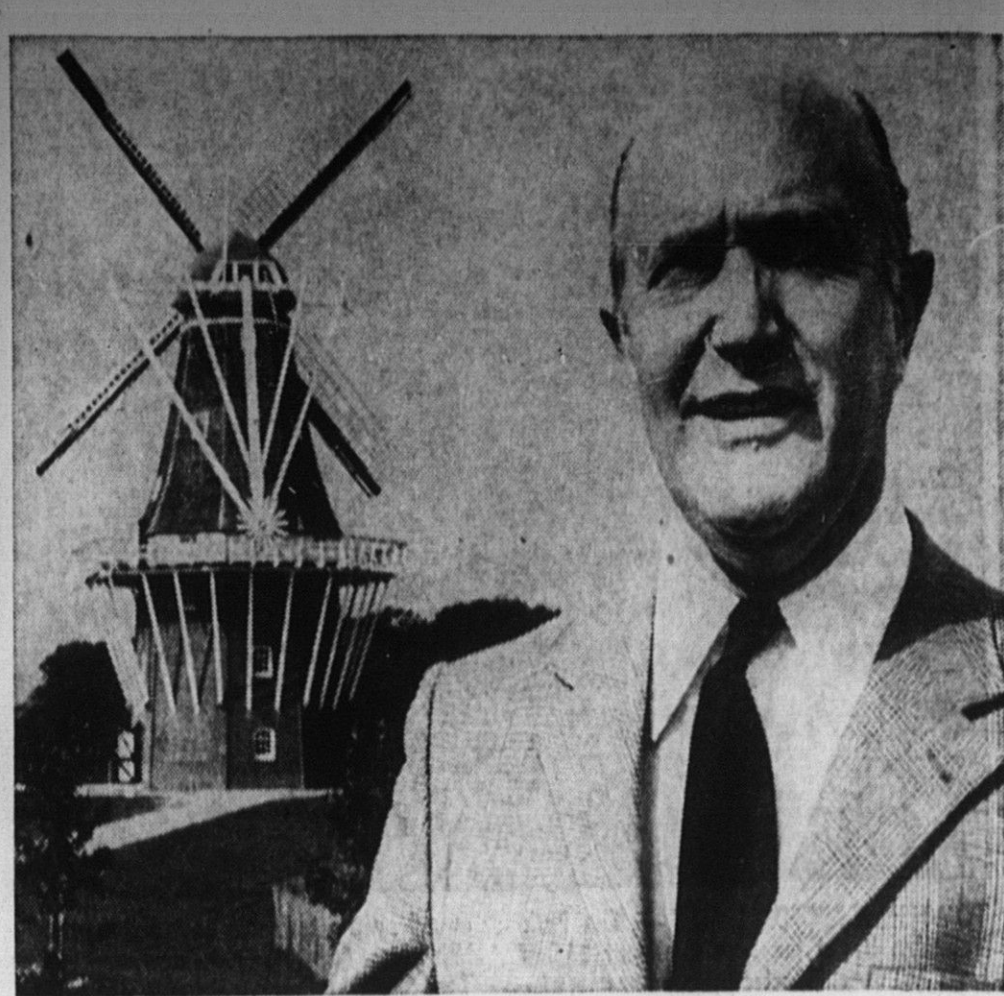

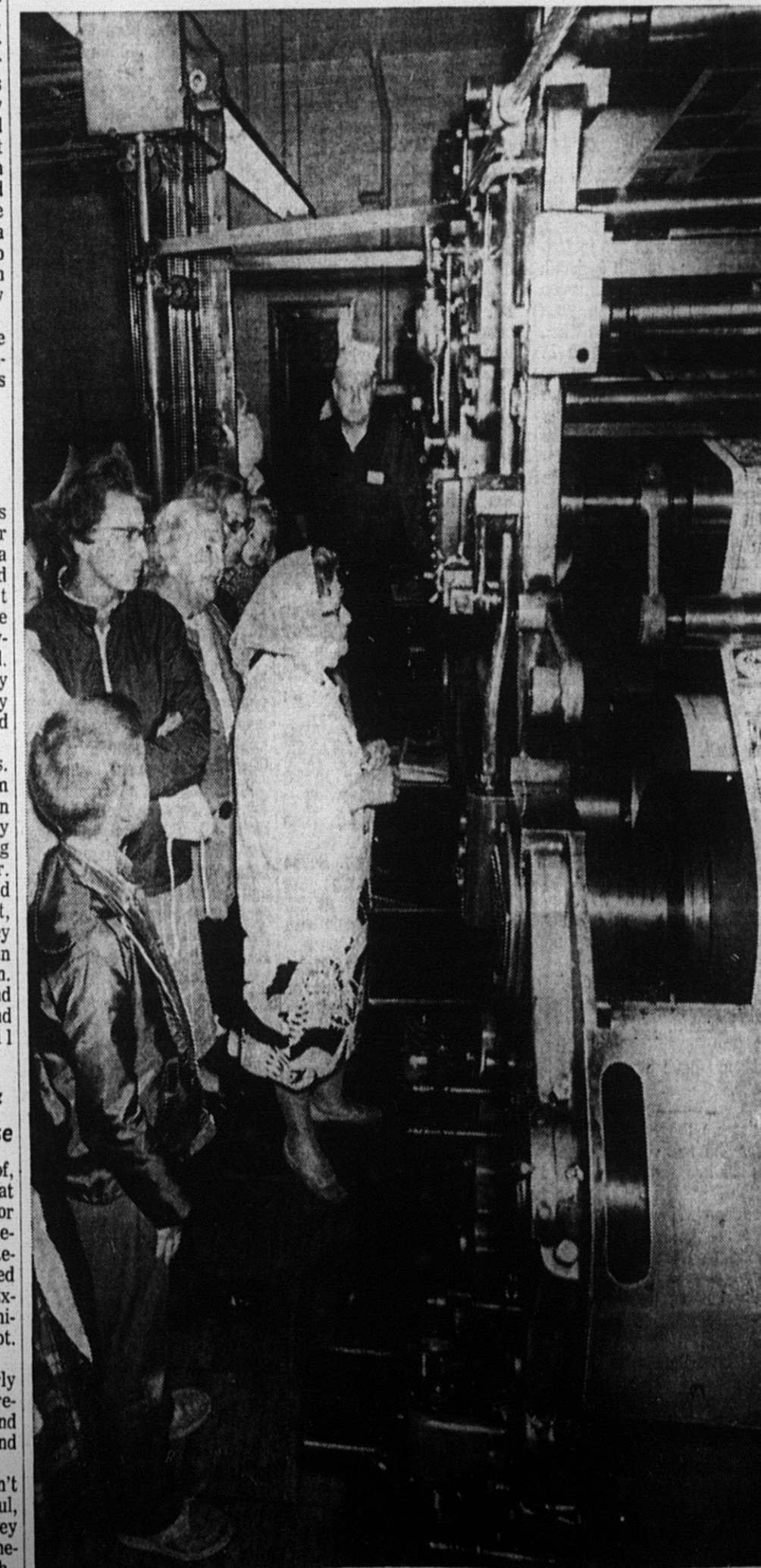
WCTU Holds Fall Potluck Meeting

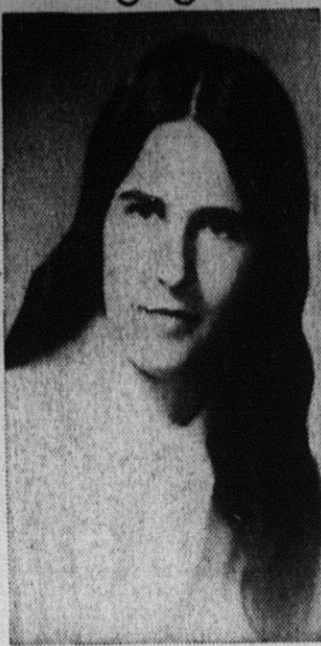

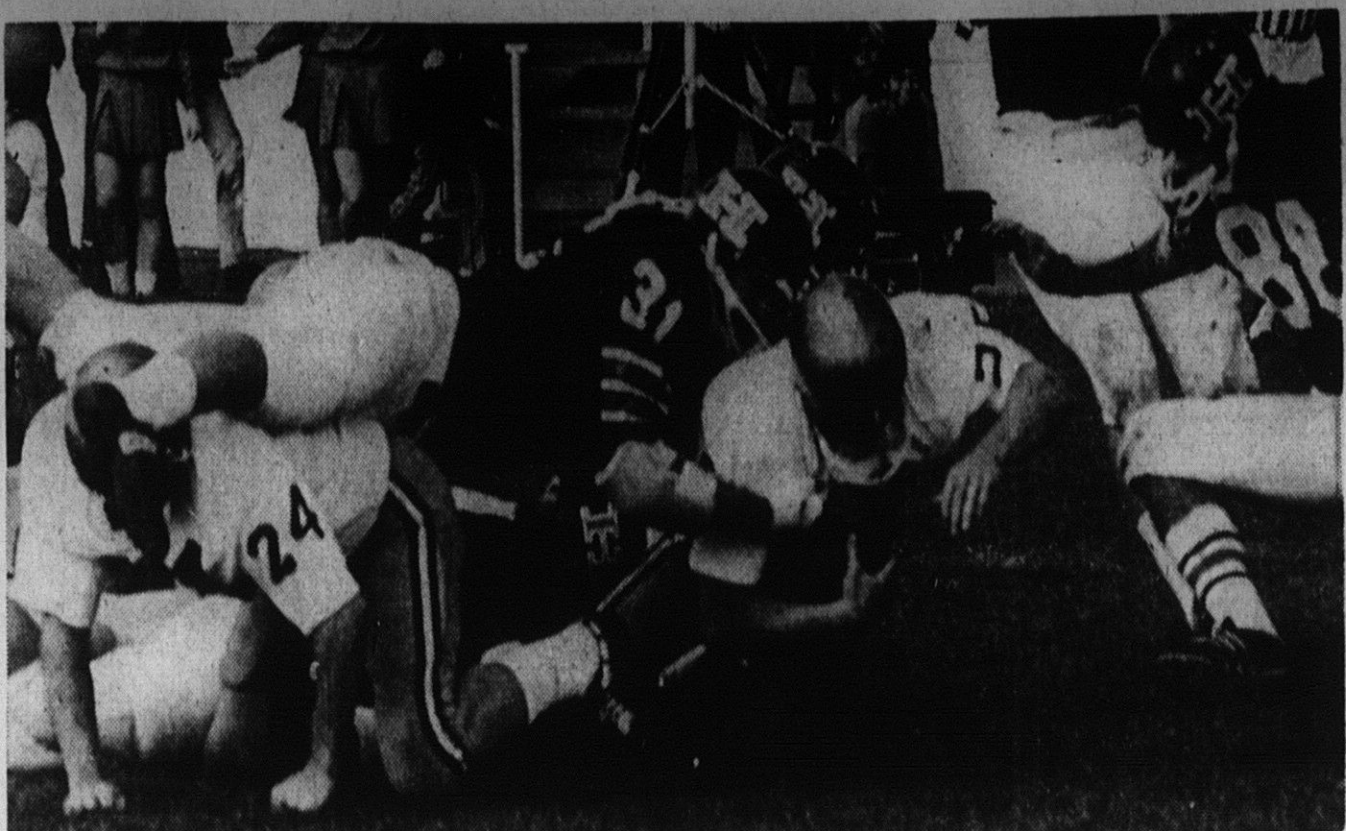

W. Winstrom Gives \$3,000 To Township

At the monthly meeting of the Park Township Board Thursday a gift of \$3,000 was received for the development of the recreational facilities on land owned by the township on Harrington Ave. The gift was made by William Winstrom, county commissioner, and is to be added to other funds already available.

Acceptance of the donation was acknowledged for the Recreation Commission by Thomas G. Shelby, chairman, who said the money will probably be used to begin construction of the new community hall proposed for the south side portion of Park Township.

Plans for the hall provide for a low-roofed, one-story structure designed to harmonize with the residential area surrounding the location. The main portion of the building will be a large hall with a fireplace at one end, and a service wing will house the heating plant, storage, restrooms and a small kitchen facility. Major costs of the unit will be met from an allocation from the State Revenue Bond Act of 1969.

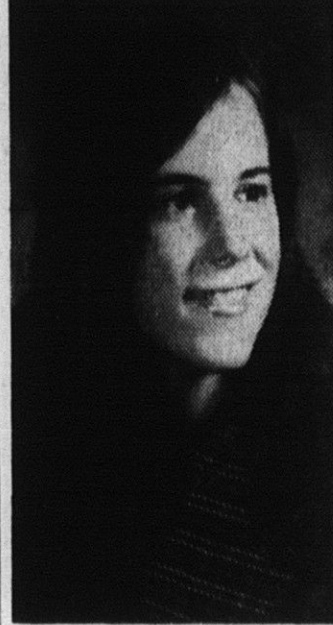
