Dr. Pollard at Hope Symposium

Science Servant of Man

"Only a renewed sense of the living reality of God can restore the poverty of spirit in the world today," Dr. William Pollard, executive director of the Oak Ridge Associated Universities of Oak Ridge, Tenn., told an audience in Dimnent Chapel Thursday night.

Dr. Pollard's appearance was in connection with a two-day symposium on "Science as Servant of Man" in association with today's dedication of Peale Science Center. Dr. Pollard, who also is an ordained deacon and priest in the Episcopal Church, spoke on "A Christian View of Science as Servant of Man."

The second lecture in the series was delivered Friday morning by Dr. William Bevan, executive officer of the American Association for the Advancement of Science. His subject "Science as Servant of Man: A Scientist's View."

Dr. Pollard said science in the 19th century seemed to be the exact opposite of today's approach that all time and space is immersed in a profound mystery, a living fascination of existence. It was natural, he said, to regard the three dimensions in space and time as science, utterly removed from any type of religion. The effort was to get at the basis of matter, and early in the century, scientists felt they had solved it, neat molecular structures following precise patterns.

"But the more we learn, the most astonishing is the universe," he said. "Science found all kinds of other things... the neutrons, the protons and many other particles, and deep in our heart we learned matter was made up of non-existent anti-matter."

He spoke on the most current field of research the last three or four years on large bodies in the field of astronomy, discoveries of interstellar masses of gas and dust forming stars, then seeing them collapse into new forms, a force so mighty that a single cubic inch weighs five million tons, then going from single atoms to single molecules weighing 10 billions tons per cubic inch, and finding stars three times heavier than the sun.

Viewing these vast masses which he said are still expanding and changing, he concluded that it might take 35 billion to 70 billion years to slow down the earth's changing patterns and have it disappear.

He spoke of the great discoveries in biology, its ingenious computerized system involving amino acids and proteins in which all life seems to be programmed by punched tape in an ingenious code of a 20-letter alphabet.

But man does not live by bread alone, he said, and modern science today is nearer to understanding something of the mystery and wonder of the word made flesh. He spoke of science and faith as the twin mysteries of life, terming the revelation of God as a movement in which God eventually became man through Jesus Christ. That took 1,700 years from Abraham to the time of Christ, he said.

"Christianity and Judaism, more than any of the other great religions, are deeply grounded in history," he said. "God is concerned with the achievement of man... and science is now emerging as nourishing the needs of man in a sort of living reality in an unseen world."

An Ohio man and a Holland woman won first prizes in the Windmill Island photo contest, it was announced today by park director Jaap R. de Blecourt.

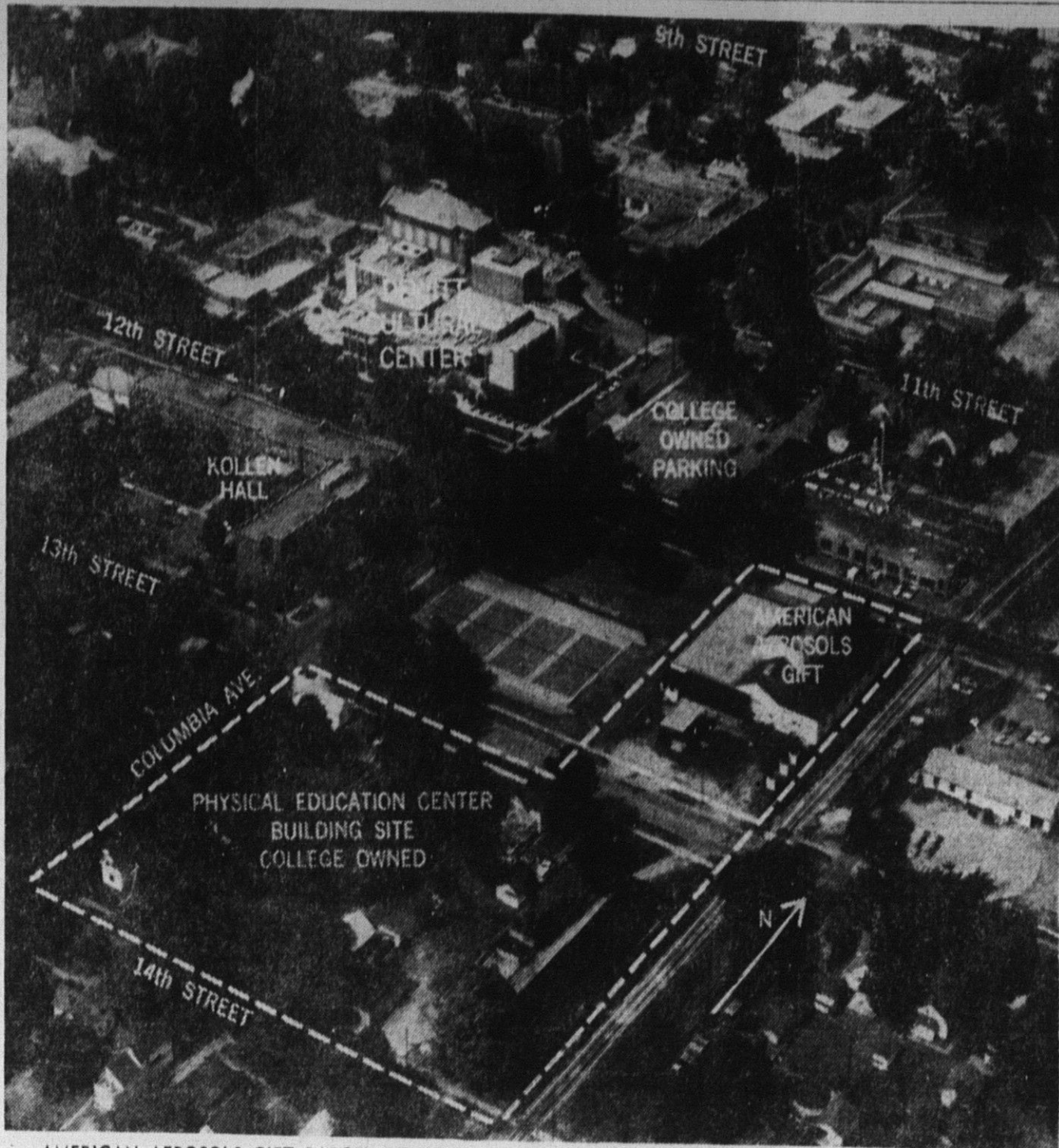
More than 100 photographs were received in the contest which limited subject matter to the 200-year-old windmill De Zwaan.

Asks Exam In Fatal Car Crash

ALLEGAN — Jonathan Cook, 49, of Pontiac, Ill., demanded examination at his District Court arraignment Monday to two counts of negligent homicide in the traffic deaths last Friday of two Otsego residents.

Bond of \$5,000 was furnished and Cook was released.

Killed in the crash were Rickey Glen Jackson, 24, and his passenger, Norma Jean Burroughs, 28. The accident occurred south of Plainfield as Cook attempted a left turn and crossed into the path of the oncoming car, Allegan County deputies said.

Pullman Cyclist Killed in Mishap

SOUTH HAVEN — Howard Dean Brown, 23, of route 1, Pullman, was killed early Friday when the motorcycle he was driving south along Blue Star Highway two miles north of here went out of control.

State Police said a passing motorist found the wreckage and Brown was pronounced dead at the scene of a broken neck. Troopers said the accident occurred shortly before 2 a.m.

Brown was believed heading south on Blue Star when the motorcycle went off the side of the road and flipped over while he was attempting to return the cycle to the pavement. He was alone on the motorcycle.

Brown was the son of Mr. and Mrs. Arthur A. Brown and was employed by Randall Co. in South Haven. Survivors include the parents, two brothers, Arthur Dale of Fennville and Richard Allen of Pullman and two sisters, Cheryl Ann of South Haven and Mrs. Helen Mae Mulac of Pullman.

Aerosols Gives Land to College

American Aerosols, Inc. of Holland has given Hope College its former manufacturing plant near the college's campus to assist the institution in completing its site acquisition program for a proposed physical education center.

The 18,000 square foot building is between 12th and 13th Sts. and west of the Chesapeake and Ohio railroad.

Announcement of the gift was made jointly by Joe Knoll and Herman Dirkse, president and vice-president respectively of American Aerosols.

Hope College is in the midst of a \$2.5 million fund raising campaign for the construction of a new physical education center. The existing gymnasium was constructed in 1906 when the college had an enrollment of 400 students. Enrollment this fall was 2,105.

The college has also acquired all property east of Columbia Ave. to the C & O tracks and between 13th and 14th Streets for the proposed center. The property is located adjacent to the southeast perimeter of the main campus.

American Aerosols, Inc., a subsidiary of Guardsman Chemical Coatings, Inc., is one of the largest custom fillers of non-food aerosols in the nation.

Founded in 1954 in an old brick utility warehouse by Knoll and Dirkse, the firm has grown to a capability of packaging products at a rate of 20 million cans per year.

The firm moved to the site near the Hope campus in 1958. In 1968 the company relocated in a new 35,000 square foot plant in the Holland industrial park.

"We are proud and happy to assist Hope College in pursuing its goal to build a new physical education center," Knoll and Dirkse said.

"We hope this demonstration of our commitment to Hope College will be a positive influence on others who will be asked to support this campaign."

Hope College President Gordon J. Van Wylen acknowledged the gift on behalf of the students and citizens of the Holland area who will use the new physical education center for decades to come.

The proposed physical education center will be activity-oriented for maximum participation. The building, which is in the preliminary design stages, would contain a gymnasium, olympic-size swimming pool, handball courts, wrestling area, training room, lockers, classrooms and faculty offices. The college plans to continue to use Holland Civic Center for its basketball games.

City Manager William E. Bopf pointed out specifications for police cars called for smaller-sized six-cylinder vehicles as being more economical and sufficient for city use. This move also is in keeping with economic performance under the energy crisis.

William Pate, 25, Injured in Fight

William Pate, 25, of 310 West 16th St., suffered several stab wounds of the stomach and back during an alleged fight reported at 2:50 a.m. Saturday at 131 Fairbanks Ave. in Holland township.

Pate was taken to Holland Hospital where he was admitted and reported in "fair" condition following surgery. Hospital sources said he suffered wounds in the kidney area.

Ottawa County deputies said a hunting knife with a 4 1/2 inch blade was recovered but no one was in custody.

Deputies said the alleged fight and stabbing was believed to have occurred on the porch of the residence. The cause of the fight was under investigation.

Annual Road Tour Taken In County

GRAND HAVEN — Members of the Ottawa County Board of Commissioners were guests of the Ottawa County Road Commission at its annual fall tour of county roads and parks Tuesday.

The tour, by chartered bus, took the group to the newly acquired Camp Kirk, a former Boy Scout camp on Lake Michigan between Holland and Grand Haven with 800 feet of lake frontage, and the Tunnel Park at Holland, where shore erosion and shifting sands have left their mark, resulting in dying trees. Shore erosion at Camp Kirk showed the same predictable results common all along shorelines plagued by high water.

More optimistic was the situation at Hager Hardwoods Park north of Hudsonville where continuing work on the arboretum points to fine planning in development of all trees indigenous to Michigan. Here, also, midday hunger pangs were assuaged by grilled hamburgers at the hands of County Park Supt. Richard Smallegange and his men.

With autumn colors framing a colorful landscape, the tour covered the four corners of the county, noting the progress along the way of I-196 which will be open in November, 1974 with its three interchanges within the county.

Road improvements, replacement of bridges and other improvements, together with their costs, were pointed out by County Engineer Ronald Bakker who hosted the day's events, together with the three member Road Commission, Chairman Neal Van Leeuwen, Carl Harrington and Frank Schmidt.

For good measure, the bus trekked along some unimproved roads pointing to the never-ending job of road repair and maintenance.

Engineer Bakker said the county department the past year has entered into many contracts with townships, much of it road improvements but in the case of Waukazoo, water service. In the case of laying water pipe through wooded areas, every consideration was given to saving as many trees as possible.

Some of the township road improvements were financed through revenue sharing funds. The bus also stopped at Allendale township hall to see a fine new addition housing fire fighting equipment.

In Michigan Lottery Super Drawing

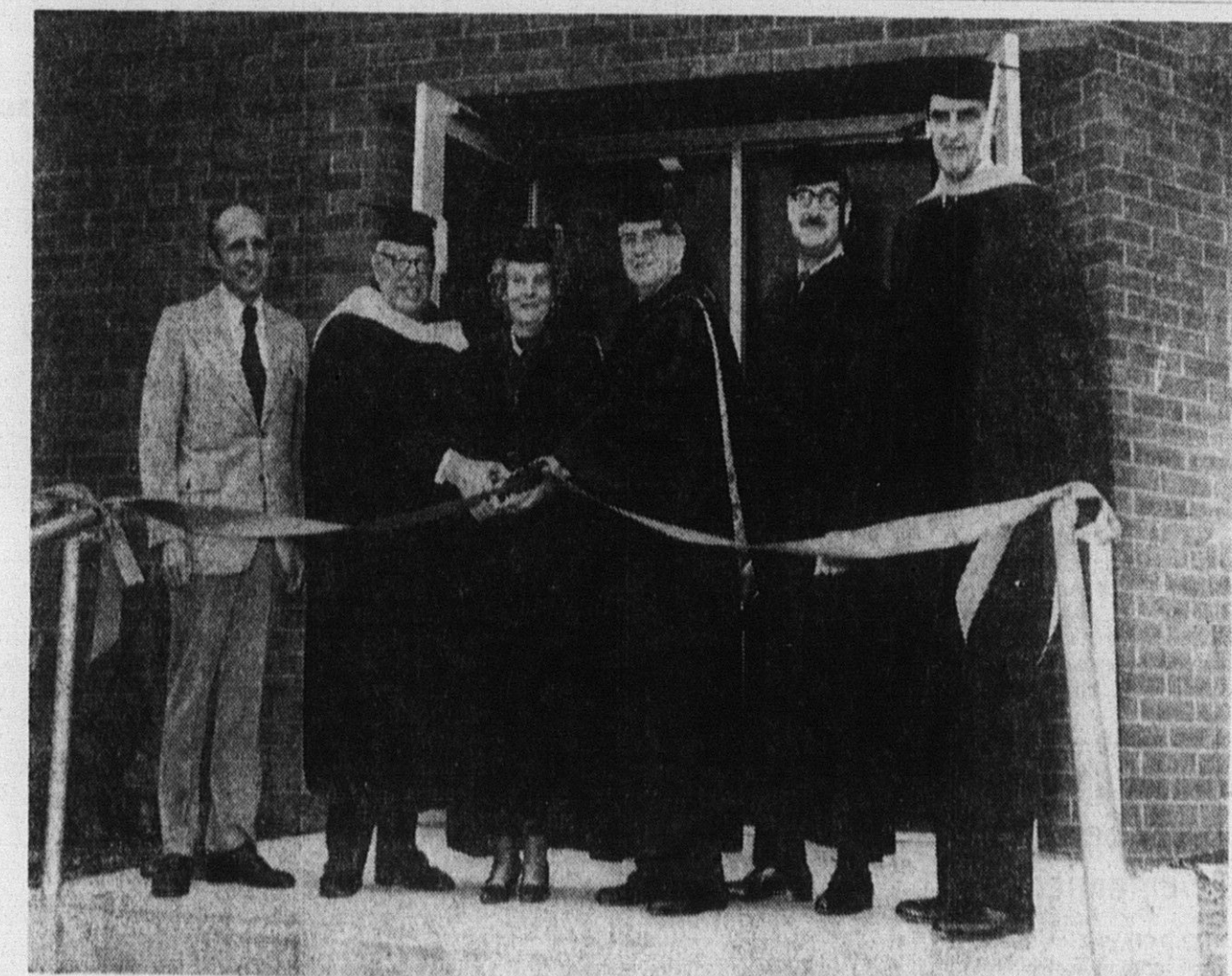
David Fairbanks Wins \$50,000

Amid Pageantry and Informal Good Cheer

Peale Science Center Dedicated

Dignity blended with informality resulting in an overflow of good cheer marked the dedication of Peale Science Center at Hope College Friday.

This fine new building is named for Ruth Stafford Peale, a member of the board of trustees of Hope College, and Dr. Norman Vincent Peale, longtime minister of the Reformed Church of America.

Today's dedication also saw the awarding of a Doctor of Humane Letters to Stanley S. Kresge, chairman of the board of the Kresge Foundation, whose challenge gift of \$500,000 (soon matched by other gifts) provided the nucleus for financing the science center.

Both Dr. and Mrs. Peale spoke informally, Mrs. Peale expressing appreciation to the college for recognizing the couple as a working team. She also recognized the fine aims of Hope College in striving for excellence in education and the atten-

tion the local institution gives in molding character.

Dr. Peale, who always exudes positive thinking, said Hope College represents a system of values that this country desperately needs, that troubles exist not only in Washington but everywhere, and the need to recover morality, humor and decency exists everywhere.

"If we had a Hope College in every city in the land, this country would be what it was intended to be," he said. "The God that creates everything can put back into this country an in-depth faith... a philosophy of the greater application of science along the line of the science of faith in our Lord Jesus Christ."

In his welcome, Dr. Gordon Van Wylen called attention to the college's commitment to liberal education and to the glory of God, quoting Dr. William Pollard in his Thursday lecture

referring to God as the great architect.

Hugh De Pree, chairman of the board of trustees, introduced the Peales and Ekdal J. Buys, a former board president, presented Stanley Kresge for the honorary degree.

Keys to the new building were presented to Earl H. Beckering, president of the Pioneer Construction Co., who recalled that his father had served as contractor of the first science building over 30 years ago. Speaking for the college was Ronald J. Posthuma, president of the Student Congress, and Dr. David Marker, associate dean for academic affairs.

Music was provided by the chapel choir directed by Roger J. Rietberg. Royer E. Davis was at the chancel organ and Alfred Fedak at the gallery organ. A brass quartet in the balcony added color to a festive event.

The ribbon-cutting ceremony followed.

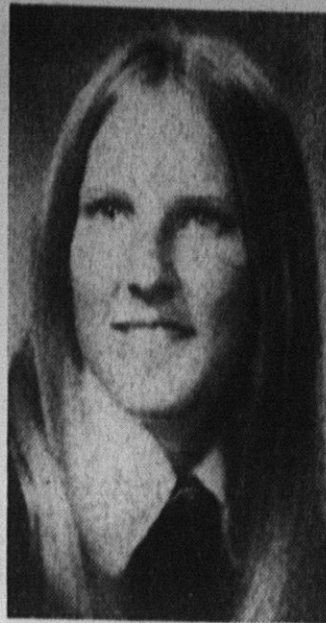

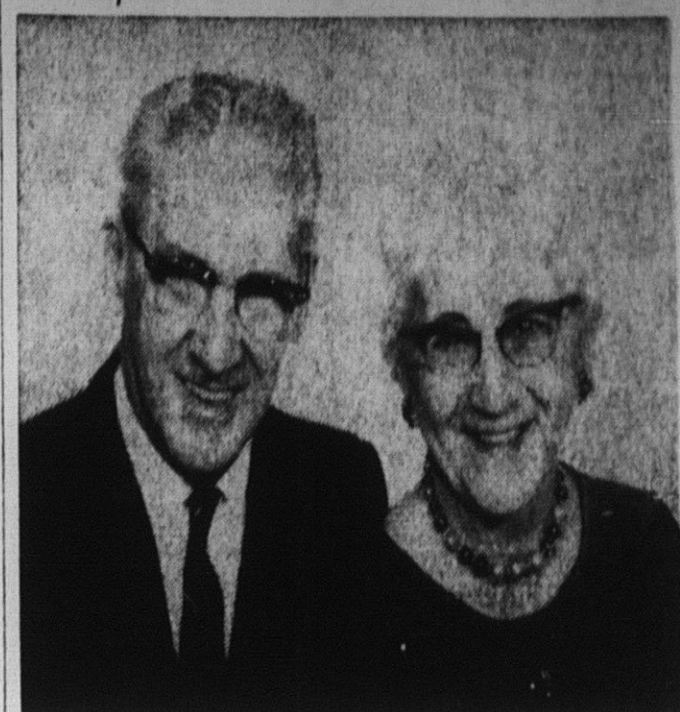

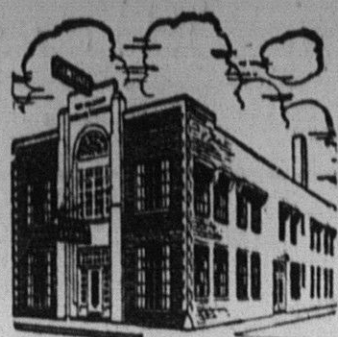

'WATT WATCHERS' GUIDE'

The "Watt Watchers Guide," published by Portland General Electric Company coupled with an explanation of the need to push ahead with developments of new sources of energy, tells how to save energy.

"Watt Watchers Guide" points out ways to cut down on the use of electricity in the home. The guide shows how to save on heating and cooling costs. In heating, each degree over 70 degrees adds about 3 per cent to your annual heating costs. Conversely, in cooling, each degree below 78 degrees uses substantially more energy.

The Guide also points out that it makes sense to be sure your laundry equipment and dishwasher are used with full loads. Cleaning the lint filter after drying clothes keeps your dryer from working so hard and will save electricity. To avoid wasting hot water while laundering, use the cooler water. Avoid leaky hot water faucets and be sure to turn them off completely after using. Fluorescent lighting is cool in operation and lasts seven to ten times longer than incandescent bulbs.

The Guide makes many other recommendations such as selecting lamps with white or ivory shades or linings that save as much as 50 per cent of the light. And, of course, the best of all "watt watchers" ideas is to turn off lights, televisions and radios when no one is using them. Combining energy economy with intelligent, long-range efforts to increase energy output from all sources, including nuclear, makes good sense. In the long pull, this is the only answer to the energy shortage.

We thought this would be interesting to our readers with the energy problems that we seem to face today.

Sunday School Lesson

Sunday, Nov. 4
Life In The
Christian Community
Romans 12:1-8;
1 Corinthians 12:12-13
By C. P. Dame

The early Christians, living in a pagan atmosphere, were very conscious of being a distinct people. The temptation to conform was strong and subtle. By living close to each other in a loving fellowship they received strength to resist their environment and live as becometh believers in Christ.

1. Conformity is common. The epistle to the Romans is divided into two parts, the first 11 chapters deal with Christian doctrine, the chapters from 12 to 16 with the practical application of doctrine. Paul appeals to Christians in Rome, to present their bodies, their whole selves, as a living sacrifice both holy and acceptable unto God, in a reasonable service. In Judaism and in pagan religions dead animals were sacrificed. Christians who had been made alive through the Holy Spirit should offer themselves as living sacrifices to God—do so with complete abandonment. Paul calls the Christians "brethren" or brothers, a term that suggests family ties.

"And be not conformed to this world" — this would keep them from giving themselves wholly to the Lord's work. The temptation to conform is common today; hence the words fit us for we are pushed all the time to do what every one else is doing, regardless of old values and principles. Instead of conforming, be transformed by the renewing of the mind. A Christian's aim is to please God, not self or the world, which pressures constantly.

II. A right view of self is needed. One can think too much or too little of self. Some people talk, think, look out for self because they think too much of self. It is hard to get along with people who are proud—the humble knew their limitations and gifts and judge accordingly. Members of the church have different gifts. All are meant to be used in the church, all should be prompted by their gratitude to God for His mercies. Paul refers to the human body which functions well when all do their part. The same is true of a church. When all serve, the church thrives. Many opportunities challenge hence various gifts can be used.

III. God's Spirit unites. I Corinthians 12:12-13, teach the same truth taught in Romans 12. In the church there is diversity and unity. When the Holy Spirit dwells in the hearts, then united action and service will follow and the longing to help one another will be there. Big things and little things will get done by people, ruled by the Spirit.

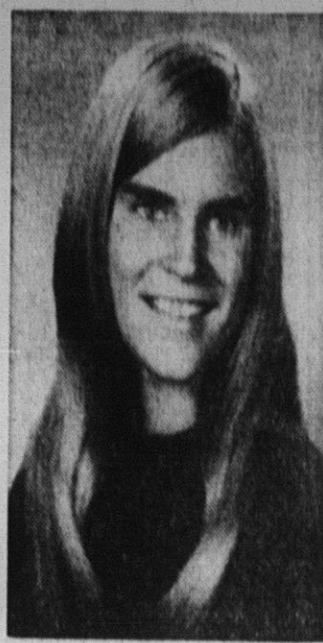
Driver Escapes Serious Injuries

Allegan Okays 1974 Budget Items

ALLEGAN — County commissioners Tuesday approved a \$3,246,534 budget for 1974, representing a 10 per cent increase over the current budget, and a new salary schedule for county employees with as much as a 12 per cent boost in wages.

Finance chairman John Vogelzang of Holland said the salary increases went as high as 12 per cent but the average boost was "between six and seven per cent."

The new budget represents a \$32 million increase in the county's state equalized valuation set at \$333,327,317.

The largest single item in the new budget is \$413,233 for operation of the county jail and sheriff's department, up \$21,390 from this year. Also included is \$333,327 for bridge replacement and \$166,663 for the county road fund. Both items were approved at special elections.

Board members also got their first look at Kalamazoo Architect Robert Cain's preliminary plans for a new 24,000 square foot building to house the departments of health and social services at the former county farm site on Dumont Lake. Slightly more than half the space will be allocated to social services, according to the plans.

Approving the preliminary plan, the board also authorized the architect to include a 4,000 square foot extension as an alternate when the project is bid.

Cain said construction costs would be approximately \$30 a square foot, including carpeting, air conditioning and a paved parking lot. Landscaping was estimated at \$10,000 and professional fees at \$50,000.

The \$230,000 in federal revenue sharing funds allocated for the project includes money for renovating space vacated by the health department in the present county building in downtown Allegan.

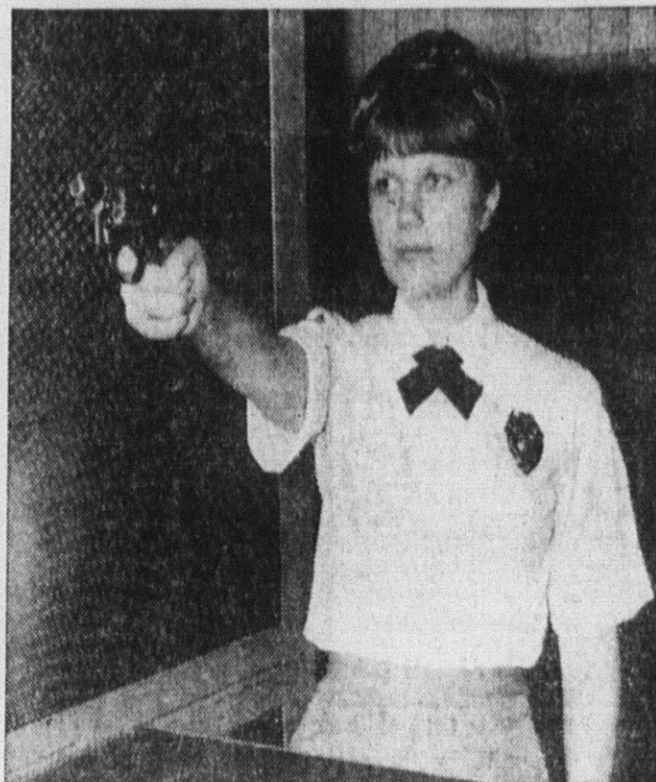

Local Police Lady Endures Notoriety

The lady is young, attractive, well-educated, well-trained, and takes her job seriously. She's a cop.

Specifically Cindy (she doesn't like Cynthia) Fricke is the first woman police officer in the Holland Department. And she's a long needed asset to the local force.

She good naturedly endures the notoriety of her unique position and occasionally relates humorous anecdotes of people's astonishment.

Her favorite reaction is the local store clerk, who, upon recognizing Cindy from the picture that had appeared in The Sentinel the day before announcing her appointment, exclaimed "I never thought I'd meet you in person."

But if the situations are sometimes lighthearted, the duties are serious. And Officer Fricke approaches them earnestly.

Though she may be called upon to assist with stakeouts, coordinate investigations with the detective bureau, patrol, enact her sworn powers of arrest, assist the school liaison officer, among numerous other responsibilities, one of her chief functions will be working with juveniles, particularly girls.

The former Muskegon resident, one of two women in a class of 39 police candidates at the Mid Michigan Police Academy in Lansing, received precisely the same training as the men during the ten-week training session.

She described the Physical and self defense training as perhaps not extensive enough but complimented most other aspects of the program.

The physical training included two-mile runs on a banked course and karate practice. The police candidates also extensively studied Michigan statutes which Miss Fricke described as much more practical than the theoretical courses she studied in her public service law enforcement courses at Grand Valley State College from which she graduated. She feels however, that both the college courses and the police training are essential to well-balanced preparation in her career.

The training stressed self preservation, respect for others, self and gun. Because of the rigid requirements and training students develop a real sense of responsibility which weighs heavily on the candidates.

During the course of the training, Miss Fricke experienced a phenomenon she describes as prevalent among police candidates. Instead of thinking "perhaps I don't want to get into police work, there is more a fear 'am I good enough

to do it?" she recalls.

Police officers in Michigan are required to have a minimum of 256 hours of training and Officer Fricke received more than 400 hours at the Mid-Michigan training center.

Occasionally burdens of her profession vanish in the face of everyday frustrations experienced by all women.

Her navy and cornflower blue uniform arrived in time for her graduation at the Police Academy. The blouses, hat and overcoat were huge. Weeks later she is still borrowing from the matrons. The uniform also includes a regulation purse but the navy shoes are of her own choosing.

She wears the uniform when on patrol, speaking in schools, or whenever she feels the situation calls for her to be readily recognized.

Officer Fricke started at the Holland Police department as an intern from Grand Valley State College in March '72 and last spring applied for the full-time position in the Holland department.

The Holland department's original decision to employ a female officer centered on the department and city's growth and the increasing contacts with juveniles.

Prior to Miss Fricke's arrival, female prisoners were searched by police matrons, who are not as extensively trained in search procedures.

Her determination to become a policewoman began in high school when, as she says, no girls thought about becoming police women. Now many more girls are entering the field of law enforcement, she said. So, she fears, the job outlook will grow increasingly more grim for future candidates unless competent women are hired on a more realistic ratio to men.

During her indoctrination the last four weeks she has worked within each of the police departments: detective, patrol, dispatching and records, and community services.

Cindy credits Holland Police Chief Charles Lindstrom and Corporal Keith Houting, head of the community services unit, as the reasons she's a policewoman today. "They gave me considerable encouragement and help," she said.

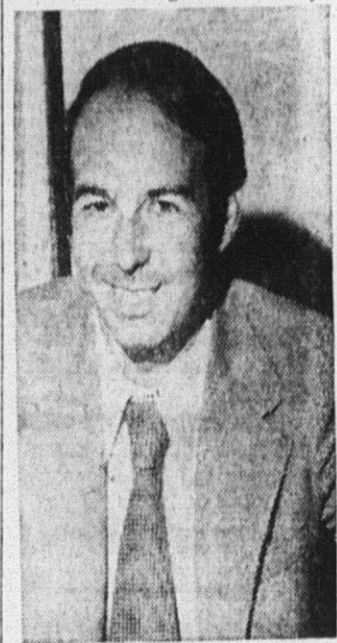
While working as an intern last year, custodians at the jail locked her in a cell for a short while. She now feels slightly better equipped to handle the psychological problems of the incarcerated.

In her counseling experience she has observed generally that men are the most polite to her and adolescent girls are the most verbally abusive.

One of her biggest frustrations is being taken seriously by young people who insist upon

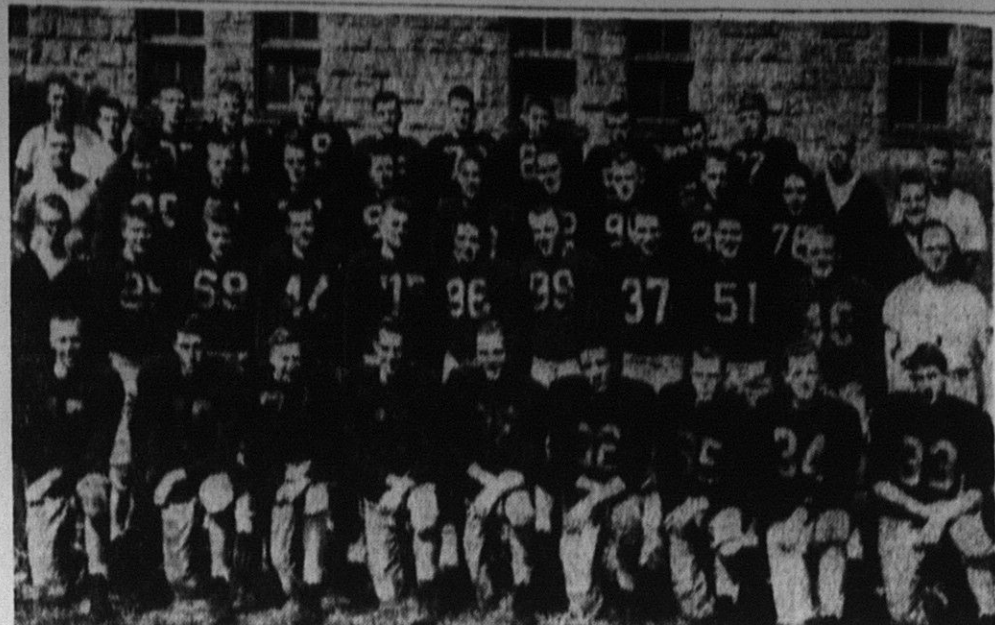
The resolution was signed by chairman Jay A. Wabeke and secretary pro tem Mary Whelan,

The 1953 squad which was coached by Al Vanderbush lost its opening game to Eastern Michigan University, 21-4, and its finale to Alma College, 33-19 but in between they were unbeatable, as they rolled to convincing victories.

Hope destroyed Olivet College, 25-0, tipped a strong Carroll College eleven, 21-14, stopped Adrian College, 33-19, and in between they were unbeatable, as they rolled to convincing victories.

The Dutchmen also tamed the Britons of Albion, 20-7 and trimmed Kalamazoo, 12-7 to lock up the league championship.

"The Albion win was probably the highlight of our season," Vanderbush said in an interview recently.

Adams and another all-MIAA halfback Frank Talarico of New York were probably the two best backs to wear a Hope uniform at the same time, according to Vanderbush.

Vanderbush wouldn't say which one was better but did insist that there was no finer pair in the MIAA.

Other players on the 1953 squad include end John Brannock, center Earl DeWitt, his brother Warren, a tackle, 300-pound tackle Bob Fales, guard Tom Harris, halfback John Holmlund, tackle Dave Karsten, fullback Dave Kuyers, guard Maurice Marcus Jr., linebacker Herm Nienhuis, guard Dave Nieneker, tackle Dick Schultz, linebacker Ian Smith, line cker Dave St. Aubin, guard Ed Stapert, end George Van Antwerp, halfback Ken Van Wieren and halfback John Walters.

Jack Schouten was the trainer back in those good old days while managers were Norm Lager, John Kenwell and Tom Keizer.

Grand Haven Strikes Like Lightning

GRAND HAVEN — Grand Haven struck like lightning, as they thundered past the Holland High Dutch in a Ottawa County scoring affair, 50-24 here Friday night.

The Dutch never knew what hit them, as the Bucs shot out to a commanding 30-0 lead at the outset of the second quarter and held a 36-6 halftime margin.

Coach Dan Poretta's club did manage to outscore the Bucs, 18-14 in the second half.

Grand Haven had only averaged around 50 yards a game in rushing going into Friday's tilt but with 5'9" 165-pound senior Larry Niemiec running wild, the Bucs finished the evening with 272 yards on the ground.

Niemiec picked up 194 of them on 19 attempts for a 10.4 per carry average, as the Grand Haven offensive line was opening holes big enough to drive a truck through each time they touched the ball in the first half.

Holland's fine running duo of fullback Clark Kuipers and tailback John Bonnette finished with 114 and 100 yards respectively, as the Dutch offensive line came to life in the second half to open some nice holes for their talented runners. Kuipers made his on 11 tries while Bonnette had 17 carries.

Grand Haven's brilliant quarterback Jim Kalsbeek hit on eight of 10 passes for 131 yards including two touchdowns passes.

It only took Grand Haven four plays to move the ball 72 yards for a touchdown on the very first series, as Niemiec ended up carrying it 41 yards for the score. Kalsbeek waltzed into the end zone untouched for the conversion.

Coach Don Constant, who predicted earlier that the Dutch wouldn't beat his Bucs after what happened last year at Riverview Park, as Kalsbeek completely faked out the Dutch the second time Grand Haven had the ball by firing a 55-yard TD pass to end Jeff Harsh.

Kalsbeek was the same quarterback who Constant insisted scored a touchdown on the last play of last year's game between the two rivals that would have given Grand Haven the win.

Moments later Kalsbeek fired a seven-yard TD strike to Tom Harrington and when Rick Zatlman ran the PAT, the homecoming crowd could hardly believe the scoreboard which read Grand Haven 22 Holland 0 with 2:19 still left on the clock in the first stanza.

As the first period closed, the Bucs had 132 yards rushing and 104 more passing compared to 11 total yards for Holland.

Holland's 13-12 win over the Bucs last year gave them possession of the "Wooden Shoes" but that wasn't going to last long, as Gary Kratt bulldozed his way into the end zone from the two at the outset of the second quarter to give the Bucs an unbeatable 30-0 margin.

The Dutch found out they could move the ball, as Kuipers and Bonnette started to run like they're capable of, as Holland moved 30 yards in 11 plays with Bonnette going the last four for the touchdown Steve Bonnette's extra point pass failed to connect.

Kratt's long punt kickoff return and eventual one-yard TD run put Grand Haven up by 30 points at the intermission, 36-0.

Holland came out fired up in the second half, as on the opening series they marched 79 yards in 14 plays for the score. Kuipers bulldozed his way into the

end zone from the one. During that drive, the Dutch ate up seven minutes and two seconds.

Gary Brugger, younger brother of former Hope College star Barry, closed out the Bucs scoring in the third period with a TD.

Behind the fine running of J. Bonnette and Kuipers and the passing combination of S. Bonnette to Paul Shashagay, the Dutch kept picking away at the big Buc margin. Bonnette scored Holland's third TD in the fourth quarter on a nice 14-yard scamper.

A two-yard TD run by Kuipers moved the Dutch within 18 points of the Bucs with 5:39 left in the game.

Constant was starting to worry as he put his first string back in and Niemiec proved him right by dashing six yards for the game's final score. Kalsbeek's extra point pass to Bill Doolittle closed out the scoring 50-24 in one of the wildest games ever played between these two rivals.

Holland's 24 points was the most scored this year in one game while Grand Haven hasn't managed that many markers in over 10 years.

Grand Haven, now 3-4, will play at Grand Rapids West Catholic next Saturday while the Dutch also 3-4 will host powerful St. Joseph.

West Ottawa Drops Close One to Rams

ROCKFORD — The West Ottawa Panthers had the opportunities, but their inability to score, and the bruising rushing of a couple of Rams backs, made a first quarter Rockford touchdown stand up, 7-0 here Friday night.

Rockford backs John Dauks and Jeff Gamble combined for 196 yards on the ground, eating up the clock when the Rams got the ball. Their pounding running was particularly frustrating to the Panthers because it enabled the Rams to hold on to their one touchdown lead when West Ottawa might have come back.

The only score of this hard-fought, well-played contest came near the end of the first quarter when Ram quarterback Stan Bayn fired a 45-yard pass to end Larry Reeves who had beaten the Panther defenders down the sideline.

Although the first half was all Rockford, West Ottawa came roaring back as the third quarter opened with a ball control drive of 45 yards on 13 plays, rolling up four first downs in the process. The drive stalled, though, when the Rams intercepted a Jack Murdoch pass deep in Rockford territory.

The Panthers got another drive started in the fourth quarter, aided by a pass interference penalty on a fourth and nine situation. But the drive stalled again. West Ottawa was never to threaten seriously for the rest of the game, unable to stop the sweeps and slices of Dauks, who picked up 65 yards in the second half.

There were some bright spots for West Ottawa, however. For the first time this season, they did not lose the ball on a single fumble. On offense sophomore Scott Tubergan broke off a couple of long runs, one for 41 yards, and totaled 96 yards rushing for the game.

End Randy Ollis, back in the line-up after an injury, stood out on defense with some fine tackles and at least one unassisted sack of the Rockford quarterback. Gord Vander Yacht played tough defense in the second half, and picked off a Ram pass with eight minutes left in the game.

But the inability of the Panther offense to get into the end zone told the tale. The game was hard-fought, as the score indicates, and West Ottawa was never really out of it. The opportunities were there, but the drives stalled.

The loss to Rockford was West Ottawa's fourth in a row. Nov. 1-6 for the season, the Panthers will take on Rogers at home next week, in search of that elusive second victory.

'Night Watch' Grips Community Audience

Suspenseful realism played to the hilt succeeds in Holland Community Theatre's production of "Night Watch" by Lucille Fletcher. Good acting and detailed visual effects highlight director Barbara Greenwood's well-integrated total production.

The pivotal role, created by Mary Kearney, is psychologically exacting because she must fool both the actors and the audience. She carries the show with her emotional portrayal of a woman who claims to have seen not one, but two dead bodies, in the space of three nights' time in the window across the street from her own living room.

Kearney is capably supported by the subtly ambiguous Daniel Parker, who plays her unfaithful husband, and a suspiciously welcome best friend played by Sandy Hemple. Dick Rasmussen, Gordon Cunningham, and Dan Resique are impressive in smaller walk-on roles.

Another striking aspect of this thriller is the minutely appropriate detail, particularly in E. Dale Conklin's set and Linda Parker's properties. The Manhattan apartment is just that—the locale is so appropriately created that we never doubt its reality, right down to the empty cigarette pack on the coffee table.

Production director Greenwood and her assistant Pat Wiersma deserve the credit for putting it all together — the minute realism of the set and props, the good acting, and the pacing for dramatic climaxes. On the edge of your seat? Maybe not. But Holland Community Theatre's production will keep you involved and guessing, right down to the last cigarette butt in Mary Kearney's hand.
