Bound Over At Hearing On Fatalities

A Holland man charged with negligent homicide in connection with a multiple fatality here last Oct. 5 was bound over to Ottawa Circuit Court following a preliminary examination before Holland Municipal Judge Cornelius vander Meulen Tuesday afternoon.

Dennis Donald Hardy, 21, of 3538 Lakeshore Dr., was ordered to appear in Circuit Court in Grand Haven at the opening of the January term or earlier if agreed upon by counsel for the prosecution and defense. It was noted court will be in session Dec. 17 and 20.

Hardy was charged in the death of 17-year-old Thomas Evan Fairbanks, one of five persons killed in a two-car crash on Riley St. some distance west of Butternut Dr.

Hardy was represented by Atty. Gordon Cunningham of Holland who had been appointed by Circuit Judge Raymond L. Smith as a court-appointed counsel. The greater share of the hearing was conducted by Prosecutor James W. Bussard who put on three witnesses. The hearing lasted an hour and a quarter. The court room on the second floor of City Hall was crowded and some stood for the proceedings.

Sgt. Gerald Witteveen of the Ottawa county Sheriff's department was on the stand 45 minutes, 30 minutes of which was taken up by the prosecution. Sgt. Witteveen, who signed the complaint against Hardy, testified calmly as to time, place, distances and other technical data. He identified Hardy as the driver of the car, adding he had established that fact several days following the accident in an interview in Holland Hospital. He added Hardy had been cooperative.

Witteveen said he measured tire tracks for some 260 feet, stating the distance where the right wheels had left the road to the point where it crashed into two mail boxes was 157 feet. Distance to get back onto the road was 38 feet, and distance to the point of impact was 68 feet.

He added he had interviewed four witnesses, a Mr. Bareman of Illinois who was driving a horse and wagon partly off the road some distance ahead of the car in which the five young people were killed; Henry Jackson, of 645 Bosma Ave., whose car was headed east on Riley; and Paul Hindert, 20, of 160th Ave., who was a passenger in a car driven by Roger Dangremond of Holland which was following the Fairbanks car.

Other witnesses called were Hindert and Jackson. Hindert said he and Dangremond, the driver, were looking for pheasants before the hunting season opened and he testified seeing the Hardy car come over a hill on Riley St., and crash into the Fairbanks convertible which was some distance ahead of the Dangremond car. The convertible had remained in its own lane, he said.

Jackson testified he was heading east on Riley and noticed the Hardy car as it passed his "with a swish." He said he saw the accident scene when he got to the top of the hill. The next day he retraced his route and determined the Hardy car passed his ninth-tenths of a mile from the impact site. He estimated speed of the Hardy car at 70 to 80 miles an hour.

Atty. Cunningham moved for dismissal stating no evidence of negligence had been submitted, but Prosecutor Bussard pointed out the Hardy car was not driving to the right of the centerline, a fact borne out by circumstances and by witnesses. Judge vander Meulen denied defense counsel's motion stating it is not incumbent on the prosecution to negate every possibility. He continued Hardy's bond of \$1,000.

Others killed in the two-car crash were Fairbanks' sister, Jeanne, 13, Pamela Bradley, 13, Todd Michael Hilbink, 18, all of Holland, and David Van Overloop, 18, Grand Rapids.

Receives Minor Injuries When Car Hits Pole

Allen D. Heyboer, 22, of route 2, Hamilton, was released from Holland Hospital Saturday morning after he was treated for minor abrasions on the leg he received when his car sideswiped a telephone pole at 1:20 a.m. near Lincoln Ave. and 48th St.

Heyboer applied the brakes on his car, causing it to spin around on the slippery road and hit the telephone pole, according to Holland police. The entire left side of the car was damaged. Heyboer was taken to the hospital, mainly for observation. Hospital officials said, and released to his physician.

Bouncing Wires? A Phenomenon

No, it wasn't "Twilight Zone" in Holland early this morning. The two overhead pedestrian signs on Eighth St. bounced up and down with a rhythm so precise that early morning risers were puzzled and baffled.

This turn of events was not man made.

The oscillating motion was a phenomenon which engineers say is caused by a combination of temperature and wind, the latter in precisely the right direction and the right velocity. After this oscillation is set in motion, the rhythm continues until the wind changes, setting up another pattern, or stopped by man.

In this case, BPW employees on the lift truck stopped the bouncing.

Though uncommon, this oscillation sometimes affects utility wires causing a swinging or bouncing which can last a considerable length of time.

Tall Scots Hand Dutch 89-81 Loss

ALMA — Alma College's basketball team bumped defending champion Hope, 89-81 here Wednesday night in the MIAA opening game for both teams in Phillips Gymnasium.

It was Hope's first loss to Alma in seven years and the game, although the MIAA opener for both clubs, was looked upon as a key league encounter since the Scots and Flying Dutchmen are regarded as chief contenders for the MIAA title.

It was also Hope's first MIAA setback in 20 games. The Flying Dutchmen swept the league last season with 12 straight wins and had racked up seven straight at the close of the 1961-62 season following a one-point, 61-60 loss to Kalamazoo.

The shorter Dutchmen almost pulled out the win over the taller Scots but a nine-point spurt in the final six minutes gave Alma the win. Alma had three 6'5" players in the lineup while starting center Bill Nichols is 6'6".

Hope was "hot" from the start and took an early lead but the Scots caught up, 21-21 and then had a "hot" streak and pushed in front, 47-41 at half. Hope hit 15 of 39 from the floor in the first half and the winners had 19 of 40.

Alma opened the second half by jumping to a 10-point lead but Hope, led by Capt. Glenn Van Wieren's shooting and aggressive defensive play, chipped away at the lead and with seven minutes to go Van Wieren's basket had tied the score at 69-69.

Bill Potter picked up his fifth foul and Bud Acton hit two free shots with 6:25 left and Alma never again rallied. After Ron Vanhuizen tallied a free throw, Hope hit a "cold" streak and although they weren't dropping, Hope started fouling and Alma cashed in.

Alma then called on 5'10" Tom Miller and 6'5" Kurt Schultz, both juniors, who had been playing in the shadow of 6'5" Acton, 6'5" Bill Pendell and Ray Moore. Schultz hit two baskets and Miller added one and two free shots to give the Scots the 79-70 lead with 2:40 left.

Clare Van Wieren made two free shots to break the famine but Miller matched it with a basket. The rest of the game belonged to Miller as he hit 12 of Alma's final 14 points. Miller was second in scoring with 23 points, 19 in the second half.

Acton led the winners with 26, 20 in the first half. Acton features a quick turn on his shots and in the second half Hope had mastered his moves and held him to one field goal. Bill Pendell picked up 22 points, 16 in the first half, while Moore had 14 points.

Coach Russ De Vette said Hope was combating Alma's superiority on the boards and rebounded the winners in the second half. Hope played a zone throughout and adjusted to Acton and Pendell's shots in the second half.

Hope sank 34 of 80 attempts in the game for 43 per cent including 19 of 41 in the second half. Alma had 33 of 92 for 36 per cent.

The difference came at the free throw line where Alma sank 23 of 27 free shots including 14 of 18 in the second half after nine straight in the first half. Hope made 13 of 17.

Capt. Van Wieren led Hope with 25 and was also strong on defense. Clare Van Wieren had 14 and Dan Overman, starting his first game and 6'4" Potter each had 10.

Hope hosts Westmont of Santa Barbara, Calif., next Monday in the Holland High fieldhouse.

Boat Picks Up Meter Buoys

A small boat, the Telson Queen, from Sturgeon Bay, Wisc., has been docked since Sunday at the Harrington Coal Docks on West Ninth St. The boat is in this area of Lake Michigan to pick up two current meters, but has been unable to complete its work because of the weather.

The Telson Queen, under contract with the U. S. Public Health Department, picks up and drops the meters throughout Lake Michigan. The meters record water currents and the data is used to help Public Health officials to minimize or eliminate water pollution.

Mefer-buoys used during the summer record water current and win velocity; subsurface buoys, used during the winter to prevent ice damage, only record currents. The subsurface meters have a time release which allows them to float to the surface where they may be picked up by the Telson Queen.

The Telson Queen, which came to Lake Michigan about a year ago from Florida, has a crew of nine men, including two Public Health men, and two skin divers.

Allegan County sheriff deputies said Miss Green was headed west on 132nd Ave. as La Fountain was entering the roadway from his driveway. Neither could stop due to icy road conditions, deputies said.

Port Sheldon Sets Township Meeting

Residents of Port Sheldon Township will meet tonight at the regular meeting of the town board in the old town hall on 152nd St. to present their ideas on a new town hall building.

Plans for the construction of the new town hall were presented at the Port Sheldon Township meeting Tuesday night at West Ottawa School. About 50 people were present.

Architects Kammeraad and stroop presented two plans one calling for a combination fire station and township hall that would cost \$54,600 and the other a combination community hall, fire station and town hall that would cost \$122,300.

Oldest MSU Alumnus Dies

Andrew B. Goodwin, 98, who came to Holland in 1942 after many years of practicing law in Carson City, Mich., died at 4 a.m. Saturday in Holland Hospital. Since 1942 he has made his home with his son and daughter-in-law, Mr. and Mrs. Harold K. Goodwin, 341 Howard Ave.

Goodwin was the oldest living alumnus of Michigan State University and as such carried the Kedzie cane. He was born in Ionia county Jan. 11, 1865, attended Ionia schools and was graduated from Michigan State University in 1888. After graduation he studied law and was admitted to the Michigan State Bar in Carson City in 1894.

At Carson City he was active in religious, civic and political life. He served as village president for two years, village clerk for 20 years, village attorney for 15 years, justice of the peace for 24 years, postmaster for nine years and as Montcalm County Circuit Court Commissioner for two years. He was a member of First Methodist Church of Carson City and of Carson City lodge No. 306, F. and A.M.

Dutch Drop 86-82 Game To Crusaders

Wheaton College's basketball team ruined Hope's home opener here Saturday night as the Crusaders capitalized on Hope's mistakes to take an 86-82 win before 1,800 fans in the Civic Center.

With Hope leading, 82-80 and 1:20 left to play, the Crusaders took the play away from the Flying Dutchmen and scored six straight points.

Five seconds after Capt. Glenn Van Wieren sank two free shots to give Hope the 82-80 lead, Steve Miller retaliated with the tying basket.

The next time the Crusaders got the ball they began playing keep away with long passes in the Wheaton frontcourt. Using a revolving offense, the Crusaders tried to spring a man loose.

But Hope fouled and John Pfund, who scored 29 points in the game, calmly sank the go-ahead free shot with 27 seconds left. Hope then had the ball intercepted and Tom Carney sank a basket with 16 seconds to play. He was fouled and added a free shot to give the Crusaders the four-point win. Wheaton's pressing defense bothered Hope the entire game.

Hope jerked along in the first half with only 6'4" sophomore Bill Potter able to hit consistently. He popped nine of 12 in the first 20 minutes and had 18 of Hope's 36 points at half.

The Crusaders, with Pfund hitting 16 of his points, had taken a 44-36 lead. Wheaton jumped off to a 10-2 lead and were in front 20-10 with 11 minutes left.

But Potter, aided by Glenn Van Wieren and Dean Overman, chipped away at the lead to cut it to six just prior to half.

Capt. Van Wieren started Hope's first really basket flurry after six minutes of the second half had elapsed. Trailing 54-47, Van Wieren got two quick baskets and before the 10-minute mark, Hope had added eight straight points to lead, 59-54.

Potter made two baskets in the spurt and Clare Van Wieren and Al Palmer each had one basket. Hope maintained its five-point lead for the next three minutes before three quick baskets in 43 seconds, one each by Charles Huibregtse, Miller and Pfund, put the Crusaders back in front, 66-65 with 6:52 to play.

The teams were tied three times in the next minute and the lead changed hands twice before Clare Van Wieren hit two quick baskets to put Hope in front, 75-72 with 4:10 remaining.

Wheaton again counted with four points in the next minute but Hope added a sidecourt basket by Overman and three free throws to take an 80-76 lead with 2:13 left.

Miller and freshman 6'6" Rog Weavers, ex-Grand Haven player, each tallied to tie the score, 80-80 before Van Wieren fired his two free shots.

Hope committed only nine fouls, two in the last half minute, and the Crusaders made eight of 13. Hope sank 12 of 18. From the floor, Hope hit 35 of 80 for 44 per cent on halves of 16 of 39 and 19 of 41. The winners made 39 of 91 for 43 per cent on halves of 21 of 49 and 18 of 42.

Potter led Hope with 28 while Glenn Van Wieren hit 17; brother Clare, 15 and Palmer, 10. Miller followed Pfund with 14 for Wheaton; Huibregtse had 12; Carney, 11 and Bill Province, 10, all in the first half.

Well Known Sportsman Dies at 73

Hine Vander Heuvel, 73, of 60 South Division Ave., well known sportsman, died Saturday of a heart attack while trapping near the American Legion Club. He was dead on arrival at Holland Hospital and Dr. William Weststrate, medical examiner, ruled death due to a coronary. Earlier authorities had unsuccessfully attempted artificial respiration.

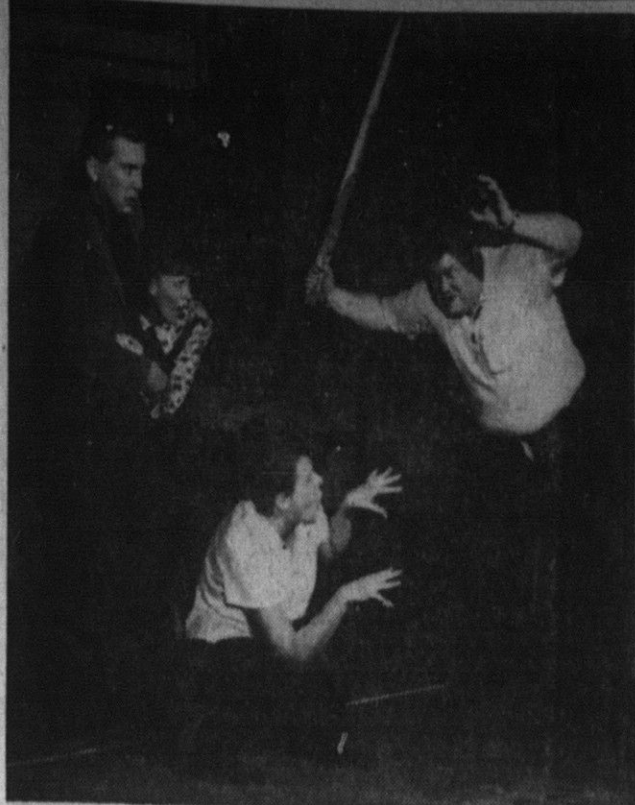

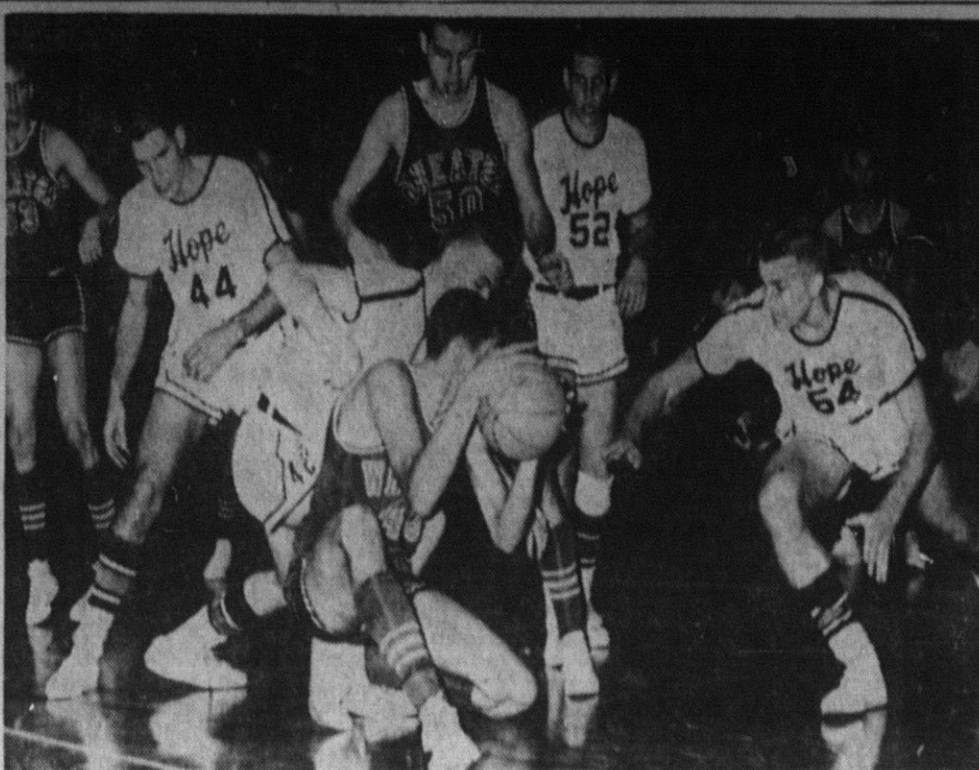

Lesson

FOR SUNDAY DEC. 15 ... 07
Entrusted with the Gospel
Galatians 1:6-17

C.P. Dame

On the last three Sundays of
this year we will study three
passages from Paul's letter to
the Galatians. He wrote this let-
ter about the year 56 or 57 to
the Galatian churches which he
founded during his first mission-
ary journey at Pisidian Antioch,
Iconium, Lystra and Derbe.

Luther and the Reformers
prized this letter highly because
it taught the Reformation doc-
trine of justification by faith.
Our lesson teachers the truth
that there is but one gospel —
the good news of salvation
through faith in Christ.

I. There is but one gospel
and there is no other. The
church is always troubled by
false teachers.

Paul had preached the gospel
to the Galatians and they had
accepted it. However, false
teachers came to them and they
perverted the gospel and misled
some of Paul's converts. These
false teachers, Judaizers, said
that faith in Christ was not
enough — they also had to ob-
serve the Jewish ceremonial
rites.

Paul strongly denounced these
false teachers and boldly said
that the gospel which he
preached was the true gospel.

And what is the gospel? It
is the good news that Christ
died for our sins. It is sad but
true that not all churches
preach Paul's gospel and it is
doubly sad that some church
members do not seem to be
able or are unwilling to distin-
guish the false from the true
gospel.

Since there is but one gospel
every one ought to be sure to
accept this gospel regardless of
what men say.

II. Paul's gospel is not after
men — he got it by revelation.
All religions can be divided in
two classes. The one class is
composed of religions which
teach that salvation is won by
character and good works.
Christianity is in a class all by
itself for it teaches that man
is saved by grace through the
power of God. It is not after
man.

God called Paul to preach this
gospel. Once he had persecut-
ed the church but on the road
to Damascus God called him
and the persecutor became a
preacher.

There are Christians today
who can speak of a heart-and-
life-changing experience brought
about by the Lord.

III. Those who have the gospel
must share it.

After his conversion Paul re-
ceived the command to preach
the gospel to the Gentiles. He
did not confer "with flesh and
blood" with fallible men, nor
did he learn the gospel from
the leaders in Jerusalem but he
went to Arabia and there he
meditated and thought in
solitude. After spending some
time in Arabia Paul went to
Damascus again — not to Jeru-
salem — and preached in Da-
muscus where he had planned
to persecute Christians.

It took courage to go to Da-
muscus and preach there. Paul
had been entrusted with the
gospel by the Lord who changed
him, and by his life he showed
that he wanted to be true to
the trust.

All Christians are entrusted
with the gospel. We have a
great many opportunities to
share in the work of spreading
the good news. Let us make use
of them while we can. Our
world surely needs the gospel.

ZEELAND — Holland Chris-
tian's basketball squad breezed
to its third straight win of the
season here by taking an easy
77-41 decision from the Ze-
land Chix Tuesday night before
900 fans in the Zeeland gym.

Coach Art Tuls used his 14
player squad liberally through-
out the game with 12 of the per-
formers breaking into the scor-
ing column. After a close first
quarter the Maroons pulled
away steadily and turned the
game into a rout soon after the
second half started.

Christian had too much of
everything for the outmanned
Chix which featured a starting
lineup of four juniors and a
senior. Coach Paul Van Dort's
club couldn't compete with the
Maroons on the boards as the
Maroons paced by its front
line pulled down 54 rebounds in
the contest. For the third
straight game, Christian shot

Snowstorm Policies Under Study

Snowstorm policies, truancy and subjects relating to finances occupied the Board of Education at its regular monthly meeting for almost two hours Monday night in the library of the high school.

Supt. Walter W. Scott explained the current snow policy of holding classes if at all possible with teachers expected to be present and students likewise, with necessary consideration for slowdowns because of ice and snow. If school is not held, teachers are still expected to be present wherever possible. In the case of secondary schools, libraries would remain open and counselors available to those students who come to school. Last year's record snowfall of 137.5 inches had posed many difficult decisions that season.

Recognizing the necessity for updated policies to cover situations which might arise in outlying schools now in the city, the whole matter was referred to the personnel committee to report at the next meeting.

Because of changing social patterns which affect school attendance, President Harvey Buter said the need for a truant officer for Holland appears greater today than some years ago. Supt. Scott said work along this line was being done by school principals, visiting teachers and sometimes other teachers, but he felt a person in authority outside the school administration would be a better answer, someone to sign complaints about parents who do not exercise responsibilities in seeing that their children are attending school. Such an officer could serve all school systems in the city and could follow cases to the court level, if necessary.

This subject was referred to the schools committee to work with the superintendent, consult other schools and report back to the board. The law provides for truant officers on the county level, and for cities, and it was felt Holland is of sufficient size that a part-time officer could operate exclusively in the city.

A suggestion from Mrs. Edward Hindert, 135 West 19th St., to name the student aid fund after the late Hannah A. Parkyn, retired high school mathematics teacher who died last Friday, was referred to the schools committee for study and report. President Buter said he had received a similar suggestion for some recognition of Miss Parkyn's 39 years of teaching service to the school.

Buter said economics in the custodial department had amounted to \$1,635.11 in the budgeted program, and the board approved a motion to adjust custodial salaries to the amount of not more than \$2,000 for this year. School custodians had received no pay boosts in three years. The work on overall economic revisions will continue. Supt. Scott added much the same adjustments had been made in the clerical staffs.

Janitors had requested pay every two weeks instead of twice a month and a change in overtime pay which had been paid twice a year. The board decided to continue the regular pay on a twice-a-month basis since all other personnel are paid thus, but arranged a monthly pay period for overtime.

On beginning work on another millage election, Arthur Sedon said many persons have volunteered their services. He said among calls he received were some from persons living in Holland Heights and Maplewood areas who felt city residents were not fully aware of the two tax bills residents had received in a seven-month period, plus extra voted millage and transportation costs. Nevertheless, some volunteers pledged further efforts in working for the next election.

Buter added he also had received many calls and messages. Some of the latter, he said, were unsigned and critical in nature — something which fails to bother him except to make him work harder for his own convictions.

John Volkema, who some time ago had written a public opinion letter to the Sentinel quoting Admiral Hyman Rickover in criticisms of modern education, was present on invitation of Sedon who got in touch with Volkema after the letter appeared in the paper.

Volkema did not have Rickover's book, had clippings from some newspapers, criticizing excess extracurricular activity in schools, the revolt in taxes and the need for relief for those persons on fixed incomes. He then spoke for the Christian schools, civil rights, and brought up Barry Goldwater, citing the latter's beliefs that there should be no federal aid for schools.

Board members explained such extracurricular activities as cheer leaders and klompen dancing were not financed by the regular school budget. Sedon tried to get across that the school must operate according to state laws and while he had

a great deal of sympathy for those persons on fixed incomes facing higher tax bills, such persons should write their elected officials in Lansing. Sedon tried to explain Gov. Romney's consideration for such persons in his tax reform program.

While the 20-minute discussion failed to resolve any differences, the board made it clear to Volkema that it appreciated his interest and they as well as all other people are anxious to keep down costs, yet provide the best education possible for boys and girls of Holland.

Dr. Mathews Addresses Noon Optimists

At the luncheon meeting of the Holland Noon Optimists, on Monday at Cumerford's Restaurant, program chairman P. Ray Gemmen introduced Dr. E. P. Mathews of Mountaineer, N. Y. Dr. Mathews is presently doing field extension work with the University of Wisconsin in the realm of rehabilitation of narcotic addicts.

Mathews, a teacher of psychology, is currently making a study of the work of the Damascus Christian Church in the Bronx, New York. Overseers of this mission are the Rev. Francisco Rosado and his wife who began this particular ministry more than five years ago.

Mathews said that the Rosados see the problem of addiction as a spiritual problem and present Christ as the only solution. At present they maintain a rehabilitation center in Mountaineer, with 50 or more men undergoing treatment. He also said that the best of hospitals have not been able to record a cure for much more than a tragic five per cent. After treatment in Mountaineer more than 40 per cent are delivered from the drug habit.

An all-out effort is made to help the trainee by spiritual counseling, psychotherapy, education and vocational training, occupational and recreational therapy, with the aim of helping the individual become a self-supporting, self-respecting, and law-abiding citizen, able to take his place in society.

Accompanying Mr. Mathews were three men, former addicts for five to 14 years, who are now completely free from the habit.

New County Road System Outlined

GRAND HAVEN — A plan to extend the county trunkline road system into the incorporated cities and villages in Ottawa County was outlined before the Grand Haven City Council Monday night by H. E. Stafseth, engineer-manager of the Road Commission.

Stafseth said that the cities in Ottawa County contribute a substantial proportion to the county appropriations for county roads and that the road Commission has made a study of the proposal along with city officials and the Good Roads Committee of the Board of Supervisors.

The county recently completed improvements and widening on a major county road near Grand Haven on Mercury Dr. The portion of Mercury Dr. inside the city of Grand Haven and a bridge over Gidley Bayou were not improved and this portion is a traffic hazard at the present time.

"This improvement on Mercury Dr.," Stafseth said, "is a good example and helped to convince the committee that this new approach to the problem would be to the best interest of the community."

To complete the Mercury Dr. improvement in Grand Haven city, Stafseth said, the job would have to be extended only 1.27 miles west on Waverly Ave. an extension of Mercury Dr. connecting with Beacon Blvd. which is US-31.

A finance review presented by the engineer and City Manager R. V. Terrill Monday night showed that Grand Haven received \$64,000 in 1961 from state motor vehicle refunds. In that year the city certified 19.75 miles of major streets which would amount to \$3,220 for each mile of major streets.

"If the city," Stafseth said, "would adjust its street system and reduce it by 1.27 miles as proposed under the plan on Mercury Dr., this would have cut the city revenue in 1961 for major streets to \$62,000 or this would allow \$3,360 a mile to be used on each of its major streets."

Under the proposed plan, he said, it can be seen that actually there would be a reduction in funds to the city from the state, but there would be more money available for the balance of the major street system on a per mile basis. The roads committee of the county board favored the plan and may bring it before the county board in January.

Stafseth's office has been asked to make a study of the roads within the municipalities in Ottawa which would meet certain standards as to the needs of the total community.

Fatality Count Rises to 32

GRAND HAVEN — The list of traffic fatalities in Ottawa County for 1963 stood at 32 today, following information that a Grand Rapids man had died several weeks ago of injuries received in a two-car crash near Nunica in Ottawa county.

Sheriff's officers said Harry Timmerman, 70, Grand Rapids, died Oct. 24 in Sunshine Hospital in Grand Rapids of injuries received in a crash Sept. 1 on 96th Ave. and State Rd. near Nunica.

Timmerman was a passenger in a car driven by Pearl Land, 47, Grand Rapids, which collided with one driven by Terry Pesch, 48, Muskegon.

A year ago today, the county traffic fatalities stood at 20 which was the total for the year.

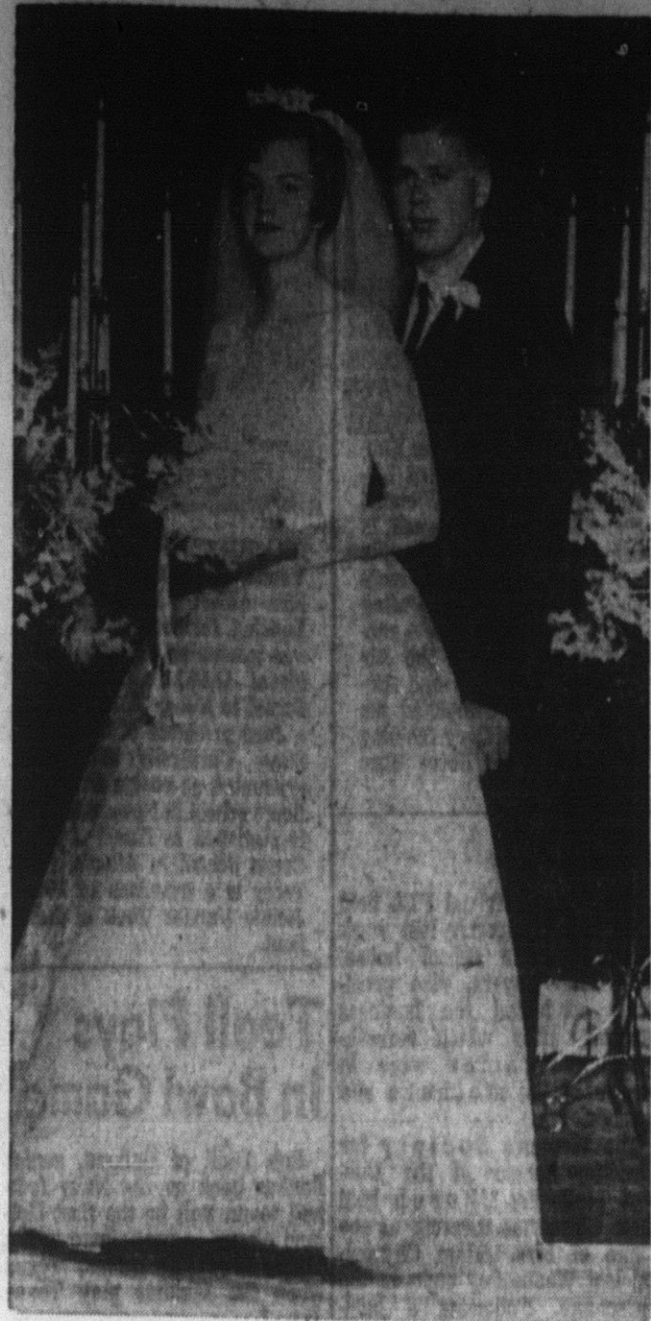

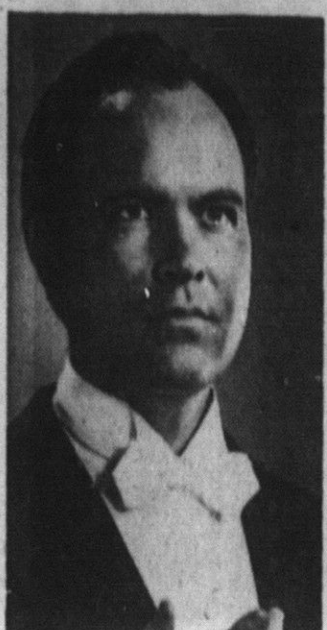

EAST GRAND RAPIDS — Holland Christian's basketball squad posted its second straight win of the season here Friday night by stopping the East

Pioneers, 68-60 before 1,700 fans on the new East Court.

Coach Art Tuls' club was in command of the score all of the way after trailing 2-0 at the outset. The Maroons upped their margin to as much as 18 markers going into the final period. After the opening period, the host club never got any closer than the final eight points.

Christian took its win in workmanlike fashion by shattering two different defenses thrown up by Coach Frank Kuta of the Pioneers. The losers played a tight zone defense during the first half and then switched to a man to man in the second two periods.

Holland didn't have much difficulty with either one as they continued to shoot well from outcourt similar to their fine display against Hudsonville Unity Christian a week ago. For the entire game, the locals hit on 30 out of 75 attempts for a good 40 per cent mark.

The Maroons got great shooting from Forward Don Kronemeyer, Jack Langeland and guards Tom Dykema and Tom Deur. Deur came off the bench in the second quarter to spark the Maroons with eight points in the stanza and nine more in the third period.

Center Jim Otte and Langeland along with Dykema did fine work on the boards as did big Chuck Abbott and Tom Blackburn of the Pioneers. Kuta has moulded a rugged East club complete with speed and a slick passing, smooth operating, set offense. The offense is paced by big Abbott and sharpshooting Forward Greg Hoefler. East is now 0-2.

Although the game was not as close as the final score would indicate Christian contributed to the East cause in the last period by repeated fouling, many of them occurring in the Maroon offensive zone. East collected 16 points from the charity stripe in the last period compared to just three baskets.

After the Pioneers opened the game on a layup to take a 2-0 bulge, the locals made their move as they repeatedly shot over the zone of the losers to take a 10-4 lead with 3:25 remaining in the period. out of reach. Finally with a little over a minute remaining and the Maroons leading 68-57, Tuls inserted a new team to finish the game.

Academic Work Cited For Board

Several examples of academic achievement among graduates and students of Holland High School were cited at the monthly meeting of the Board of Education Monday night.

Holland ranks 19th among the high schools in Michigan in the number of doctor's degrees issued during the years of 1957 to 1962. Eighteen persons who received Ph. D. degrees during this period listed Holland High as the school from which they were graduated. In size, Holland ranks 140th in a list of 767 high schools in Michigan. Holland is one of the smallest high schools in class A.

Seven Holland high seniors have been selected as mathematics finalists in state-wide examinations. Screenings to date place the seven seniors among the top 4 per cent of mathematics students in the state. Fred Bertsch of the school faculty has been conducting the examinations locally. Board President Harvey Buter said the number of finalists is a significant increase for the local system.

"Many fine things that happen in Holland are taken for granted, and this example on the mathematics level is the culmination of dedicated work by teachers on all levels, but usually are recognized only when our students are about to leave the system," Buter said. He pointed to other fine work done on school papers on both junior high and high school levels, the art show, the fine work of athletic organizations, and others.

Supt. Walter W. Scott said he and 11 teachers had attended a mathematics seminar in Muskegon last Saturday aimed at new methods of teaching mathematics in a changing world. School representatives were to study electronics courses at the Technical Institute at Benton Harbor high school today.

"Over half of the new jobs developed in the last 50 years came into being in the last seven years, and educators expect this rate of change will be increased. To meet the needs of a new age, we must prepare our students today, and the best way is to start on the primary level, and work up through the upper grades, not only in mathematics but in all subjects," he said.

Another example of academic achievement cited was the fact that seven seniors have qualified as semi-finalists in National Merit examinations. With one exception, Holland had the highest number of any high school in Western Michigan.

Following a successful series of family recreation and educational programs for eight successive Thursdays in Holland High School, the YMCA is planning another series starting Thursday, Jan. 16. Rental of \$400 will be forthcoming Dec. 15. Meanwhile, costs will be studied by the schools committee towards any adjustment of this figure for the second series.

Supt. Scott reported having received a letter from the athletic director of the Naval Academy at Annapolis, Md., congratulating the system on turning out young people like Bob Teall, a Holland youth who is on the varsity of both football and tennis at Annapolis, and stating the academy would be happy to welcome any others like him.

The finance committee in compliance with a resolution Nov. 27 has set up a system whereby purchases for secondary school athletic supplies and equipment henceforth will be requisitioned by coaches and forwarded to their principals. Purchase will be contingent upon need, funds available, and only through sealed bids. No purchases will be made except on recommendation of the principals.

All board members were present at the two-hour meeting. James Lamb gave the invocation.
