## Safe Jobs Solved By City Police

Four Thanksgiving Day Break-ins in Holland, including two safe jobs, were cleared up with the arrest of 22-year-old Jack Cooper Moss of Fennville Saturday.

Holland detectives Gil Tors and Dennis Ende along with detective Charles Long of the South Haven State Police post picked up Moss at work Saturday afternoon in Fennville. They were assisted by Fennville Chief of Police Clayton St. John.

Jack Cooper Moss, 22, of Fennville, waived examination at his arraignment in Municipal Court Monday on three charges of breaking and entering in the night time. He was bound over to Circuit Court to appear Jan. 9. Bond was set at \$3,000 and was not furnished.

Moss was charged with breaking into the Hertel Insurance Agency on Nov. 22 and with breakings at the De Nooyer used car lot office and the Ter Haar-Venhuizen used car lot office early Thanksgiving Day.

According to Holland detectives, Moss also admitted breaking into Vandenberg Motors where he allegedly chiseled open a safe. He was not charged with the break-in in Municipal Court since the offense occurred in Allegan County.

A John Doe warrant for an accomplice in the Hertel break-in was issued out of Municipal Court. Holland detectives conferred with FBI agents concerning the alleged accomplice who was believed to have fled to Alabama.

Detectives took a written statement from Moss Saturday night.

## Blind Persons Entertained By Lions Club

Members of the Holland Lions Club entertained blind persons from the Holland area and their escorts at a Christmas dinner Tuesday evening in Hope Church. Wives of Lions Club members also were guests.

William Countryman who has been blind since 1956 and who has spent many years in the business world, presented an interesting talk about the Leader Dog Foundation and told of training leader dogs.

Mr. Countryman, who has spoken in 33 states in the interest of Leader dogs, said that dogs are furnished free to the blind people. He told humorous incidents concerning the blind and their dogs and also many incidents in which the dogs kept their masters from being injured.

Richard Nykamp, member of the blind committee, introduced the guests and their escorts and special music was provided by the Holland Windmill Chorus and the Chord Counts. Miss Lois De Jonge played organ numbers during the dinner hour. Don Thomas was chairman of the program committee. Christmas gifts were presented to the blind from the Lions Club.

## Strike Trials Set Jan. 31

Municipal Court has scheduled Jan. 31 as date for trials for two men charged in connection with violence during the General Electric plant strike here Oct. 10.

Fred Sherell and Delone Fugleth of Holland will appear on charges of interfering with entrance to a place of employment. Trials are scheduled for 1:30 p.m. The hearings had been postponed several times.

Billy Gean Lacy, 18, of 231 West Ninth St., was found guilty of reckless driving at a non-jury trial in Municipal Court Monday afternoon and Judge Cornelius vander Meulen sentenced him to 30 days.

Glen Henry Siver, 45, of 75 East Ninth St., paid fine and costs of \$106.20 on a drunk driving charge.

Ralph Dean Lasswell, 21, of 417 Howard Ave., who pleaded guilty Nov. 21 to a disorderly drunk charge, was placed on probation for six months. He must pay \$9.70 costs and a monthly supervision fee of \$5. There may be no drinking or frequenting places where served and he must make every effort to find employment.

## Zeeland Buys Site for New Christian High

ZEELAND — Zeeland Christian School officials have purchased a 15-acre site on North State St. for a new senior high school slated for construction in 1964. The property, owned by John Bouma, is just within city limits.

The board also is taking an option on an 11-acre parcel directly north of the 15-acre site, known as the Koning property. A finance committee headed by C. Karsten is planning two campaigns, one in 1961 and another in 1962, each with a goal of \$80,000.

The society presently operates a nine-grade school. Plans call for adding another grade beginning in 1964 and adding another grade for the next two succeeding years. The new school eventually will serve Christian school students from Zeeland, Bodeculo, Drenthe, Overisel, Oakland and possibly Beaverdam.

## Shotgun Blast Hits Youth, 17

GRAND HAVEN — Jack Roossien, 17, of 1717 Pennoyer Ave., was in good condition today in Municipal Hospital following a shooting accident at 5 p.m. Saturday in which a blast from a double barreled 12-gauge shotgun hit his right wrist and right thigh from a distance of about 15 feet.

The weapon was held by a companion, 15-year-old William Poe, who told state police he swung around when he heard a noise and evidently squeezed the trigger at the same time.

The shooting occurred in a wooded pine tree area at the rear of the Frank Kiles residence east of Beech Tree St. Kiles said he heard a call for help and found Roossien lying on the ground.

Roossien had gone hunting rabbits with his brother, Robert, 19, and 15-year-old Poe.

## Car, Garage Are Damaged by Fire

Fire Tuesday night destroyed an automobile and caused extensive damage to a garage at the home of Mrs. Jennie Thompson at 28 1/2 West 21st St.

Holland Fire Chief Dick Brandt estimated total damage at \$1,500. Brandt said the fire started about 8 p.m. when a trash fire behind the garage spread to the building.

According to Brandt, the rear of the garage suffered considerable damage. The 1954 model car in the garage was declared a total loss.

Two pumps and ladder truck along with a full complement of men from both downtown fire stations answered the alarm. Firemen were at the scene for about 40 minutes.

Scripsma urged all senders to use first class mail and to include a return address so improperly addressed mail can be returned.

## Holiday Mail Load at Peak

The Christmas mail load is reaching its peak this week, according to Acting Postmaster Kenneth E. Scripsma.

Scripsma said it was too late now to urge early mailing of Christmas cards and packages, but he said it is still possible to avoid disappointing friends by mailing items properly.

Using air mail for out of town pieces of mail will enable friends to receive their cards before Christmas. There is still time for local delivery Scripsma said, but he urged using first class delivery and stressed the importance of addressing items properly.

Several hundred pieces of mail each day wind up in the hands of the "nixie clerk" whose job it is to review insufficiently addressed first class mail with the objective being to effect delivery. If the mail does finally reach its destination, it will be delayed by a day or two at best, Scripsma said.

Most common errors in addressing items are failure to use a street address, using a number which does not exist and using no return address on first class mail. Third class mail cannot be returned, Scripsma said.

The postmaster urged all patrons to use first class delivery. He cited the importance of using proper address and including a return address on all cards and package labels.

Post office employees are striving to have all Christmas mail delivered by Christmas Eve. The post office will remain open from 8:30 a.m. to 5:30 p.m. each day, including Saturday.

## Hope Listed In Esso Grants

Hope College is among the 494 Colleges and universities receiving grants from the Esso Education Foundation since its establishment in 1953.

During the five-year period, nearly \$9 1/2 million was distributed to educational institutions including \$1,609,695 during the academic year 1960-61. Esso Education Foundation funds have gone directly to universities, technical schools and colleges of many sizes.

Other Michigan colleges receiving unrestricted grants are Adrian College, Alma College, Calvin College and Marygrove College. Central College at Pella, Ia., also is listed.

Among colleges and universities receiving capital grants is Kalamazoo College.

M. J. Rathbone, foundation chairman, said broad coverage is possible through the foundation's policy of not supporting all of the same institutions each year. The resulting flexibility has the effect of permitting provision for some projects of a pioneering nature that might not fit into a more rigid program.

## Trio Had Passed Out At Drive-in

### Garbled Phone Call To Police From Ray's Drive-in Saved Group

GRAND HAVEN—Tragedy was averted early Wednesday when city policemen rushed three persons to Municipal Hospital after the trio had nearly suffocated in a small drive-in restaurant on Beacon Blvd.

Ray Harz, 45, owner of Ray's Drive-in at 20 Beacon Blvd., and two waitresses, Charlene Porter, 20, and Karen Groeneveld, 19, were recovering at home Wednesday after treatment at Municipal Hospital.

Cause of the near tragedy was insufficient oxygen in a small building which had no customers between midnight and 1 a.m. Wednesday, doors remained shut and the restaurant equipment including a deep fat fryer and a gas heater consumed oxygen in the air.

Miss Porter was able to dial 'O' for operator who transferred the call to police headquarters. Because of the incoherent words and groaning, Sgt. Charles Rumsey first thought there was a drunk on the other end of the line, but he finally made out the word "Ray's" and knowing there was only one Ray's place in Grand Haven dispatched a cruiser there.

Police found Miss Porter lying in the rear south doorway and Miss Groeneveld lying just outside the door. Harz was lying under the counter. An ambulance took Harz, who appeared to be near death, to the hospital. A police cruiser took the two waitresses to the hospital. All three were soon released. Harz and Miss Porter were given oxygen.

Harz told officers he had gone to work at 5 p.m.

The drive-in, a new establishment, has been in operation since summer. Gas company men examined the place and felt that the deep fat fryer was responsible for using up most of the oxygen. The building had a well designed circulation system but because of the 20-degree temperature outside, fans apparently had not been turned on.

## New Dart Gun Makes Capture Of Animals Easier, Safer

The City Sanitarian's work is often complicated by orders to capture vicious or evasive animals. But with the acquisition of a new dart gun, Sanitarian Sam Stephenson's problems are greatly reduced, and there is no need to destroy animals which may elude capture for long periods.

This new "Cap-Chur" gun went on the market last year, and since then some 2,000 have been bought. One of these guns recently became available in Holland to aid the sanitarian's office in capturing animals.

The gun is based on the Crossman pellet gun which uses carbon dioxide gas as a propellant. It is a .30 caliber gun, and instead of shooting pellets it shoots a small hollow dart filled with a tranquilizing drug.

The dart-like projectile is actually an automatic syringe. The body of the syringe is made of a light metallic alloy. The syringe has screw caps at each end. The forward cap holds a hollow needle like one used in a hypodermic syringe. The rear cap is fitted with a tuft of rayon to act as a sort of stabilizer.

Inside the barrel of the syringe is a rubber plunger, open at the rear end. A small pill is placed in the hollow end of the plunger, and the plunger is closed with a brass plug. When the dart strikes the animal, the pill releases carbon dioxide gas which forces the plunger forward, driving the drug charge into the muscular tissue of the animal which is hit.

The drug used is a nicotine alkaloid. Animals injected with the drug become immobilized within minutes and remain in a tranquilized state for periods of one to several hours with no ill effects. Stephenson said the new gun will be especially helpful in capturing animals suspected of being rabid. Rabid animals are often killed and sent to laboratories in Lansing for analysis, Stephenson said, but these tests often fail to show the necessary results. Taking possibly rabid animals alive is one method of positive detection of rabies.

Stephenson said the animals shot with the dart from the "Cap-Chur" gun experience no pain. The hypodermic needle enters the animals' hide with such velocity that pain is not felt.

The use of the "Cap-Chur" gun has been endorsed by humane associations and conservationists.

Presentation of a \$500 check for the School Scholarship Fund from proceeds of the High School Musical "The King and I" highlighted a regular meeting of the Board of Education Monday night in E. E. Fell Junior High School.

The presentation was made by Larrie Clark of the music faculty who also submitted a financial statement listing total receipts of \$4,023. Expenses listed royalties and rentals of musical scores, \$1,098; rentals including Civic Center, costumes from Tracy Music Co. in Boston, and service equipment, \$1,002.85; express charges, \$48.85; materials, \$297.51; makeup supplies, \$196.78; advertising, \$842.96; total disbursements, \$3,486.95; net profit, \$536.05. The remaining \$36.05 is held for outstanding bills and auditing expense.

Supt. Walter W. Scott commented that the purpose of such a production is to provide an activity for the total music department as well as an all-school project after the football season. He said the musical was excellently received and proved to be a real credit to the music department and to the school.

Clark said the department looks forward to presenting such productions every two years and that it certainly will be using the facilities of the new 700-seat auditorium in the new high school in the future.

Several reports on progress on the new high school were presented by the buildings and grounds committee. ## Sunday School Lesson

The Compassion of Christ  
Isaiah 61:1-3; 61:10-11;  
Matthew 11:27-30  
By C. P. Dame

Our lesson text is composed of several verses from Isaiah 61, in the Old Testament, and of four verses from Matthew 11, of the New Testament. Both passages reveal the compassion of Christ.

I. Jesus knew what His mission was. The Lord had been preaching in Galilee for some time. He returned to Nazareth, His home town. On the sabbath day He followed His usual custom and went to the synagogue (Luke 4:16-20). Jesus was asked to preach and He read from Isaiah 61 and then gave the book to the attendant and sat down.

The eyes of all the worshippers were fixed upon him. He said, "Today this scripture has been fulfilled in your hearing." They did not realize this fact. And then Jesus preached a sermon which His hearers did not like, it got them so angry that they pushed Him out of the synagogue and even out of the city and led Him to the brow of a hill in order to throw Him down headlong, but He escaped.

In His sermon Jesus applied the words of Isaiah 61 to Himself. What Isaiah had foretold was fulfilled in Jesus.

Jesus said that the Spirit of the Lord was upon Him. At His baptism Jesus was anointed by the Holy Spirit to heal and to preach. Observe how the words of the prophet were realized in Jesus. One of the main tasks of Jesus was preaching—he was anointed to preach good tidings to the afflicted.

Jesus ministered in a special way to the forgotten people of His day. He fulfilled the words of the prophet—"He has sent Me to bind up the broken-hearted, to proclaim liberty to the captives, and the opening of the prison to those who are bound." Jesus was always ministering to the people whose needs were the greatest.

Today Jesus is still setting free prisoners of sin—freeing the sensual, the alcoholic, the "needy," the mad, and the slaves of pleasure. That our Lord has brought much comfort to people in their sorrows is well known.

This ministry of giving comfort goes on day by day. The gospel we preach gives the best in place of the inferior—it gives "beauty for ashes" and "the oil of gladness instead of mourning, the mantle of praise instead of a faint spirit." The Christian has every reason to be joyful inasmuch as he has received salvation. Seeing that he has received this gift he should reveal it in living a radiant Christian life.

II. Jesus offers to the weary and heavily laden rest. We all receive invitations occasionally. The value of an invitation depends upon the person who gives it. Jesus who said, "All things are delivered unto Me of My Father" extends the invitation. The Lord uses the word "Come." It is a winsome word.

Who are asked to come? Note the words—"all ye that labor and are heavily laden." The word "all" includes every one.

In the days of Jesus some people were burdened with rules, regulations and ceremonies and they were trying, by keeping them, to earn their salvation, and others were troubled by sins.

Jesus told all to come to Him, to take His yoke and to learn of Him. Jesus promises rest and yet tells them to take His yoke. We know that bearing a yoke involves work and self-denial too. We can loaf our way to hell but not to heaven. Remember that a yoke is meant for two. Jesus tells us to take His yoke, to carry a yoke with Him, which means to be yoked to Him. And Jesus describes Himself as "meek and lowly of heart." No wonder Jesus says that His yoke is easy. Any one with such a disposition could only offer a yoke that is easy.

The person who is yoked to Jesus will learn of Him and he will find rest for his soul. Are you yoked to Jesus Christ?



# Holland Notches 3rd Cage Victory

## Dutch Stop Traverse City In LMAC Play

Holland High's basketball team opened Lake Michigan Athletic Conference basketball action Saturday night with a 63-54 victory over Traverse City before 1,200 fans in the Civic Center for its third straight win.

The Dutch won't play another LMAC team until Jan. 27 when the Dutch entertain Muskegon Heights but since Holland plays Traverse City only one game this season, the Saturday encounter served as the league tilt.

After a slow first half, Holland picked up the play in the second half and had a third period of 22 points and a fourth quarter of 20 points. Traverse also had a better scoring output with periods of 18 and 19 points in the second half.

Neither team could get into the swing of things in the first quarter and the Trojans held the lead most of the period before Holland jumped one-point ahead, 13-12, on Jim De Vries' layup but Jim Anderson's free shot tied the score at the quarter, 13-13.

The second period was the lowest scoring seen in Holland in a long time. It took the teams four minutes and 41 seconds to make a basket. De Vries hit a layup with 5:19 left.

Holland scored only eight points in the second quarter and the Trojans made only two baskets, both in the last two minutes, and Holland led 21-17 at halftime.

The Dutch did get their fast break moving somewhat in the third period, including the first basket made by Gary Alderink off the center tip with the quarter eight seconds old. Center Ben Farabee added another layup on a break and Holland kept four points in front.

Keeping six and eight points ahead the rest of the period, Holland did enjoy 10-point margins twice in the final two minutes of the third quarter. The canto ended with the Dutch in front, 43-33.

Traverse City, paced by 5'10" Dennis Antz in the fourth period, narrowed the count to four points with 5:57 left, 47-43 and 49-45 with 4:26. One final spurt of six straight points put the Trojans within five points, 57-52 with 1:53 left and 59-54 with 1:17 remaining.

Holland played a zone throughout and forced the Trojans to shoot from the corners and out-court. But Traverse seemed to be content to shoot from out and didn't try to drive through the Dutch zone.

A few times in the second half, Traverse worked in for shots. The Trojans looked their best on the boards this season according to Coach Irv Menzel, and Traverse did recover many of the rebounds. Traverse has now dropped four straight. Two of the setbacks have been by 21 points and one by 19 points.

Holland got its share of the rebounds with De Vries working well under the offensive boards but the Dutch had trouble moving the ball.

Only a few times did Holland seem at full speed on an attempt for a fast break. Frequently, Traverse intercepted Holland passes because the Dutch didn't move the ball.

But Holland's reactions were quick enough back on defense to keep the Trojans outside. Coach Bill Noyd hopes to speed up the Dutch ballhandling, fast break and reaction time this week before Holland plays at Muskegon Heights Friday night.

The Dutch hit 23 of 67 for 34 per cent on halves of eight for 33 and 15 of 34. Traverse had 18 of 71 for 25 per cent with halves of six for 21 and 12 of 40. Holland made 17 of 26 free shots and the Trojans hit 19 of 25.

Gary Alderink led Holland with 15 points, including six in the last quarter, while three others hit in double figures. Rog Buurma, who made seven baskets near the key, and De Vries each had 14 while Farabee, who fouled out with 4:47 left, had 12.





## Concerned Over Number Of Violations Of Law

Complaints about motorists failing to stop for school buses taking on and discharging their youthful passengers are coming in with increasing frequency, particularly from the Holland area, County Safety Director Avery D. Baker said today.

Baker said the chief violation seems to be that of failing to stop when meeting a stopped bus in the process of loading or unloading children. He reminded area motorists that the stop rule for motorists approaching stopped school buses from either direction has been made a part of city ordinances, and is enforced inside the city as well as out.

The only time this rule is not applicable is in the case of divided highways, Baker said. He said bus routes are being observed and motorists seen violating the laws, and positively identified, are being cited to court.
