## Porretta Resigns As Dutch Mentor

### Board Has Visit From Ex-Member

Former School Board member John Keuning paid a visit to the monthly meeting of the Board of Education Monday night and told his former co-workers he was impressed with what he witnessed.

He said the board seems to have increased its efficiency, and that its adoption of an evaluation program and its affirmative action program on commitments on equal opportunity and nondiscrimination in employment were only in the discussion stage when he was a member some years ago.

Keuning voiced his interest in the forthcoming special election for two new junior high schools Dec. 17. He said no local citizen could deny the need for improved facilities, and he pointed to the need of proper planning for the future.

Holland is proud of its commercial and industrial development, and even though there may be a slight decrease in census figures at the moment, the State Highway Department, Consumers Power and many agencies concerned with community welfare point to substantial growth in this area.

He said Holland is justifiably proud of its Christian school system and he said it was the combined efforts of many groups that liquidated the system's debt earlier this year.

"We must plan 40 to 50 years into the future," he said. "Can we afford not to build these schools?"

Keuning made his remarks at the close of the meeting.

Member Charles Bradford said the building program had offered many alternatives and it was hard to have unanimous agreement for a single plan, but the board adopted a program which it felt was the best answer to the needs, and the plan it felt would be most agreeable to the people.

"Remember," he said, "a 'no' vote is not a vote for another solution. It would be a vote for no solution."

Board President James O. Lamb spoke of the years of planning of curriculum and plans for junior high needs and he expressed appreciation to the citizen groups in planning the schools and in promoting the election.

Lamb said efforts had been made to answer all questions, but if any voters would like more information, they may call the school administration or himself (at home or office, anytime) and every effort would be made to provide the answers.

The discussion on the election followed some routine resolutions the board passed on election boards and an absent voter counting board. Absentee ballots are available at the city clerk's office up to 2 p.m. Saturday, Dec. 15.

### Armed Man Robs Patrons in Bar

SOUTH HAVEN — State Police Wednesday sought a male subject in connection with an armed robbery at 2:15 a.m. today at the Willow Side Bar along Blue Star Highway six miles north of here and fled with an estimated \$400 from the bar owner and patrons.

Troopers said the lone subject carrying a sawed-off weapon entered the bar shortly before closing time and ordered patrons to the floor as he removed their wallets.

Troopers said no one was injured but patrons reported hearing what sounded like gun "shots" after the bandit left the bar.

The subject sought was described as a male about 20 or 25, 5 feet 8 to 5 feet 11 and weighing about 160 to 170 pounds. He was wearing a nylon stocking over his head during the robbery.

### Youth Charged in Alleged Break-In at Residence

Nicholas Rodriguez, 17, of 46 East 16th St., demanded examination in Holland District Court Wednesday to breaking and entering in connection with an alleged entry Tuesday at the residence of Michael J. Zarzecki, 95 East 17th St. Bond was set at \$2,000 and Rodriguez demanded a public defender.

Police said a neighbor reported seeing a subject try a rear door at the Zarzecki residence and police were notified at 2:30 p.m. Moments later Rodriguez was taken into custody outside the home. Nothing was reported missing from the house.

In a surprise announcement, Wednesday Dan Porretta, head football mentor at Holland for the past two years, has resigned immediately from that position.

Porretta, who won one game in nine tries in his first year as head coach in 1972, had a 3-6 mark this past fall. His two-year record is 4-14 but could have been much better, as the Dutch lost some games that could have gone either way.

"I don't care to make a comment on the reasons that I'm

resigning," said Porretta in a press conference this morning from the office of Gardner Wieringa, assistant superintendent of personnel.

"I wish to thank all my assistant coaches for their help and I hope if things work out with the new coach that they will stay on as assistants," added Porretta.

"We had a fine bunch of kids and I feel that whomever inherits the team next fall, will be getting a good group to work with."

"I also would like to thank the Parent's Club and especially Gene Emerson, Chuck Armstrong, Don Schutt and Fred Geary, as well as all the fine coverage we received from the media," Porretta stated.

Porretta will continue in the Holland school system at this time as physical education instructor at E. E. Fell but his future plans are up in the air.

"I really don't have any definite plans at this time but my possible plans would be to find a new coaching job elsewhere, go back to college to work on my master's or stay in my present position at Fell as an instructor."

Porretta is a graduate of Ohio State University where he was a football standout under Coach Woody Hayes.

Before accepting the head coaching position in 1972, Porretta was assistant reserve coach at Holland for four years.

### Red Ball Stickers Still Available

More than 7,000 Red Ball stickers have been distributed in the Holland area by the Holland Jaycees as part of their program to identify bedrooms of children and invalids in case of fire.

The stickers were made available through elementary and nursery schools and fire stations in Holland as well as in Holland and Park townships in conjunction with Fire Prevention Week.

The stickers were designed for placement in windows of the bedrooms to alert firemen in the event of a fire. The stickers are still available at the fire stations.

Project co-chairmen for the Jaycees were Bob Hunt and Art Simmons.

## Water Proposal Muddies

The bouncing ball that has characterized negotiations for Holland water service in certain areas of Holland, Park and Zeeland townships landed in muddy water today after Ottawa County Commissioners hoped they had cleared the issue Monday.

A compromise proposal hammered out during a commission meeting in Grand Haven Monday by Holland City Manager William L. Bopf, superintendent of the Holland Board of Public Works Ronald L. Rains and representatives of the county Road Commission and the townships was submitted to the Holland BPW at its meeting later Monday.

The BPW decided to have Rains evaluate the proposal and report back at a special meeting Dec. 17.

"In general the proposal did not seem very well defined," Rains said today.

"It is going to require some evaluation by the board, particularly since the board had considered its last proposal its final offer," he added.

## Eight Inches of Wet Snow Blankets Holland Area

An unusually mild fall and December came to an abrupt end today as a mixture of rain and snow plastered Holland area and a good share of Michigan.

The rain-snow combination fell around 6 a.m., providing a soggy, sticky, icy base trapping cars at curbs and impeding traffic generally. Continuing snow remained wet and heavy, clinging tenaciously to all surfaces.

Weather Observer Glenn Timmer said five inches of new

snow fell up to 11 a.m., leaving a total of eight inches on the ground.

The heavy snow was extremely difficult to move, and city plows were further hampered because of timing. Street Supervisor Henry Terpstra said further attempts to clear main streets would be made this afternoon, but this is always difficult because of traffic.

Schools closed because of the

snowfall were Saugatuck, Hamilton, Fennville, Hudsonville public and Christian, Spring Lake and St. Mary's, and Ottawa Area Center. The South Side Christian afternoon kindergarten was cancelled. Certain school bus routes also were cancelled.

Several social events in the community also were cancelled for tonight.

### Center Plans Holiday Program

All 142 students at the Ottawa Area Center will participate in a Christmas program for their parents and friends, Tuesday, Dec. 18 at 7:30 p.m. at the Robinson Public School, on 120th Ave., just north of M-45.

The center provides training for trainable mentally retarded students from the Ottawa Area Intermediate School District, and operates at full capacity this year with 13 teachers and 17 aides, plus several part time professional specialists including a speech correctionist, physical therapist, school nurse, school psychologist and social worker.

### Local Firm Fined in Gas Pipe Case

WASHINGTON — The Hart & Cooley Manufacturing Co. of Holland, Mich., one of five manufacturers of gas vent pipe charged with conspiring to fix prices, has been fined \$15,000.

The five companies were indicted Oct. 4 by a federal grand jury in Washington by Assistant Attorney General Thomas E. Kauper, head of the anti-trust division. It was alleged the companies were in violation of the Sherman Anti-Trust Act. Gas vent pipe is a double-walled aluminum pipe used to vent gas appliances in residential, commercial and industrial dwellings.

Hart & Cooley President George Heeringa said a plea of nolo contendere was entered on advice of counsel as a means of stopping further litigation which could have resulted in expenditure of many thousands of additional dollars by taxpayers and defendants.

He said when suit was initiated three years ago in Federal Court in Los Angeles it involved seven companies, and he said it was difficult to understand why the leader in the industry, the William-Wallace Co., which serves nearly half of the total market, was not named in the indictment even though this company was involved in the original investigation.

Heeringa stated that neither he nor any other member of the firm has ever attempted to control industry prices and concluded that the company has been forced, from an economic standpoint, to accept the decision of the court even though the Holland firm has never been involved in any form of collusion in an attempt to control prices.

## Woman Killed In Car-Truck Crash

Arlene Joyce Zoet, 36, of 4966 Russcher Rd., route 3, Holland, was killed Monday at 11:32 a.m. in a head-on collision of her car and a semi-trailer truck along M-40 north of 138th Ave. in Allegan county's Fillmore township south of Holland.

Allegan County deputies said Mrs. Zoet was pronounced dead at the scene by Dr. K. L. Miller of Hamilton.

Deputies said her car was northbound on M-40 and apparently went out of control on an icy patch of pavement, slid on the highway and crossed the center-line into the path of the on-coming truck. She was pinned in the wreckage of her car.

The truck was driven by David N. McClure, 32, of New Albany, Miss. He was not reported injured. A passenger in the truck sleeping in the sleeper unit, Alan Goudy, 25, also of New Albany, Miss., suffered minor injuries in the crash.

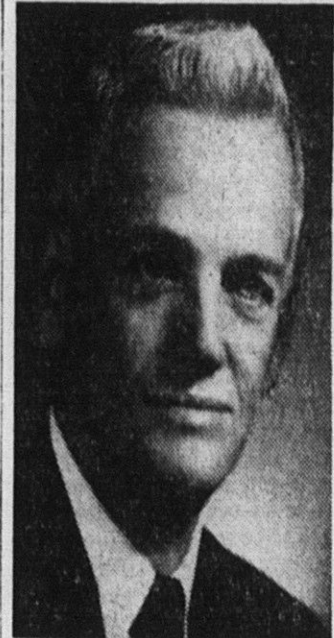

Miles, 57, was picked from a field of 15 judges and attorneys from western Michigan. The recommendation by Sen. Griffin makes the appointment almost a certainty.

### County To Study Hikes In Salaries

GRAND HAVEN — An estimated treasury surplus of \$382,348 at the end of the fiscal year December 31 prompted some Ottawa County commissioners Monday to favor re-opening the 1974 budget and distribute the surplus where cuts were made, possibly in higher salaries.

County finance committee chairman J. Nyhof Poel recommended \$150,000 of the projected surplus be earmarked for the county improvement fund and \$50,000 be used to start the general fund in January. That would leave an \$82,348 surplus, he said.

Commissioner James Dressel of Holland favored re-opening the budget to re-distribute the surplus where 1974 budget cuts were made, rather than put most of the surplus in the contingent fund.

Commissioner William L. Kennedy of Allendale said an addition was needed to the branch building in Holland and a new branch building was needed in the southeastern part of the county and urged at least \$150,000 be set aside for the improvement fund. Commissioners agreed.

But Commissioner William Kieft Jr., of Grand Haven moved a decision on the remaining \$432,000 surplus be tabled until after the first of the year and agreed with Dressel's amendment that commissioners ask the finance committee to begin re-working the 1974 budget, taking into consideration salary increases. The amended motion was carried.

Along those salary lines, commissioner Kenneth Northhouse later reported that 1974 salary increases were set at 6 per cent or at the cost of living, whichever ever was greater. Northhouse said latest cost of living figures showed the rate was 7.9 per cent and added that the salary committee was working on a new salary schedule.

Acting on separate salary increase requests, commissioners voted to stay with the 7.9 per cent increase in the county's share of the salary of District Court judges and for Donald Meindersma whose probate court duties were expanded to include referee in the court.

In other action the commissioners:

—agreed to the county's full faith and credit behind \$100,000 in bonds for preliminary engineering, advertising of bids and hearings in conjunction with an inter-county drain system in Holland.

—referred back to committee a request for \$8,483 as the county's share of expenses for the West Michigan Comprehensive Health Planning Unit.

—accepted the re-appointments of Mrs. Robert Stobelaar, the Rev. Rodney Westveer and Larry Vredevoegh to the mental health board and the appointment of Mrs. Bareham to succeed Dr. Peter MaArthur who resigned.

—re-appointed Donald Williams to a second five-year term on the county health board.

—approved commission chairman William Winstrom's appointments of commissioner Herbert Wybenga to the council on aging and commissioner Poel to the county committee on computerizing records.

### Professional Group Raises Record Amount; 3 Divisions Top Goal

The Greater Holland United Way continued its string of successful campaigns today as chairman Laurence J. Overbeek reported 100.1 per cent of the goal reached.

Campaign officials braved chilling temperatures and a snowstorm to symbolize the successful campaign with the traditional sign painting ceremony on Eighth St.

Overbeek said \$247,091 was reported today, surpassing the goal of \$246,741. He expressed his appreciation to the campaign volunteers who carried the message of the United Way agencies to the citizens and praised the cooperation of the community in meeting the needs of those agencies.

Topping the per centages of goal was the professional division with 108 per cent of its goal of \$11,337 or \$12,350 reported. Campaign officials say it was the largest contribution from the professional division.

Divisional chairman William C. Coupe commended his section leaders for their efforts in raising the record amount. They included Dr. Don Dephouse, Dr. George Buskirk, Paul van der Leek and Dr. Clark Weersing.

Other divisions going over the top this year were Industrial and Commercial. Industrial chairman Gary White reported \$180,31, or 104 per cent of the \$153,490 goal. Commercial chairman Ron Hermanson reported \$20,310 or slightly more than 100 per cent of the \$20,305 goal.

Special Gifts, with L. C. Dalman chairman, reported 97 per cent or \$7,643 toward a goal of \$7,850. Retail division chairman Mrs. William Venhuizen showed 95 per cent or \$12,485 or a goal of \$13,116. Public - civic chairman Val Young reported \$20,770 or nearly 85 per cent of the \$24,463 goal. Construction, with Marvin Freestone chairman, showed \$3,865 or \$6,180 or 62 per cent.

Overbeek said more contributions are expected to be reported and some monies reported to the campaign have yet to be collected. He urged campaign workers to return their completed contributions as quickly as possible.

The GHUW supports financially 11 local agencies and 24 others in the state and nation through the United Way of Michigan.

Local agencies include Boy Scouts, Camp Fire Girls, Family YMCA, KANDU Industries, Salvation Army, Red Cross, Community Mental Health, Higher Horizons, Child & Family Services, and on a grant basis Holland Day Care Center and Ottawa Association for Retarded Children.

Assisting Overbeek in directing the campaign were Terry L. Hofmeyer and William R. Sturgeon. John Amaya is president of the GHUW board.

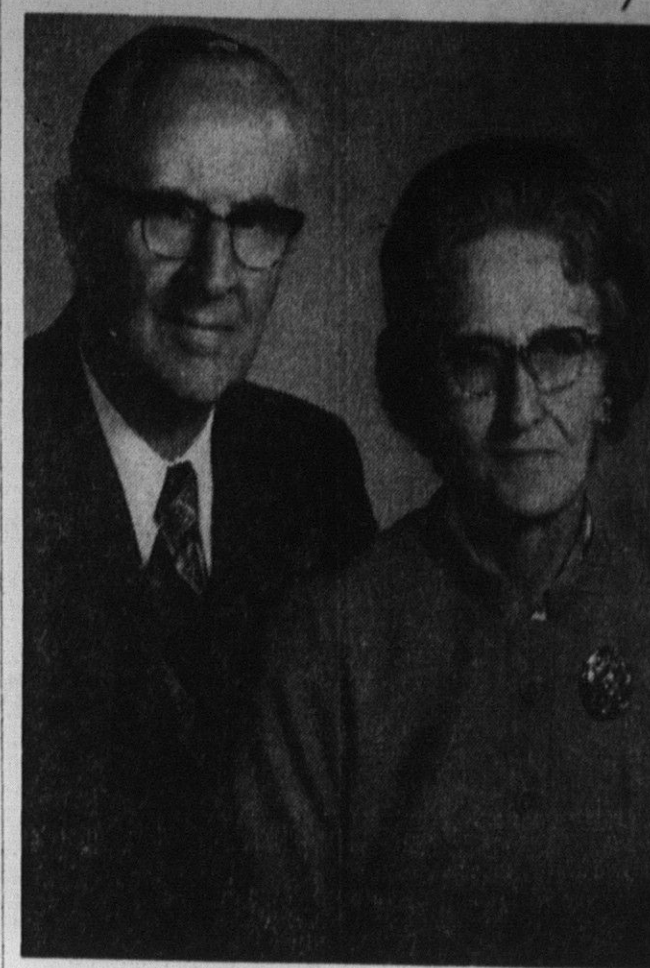

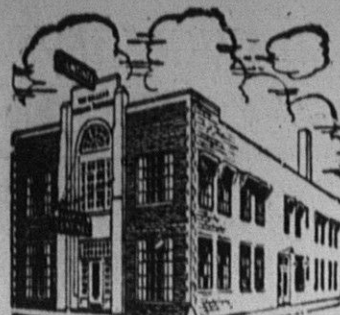

## EARLY CHRISTMAS MAILING

Do your Christmas mailing early. This will allow postal employees to move the mail and avoid problems like last Christmas. A story from Washington D.C. has this to say: "There will be no repeat of last Christmas Eve's mammoth backup of 300 million pieces of mail, Postmaster General E. T. Klassen has promised."

"Despite fuel shortages, he said last Friday, 'We are committed on Christmas Eve, Dec. 24, our Post Offices will be free of mail,' Klassen said, however, that not every letter, card and package will get delivered by Christmas no matter how late it is mailed, because 'There will always be mail in the pipeline.'"

"But he said it was a 'Commitment to the American people.' That barring unforeseen events that the postal service cannot control, mail will not be backed up as last year. 'We don't plan ever to get caught as we did last year, again,' Klassen said."

"The 1972 crisis resulted from a hiring freeze imposed in March and not lifted in time and from an unexpected crush of Christmas advertising mail, he said. Klassen said he has adequate manpower this year."

"Plans are being made to get military help if needed to move the mails," Klassen is reported to have said."

## New Stamps Of 10 Cents Coming Here

Several new stamps will be available at Holland post office over the next several days.

Coming soon is the 10-cent crossed flags stamp in sheet and coil form, designed for use when proposed new postal rates go into effect Jan. 3. The two flags depicted are the present 50-star flag and a 13-star flag in salute to the Bicentennial of the American Revolution coming in 1776.

Slated to go on sale Dec. 15 is the 10-cent Jefferson Memorial stamp in sheet, coil and booklet form. Sheet stamps will be in panes of 100 and coils will be issued in rolls of 100, 500 and 3,000. One booklet form will have eight stamps to a pane and the other will have five. The latter is intended for use in vending machines. The stamp portrays the Jefferson memorial in Washington with the words, "We Hold these Truths."

The third of the new series of 10-cent stamps is a Zip code stamp which will be available Jan. 5. The theme is based on a poster created by Randall McDougall, a Postal Service artist. The modern design shows several means of transportation by which the mail is moved and conveys the message, "It All Depends on Zip Code."

An eight-cent Samuel Adams postal card and 16-cent reply-paid card will be available Dec. 17. It is the third in a series honoring colonial patriots. A card was issued in 1971 for Paul Revere and in 1972 for John Hanson. It also is associated with the Bicentennial of the American Revolution.

## Sunday School Lesson

Sunday, Dec. 16  
Belief or Unbelief  
John 12:37-50  
By C. P. Dame

It is more popular to talk about belief than unbelief. Some people believe, some will not believe and pay the penalty. Unbelief hurts, belief enriches life. A lesson like this one tells us that we can choose to believe or refuse.

I. Some people will not even consider believing. John's story of the public ministry of Jesus ends at chapter 12. Verse 37 to verse 43 tells about the results of the Lord's ministry. From verses 44 to end of the chapter John gives a summary of the claims and teaching of Jesus. "Though he had done so many signs before them, yet they believed not on Him." The word "signs" refers to the miracles of Jesus. John records several. Through these miracles Jesus revealed His power over nature, and diseases, and even over death. The teaching and the miracles astounded the people but they did not instill belief in their hearts.

Isaiah the prophet foretold the unbelief of the people. A casual reading of Isaiah seems to suggest that God caused the unbelief. The real fact was that the people stubbornly set their will against belief. Some people today will not consider the claims and teaching of Jesus, in spite of the great influence He has and is exerting upon mankind.

II. Some did not dare to take a stand for Jesus. "Nevertheless many, even of the authorities believed on Him." The words, "but because of the Pharisees they did not confess Him, lest they should be put out of the synagogue." For they loved the praise of men more than the praise of God. "I reveal cowardice. Recall what Jesus says about cross-bearing. The Bible says that belief must express itself in public confession (Matthew 10:32, 33; Romans 10:9, 10). Faith costs."

III. Some do not realize what it means to be a Christian. It is not enough to believe in God, belief in Jesus is essential. Jesus came to save the world, not to judge it but His word will judge him. Today it is time to teach that judgment is sure. Many people do as they please regardless of what the Bible teaches. And this holy Book says that God "hath committed all judgment unto the Son" — who knows our weaknesses and trials and the strength of the enemy.

The choice we face is between belief and unbelief. And let us note that unbelief involves rejection. Any one who rejects Jesus hurts himself and hurts the Lord who called, gave up His life, so that rebels might believe and really live. Why refuse to believe when the evidence is so great?

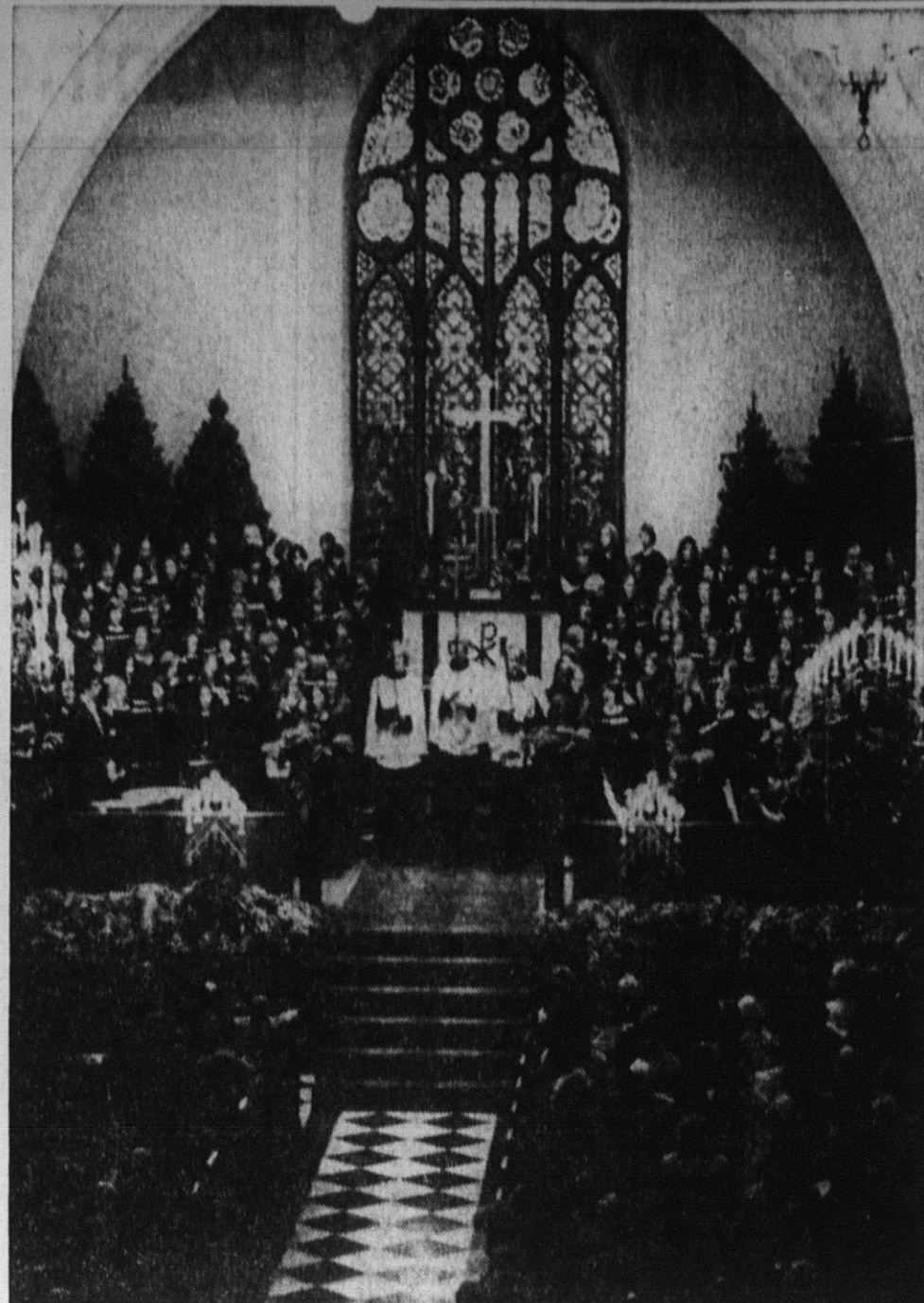

## Bicentennial Group Meets In Holland

Financial requests, selection of an official name, and election of a treasurer were agenda items of the now named "Ottawa Bicentennial Committee."

## League Program Focus Is on Best Use of Land

The League of Women Voters held its December meeting Monday at First Presbyterian Church. The president, Eleanor DeKruif, reminded the League of the vote for two junior high schools on Dec. 17.

She introduced Mary Brown who is chairman of Environmental Quality and Land Use in Michigan. Mrs. Brown was president of the Kalamazoo League for four years, is now a full time teacher at Western Michigan University, and a mother of young children. She has been active in the desegregation busing in the Kalamazoo schools.

By 1920, any urban area of 5,000 or more population had zoning ordinances. Today one-half of all governmental units have land use plans, but many townships have no plans other than zoning codes. Most townships have a zoning board, but some rules cannot be enforced. Strip zoning has become common along narrow developed areas.

Grand Traverse County called "Michigan's Frontier" has been subdivided into 10.1 acre plots. Many cabins have been built in cedar swamps where no utilities are available. Developers have paved big areas and leveled off hills with no place for the drainage of water. High sedimentation in the local rivers and dredging in the lakes result from this kind of fast land development.

## Thrasher Draws Prison Sentence

GRAND HAVEN — Charles C. Thrasher, 40, of Holland, who pleaded guilty to a charge of abducting his sister-in-law July 9, was sentenced to two to five years in prison by Circuit Court Judge James E. Townsend.

Thrasher was charged in connection with the disappearance of Marie Hunter, 17. He was located in Florida July 25 and both he and the girl were returned to Michigan. Officers said they believed Thrasher took the girl in an effort to force his wife to end their separation.

Also sentenced Monday in court was Jewell Cathy Carroll, 23, of Holland, for forgery of records. She was placed on 18 months probation and ordered to pay \$114.54 in restitution.

## Many Items Processed For Schools

The Board of Education updated its plans for meeting the energy crisis, approved forms for administrative evaluation, affirmed its commitment for equal opportunity and nondiscrimination in employment, and hired a computer payroll service for the remainder of the 1973-74 school year at its monthly meeting in the high school library Monday night.

The energy crisis update dealt entirely with gasoline for school buses, and in all cases, safety and the wellbeing of the pupils remained the primary consideration.

Transportation for special education is mandated by statute and is priority area No. 1. Other areas are in instruction with transportation to and from schools (elementary and secondary) with the greater the distance, the higher the priority. Other priority areas are in services, affecting transportation for maintenance and service vehicles, deliveries and other gasoline powered equipment. Other uses listed transportation of pupils in educational activities including field trips, as well as athletic and recreational events.

Limiting and consolidating bus stops, eliminating non-essential travel of buses, reducing warmup periods, driving at moderate speeds and other considerations also are listed.

In adopting data processing for payroll, the board adopted a recommendation to obtain this service from First Michigan Bank and Trust Co. of Zeeland, with the business of office continuing to investigate sources for a possible July 1 implementation of general fund accounting. Business Manager Lee Van Aelst outlined the program. Costs of payroll services for the six-month period are estimated at \$2,200.

In adopting its affirmative action program on human rights, the board is committed to continue to increase the number of qualified Latino staff members in the district so as to approximate the proportion of Latino students in the district. On recruitment college teacher placement offices will be informed that the local district is especially interested in receiving application from minority members, particularly Latino, to meet the needs of its Latino student population.

The district also will continue to assess and modify the currently adopted curriculum from a multi-ethnic perspective. This review may involve teachers, administrators, students and parents as determined by the Board of Education.

The new evaluation program follows the philosophy that the school district is determined to provide high quality for its pupils. Consistent with this goal is the expectation that each member of the administrative staff, given fair and reasonable treatment, effectively discharges the full responsibility of his assignment. Each administrator will be evaluated annually.

A communication from Police Chief Charles Lindstrom reviewed a study aimed to improve safety at the intersection of 15th St. and River Ave. A suggested overhead passing is too costly, and a four-way flasher was not approved by the State Highway Department. A full time crossing guard was recommended and the board will study this recommendation at its next work session.

A communication from Raza Unda pledged its support of the forthcoming bond election Dec. 17.

John Weeber of the building committee explained that a lease has been drawn whereby the Ottawa Intermediate District will rent two rooms in the new addition of the old Maplewood school starting July 1, 1974, at an annual rental of \$3,700. The lease will run two years. Two other rooms also are being renovated. The old section of the school is used for storage.

The board granted a release of contract for Mrs. Mary Flint, junior high physical education teacher, at the close of the first semester for family purposes. The board also rescinded its action taken last month for a release of contract for Phyllis Hilborn, inasmuch as Mrs. Hilborn had signed a contract for one semester only. The action was taken to clarify the situation.

A request from the manager of 40 West Apartments requesting bus service to Junior High School was regrettably declined because the housing project is less than the three-mile limit for busing students.

President James O. Lamb presided at the meeting which lasted 1½ hours. Robert Gosse gave the invocation. Absent were Mrs. Katherine McKenzie and John Amaya.

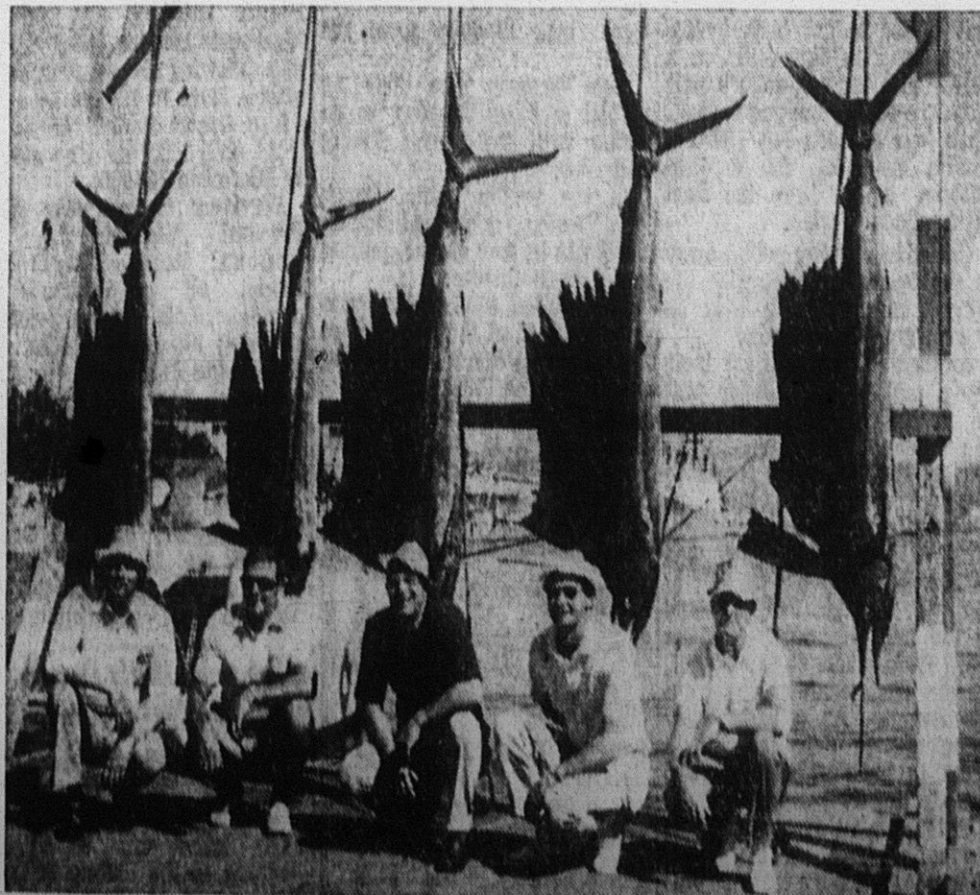

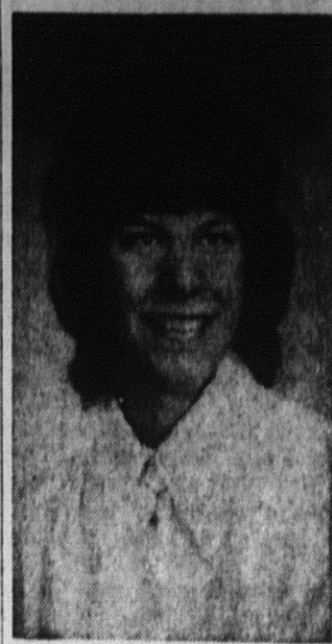

At Hope College

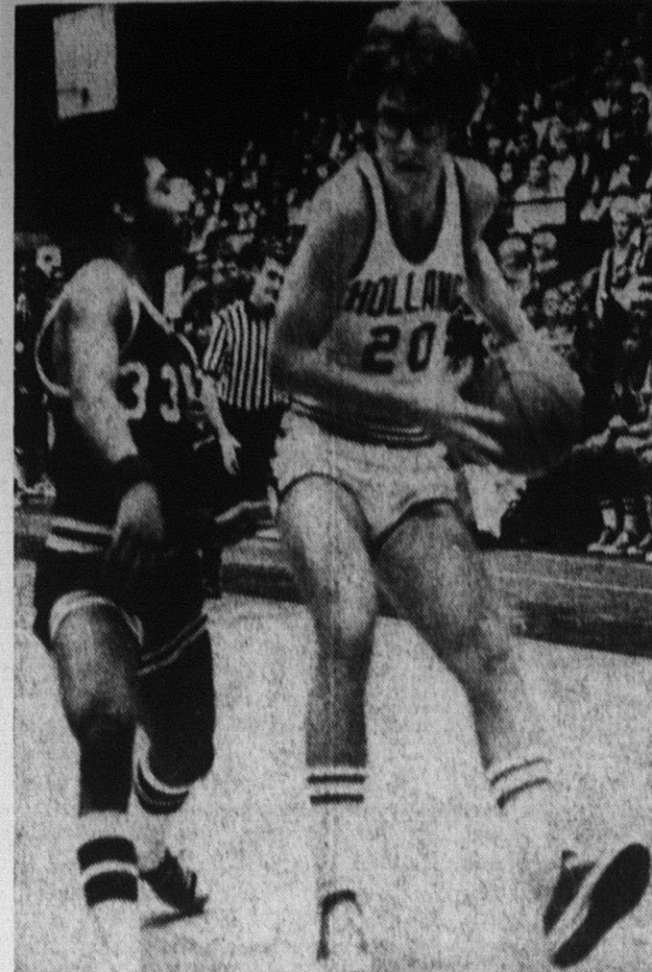
Three courses in the Executive Management Development Series, sponsored by Hope College and the Chamber of Commerce, will open the third week in January on Hope campus.

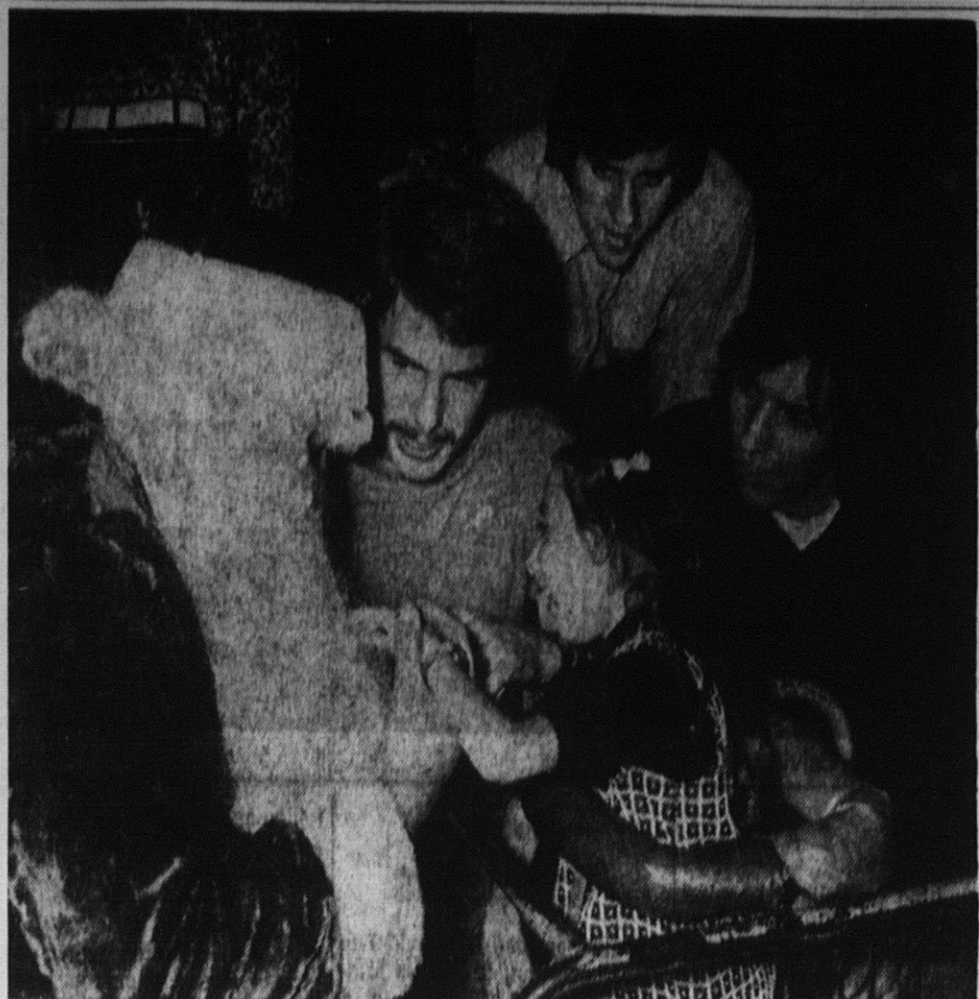

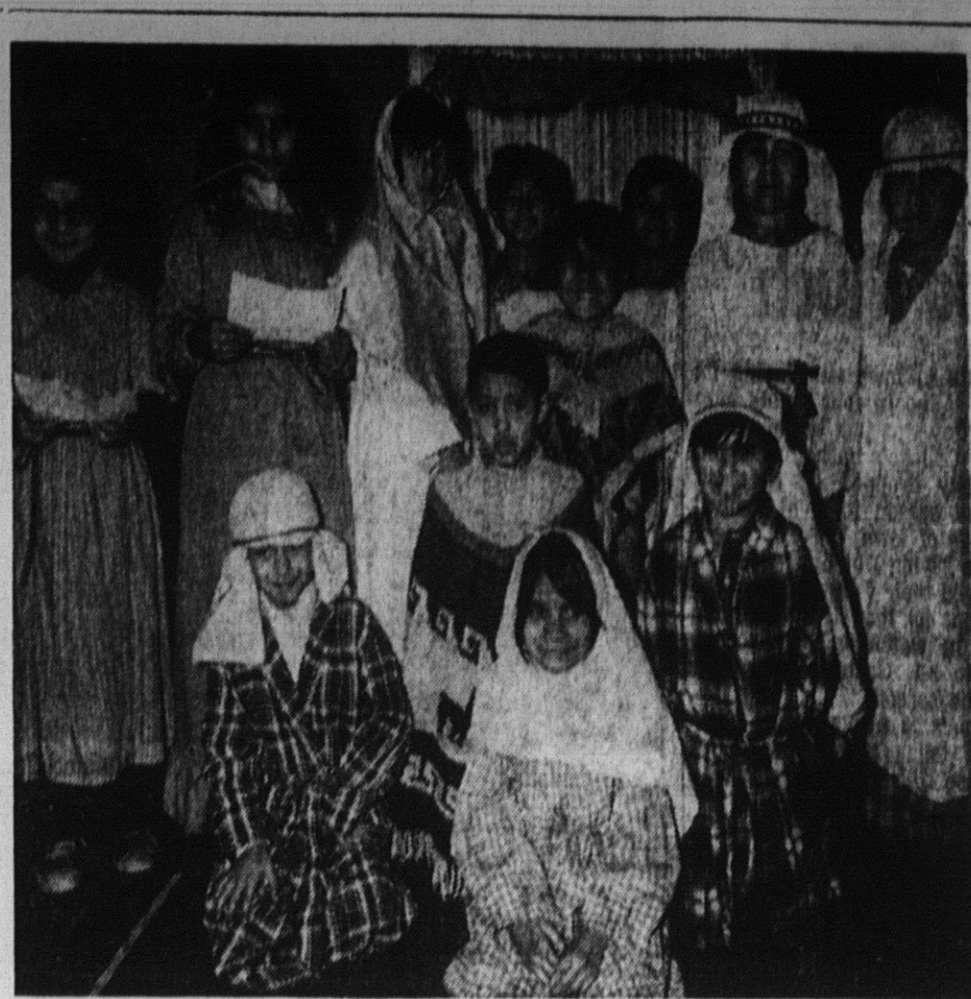

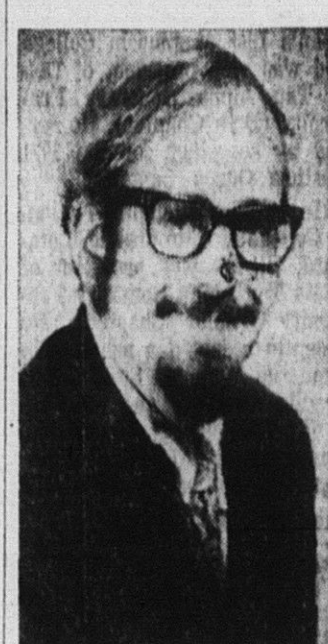

The Flying Dutchmen of Hope played their worst game of the season, as they trailed all the way in watching their record fall to 3-1. Central is now 2-1 for the season.

Hope's 23 turnovers and Central's tough man-to-man defense did the Flying Dutchmen in.

Central netted two more baskets than Hope, 28-26 on 61 attempts for a 46 per cent average. Hope took only 49 shots in the contest for a 52 per cent mark.

Hope did manage to out-rebound Central, 38-32, as Brian Vriesman led the way with 11. Mark Gosselink had the same total for Central.

While Central had three players in double figures, Vriesman was the lone Hope player to score over 10 points. The 6'6" Hope junior had 19 markers against Central. Pacing the winners was Wiersma with 19 counters, Gosselink with 18 and Dave Swanson with 15.

## New Heinz Book Is Fascinating Story

"The Good Provider: H. J. Heinz and His 57 Varieties," a new book by Robert C. Alberts, is a fascinating story of the founder of the great American food empire which bears his name.

Henry J. Heinz (1844-1919) was a many-sided man: producer of food products, showman, collector of art, horseman, world traveler, religious leader and philanthropist. The book is based largely on a wealth of recently discovered family dairies, including those of H. J. himself, letters, documents, scrapbooks of magazine and newspaper articles and employ publications.

In 1888, Heinz purchased interests in the business, renamed the company the H. J. Heinz Company and went on to become an industrial tycoon. He led crusades for two of the advanced ideas of his time: he built a model factory complex in the 1890s on the principle that employees deserved clean and pleasant working conditions with opportunities for leisure and self-improvement, and he risked his business and his position in his industry by campaigning for the Federal Food and Drug Act which Congress passed in 1906.

The book makes no mention of the pickle and vinegar plant in Holland, Mich., often called the world's largest pickle factory.

Today the H. J. Heinz Co. includes 23 subsidiary companies in 17 nations, has 35,000 employees and maintains world headquarters in Pittsburgh. Its 1973 net sales totaled \$1.2 billion and its 1973 net income \$46.5 million.

The symbol "57" has long been lacking in accuracy. There are some 1,200 products today.

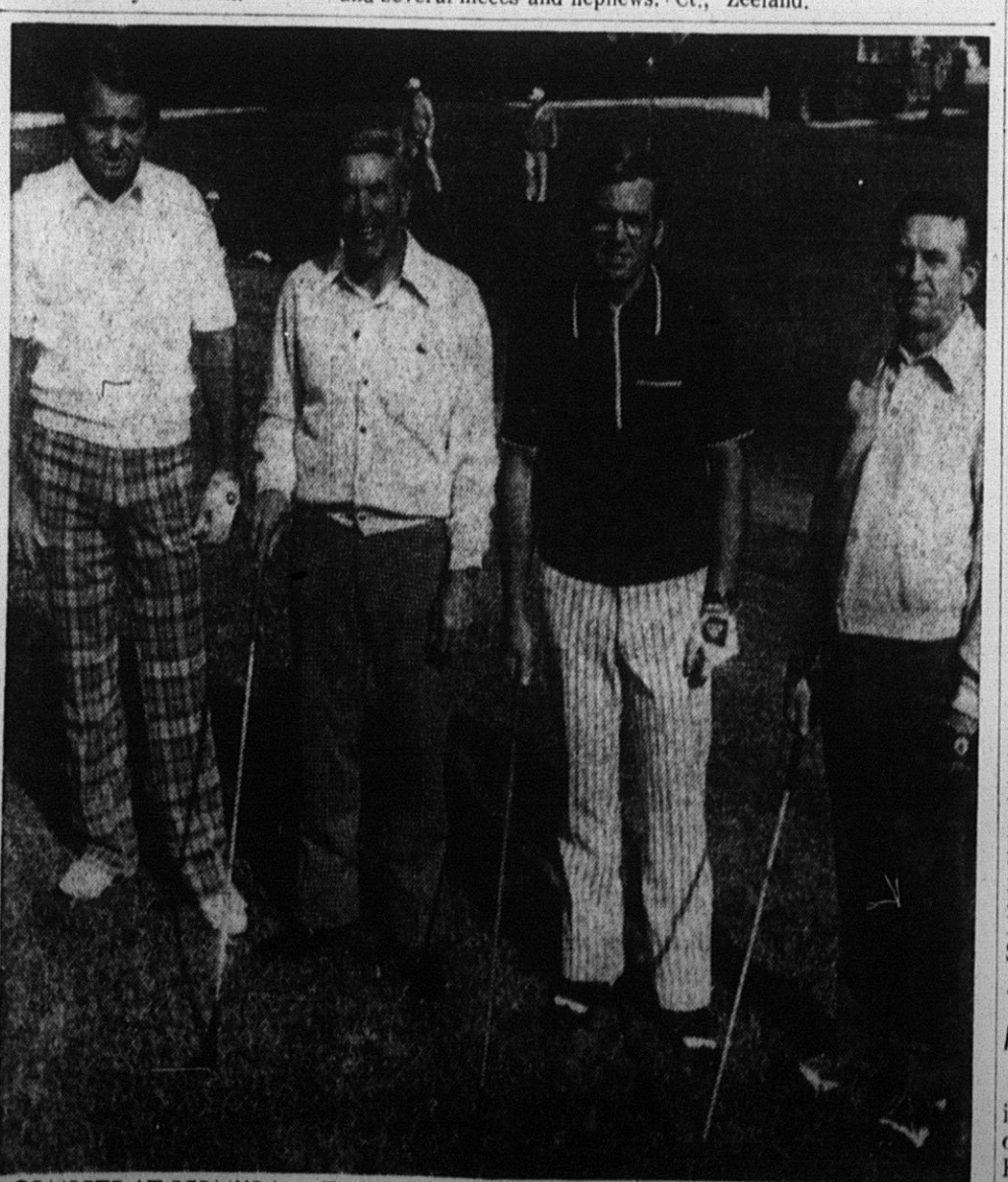
