Holland, Michigan

Dr. Albertus C. Van Raalte was present at this meeting of the Board of Regents of the Holland Academy on this date. Since the Board was in debt, it simply not accept any students who depended on the Board for financing their education. All students will need to fund the purchase of their books now.

Art 5. Whereas the embarrassing condition of the Board, of being in debt without funds to pay, continues to press upon the Board it was resolved: to take no more boys on the Funds of the Academy, untill all debts of the Board are paid

Art. 6. In order to relieve the treasury, and to prevent misunderstandings, as to the Terms on which Students are taken on the Funds of the Academy, it was resolved: that after the close of this Academical year, every Student shall have to provide for his own books, except in such cases where the Faculty shall deem it proper to grant them.

Art 7. The meeting was closed with prayer.

Art. 2. The minutes of the former meeting
were read and approved.

Art. 3. The committee of accounts reported
that the book of the treasurer was
found in due order; and ^{also} presented to
the Board to accounts of receipts, expenses
and debts, which were accepted.

Art. 4. The Pres. Ch. v. d. Veen & A. J. Zwaren
with the Elder G. Watter were appointed
a committee, to look at the repairs, done
and in progress, of the Academy buildings.
