November 23, 1859 Kingston, Ulster Co., New York

A letter from John Van Vleck to ACVR, responding to ACVR's letter to him, dated November 12. Van Vleck has now moved to Kingston. Apparently ACVR promised to pay him what the Academy owed and, therefore, the tone of the letter is more cordial. He hopes that ACVR will see him in Kingston.

Rev. A. C. Van Rualte:

Dear Sir, Yours
of Nov. 12th I have this moment received.
The reason why it was so long in reaching
me is that I do not reside in Ulsterville.
We moved to this place about three months
ago.

I am very sorry to hear that you
were unwell. I hope you have recovered
before this. Had I suppose that you were
now sick in New York I should come
immediately down to see you. Hoping
that you have recovered I shall wait to
hear from you further. We will be
very glad to see you at Kingston.

I am glad you have money to send
me. I need the money, and ought to have
it soon. I have heard that you were
actually engaged in the construction of

a wing to the Academy. Previous to any
outlays for this purpose I have a right
to expect that my claims should be cancelled.
I suppose money may be safely sent in
form of checks or by Express: or if you
will appoint a time and place I will
endeavor to come and get it, although
it is difficult for me to leave here just
now. Could you not come to Kingston?
My sisters are here also, & we will all
be very glad to see you.

Please let me hear from you soon
as I am in considerable anxiety. With the
best of wishes I remain
