Enclosed I send you tax Receipt & redemption Certificate the reason why these tax receipts were not made out in the time of the Sale was ~~that~~ they had no blank tax receipts on hand and again During the fall I was Sick the Greater part of the time and urgent business to be attended to occupied about all the time I was able to be moving around.

Lot 5 Sec 22 ~~W~~ W $\frac{1}{2}$ of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ Town 5 N of Range 15 W was sold to the State I have written to the Auditor General to Cancel the Sale and Change back to the County as the taxes had been paid to the Town Treasurer the balance of yours returned for 1849 I can take care of before the next Sale Excuse the Delay in finishing up your business this time and I will Endeavour to be more prompt hereafter i.e. being blessed with good health
