29 April 1874

Holland, Michigan

Dr. Albertus C. Van Raalte was not present at this spring session of the Council of Hope College. The meeting was called to order by Rev. John H. Karsten. A vote of thanks was voted for the gift of Samuel B. Schieffelin. Examinations of students were conducted. Profs. Scott and Crispell were thanked for filling in for Prof. Gerrit J. Kollen while he was out fundraising. More gifts of books to the library were reported. Many volumes came from the library of Rev. Abram Swits. The minutes of this meeting were poorly reported, leaving many blanks. The long-serving secretary, Abel T. Stewart, may have been tiring from his service as the faithful secretary for both the council and for its executive committee.

That a credit is proposed of 121. for rent and 9.00 for some repairs = 130. It was resolved to accept this proposed audit and change the mortgage securing the \$1000 in in a way satisfactory to the Council and the Professor. and liquidate all other claims as soon as possible practicable.

Salaries of Professors. referred to Gen Syn. In the Communication of Prof Scott it is stated that on the 30 of April 1874. ~~there is due~~ which closes the fiscal year of the Board of Education & of the General Synod, there will remain due to him for Salary about \$660.11 \$525.00 and as there will be a similar deficiency in the case of all those whose salaries were fixed and have been paid by the Board of Education, your Committee recommend that the attention of the next Gen. Synod be especially called to this important matter. The report including this recommendation was approved.

The Rev Mr. Broek appeared in Council in the early part of this session. A letter was read from Prof Crispell stating his reception of 235 vols and a quantity of unbound magazines & pamphlets all more or less valuable from Rev A J. Swits[?] of Schenectady, also his presentation for Mr Swits[?] of these books as follows cataloged & labelled[sic] as follows
137. vols to the Theological Seminary at Hope College and the remainder of the bound vols with the magazines & pamphlets[sic] to the Academical Department of the College.

The letter also stated that the vols presented to "the General Synod for the Theolog

Rev H Vedder of Gallatin N. Y. and Mrs Eliza, widow of Rev Joseph A Collier of Hudson N.Y. (see minutes of 1872 page) are labelled[sic] and ready for delivery. The donors wish them to be placed in the library of Hope College the Theological Seminary at Hope College.

Res^d that the 235 vols and miscellaneous magazines and pamphlets presented per Doctor Crispell for Rev A J Switzts[?] the different

Departments of Hope College be received, and that the thanks of this Council be presented to Mr. Swits for his valuable gift.

Res^d that the vols presented by Rev H Vedder and Mrs Eliza Collier to the Gen. Synod be placed in the Library of Hope College. Adjourned till 2 P.M
