The tax bills of ACVR for 1848. One list is of 1,152 acres plus city lots for which he paid \$26.26 in state and county taxes and \$4.10 for school taxes. Another list is for 503 acres for which he paid \$7.72 in state and county taxes and \$0.77 for school taxes. The third list for 480 acres is called "A. C. Van Raalte's personal Estate," for which he paid \$15.25 in state and county taxes and \$2.39 in school taxes. All of the above properties are in "Ottawa" township.
