Ottawa County, Michigan

Rev. Albertus C. Van Raalte paid \$39.18 for back taxes on four properties in Ottawa County totaling 580 acres on this date. Since the taxes were paid at this time of the year rather than in January, these taxes were for tax delinquent properties presumably.
