Abstract

Michigan state senator (1944-1950) and lieutenant governor (1950-1952). Correspondence concerning politics and with local businesses as a leader in the Holland Chamber of Commerce; biographical material, personal correspondence with many well-known individuals, both local and national, like Earnest Brooks, W. A. Butler, G. J. Diekema, E. D. Dimnent, George Getz, and Willard Wichers; records and correspondence from the various companies and officials with which he was associated, such as the Sugar Beet Factory, Benjamin Hanchett, Holland Furnace Company, and Parke Davis and Company; political material including local, state senate, lieutenant governor, and his unsuccessful campaign for governor in 1952, as well as his connections with many national political personalities throughout his lifetime, such as Gerald R. Ford, Jr., Rep. Bartel Jonkman, Rep. Carl Mapes, Sen. Arthur Vandenberg, Gov. Harry F. Kelly, Gov. Kim Sigler, Gov. G. Mennen Williams, and Sen. Homer Ferguson; corporation record books from the Wolverine Advertising Company and the Vandenberg Brothers Oil Company.

Biography

William C. Vandenberg, Sr. was born in Holland, Michigan, on October 3, 1884, and with the exception of the period from 1904 to 1919, lived in Holland his entire life. After graduating from Holland High School in 1904, he entered Voorheis' Business College in Indianapolis and began his active business career in Grand Rapids in 1906.

In 1909, he married Florence Fairbanks, granddaughter of Isaac Fairbanks, an early pioneer of the Holland area. They had a daughter, Mrs. Jack (Florence) Daniels, and a son William C., Jr.

Mr. Vandenberg began working in 1909 in the office of the former Grand Rapids Street Railway Company and later was assigned to the office of Benjamin S. Hanchett, president and general manager. Hanchett was active in Republican politics and it was here that Vandenberg became interested in Republican affairs. Hanchett later became president of the old Grand Rapids, Holland and Chicago Railroad and headed both the Ottawa Beach Hotel Co. and the Ottawa Beach Resort Co. Vandenberg became treasurer of the interurban operation and secretary and treasurer of the hotel and resort companies.

In 1919, Vandenberg left Grand Rapids to enter the wholesale and retail oil business in Holland and during the next few years expanded the operations to cover five counties in Western

Michigan. In 1934, he helped promote the Burnips oil field and later promoted and developed the Fillmore oil field.

In 1923-1924, Vandenberg spearheaded a group to organize the Holland Chamber of Commerce, whose first assignment was to help Holland Furnace Company in building Hotel Warm Friend. He became a charter member of the Rotary Club in the early 1920s and around the same period was a member of the South Ottawa and West Allegan County Fair Association. In 1931, he set up the Holland Community Chest and headed the first two campaigns. He then served as chairman of the Ottawa County Chapter of the American Red Cross.

Vandenberg served as a Holland city councilman in the 1930s, was elected in 1944 as a Republican state senator from the 23rd district and was reelected in 1946 and 1948. During his six years as a state senator, Vandenberg remained very active in local projects, one of which was arranging for the Parke Davis and Company plant to locate in Holland in 1949. He also aided in negotiations to establish Baker Furniture Company in Holland, and was active in the early studies of a bridge over the Straits of Mackinac. In 1950, he was elected lieutenant governor, serving under Democratic Governor G. Mennen Williams. In 1952, he was unsuccessful in a bid for the Republican gubernatorial nomination.

For many years Vandenberg was a member of the Methodist Church in Holland and in 1958 was one of a group of six attempting to organize a second Methodist Church in Holland. Obstacles which he encountered in the organizational process resulted in him becoming one of the founders and charter members of First Presbyterian Church.

At the time of his death, Vandenberg served as vice president of Vandenberg Motors, where he had been since establishing the business in 1946. He died in Holland Hospital on June 9, 1971, after suffering a heart attack in his home.

Scope and Content

The papers of William C. Vandenberg cover his time as a Michigan state senator and his term as lieutenant governor, as well as his involvement in the community of Holland. There is a considerable amount of political correspondence, and correspondence with many local businesses with which Vandenberg was associated through his involvement in the Holland Chamber of Commerce.

Much of the correspondence is from voters urging Vandenberg to vote one way or another on particular legislation. The fact that Vandenberg's responses were attached to the letters is particularly helpful in revealing Vandenberg's stance on political issues of that time.

The material is divided into three main series: **Personal**, **Business**, and **Political**. The **Personal** series contains biographical material, personal correspondence with many well-known individuals, both local and national. Correspondents include Earnest Brooks, W. A. Butler, G. J. Diekema, E. D. Dimment, George Getz, and Willard Wichers. It also contains photographs of Vandenberg and others.

The **Business** series includes correspondence with many local businesses, records from the various companies with which he was associated, particularly his involvement with the reopening of the Sugar Beet Factory in 1933. Correspondents include Benjamin Hanchett, Holland Furnace Company, and Parke Davis and Company.

The **Political** series is subdivided into local, state senate, lieutenant governor, and his unsuccessful campaign for governor in 1952. This is the largest of the three categories and

includes large amounts of correspondence with political figures. The local subsection details his involvement in local politics, but also reveals his connections with many national political personalities throughout his lifetime. Correspondents include Gerald R. Ford, Jr., Rep. Bartel Jonkman, Rep. Carl Mapes, Sen. Arthur Vandenberg, Gov. Harry F. Kelly, Gov. Kim Sigler, Gov. G. Mennen Williams, and Sen. Homer Ferguson.

There are three corporation record books from the Wolverine Advertising Company and the Vandenberg Brothers Oil Company. These are located in Box 6. The oversize materials are a memorial resolution from the state senate and the certificate of election to his first term as state senator.
